Dear Senator Kaine:

This is in response to your May 25, 2018, inquiry on behalf of your constituent Mr. Brian D. Hill, who makes numerous allegations involving his 2015 criminal court case and requests an investigation.

The FBI is familiar with Mr. Hill and has received similar complaints from him. However, in order for the FBI to initiate an investigation of any complaint we receive, specific facts must be present to indicate that a violation of federal law within our investigative jurisdiction has occurred. Based on the information Mr. Hill has provided to your office, as well as that which he previously provided to our Richmond and Charlotte Field Offices, there are insufficient facts to demonstrate a violation of federal law within our investigative jurisdiction or to support the initiation of an FBI investigation. We are, therefore, unable to provide any assistance to him.

I hope this information is helpful to you in responding to your constituent.

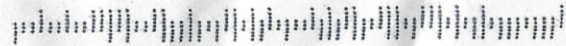
