RADIOLOGISTS REPORT NO SIGNIFICANT ABNORMALITY

RIGHT HUMERUS:

Bony structures appear normal. There are several small metallic foreign bodies in the soft tissues about the distal humerus.

RIGHT ELBOW:

Bony structures are normal. There is no evidence of joint effusion. Several tiny metallic foreign bodies are evident in the soft tissues.

CHEST:

Lungs are clear and heart and bony structures normal. There are one or two small metallic fragments seen over the right lower chest.

LEFT FEMUR:

Bony structures are normal. One small metallic body is seen in the soft tissues medial to the distal femur.
