PRESS RELEASE

HERBERT L. MONAHAN, JR., Special Agent in Charge of FBI operations in the state of North Carolina, announced today the arrest of JACK WILSON FOWLER, JR.

FOWLER, a 28 year old resident of Winston-Salem, N. C., was arrested by FBI Agents in Hinsdale, Illinois, on November 15, 1979, as a result of a Federal warrant issued at Greensboro, N. C., on November 8, 1979, charging him with unlawful flight to avoid prosecution. He was sought in connection with the deaths of five Communist Worker Party members during an anti-Ku Klux Klan demonstration in Greensboro on November 3, 1979. FOWLER, a member of the National Socialist Party of America, is scheduled for an appearance before a U.S. Magistrate in Chicago, Illinois, today.

TO AIDE FAMILIES OF THE CLAN DEMONSTRATORS. ADDRESS LISTED ON THE PAMPHLET IS COMMITTEE TO AVENGE THE CWP 5, CARE OF POST OFFICE BOX 4201, BERKELEY, CALIFORNIA, 94704, TELEPHONE NUMBER 982-9662.

DURING THE DEMONSTRATION, A FIGURE, VARIOUSLY DESCRIBED AS A KLU KLUX KLAN MEMBER OR A FBI AGENT WAS BURNED IN EFFIGY. AT APPROXIMATELY 1:00 P.M., ABOUT 20 INDIVIDUALS, SOME WITH BATONS, ENTERED THE LOBBY OF THE FEDERAL BUILDING AND ATTEMPTED TO SET UP BANNERS THERE. A CONTRACT GUARD ATTEMPTED TO INTERVENE AND WAS STRUCK BY A DEMONSTRATOR. FEDERAL PROTECTIVE SERVICE PERSONNEL ENGAGED THE DEMONSTRATORS AND PUSHED THEM OUT OF THE LOBBY. SHORTLY THEREAFTER, THE SAN FRANCISCO POLICE DEPARTMENT, TACTICAL SQUAD, ARRIVED AT THE SCENE AND QUELLED THE DISTURBANCE. THE DEMONSTRATION ENDED AT APPROXIMATELY 1:30 P.M. NO ARRESTS WERE MADE. CONTRACT GUARD APPARENTLY NO SERIOUSLY HURT. THERE WERE NO INDICATIONS OF ANY TRAVEL PLANS BY THIS GROUP TO GREENSBORO, NORH CAROLINA.

GREENSBORO CARAVAN, BUT WOULD NOT TELL THE FBI IF HE DID KNOW. HE STATED HE IS WELL ACQUAINTED WITH [REDACTED], AND WAS IN TELEPHONIC CONTACT WITH HIM NIGHT OF NOV. 14, 1979. [REDACTED] ALLEGEDLY CALLED SCOGGIN AND INQUIRED AS TO HOW TO SET UP A DEFENSE FUND. ALLEGEDLY DETAILS OF SHOOTING INCIDENT NOT DISCUSSED BY SCOGGIN AND [REDACTED]. SCOGGIN ADVISED HE WOULD VIEW PHOTOGRAPHS OF GREENSBORO SHOOTING IF AVAILABLE, BUT WOULD NOT IDENTIFY ANYONE IN PHOTOS. WOULD VERIFY NAMES OF INDIVIDUALS IN PHOTOS IF KNOWN BY FBI. SCOGGIN ADVISED HE KNOWS NO ONE FITTING DESCRIPTION OF WHITE MALE, 22-23 YEARS OLD, MEDIUM LARGE BUILD, MUSCULAR, RED WAVY HAIR, REPORTEDLY SEEN IN WHITE PICKUP IN CARAVAN AND LATTER SEEN TO FIRE TWO SHOTS INTO THE AIR. SCOGGIN AGAIN REPEATED HE WOULD NOT TELL FBI EVEN IF HE DID KNOW. AT THIS, SCOGGIN TERMINATED COVERSATION STATING FBI WAS WASTING HIS TIME. HE WAS ADVISED HE COULD BE SUBPOENAED TO TESTIFY REGARDING THE MATTER AND HE REPEATED HE HAS NOTHING TO TELL. CONVERSATION WAS THEN TERMINATED.

In July, 1979, the Ku Klux Klan (KKK) advertised a rally to be held at China Grove, North Carolina, on July 8, 1979, where the film "Birth of a Nation" was to be shown.

On July 8, 1979, the KKK meeting was disrupted by a group identifying themselves as members of the Workers Viewpoint Organization (WVO). During the disruption, members of the WVO obtained the Klan flag and burned it in their presence. Photographs of the incident reflect both members of the WVO and Klan had firearms but the presence of law enforcement officers at the scene prevented bloodshed.

Subsequently, members of the WVO advertised a "Death to the Klan" rally and parade to be held in Greensboro, North Carolina, on November 3, 1979. Numerous posters advertising the event were posted in the area and it received considerable media coverage as well.

On November 3, 1979, at the starting point of the planned parade of the WVO, numerous members of the Klan and Nazi Party appeared in a caravan of vehicles. Shooting erupted and five members of the WVO were killed and several others wounded.

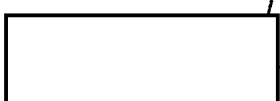

A spokesman subsequently advised his group was no longer affiliated with the WVO but three weeks earlier the name of the group had been changed to the "Communist Workers Party" (CWP). It was also announced the CWP would hold a funeral procession in Greensboro, North Carolina, on November 11, 1979, for the five members of the CWP who had been killed November 3, 1979. The city of Greensboro thereafter declared a state of emergency on November 10, 1979.

In accordance with the declared state of emergency, the city of Greensboro obtained assistance of the Guilford County Sheriff's Department, the North Carolina Highway Patrol, the State Bureau of Investigation, as well as the National Guard. The National Guard effectively sealed all intersections along the parade route. Members of the Greensboro Police Department encircled those marching in the procession and acted as a mobil shield from the starting point until the cemetery was reached.

It had been previously ascertained that a caravan of demonstrators would be transported from Durham, North Carolina, to take part in the funeral procession in Greensboro on November 11, 1979. On the morning of November 11, 1979, agents of the Federal Bureau of Investigation (FBI) observed the demonstrators in Durham, North Carolina, gathering at the "Break the Chains" Bookstore. Demonstrators were observed in possession of weapons which were placed in a number of vehicles. The demonstrators then formed into a 16 vehicle caravan led by CHARLES FRANKLIN FINCH, owner of the "Break the Chains" Bookstore.

Information regarding weapons in possession of the demonstrators was relayed by the FBI to local authorities. It was determined that sufficient probable cause existed for issuance of a state warrant for transporting dangerous weapons to the scene of an emergency. FBI surveillance of the caravan continued as the caravan proceeded toward Greensboro and state and local authorities were provided with continuous coverage through previously arranged channels of communication. FBI surveillance of the caravan continued to the city limits of Greensboro where members of the Greensboro Police Department, North Carolina Highway Patrol and the State Bureau of Investigation stopped the caravan. All vehicles and persons in the caravan were checked and numerous weapons were confiscated. Twelve persons were charged with transportation of dangerous weapons. Remaining individuals were permitted to proceed to downtown Greensboro to participate in the funeral procession.

In accordance with prior agreement, with city officials, an honor guard with the funeral procession was permitted to carry rifles, shotguns and semi-automatic weapons but they were instructed not to have loaded weapons or available ammunition. Prior to the beginning of the procession the National Guard confiscated all ammunition from the honor guard.

Prior to the beginning of the funeral procession, a considerable amount of time was spent at the point of embarkation. Those to march in the procession were furnished with placards and signs. A sound truck was utilized to issue instructions to the marchers and a musical group sang revolutionary songs. Five caskets draped in red were placed on rolling metal stands pushed by pallbearers. One casket was placed at the front of the procession and the remaining four caskets were placed at a point mid-way in the procession. The approximately 300 marchers then proceeded slowly along the parade route to the cemetery. Mobil sound equipment and the sound trucks were utilized in chanting slogans such as "Avenge the CWP-5." Numerous media personnel were present and at some points the procession was slowed by efforts of the media to interview some of the marchers.

The graveside ceremonies consisted of the singing of revolutionary songs. Several speakers eulogized the deceased and their efforts on behalf of the CWP. The procession then reversed and marched along the parade route to the assembly area where they dispersed.

Included in the funeral procession was a group, self-identified as members of the Revolutionary Communist Party (RCP). Also approximately ten young adults who appeared to be Iranian students marched in the procession chanting "Death to the Shah."

A contingent of CWP members, mostly from Pennsylvania, were observed by police to arrive after the funeral procession had started. They were observed removing weapons from their vehicles and police arrested eight of them.

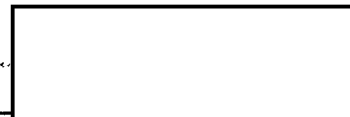

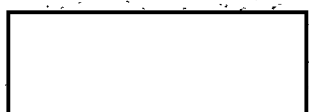

This will record that on November 27, I spoke with SA [redacted], Bureau of Alcohol, Tobacco and Firearms (ATF), Toledo, Ohio, by telephone, and Mr. [redacted] advised that he was preparing a summary statement covering his undercover activities in the National Socialist Party in Winston Salem, North Carolina, from the period of May, 1979, through early November, 1979. Mr. [redacted] further noted that there would be no restrictions on the statement that he would furnish and that he has no objection to the statement being used in an official FBI investigative report.

[redacted] further advised that following the shooting incident in Greensboro, North Carolina, on November 3, 1979, two officials from ATF Headquarters came to Winston Salem, North Carolina, and obtained a signed, sworn affidavit from him relative to his undercover activities in the National Socialist Party. He said he presumes that statement would be available upon request by the FBI through his headquarters.

On November 27, 1979, ASAC [redacted] received [redacted]'s statement in the mail, which is attached. It is to be noted that the statement is not signed and bears no date; however, it is presumed the statement was prepared by [redacted] sometime between November 20, and the date of receipt.

THE TESTIMONY WOULD BE LIMITED TO THE GENERAL IMPORTANCE GIVEN THIS MATTER AT FBIHQ AND GENERAL ASSURANCES THAT THE FBI IS AFFORDING THIS MATTER HIGH PRIORITY. PROSECUTOR RECOGNIZES THAT LOCAL OFFICIALS OF THE FBI COULD HANDLE THIS TYPE TESTIMONY, BUT HE FEELS THAT THE APPEARANCE OF A "WASHINGTON OFFICIAL" IS ESSENTIAL. CHARLOTTE OFFICE IS CONCERNED THAT ANY DISMISSAL OF CHARGES FOR A PERIOD OF TIME WILL KINDLE LATE SUPPORT FOR THE KKK IN THIS AREA AND INCREASE SUPPORT FOR THE COMMUNIST POSITION THAT THE JUDICIAL SYSTEM CANNOT BE TRUSTED TO PROSECUTE THE KKK. ADDITIONALLY, IF THE STATE DISMISSES MURDER CHARGES, LOCAL OFFICIALS AND LOCAL MEDIA MAY ATTEMPT TO PLACE SOME OF THE RESPONSIBILITY ON THE FBI.
