Wish we could give small haz-mat containers to those folks that help us by bagging their own trash, but they are so transient, we can never predict when they'll need them, when they'll be around, when they'll be able to bag their items for us to pick up Not sure if that's a helpful solution. At times, they also overfill the bags.

Such things are hard to anticipate. Any thoughts?
