A meeting organized by "Frontier" Magazine, sponsored by PHIL KIRBY, its editor, was held at the Wilshire-Ebell Theater in Los Angeles on 5/25/54, commencing at 8:30 p.m., admission \$1.50. It was fairly crowded.

The talk given by Dr. HAROLD C. UREY of Chicago was to have dealt with the question of the H-Bomb, mass retaliation, and the Oppenheimer Case. UREY, however, only touched on these subjects. In connection with the H-Bomb, he said he has no authority on it, since he had nothing to do with its development. On the Oppenheimer question, he indicated he had had some differences with him - that OPPENHEIMER believed it was a mistake to make the A-Bomb without his consent, whereas he, UREY, was against that opinion and was in favor of making the A-Bomb. On the subject of mass retaliation, UREY spent most of his time.

He pointed out that in his opinion, it was impossible to make peace with the Communists, but if the United States would become a Soviet America, we could have peace tomorrow; however, on the other hand, if the Soviet Union became a democratic country like the United States, we could also have peace tomorrow. Since neither of these two things is possible, we have to face reality - a third war is inevitable. The United States must prepare, organize, produce a

preponderance of weapons that would overwhelm the enemy. UREY said the only hope for survival is in being bigger and stronger than the U.S.S.R. UREY stated he proposes the formation of a western federation of states, which would include the United States, Great Britain, France, Mexico, Spain, Denmark, Sweden, Italy, and a number of the other smaller countries, as well as Canada. Such a federation, united under one government with the United States at the head, would make a combination that would one day defeat the U.S.S.R.

There was a question and answer period after, and in all cases UREY answered that as a scientist he was giving an obvious opinion, and whether the people agreed or like what he said, this was his program, this was his analysis, and this was what he was fighting for.

There were about 75 people in the audience who were antagonistic to what UREY said. The rest appeared to be favorable.

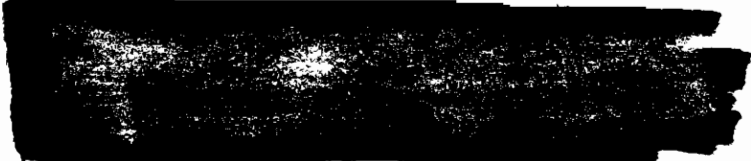

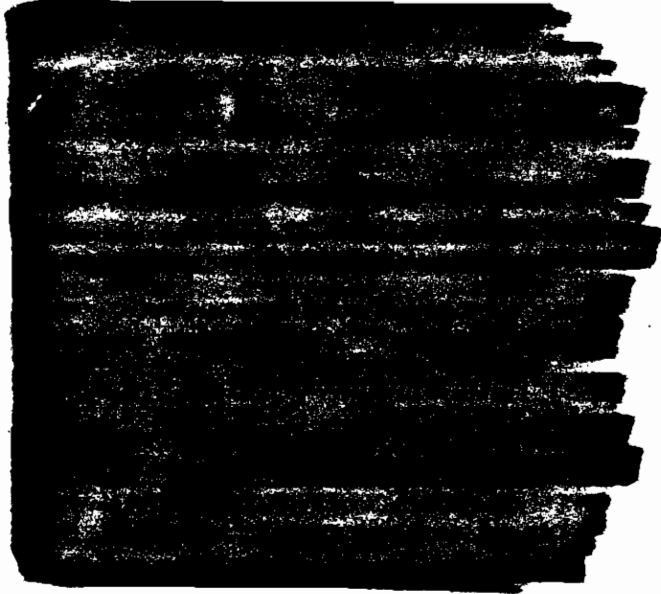


SUMMARY PROCEEDINGS

"Nathan Caldwell, Jr., executive secretary of the MCPFB, delivered the Committee's annual report. 

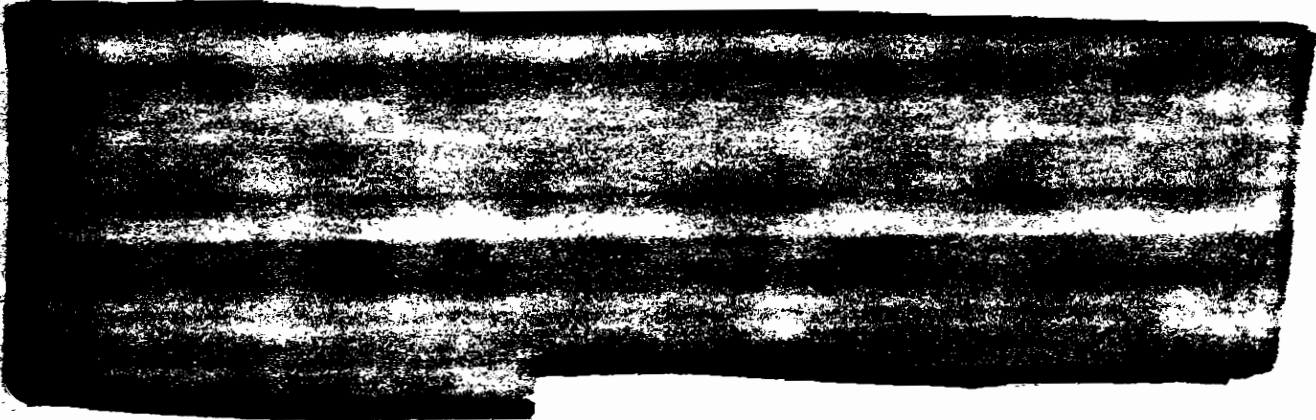



Soviets' Technical Ability Underrated, Urey Warns

By Robert S. Kleckner

Harold C. Urey, Nobel prize winner, has asserted that Americans generally underestimate the technical strength of Soviet Russia.

The distinguished University of Chicago chemist and atomic scientist in an exclusive interview lashed out at our complacency which he said was based in large part on the belief that the Reds had little know-how.

"It seems to me there is considerable evidence that they can do a great deal in the military way," he commented.

"There is little doubt that they even made the A and H-bombs more rapidly than the English, who can't be considered backward at all."

'Some Misconceptions'

Urey said there seem to be some misconceptions in this country about the Soviets that could be dangerous in our thinking.

"Most persons appear to believe that the Soviets are mainly strong politically. This is nonsense," he declared.

"Then there is a great tendency to think that the Soviets do not know much technically and cannot do much technically.

"This I believe also to be in error.

"We can't judge their technical achievements by the Russian standard of living which admittedly is low. It is their own choice if they don't apply their know-how to living."

Urey is an outspoken foe of some security regulations he believes not only are silly but also are keeping young scientists from going into government

service. He said so-called "leaks" of information had little to do with the Russians attaining atomic weapons.

"The leaks may have helped a little but not much," he said.

"It is possible to write up all the technical knowledge we have and give it to a non-technical person and he would not understand a thing about it.

"To apply the information requires almost the same technical knowledge that was needed to produce the material in the first place."

- Oppenheimer Remarks

Another famed atomic scientist, J. Robert Oppenheimer, said in New York that scientists' proper place is in the university where "the analogies, insights and harmonies of scientific discovery can find their way into the wider life of man."

Last June, the Atomic Energy Commission refused to reinstate Oppenheimer, wartime head of the Los Alamos (N.M.) laboratories that developed the atomic bomb, to access to restricted information. It ruled he is a security risk but not disloyal.

Oppenheimer, speaking at Columbia University's bicentennial celebration, said scientists were too isolated in their work. He urged them to be part of the community, adding, "And the community can only, with loss and peril, be without him."
