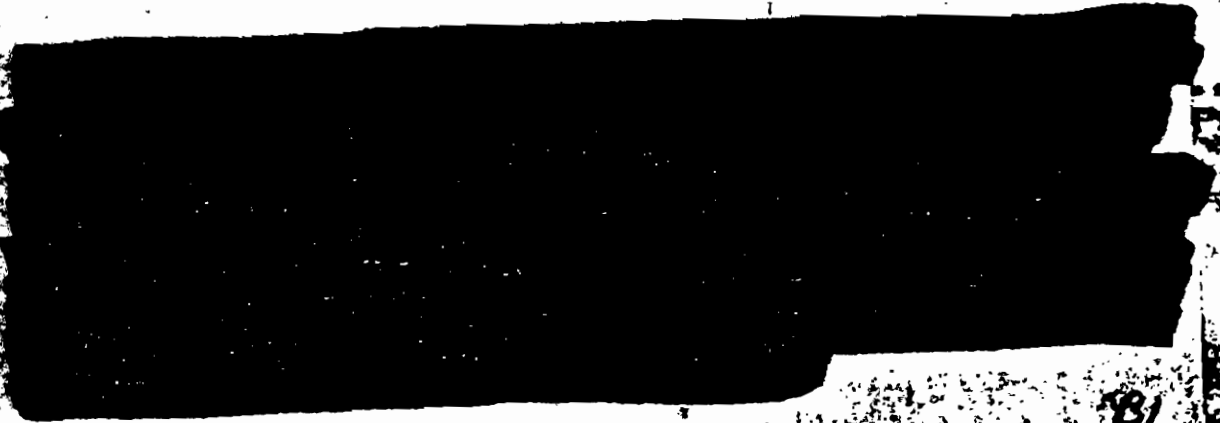

SUBJECT: WILLIAM PARTRIDGE

Former Senator Harry Cain who is now a member of the Subversive Activities Control Board called at 1:00 a.m. this morning. He received a call from William Partridge, Arcadia, California, residence telephone Douglas 6-4007, office telephone Edgewood 4-1211. He pointed out that several years ago when he was in the Senate he, Cain, served on the board of an aviation magazine entitled "Air Affairs." The magazine had a good reputation but subsequently went broke. It was supported by several high Air Force and Navy officers. The editor was William Partridge. He had known Partridge a number of years. Partridge is exceedingly brilliant but at times is a radical. He has recently had marital difficulties. Cain saw him about two months ago when he was in Washington after his wife had filed a suit for nonsupport. After he left Washington Partridge went out to Arcadia, California, and in his telephone conversation last night Partridge advised Cain that for the past seven weeks he had been employed by the Aero Jet Corporation at Azusa, California. Former Under Secretary of the Navy Dan Kimball got him this job.

Last Saturday Partridge stated that he uncovered a conspiracy against the security of the Nation and he asked Cain to send a courier plane out there immediately to pick up the material and bring directly to Cain. Cain told him that he could not do this that in his position there was nothing he, Cain, could do and furthermore the proper thing for Partridge was to go to the nearest FBI office. Partridge insisted that he must deal only through Senator Cain as he trusted Cain. Cain told him that this was impossible that the Bureau would have to handle such a matter and that the Bureau could be trusted to do the right thing. Cain further told Partridge that he would wait until 9:20 this morning and if he did not hear from Partridge he would feel duty bound to call the FBI and have an Agent contact Partridge immediately. Cain stated that Partridge was agitated at 1:00 a.m. this morning, however, it did not appear that Partridge was drunk. Whatever it was was causing Partridge considerable worry and at 9:25 Cain received a wire from Partridge stating that he will remain at home in Arcadia awaiting a call from some authority and gave the telephone numbers above-mentioned. Cain stated that the chances are one million to one that Partridge would have nothing but he did not think this should be overlooked and he therefore wanted to suggest that we have an Agent contact Partridge as expeditiously as possible at his home. I told him we would be glad to do this promptly.

It is suggested that the Intelligence Division issue the appropriate instructions to have an Agent contact Partridge.

A representative of another United States Government Agency advised this Bureau on July 7, 1954, that Doctor Urey plans to leave New York City on July 21, 1954, aboard the SS "Stavanger Fjord" of the Norwegian-American Line, port of destination, Bergen, Norway. This is an eight-day ocean trip. Urey will be accompanied by his wife, Frieda, and his fifteen-year-old son, John Clayton Urey. Urey and his family contemplate visits to the following countries:

Norway: Urey plans to remain in Norway for ten days, and will visit Doctor Odd Dahl, Physical Institute, Bergen; Doctor Thomas Barth, Geology Department, University of Oslo; Dr. Sven Rosselund, Astro-Physical Institute, Oslo; and the Heavy Water Plant at Rjukan, Norway.

Sweden: Urey and his family will spend the next ten days in Sweden visiting Doctor Hans Pettersson, Oceanografiska Institute in Gothenberg; Doctor J. Arvid Hedvall, Chalmers Institute of Technology, Gothenberg; a general tour of the University of Stockholm at Stockholm; and will visit with Doctor Svedberg at the University of Uppsala, Uppsala.

Denmark: Urey will spend approximately five days in Denmark visiting with Doctor Niels Bohr at the University of Copenhagen.

France: Urey will spend three days in France visiting Paris and LeMans in the Western part of France. The family of Urey's son-in-law, the Baringers, reside in LeMans. Urey said he had no plans to visit with any scientists in France, and emphasized he will not visit with the Joliot-Curies.

Switzerland: Urey will spend two days in Switzerland. During this period he will visit the town of Ascona, staying with the parents of Mrs. Gregor Wentzel. Mr. Wentzel is a Professor of Physics at the University of Chicago and a personal friend of the Ureys. Urey has no definite plans but may stop at the International Atomic Energy establishment in Switzerland.

cerely to view the construction progress. Urey said he had no definite plans to visit with any Swiss scientists.

Italy: Urey said the main purpose of his European trip is to deliver two papers at the International Geo-Physical Union in Rome. This meeting is scheduled for the period of September 15 to 28. Urey said he has been appointed a representative of the National Academy of Sciences and the National Research Council to attend this meeting. The titles of the two papers which he will deliver at the conference are: "Source of Energy for Convection in the Core of the Earth," and "Temperature Formation of the Earth." Urey said he planned to visit the University of Rome, but will spend most of his time in Italy sight-seeing.

London: The Ureys' will spend one or two days in England in London, Oxford, or Cambridge. Urey said he may visit Harwell, but he has no definite plans in this regard.

Urey said he has no hotel reservations in any of the countries that he plans to visit. He has reservations on the American Air Lines to return to New York City on October 1, 1954.

The records of the Passport Office, Department of State, reflect that passport #428295 was issued to the subject on July 1, 1954, which is valid until November 1, 1954. This passport was issued based on Urey's application which was received on April 28, 1954.

A review of instant file indicates that certain logical investigation has been deferred pending efforts to resolve inconsistencies in information furnished abroad. Specifically, it is submitted that American delegates to the conference in Zurich, Switzerland, on August 11-13, 1953, of the Commission on Geochemistry should be interviewed in regard to the alleged meeting between JEROME CARDAN and the subject.

To aid in the possible identification of CARDAN as a contact of the subject in Zurich, it is felt that in the course of these interviews, each United States delegate should be exhibited a photograph of CARDAN. It is pointed out that, unless the alleged contact was most surreptitious, CARDAN, if present, was probably observed by other delegates during the conference.

In view of the above, the Bureau is requested to obtain, through its Paris representative, a photograph of CARDAN. Upon this photograph being furnished Chicago, this office will set forth leads to have all known United States delegates to the Zurich conference interviewed and CARDAN's photograph exhibited to them.

Also, the Bureau is requested to obtain through the Legal Attache at Paris, any available information pertaining to MICHAEL BARANGER, the subject's son-in-law. BARANGER, it is noted, was born in Le Mans, France, on July 31, 1927, the son of JACQUES and MARIE ANTOINETTE BARANGER. He is a physicist at Cornell University, a citizen of France, and on September 26, 1951, married ELIZABETH (GERTRUDE BESSIE) UREY, subject's daughter.

Dear Bill:

While in Chicago recently on a business trip, I attended a meeting of the Chicago Chapter of the American Institute of Chemists. The meeting was a testimonial dinner in honor of Harold C. ~~Urey~~ Urey. A copy of the program and the description of the award are attached. Also included is a news clip (Washington Post October 9, 1954) together with a prepared text of his address. On page 5 you will note a brief reference to the Bureau.

When he actually delivered the talk, however, he departed on occasions from the prepared text. He did this particularly with respect to the Bureau. Among the things he said ~~was~~ was a reference to the Director supporting Sen. McCarthy. He questioned why the Director should publicly support McCarthy. He did not cite time, place nor date of such support.

He then rambled on about the caliber and morale of Bureau agents. He said that while Bureau agents were lawyers by training, he questioned whether they were good ~~scientists~~ lawyers. The implication I got was that a good lawyer would have no incentive to join the Bureau staff.

With respect to morale, he said that agents must begin to wonder why they are carrying on investigations when they never get any derogatory information on people. He referred specifically to agents who investigate scientists and who never get anything against them. I seem to recall that he indicated that he and other scientists have been questioned by agents about other scientists and that he has never been able to give any derogatory information.

These comments are based on a few brief notes I made while he talked. I knew that I would be able to get a copy of his prepared talk after the meeting and assumed at the time that he was reading all the above, when in fact he was speaking extemporaneously.

I was hoping that they would have a question and answer or discussion period following his talk because he made me so mad I couldn't see straight.

However, no such opportunity presented itself and I merely had to keep it to myself. I did talk to a few chemists I knew there and they feel that Urey loves the sound of his own voice and has a tendency to run off at the mouth when he doesn't know what he is talking about.

I feel certain that he is no friend of the Bureau and would suggest that he not be contacted by Bureau agents unless absolutely necessary. In such cases the agents should be very careful as I would bet that at some future occasion their visit will be discussed and the interview twisted!

Hits at Book

Urey Decries 'Pillorying' A-Scientists

CHICAGO, Oct. 8 (INS)—The Nobel Prize-winning chemist, Dr. Harold C. Urey, declared tonight scientists who worked on the atomic and hydrogen bombs have "heard rumors" they might get the "Oppenheimer treatment."

Dr. Urey, discoverer of heavy hydrogen and a member of the wartime team which developed the A-bomb, told a group of chemists in Chicago "the celebrated case of Dr. Oppenheimer has been discussed until there is nothing new to say," but added:

"Rumors come to us that other people will be summoned for clearance proceedings.

"If this continues, how do we recruit new scientists and engineers, not only for military work but for any kind of scientific and engineering work?"

(Dr. J. Robert Oppenheimer, head of the Los Alamos laboratory which built the first atomic bomb, was recently denied access to atomic secrets after exhaustive security board hearings.)

Urey's reference to the Oppenheimer case came during his remarks on the new and controversial book, The Hydrogen Bomb, by Clay Blair and James Shepley. Urey noted that Dr. Enrico Fermi, the "A-bomb father," former Atomic Energy Commission Chairman Gordon Dean and Rep. W. Sterling Cole (R-N.Y.) chairman of the Joint Congressional Atomic Energy Committee, had all attacked the book as "unjust," and added:

"It is completely unjust and false."

Urey urged that the United States "turn from the Roman circus antics of pillorying scientists" and get on with the job of training scientists and engineers. "Unless we do," he warned, "work which might be done in the United States may well be done in some other country—and that country may not be friendly to us."

Before his talk, Urey was awarded the honor scroll of the American Institute of Chemists, for service "beyond the call of scientific duty."

SCIENTISTS, SECRETS, AND SECURITY

Harold C. Urey

Institute for Nuclear Studies,
University of Chicago

Introduction

The problems covered by the subject of this lecture have plagued scientific people ever since the war, and all of us have hoped that in some way sane and sensible discussion of the subject would be possible. As time has passed, we have observed that the annoying procedures of war time have grown to be far more irritating, and the discussion of the subject by the press and public seems to me to become less and less rational. This is probably partly because the public does not understand the nature of scientific facts, but also I suspect it is because of the decreased security of this country relative to foreign attack that has occurred during this century. We are all appalled by the dangers to us arising from the invention of nuclear weapons and the development of aeroplanes during this century. The continuous developments in both fields with no very obvious limitations in the future have given the people of this country a first class case of hysteria.

I would not be honest with this audience if I did not say that I believe we as a nation are in a more dangerous position than we have ever been in since the time of our own Revolution. There is an implacable enemy to our way of life in the world today. We are not at all the only people who face this situation; some other democratic countries are in even more dangerous positions than we are. But to us the situation is a new one, whereas it has been almost a normal one for some other countries, for example, in western Europe. For this reason we may become much more perturbed than they do. Also, it may be that people do not discuss such imminent dangers as those of western Europe continuously, whereas people who are somewhat more removed, as we are, find that it is possible to discuss them just because it may be possible to do something constructive about them. However this may be, the discussion of our difficult world situation is continuous in this country, and much of the discussion deals with trivia rather than with the really important problems of the situation. At the same time our position as the most powerful nation of the free world requires that we do consider these problems with some courage and calmness.

The problem of security

By security I mean some degree of safety for this country against military attack from without, violent revolution from within, and subversion of our democratic institutions by other means. This broad security is a very

complicated problem and depends on almost all activities of people within the country. To review all factors of this security would require a very large document, but I do wish to outline some features of security in order to discuss scientists and secrets in a proper perspective.

The nineteenth century was the golden age of the United States from the standpoint of external attack. The Atlantic and Pacific Oceans were extremely broad in those years, and we were indeed isolated. Isolationists had all the arguments on their side at that time. We also were not endangered by any foreign revolutionary ideas. As a matter of fact we were the revolutionary idea of the century and were greatly feared on this basis by some other countries. In fact the ideas of our Revolution resulted in very important changes in governments in Europe. But this disturbed us not at all and we viewed these changes in much the same way that Communists view the spread of their doctrines today. We really were happy about the whole thing. But today our isolated military position is gone. It went at the turn of the century with the invention of the aeroplane, and today we fear attack from across the Arctic Ocean. Who would have dreamed of this when a machine flew at Kitty Hawk? Of course none of us really realized this until somewhat later, and I am sure that we belong to the conservatives in connection with these ideas. I believe that our old revolutionary ideas were superior to the new ones and that they will serve the world in the future as they have in the past.

It is impossible to talk of external and internal security of a country unless certain fundamental conditions exist. A certain social, political and economic stability must exist within the country. This depends on the psychological state of the people of the country and such a state depends on their past history, their cultural history, and their religion. It is a sort of internal feeling of well being of the body politic, analogous to a similar feeling on the part of the individual citizen. Political, religious, and economic arguments must not become too violent and there must not be a widespread feeling that great injustice exists for a substantial fraction of the population.

Such a satisfactory condition exists in this country and many other free countries of the world. Some people in this country have been very angry at some governmental developments of the last 20 or 25 years, but I do not believe that these cries of treason really represent a deep-seated split in the population. On the other hand, the situations that exist in France and Italy do come close to causing great weakness in these countries. I am sure that nothing remotely approaching such a situation exists in this country. We will always have extremists of various kinds, but as long as the overwhelming majority regard conditions as acceptable even if decisions are not always as they would like, we have a secure basis from which to construct

our external and internal security. (I wish sometimes that fewer people talked as though this essential stability in this country did not indeed obtain).

In particular, the United States is exceedingly stable with regard to Communist ideas and philosophy. We probably have some 25 or 50 thousand Communists in this country, and about ten times this many people who are insane enough to be confined in institutions. We also have a considerable number of people who would readily subscribe to a totalitarianism of the right. But all categories of such people are very limited in number. I am sure that there is not the remotest possibility of the number of Communists increasing in any important degree. Communism appeals to people who are socially and economically on the wrong side of the railroad tracks, i. e., without satisfactory jobs, social position and opportunities. There just is a vanishing small fraction of our people who are in this situation or who do not see the unfavorable situations changing.

I feel less certain about our fanatics of the right, perhaps because I do not know what it is that makes them what they are. Why are people who are on the right side of the tracks socially and financially sometimes antisemites and antiminority groups generally, and why are they willing to discard all democratic procedures in order to attain ends which really do not benefit them at all but make other people miserable? Why did Hitler wish to exterminate 6 million Jews?

But in spite of these insane groups at the fringes, this country is just solidly middle of the road democratic, and I do not believe that these minority groups have any possibility of undermining this country. I am not concerned about our teachers, our political leaders, our religious leaders, or anything in this connection. All imperfections are minor and of small consequence. I emphasize this as strongly as possible and I wish the people of this country could be brought to realize it. Their approach to all problems would become more confident and more sensible. In this troubled world situation we "lead from strength."

But in other non-military ways we have considerable strength. The ideas of our own Revolution have partly influenced much of the free world as other countries and peoples have spontaneously evolved along similar lines. Our ties to the British Commonwealth of Nations are very genuine even if entirely informal. Similarly our ties to the free countries of western Europe are very strong. My wife, my son, and I have just returned from two months in Norway, Sweden, Denmark, France, and Italy. We liked the people, the food, the cathedrals and antiquities. But most of all, we found the general political conditions so similar to those in our own country. The police will protect us and not persecute us. If we ran afoul of the law we

would get very similar treatment to that given us here. We moved freely about the cities and countries. During the last centuries these countries and others have moved along very similar lines of development to those followed by ourselves. We are allies in very fundamental ways. We cherish the same political customs, the same religious views, the same literature and art, and look back to the same ancient historical cultures of Greece, Rome and the Hebrews as the inspiration of our own. We also have endured recent wars together. We are trying desperately to construct measures of mutual defence against militant and tyrannical Communism. Our attachment to these people is an important part of the 20th century security of the United States.

Since the war I have devoted some effort toward extending the American revolutionary idea of federalism to these western democratic countries. It is not my intention to go generally into this problem tonight. Nevertheless, it seems to me that most of our international problems could be handled more effectively if the western democracies created a limited super-government of limited powers of a federal type to take care of defense of all our liberties. Much support for the Atlantic Union idea exists in this country. Senator Kefauver has been a staunch supporter of this idea and was attacked in his recent campaign for his stand. His last words to the people of the state of Tennessee on the night before election were "I am for Atlantic Union." He won over his opponent 2 to 1. I am sure that France and western Germany would both join such a union, whereas it has proved to be impossible to get the French into E. D. C. We Americans should push our own revolutionary ideas based on our own history. They could be extended to a wider community and would give us greater security.

Finally, we should mention the purely military contributions to security. Without this I am convinced that no security exists for this country in the middle of the 20th century. It is unnecessary in this group to emphasize its importance. India may accomplish much by passive resistance, but I do not believe that this will suit us in the slightest. And military matters involved some things which are scientific and engineering in character as do, as we well know, most of our non-military activities. And this circumstance brings us into the problems of secrecy.

No scientist of my acquaintance questions the need and advisability of keeping secret information that pertains to military matters. The difficulty arises in regard to the line where secrecy begins and in regard to the amount of effort which should be put into keeping scientific things of this sort secret. It is always a losing battle, for all scientific knowledge can be learned independently by a technically advanced enemy, quite independently of any leak of information from us. It may also be said that espionage can supply

no information to people who have no technical knowledge. The Russians seem to have discovered the cheap hydrogen bomb before we did (my authority is Sir Francis Simon). Such people can profit from espionage. On the other hand, the Indians of the Amazon Vally could be supplied with any amount of information and would learn nothing. Only if a country has approximately sufficient technically trained men to discover things for themselves is it possible to transmit valuable knowledge to them. Mostly the Russians developed their own bombs.

What fraction of our effort should be concerned with keeping our military scientific secrets really secret? This entire address up to this point has been given with the idea of making an estimate. Security for this country depends on many things of a non-military character. Of the military category only a part concerns technical matters. Of technical matters much deals with the operation of machines of many kinds, and these are kept secret only partially at best because of the large number of people involved. Much of scientific effort must be devoted to discovering, inventing, and developing new defensive and offensive devices. Interference with these efforts costs us dearly from the standpoint of security.

I should like to suggest that less than 1 per cent of the personnel of a military research laboratory should be concerned with all the mechanical details of keeping information secret. I rather think that this may be a proper estimate of what effort is devoted to this problem. Also, I should like to suggest that the appropriations for the F. B. I. are large enough to deal with subversives, etc. In fact, I believe this agcy could do a better job if some of the investigative duties assigned to them were discontinued. It seems to me that the entire field of secrecy, either of scientific or non-scientific matters, should not concern the average Americancitizen tomore than about 1 per cent of the time that he gives to his responsibilities as a citizen. He should rather give his attention to the problem of a substitute for E. D. C. in Europe, a proper solution to the Indo-China problem, a proper foreign policy for the United States, etc. How many of our citizens do this? How many of us in this room have devoted 99 per cent of our attention to governmental problems to questions of this kind during the past year? I for one have not. I have thought and talked about--well, you know what. The same things that you talked about.

The problem of proper secrecy in military matters exists. It is a
an all problem in the overall problem of security for this country.

Incidentally, much attention is given to these problems, but I wonder if the attention is mostly not due to our sadistic tendencies? The Romans liked

gladiatorial combats. We really enjoy in a way seeing the wicked or perhaps even the innocent suffer. I feel sure that the attention in the press given to accusations against people, whether true or false, is due to our basic cruelty. Isn't it at least partly a substitute for the Roman arena that we seek?

Don't misunderstand me! I believe that the importance of secrecy and espionage is greatly exaggerated. However, I have no illusions in regard to the detrimental effects of this exaggeration on our own activities and our position of leadership in the world. We are being laughed at by some and almost abhorred by others whose good opinion we need, and indeed had a short time ago.

Some problems of importance in science and security

Among all the diverse problems relating to this important problem of security for this country at this time, there are some that we as scientists should think about. Many of our fellow scientists in spite of public criticism do continue patiently to study military technical problems without expecting or receiving public recognition or any additional financial regard. These efforts we hope will be negative, i. e., that the devices will never be used. Still the work must be done.

But I often wonder how long this will continue to be true as case after case of denied clearance occurs. This has been going on for a long time. Many little people have been denied clearance and mostly we hear nothing about them. Sometimes the men have appealed to me for help and I have never known of anything I could do. For years Dr. Edward Condon has been forced to defend himself against public accusations and in formal clearance hearings, but he has always been cleared for secret work as far as I know. The most celebrated case is that of Dr. Oppenheimer. This case has been discussed until there is nothing new to say. I do not believe that Oppenheimer ever intentionally damaged the security of the United States. Rumors come to us that other people will be summoned for clearance proceedings. A book has been published attacking large numbers of scientists who have worked on the hydrogen bomb. Gordon Dean has denounced the book as completely unjust, and indeed as false. If this continues how do we recruit new scientists and engineers, not only for military work but for any kind of scientific and engineering work?

Let us look at this problem in outline at least. How about primary and secondary schools from the standpoint of production of technical people? Most of us in this room have expressed our dissatisfaction many times in this connection, in private at least. Fundamentally, how can we expect good schools with inadequate school plants and inadequate salaries for teachers?

We treat teachers as though they were inferior human beings instead of as among the most important of professions. This has gone on for many years until today there is a lack of teachers of any qualifications. It is no longer a matter of securing men and women of ability, training and personality. It is a matter of getting anyone at all to do the job. The science teacher is usually the athletic coach. It is time we think of this problem.

Do we attract a substantial fraction of the people who have natural ability in the exact sciences into college? Or do they become mechanics of one kind or another? The wages of labor, due to effective union activities, do keep up with the depreciating value of the dollar, whereas scientific, engineering and professional salaries do not. And once attracted to college, do the students secure an adequate scientific training? Mostly industrial and government laboratories pay better salaries, and it is difficult to find capable professors for our colleges at the present time. Some offers that I have seen during the past years are pathetic. We face in this country a near-crisis in training scientists and engineers.

Are these adequate incentives for young people to enter technical professions at the present time? I see many young people starting the long road to a competent scientific career, four years of college and three to four years for a doctoral degree, and then some time spent in acquiring experience after this. Surely, public hearings for prominent scientists are not encouragement in this direction. Such appellations as "egg head" applied to all intellectuals including scientists and engineers are no inducement either. I believe that science is still sufficiently glamorous to attract large numbers of young men, but I begin to wonder what I would have done in 1914 if conditions had been similar to what they are now.

A lack of scientific and engineering talent may go completely unnoticed for years simply because we cannot see something that does not exist. Men calling themselves scientists will continue to be graduated and employed, but are they the best that we could produce? We never know. If Planck had not proposed the quantum theory in 1899, when would it have been proposed? If Bohr had not given that first push to the theory of the atom, who would have done it? I am convinced that if we do not do a better job of training scientists and engineers work which might be done in the United States may well be done in some other country - and that country might not be friendly to us.

Efforts to improve our educational system and the conditions under which the best minds of our country work are likely to require diligence and great perseverance. They will require hard work and it will not be nearly so exciting as turing a bull into a china shop. We as scientist are

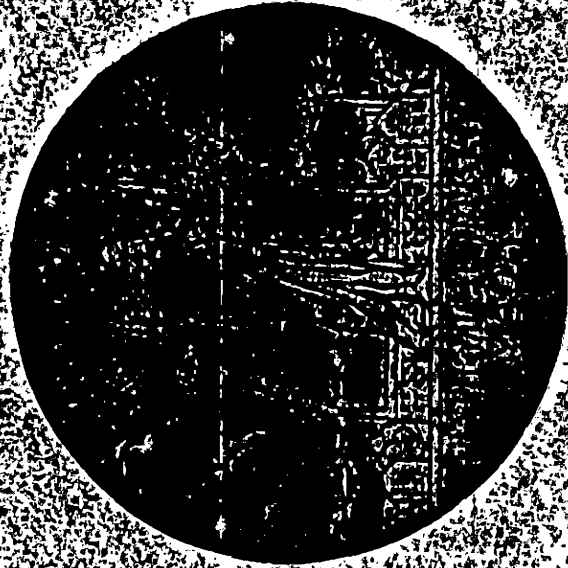
accustomed to persistent work, and might well devote our efforts to such problems instead of helplessly wringing our hands or aiding and abetting some of the disruptive activity of shortsighted people.

Summary

The maintenance of our security of the United States and the free democracies of the west is by all odds the most important problem facing the people of the United States at the present time. The problem of such security is a very complex one, involving the entire life of the country and its relation to other democratic countries. Military defense is an important part of maintaining security. Scientific discoveries and developments are important in military effectiveness, and it is important that such processes remain secret as much as possible without impairing the overall effectiveness. Perhaps this secrecy has an importance of 1 per cent of the total effort, but hardly more. The general public should hardly know that the problems of secrecy and espionage exist. Much more important for general consideration are the means of improving our general education of scientific men, as well as scholars in other intellectual fields. It would be well for the people of this country to turn from the Roman circus antics of pillorying scientists and hunting Communists and subversives to the less spectacular job of improving education in this country.

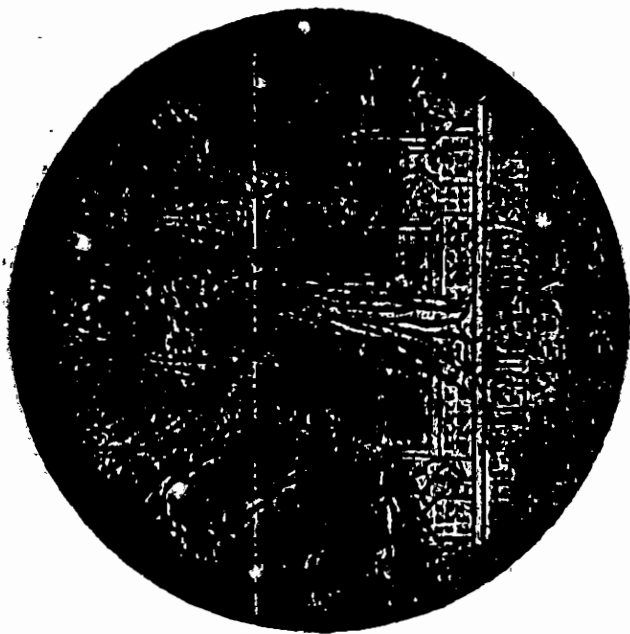

There is attached a letter to W. C. Sullivan from [redacted] dated November 11, 1954, the contents of which are self-explanatory. There is also attached a speech given by Dr. Harold C. Urey, along with a copy of the program of a meeting of the Chicago Chapter of the American Institute of Chemists. [redacted] attended a related testimonial dinner given in honor of Dr. Harold C. Urey by the American Institute of Chemists. [redacted] advises Sullivan that Dr. Urey departed on occasion from his prepared speech making a vicious attack upon the FBI and the Director. According to [redacted] among other things, he made reference to the Director supporting Senator McCarthy, he rambled on about the caliber and morale of FBI Agents saying that while Agents were lawyers by training, he questioned whether they were good lawyers. The implication which [redacted] received was that a good lawyer would have no incentive for joining the FBI. Relative to morale, Dr. Urey said that FBI Agents must wonder why they are carrying on investigations when they never get any derogatory information on people. He referred specifically to FBI Agents who investigate scientists and allegedly never develop any evidence against them. (From [redacted] letter it appears the speech was given about October 8 or 9, 1954)

[redacted] said he hoped for an opportunity to arise whereby he could question Urey but such an opportunity did not present itself. [redacted] said he did talk to a few chemists he knew, and they feel that Urey loves the sound of his own voice and has a tendency to run off at the mouth when he doesn't know what he is talking about. [redacted] is of the opinion that Urey should not be contacted by Bureau Agents because their interviews would be very likely twisted to suit Urey's purposes.

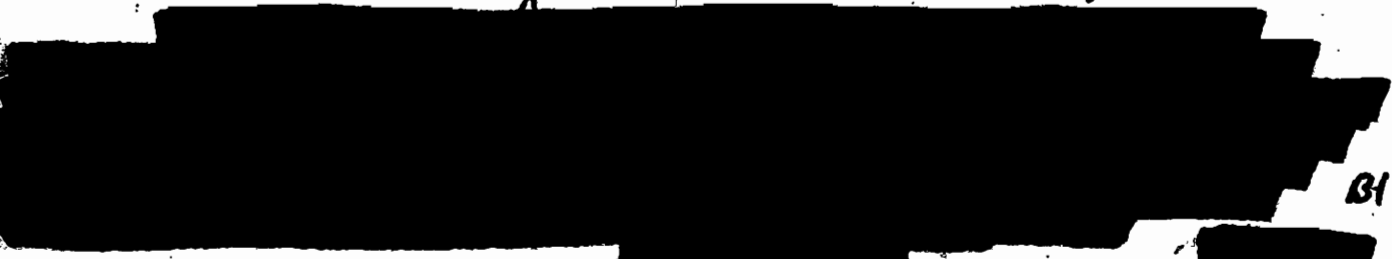

Scientist's Stand Opposed

Diservice to Our Judicial System Is Seen in Dr. Urey's Statement

To THE EDITOR OF THE NEW YORK TIMES:

Once more the question of government by law or government by scientist has come to the fore. Prof. Harold C. Urey, at a dinner in Chicago Feb. 12 reported by The Times on Feb. 13, is quoted as being convinced that a grave injustice has been done the Rosenbergs and Morton Sobell, who were convicted in connection with treason to the United States in revealing secrets of the atomic bomb to Russia.

It is every man's right to adjourn to the nearest tavern and revile the court which may have rendered an adverse decision, but when it comes to a question of standardizing justice how can one better the process of assuming that truth has been served by the hands of the United States District Court (in which Judge Irving R. Kaufman did a palpably honest job), the Circuit Court of Appeals and the United States Supreme Court, which had the Rosenberg case before it three times?

How is our thinking to be formulated? Is it to be based upon the convictions of an individual or the concerted efforts of the courts, acting as a verdict of our fellow-citizens sitting as a jury—a method that represents the highest form of public opinion?

Believe Methods

Professor Urey is undoubtedly a scientist of high order, but does that fact equip him to hold his opinion better than the rest of us who may not know how to make heavy water, but who know and feel the claims of justice? The explanation does not lie in the superiority of his opinion nor that of his dilemma. It lies in the common belief that certain types of scientists are born into themselves. They have not yet become certain that, for better or for worse, nationalism is still prevalent. Accordingly, self-protection of a country requires an immediate and an adequate defense against any form of security violations.

Perhaps in the future we will have outgrown nationalism. Perhaps I doubt it. But until that time comes I do not see that the attitude of men like Urey or J. Robert Oppenheimer, nor whom I hold in other matters, a good opinion, should be permitted to

destroy the methods of defense through our courts that have been so laboriously built up since Magna Charta.

I think that Dr. Urey's utterance was incendiary. He has a right to an opinion, but I submit that, airing it in the manner in which he did, supported by a galaxy of names, it is not inclined to strengthen our judicial system.

Mind this: I am not one of those who demand conformity; Hitler made "Gleichformigkeit" an abhorrence. To me, democracy is defined best as dissent. But dissent can be expressed in a less arrogant and provocative manner than Professor Urey employed. I would not stop him from a free expression of opinion, but I ask that the forces of those who do not agree with his views become articulate so that their silence will not be taken to mean their assent.

Science of Law

Let them believe that the science of law, even though it be occasionally in error, is as important to us—even more important—than the nuclear sciences. We live under the law every day, but the amount, praise be, is one that touches us only occasionally and up to now it has done us no good except in the increase of knowledge.

Good knowledge, too, is restricted. Not long ago a distinguished scholar, Dr. Grayson Kirk, who is doing so well at Columbia University, used a slogan for the university's biannual celebration, "Man's Right to Knowledge and the Free Use Thereof." The first part of the statement

"Man's Right to Knowledge," is sound; but the second part—"and the Free Use Thereof"—is not true. There is much knowledge that we have not enough space for to attempt. The use of knowledge that does us go with our defense.

Mean that I have said about Professor Urey applies to other scientists; and I would not exclude Professor Einstein from that group.

The Times, always seeking to be scrupulously fair, printed Urey's statement at length. It owes at least one dissent to the opposition. This, then, is an effort to express that dissent.

TEXT OF ADDRESS BY DR. HAROLD C. UREY, PREPARED FOR DELIVERY ON
FEBRUARY 12, 1955
AT THE DR. UREY TESTIMONIAL DINNER, HOTEL HAMILTON, CHICAGO, ILL.

Naturally I am pleased that so very many good people have been fit to honor me this evening. Also, I am pleased that Mrs. Sobell should present this scroll to me and thank her for her very kind words. But in a certain way the honor is of minor importance to me, certainly very minor as compared to other things associated with the activities of this evening.

As I am sure you all know, this occasion was organized from the beginning by people who believe, with me, that the Rosenberg - Sobell trial was not in the best tradition of American justice. I hope my friends who signed this scroll understood this.

I have not been personally acquainted with either the Rosenbergs or the Sobells. I am not unmindful of the terrible tragedies that have come to their lives and am very sorry about these matters, but my concern with this trial has stemmed more from a belief that the integrity of justice, as it is administered in the U.S., is at stake: If proper trials cannot be secured for unpopular people -- and it is evident from the publicity of this trial that all those charged with crimes were unpopular -- then it will become impossible to secure justice for other somewhat less unpopular people and so on until no justice is possible at all.

The power of our government is very great and it can afford to be just because of that great power. But there is an illness in this country since the war from which we will surely recover in time. This illness arises from a sense of insecurity and this sense of insecurity is due to the loss of our natural security barriers, namely: the Atlantic and Pacific Oceans. Our danger from foreign foes is now greater than it has ever been before in our history. This danger comes from the long range effectiveness of the aeroplane, as a carrier of powerful military weapons and to the existence in the world of a powerful revolutionary country, whose rulers do not accept the fundamental concepts of our way of life. There is a life and death struggle going on between these ways of life and I am convinced that each group is really determined to eventually destroy the other. I am in favor, as we all are, of the preservation of our way of life and I am sure that we will win in the long run and hope that the war stays cold.

This concern with our basic security as a country has led many people, often in high places, to look for a scape goat, that is, an easy way to solve our difficulties. That scape goat has been spies, espionage agents, subversives in government. I do not condone such agents, but if all communists and all communist sympathizers should quietly die, the fundamental insecurity of this country would be the same as it is now. This very well justified concern for our security in a modern, dangerous world has led us to do things which will undermine our way of life, our form of government, our freedoms. This is my primary concern in this matter. I welcome this dinner and this scroll as a means of fighting one angle of hysteria, one bad case of injustice, as I view it.

There are many things of this kind, such as: the Oppenheimer hearings, Condon's clearance problems, the Lattimer case, passport problems, visa problems, etc. If I do not do anything about some of these things it is because of lack of energy to do so or because many other people have protested them. Perhaps the most disturbing feature of many of these procedures is the increased use of the professional informer by the Department of Justice and Congressional Committees. Recently one of these informers, Mr. Mattusow, has stated that he has given false testimony and has accused Mr. Roy M. Cohen of complicity, which Mr. Cohen has denied. This specific accusation reminds one that Mr. Cohen was assistant prosecuting attorney in the Rosenberg - Sobell case. However, I warn you all that, in my opinion, communists, reformed communists and reformed reformed communists are not particularly

Mr. Sobell. Yet I am of the opinion, after study of the record, that Mr. Cohen's side of this story is incorrect and that Mr. Sobell was not properly tried and that the verdict and sentence were not justified.

One cannot separate the discussion of Mr. Sobell from a consideration of the Rosenberg case. In fact, one finds it difficult to understand what the evidence was against Mr. Sobell -- for it was certainly far less important than that against the Rosenbergs. In fact, the great concern about the latter generally obscured the interests of Sobell. I wish to give you a brief outline of the case for I am sure many of you are not acquainted with the case and its general structure. Being a scientist, I have made a diagram of the case which enables me to understand the relationships.

The alleged conspiracy is represented by the diagram (Fig. 1). In this diagram an arrow pointing from individual A to individual B means that A testified that he had contact on espionage matters with B. No such arrow means that the individual denies such contact or there is no testimony. A broken line means assumed contact but no evidence or only indirect evidence. Gold admitted that he gave information to Yakovlev, but Yakovlev escaped from the U.S. and was not apprehended. Gold and Fuchs both admit contact. The Greenglasses admit that they gave information to Gold and that they received \$500 from Gold which he said he received from Yakovlev. The money was accounted for in the Greenglass' bank account. They agreed that they matched the pieces of the gelatin box top. Gold said he received his half from Yakovlev. The Greenglass portion was in Mrs. Greenglass' hand bag. They say that they received this from Rosenberg and that the division of the gelatin box top occurred in the Rosenberg apartment. The guilt of the Greenglasses and Gold was agreed to by all three. The Rosenbergs denied dividing the gelatin box lid or giving it to the Greenglasses.

The Greenglasses say that they gave information to the Rosenbergs and that they were recruited into espionage by the Rosenbergs. The Rosenbergs denied this, and denied that they had anything to do with espionage of any kind. They maintained that their contacts were the normal relations of in-laws. (Mrs. Rosenberg was David Greenglass' sister.) Elitcher and Sobell were college acquaintances of Rosenberg. Elitcher testified that he and Rosenberg discussed espionage several times, although he maintained that he and Rosenberg never gave each other any secret information. Elitcher had been a communist; he had sworn in connection with his employment on war work that he was not, and thus had committed perjury. He testified that this was so and that he hoped for clemency as he testified against Rosenberg. He has not been indicted. Elitcher testified that he drove from Washington to the home of Sobell in 1948 and that he thought he was being followed by F.B.I. agents. He says that when he reached Sobell's home, Sobell was much disturbed by his arrival with F.B.I. agents on his trail, and that thereupon the two took a car, presumably containing photographic film, to the neighborhood of Rosenberg's home. Elitcher said that he waited in the car while Sobell delivered it. This is the only evidence of an overt act on the part of Sobell introduced at the trial. Sobell did not take the stand in his own defense. Hence a broken line in the diagram.

The Rosenbergs denied all espionage contacts with Elitcher and Sobell.

No evidence was introduced to prove contact between Yakovlev and the Rosenbergs. Gold's testimony established no contact between him and the Rosenbergs. Greenglass testified that Rosenberg tried to get him to go to college to study atomic physics in order to be more valuable as an espionage agent, and the Government inferred that Julius Rosenberg was the center of an important spy ring. No evidence, beyond that mentioned above, was introduced in support of this.

The Rosenbergs denied all accusations but refused to answer questions relative to membership in the Communist Party. They did admit to a very leftist political point of view. They never, at any time, admitted any traitorous act. Many people with whom I have discussed this case do not know this, and I, therefore, emphasize it. Had they made any such admission, I would have never spoken the word in regard to the case.

In general, it is easy to deny accusations, but it is difficult to make false accusations without incriminations appearing in the testimony, and for this reason it is important to consider the details.

reliability, and it is important to consider motives and opportunity for wrongly accusing the Rosenbergs. Also, if one assumes that the evidence against the Rosenbergs was perjured, it is necessary to be able to account for the essential facts by some other set of contacts. I believe that the essential evidence for the conviction of the Rosenbergs was that given by David and Ruth Greenglass, that their testimony contains unbelievable statements, that the plausibilities of certain details of their testimony can be explained, that they had powerful motives for involving the Rosenbergs unjustly, and, finally, that all the facts of the atomic espionage can be accounted for without the involvement of the Rosenbergs at all.

Eltcher testified to several conversations with Sobell in which espionage was discussed, but that no information ever passed between them. Do espionage agents constantly discuss their activities with old college friends without getting any information? This seems most improbable. The tale that Eltcher, who had never engaged in espionage, told of accompanying Sobell on an espionage errand when he believed F.B.I. agents were following him seems to me to be completely fantastic. Why choose to do this right under the eyes of the F.B.I.?

The bitterness that the case has aroused and the sentence imposed on the Rosenbergs and on Sobell was justified by Judge Kaufman on the basis of atomic espionage and yet no evidence was given connecting Sobell with this activity at all. In fact, no evidence was given except that relating to the transfer of a can containing 35 mm. film, and that by a confessed perjurer hoping for leniency.

Sobell was convicted and sentenced on the basis that he was part of a conspiracy and hence was guilty of many things which he personally did not do. Judge Jerome Frank stated that he should have been tried on a separate conspiracy. Judge Kaufman stated to the jury that they could not find Sobell guilty unless they believed Eltcher. I find Eltcher's testimony very doubtful -- in fact, I find it most unconvincing. We should note that no court passed on the credibility of the testimony of any witness, due to the fact that higher Federal Courts do not review this question. The Supreme Court of the U.S. has refused to accept jurisdiction and this does not constitute a review of the case.

However, to return to the general case, we need to recognize that some espionage was performed. Fig. 2 shows an alternative diagram of the case. This differs from the first case only in the shifting of the arrow from the Greenglasses to the Rosenbergs to an arrow from the Greenglasses to Yakovlev. A contact to another agent of the U.S.S.R. would serve as well.

If the Greenglasses had direct contact with Yakovlev or other Russian agents all the requirements of the other testimony are met. A gelatin box lid was divided. Gold presented one half at Albuquerque which he said he got from Yakovlev. The Greenglasses hid the other half which they said they received from Rosenberg. On this basis Rosenberg gave the other half to Yakovlev and he in turn gave it to Gold. But, suppose Yakovlev divided the lid and gave one half to Gold and the other to Greenglass or to Mrs. Greenglass. In this case Rosenberg was unnecessary. Also, the Greenglasses can tell a very realistic tale of the division by substituting the Rosenbergs for Yakovlev. In fact, the inclusion of the Rosenbergs in the conspiracy makes no sense at all. They are unnecessary unless Julius was, indeed, the head of a big espionage ring, and the proof of the existence of that ring is non-existent up to the present time. If only the Rosenbergs had confessed! But we are reasoning in circles. The Rosenbergs were unnecessary to the plot and would have been only another print where the entire espionage effort could have been discovered.

If Yakovlev, or another Russian, could contact the Rosenbergs, why could he not contact the Greenglasses, and then why pass \$500 through the Rosenbergs' hands instead of giving it to the Greenglasses directly? Would you confess to being the head of a non-existent spy ring and let your children live under that stigma, or would you go to the electric chair maintaining your innocence? The letters of the Rosenbergs written to each other in Sing Sing prison give their answer to exactly this question.

Note where this diagram leaves the Rosenbergs and Sobell. Both are completely out of the atomic espionage ring and now we ask what are they to do? Even the confessed perjurer's testimony, except for the

doing any. Well, one should not talk espionage and if they had been given five years at Lewisburg, we might think justice had been done -- that is, if you believe the testimony. I do not believe the testimony.

On such a basis, two people have been executed and one is in prison for 30 years on Alcatraz. And where are the surely guilty ones? One, David Greenglass, is in Lewisburg for 15 years. Two others, Ruth Greenglass and Max Elitcher, have never been indicted and tried.

Would it not be a wonderful trick for the communists if they could get innocent people sent to the electric chair and imprisoned for 30 years and get guilty ones set free or given moderate sentences? This is exactly what I think has occurred. This is one point to which the current hysteria has carried us.

MOTIVES

Elitcher had committed perjury and at the time of his testimony had not been indicted, tried and sentenced. He has not been so indicted or tried since. Had he been sentenced, no matter to what term, at the time of his testimony he would still have been anything but a reliable witness. I do not trust communists nor ex-communists nor perjurers, and I am sure that this view is shared by many others. But when pressure is put on such people, I trust them to do whatever they think necessary to get themselves out of their difficulties, especially when wives and children are involved. Surely Elitcher was tempted to give the testimony that the government wished to have.

The Greenglasses have admitted to a crime for which the maximum penalty is death. It is a custom in the United States to give consideration in sentencing a criminal to the degree of co-operation which he has given to the law enforcement authorities during the preparation and prosecution of the case. I suppose that criminals are advised of this situation by their attorneys or in other ways. At the time of the trial, David Greenglass had been indicted and was on trial but had not been sentenced, and the sentence could have been death. Ruth Greenglass has never been indicted and she was not a defendant in the trial. David Greenglass was given a 15 year prison sentence. It seems to me that the hope of lenient treatment must have constituted a motive for cooperation with the prosecution.

But "cooperation" is not synonymous with perjury and accusation against innocent people. Or is it? Does it not depend on what the facts are? If the Greenglasses' contact was Yakovlev and not the Rosenbergs (see Fig. 2), the revelation of this fact would have given the government nothing since Yakovlev was in Russia. What takes place in a criminal's mind when he is trapped and the electric chair appears in his dreams? I do not know, but it seems likely to me that both the Greenglasses would have confidently expected 30 year prison terms if they had admitted that their contact was with Yakovlev or some other agent of the U.S.S.R.

People ask why the prosecuting attorney and the F.B.I. and the judge should wish to see two insignificant people put to death unjustly. After considerable conversation with lawyers on this subject, including one who worked on the government side of the case, I conclude that lawyers are more interested in the law than in justice. Mostly they are interested in whether all the legal machinery functions according to all the rules, and are not in the least interested in the argument presented in this paper. There are exceptions, of course, as for example Professor Stephen Love and Professor Sharp, who helped the defense during the last weeks of the case without remuneration once he believed that a serious miscarriage of justice had occurred. However, it is my belief that the prosecution believed the Rosenbergs guilty. Once having believed the Greenglass account and having based the prosecution on this it would be difficult to adopt another point of view later. In fact, people do not allow themselves to be convinced that they have made such a horrible mistake as I believe has occurred. Once the government adopted this theory of the case, all concerned with it were trapped and were forced to continue to believe it.

CONCLUSION

I cannot review in a talk of this kind all the details of this case. This is better done by lawyers anyway. I commend to you Professor Love's statement on the case and Professor Sharp's book on the subject. But also a word in my own defence in presuring to say any-
we have public trials in this country. We

judge the conduct of the trial. This means that you and I have the right to criticize the court, the jury, the prosecution, the defense, everything about it. In criticizing this case, I am exercising certain rights that were mine at birth and I wish to keep them until death. We all of us have the right to form an opinion in regard to these matters and mine is adverse in regard to this case.

I also wish to make a statement in regard to a remark that has come to me from a number of scientists. They say essentially, "Well, if you only knew what I know," or rather mostly, "If you only knew what someone I know knows about the case!" The inference always is that much secret information exists that proves everything but for security reasons, it cannot be made public. My answer to that is that I do not believe this inference and do not believe people should be executed and imprisoned on secret evidence. I have discussed this question with a man, who saw some of the secret data at least. He says that Greenglass' paper looked to be genuine and that it contained valuable information. I have accepted this as fact, but does a paper tell you to whom the paper was given? My reply to these insinuations has been just as I have said above. There has been no answer to them. Before I accept these statements they must be told publicly so that we all can judge them.

I have been interested in this case and shall be interested in other similar cases because of my concern for the integrity of justice in this country. It is better to review a case in which we believe injustice has been done than to wait for the next one, when further injustice may occur. Will you not all try to do something about this series of doubtful trials or quasi judicial procedures that threaten our security as individuals living in a great free country?

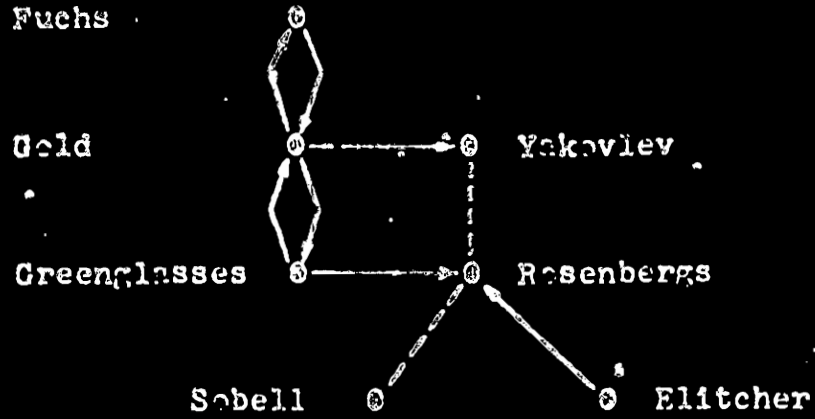
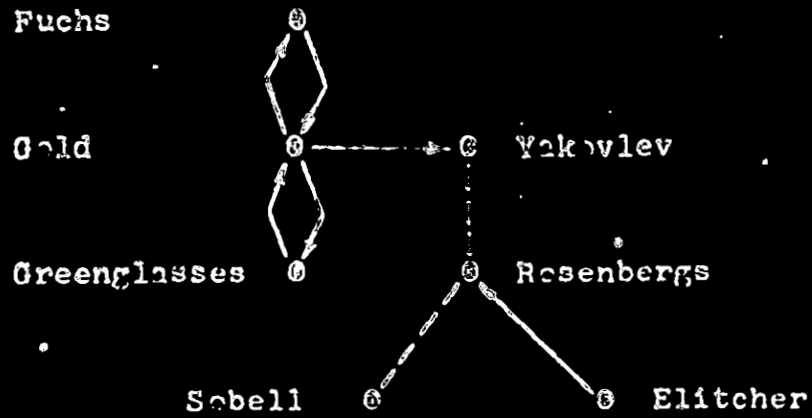

The American Daily, a European American language daily newspaper, carried an AP dispatch on February 15, 1955, about UREY's condemning the ROSENBERG trial and UREY's statement before the meeting under the auspices of the Chicago SOBELL Committee that the conviction of JULIUS and ETHEL ROSENBERG and MORTON SOBELL "does not in the best tradition of American justice". UREY indicated that SOBELL "was not properly tried and the verdict and sentence were not justified". UREY also added that "inclusion of the ROSENBERGS in the conspiracy makes no sense at all" because "the ROSENBERGS were unnecessary to the plot".

Judge Irving Kaufman is very proud of his contribution to the counteraction of Dr. Harold C. Urey's statements last Saturday night. He talked to General Sarnoff of the Radio Corporation of America (RCA) and last night, Morgan Beatty devoted considerable time on his radio program to this and to the background of the people involved. E. E. Chappell also used it as did John Cameron Swayze on the Camel Caravan. These three programs have a total listening audience of some 25,000,000.

Irving wondered if the Director had seen the letter to the editor by Herbert Bayard Swope. I told him he had and that the Director thought he had done an excellent job. I told Irving that we had gotten copies of the full text of the Urey speech and the press release and I was certain the boss would send him a set, although it might make his blood pressure go up. Irving stated he would like to see the full text. A letter is attached to him.

Irving is going to Florida this week to spend five days. He will be staying at Lou Rosensteel's place. I asked him if there was anything we could do. He stated he would tell us if there was.

I further pointed out to Irving that when he got the press release listing the names, I knew that he would be impressed with the number at the University of Chicago; that, after all, Robert Maynard Hutchins was President of the University of Chicago for years and he now heads the \$15,000,000 Fund of the Republic making a survey on loyalty and security.

I told Irving that sooner or later they would probably be probing around on the Rosenberg case and his participation and he could rest assured nobody would get a fair break if we are to judge by the action of their associate, Dr. Urey. Nobel Laureate Replies to Recent Criticism of Statements

TO THE EDITOR OF THE NEW YORK TIMES:

In reply to Herbert Bayard Swope's letter published in The Times of Feb. 16 in regard to my statements on the Rosenberg-Sobell case I should like to make the following points:

I am an amateur in these matters of law, but this country is founded on the assumption that we ordinary people who are not specialists in governmental matters can make the proper judgments about questions of government in all its phases. I claim only my rights in such matters. It is my duty to protest as vigorously as I can when in my opinion injustice has been done. In the case of the Rosenberg-Sobell trial I did this only after I had read the transcript of the case.

In science "authority" is of no importance. Scientists accept the arguments of the famous and the most unknown on scientific matters on their merits as nearly as they can be judged. We only ask the same treatment in other matters.

Mr. Swope does not answer my arguments—namely, that the evidence was given by confessed accomplices. No court reviewed the question of the reliability of witnesses. Our judicial system stands in the end on its merits, not on either Mr. Swope's or my statements. The Rosenberg-Sobell trial was in my opinion a bad example of American justice and the reputation of our justice would be improved by correcting such errors as much as possible.

Drs. Oppenheimer and Kirk have never expressed any opinion on the matter of this case and should not be dragged into this problem. Don't Mr. Swope's remarks about myself and other scientists partake of the current and rather popular anti-intellectualism? Isn't he saying in effect that we should shut up and tend to our knitting in our limited specialties? It seems to me that this country, unlike revolutionary France, needs its scholars.

I am flattered by being included with Drs. Kirk, Oppenheimer and Einstein. But why should Mr. Swope judge us publicly? It is his right to disagree with us; he should not deny us the right to our opinions and the public expression of them.

I am pleased to join my fellow citizens in this greeting to you.

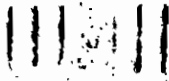

Dear Edgar:

Thank you so much for your letter of February 18th with which you enclosed a copy of Dr. Urey's address in Chicago on February 12th.

I find it very difficult to understand Dr. Urey, for as a Nobel prize winning scientist one may draw the inference that he possesses intelligence. Yet, here is a man who is willing to draw whatever conclusions he seeks to draw from the most faulty reasoning. As a scientist, who believes in exhaustive tests before he reaches conclusions, he refuses to utilize the essential legal test in credibility. I refer to the observation of witnesses by the jury, which passes upon credibility. The jury was told by me, as all jurors are told by Judges in criminal cases-to observe the witness; to observe whether the witness was direct or evasive in his or her testimony, etc. All this Dr. Urey brushes aside and says, in substance, that because he is Dr. Urey, he can tell whether a witness has been lying by merely reading the cold record, and he does not, therefore, have to adjudicate the credibility of witnesses by observing them.

He admits in his speech that I had told the jury that they could not find Sobell guilty unless they believed Ellitcher. It follows that the jury after testing credibility believed Ellitcher and the other Government witnesses. How unscientific these scientistist get when it suits their purpose!!

Furthermore, Dr. Urey does not explain why, if their was perjury in this case, did not Ellitcher go further on Sobell? He says that the case of Sobell was not light or were weak. If all associated with the government's case were suborners of perjury, as he seems to suggest, it would follow that they would try to make the case against Sobell stronger. Dr. Urey does not answer this argument.

A request for additional investigation concerning Urey has been received from Atomic Energy Commission (AEC) which requests recontacts with two informants who furnished information concerning Urey in 1947 and 1952. AEC also requests any information in our files concerning the Atlantic Union Committee with which Urey was affiliated in 1952.

Urey (noted atomic scientist, University of Chicago, 1945 to present) investigated by Bureau in 1947 under provisions of Atomic Energy Act of 1946, was investigated under Loyalty Program in 1952 in connection with employment with Army. At request of AEC supplemental investigation was conducted in 1954 for position as Consultant with Carbide and Carbon Chemical Corporation, Oak Ridge, Tennessee. We also opened espionage investigation concerning Urey in August 1953 based on allegation that Urey furnished French Communist with information regarding our progress in Atomic research. Investigation did not substantiate allegation and espionage case closed 12/21/54.

Our investigations have developed that Urey has been affiliated with numerous cited Communist front organizations and was active in support of the Rosenbergs (atomic spies who were executed 9/6/53). Associate stated Urey is a "liberal" and "joiner" or organizations.

Urey's name appears on list of persons not to be contacted by Bureau Agents. He has publicly made both favorable and unfavorable remarks concerning Bureau. As late as October 1954 in a speech in Chicago he made a vicious attack on the FBI and the Director.

In September 1955 request ¹¹⁶⁻¹⁸³¹⁵⁻¹⁸⁶ was received from Civil Service Commission (CSC) to investigate Urey under Public Law 298, for National Science Foundation wherein CSC requested that previous investigations be brought up to date. By memorandum 9/22/55 it was recommended and approved that the results of our investigations subsequent to 1952 be furnished to CSC and that CSC be advised that our investigations conducted in 1947, 1952, 1953 and 1954 represented

an extensive investigation of Urey and no further investigation was contemplated by this Bureau. This action taken by letter to CSC dated 10/3/55. AEC also has results of all of our investigations.

Concerning the Atlantic Union Committee, mentioned above, we have never conducted an investigation of that organization and our files contain no derogatory information concerning it. AEC will be so advised at the completion of this investigation.

Urey is currently an applicant for reinstatement of his clearance as a Consultant to the Union Carbide Nuclear Company, Oak Ridge, Tennessee. AEC has requested the above-mentioned investigation under the Atomic Energy Act of 1954; therefore, it is believed that investigation should be conducted for the AEC.

RECOMMENDATION:

Attached for your approval is an airtel to Chicago instructing that the requested investigation be conducted. In view of sensitive position involved and the controversial nature of Urey, field is being advised to inform persons interviewed that investigation is being conducted at request of AEC.
