HARRY GOLD, WAS, ESP. -R. MORE PHOTOS OF A. A. YAKOLEV FURNISHED BY N.Y. SHOWN TO GOLD WHO STATED THAT HE IS ALMOST POSITIVE THAT YAKOLEV IS IDENTICAL WITH JOHN, BUT WOULD NOT WANT TO MAKE UNQUALIFIED IDENTIFICATION. GOLD ADDED THAT HE WOULD QUOTE HANG SAM ON HIS PICTURE UNQUOTE REFERRING TO PICTURE OF SEMEN SEMEMOV. GOLD ADVISED THAT HE TOOK HIS NINETEEN FORTY-NINE VACATION DURING FIRST TWO WEEKS OF AUGUST AND SPENT IT AT HOME. RECALLED TELLING SEVERAL PEOPLE THAT HE HAD GONE TO MAINE BUT HAD RETURNED TO PHILA. WHEN MONEY RAN OUT. SAID HE REMAINED IN PHILA. PRINCIPALLY TO TRY AND GET HIS GIRL FRIEND TO MARRY HIM BUT HE WAS UNSUCCESSFUL. SAID HIS PRESENCE AT HOSPITAL AT ALL OTHER TIMES COULD BE VERIFIED BY SPECIMEN RECORD BOOK AT HOSPITAL KEPT BY THE DAY AND CONTAINING HIS HANDWRITING, THAT HIS PRESENCE AT HOME DURING VACATION COULD BE VERIFIED BY HIS BROTHER. ALSO STATED HE CAN NOT DRIVE AUTO. THIS LINE OF QUESTIONING USED IN CONNECTION WITH INFO THAT GOLD WAS SEEN IN WHITE SANDS SEPT. LAST. SAID HE WOULD PREFER NOT TO QUOTE DRAG UNQUOTE HIS EXGIRL FRIEND IN THIS UNLESS IT WERE ABSOL-

UTELY VITAL. DO NOT PRESS HIM AT THIS TIME.

GOLD ADVISED THAT HE IS GOING TO ASK THE WARDEN OF THE PRISON TO ALLOW HIM TO CONTACT JUDGE MC GRANNERY AND ARRANGE TO HAVE A COURT APPOINTED ATTORNEY REPRESENT HIM. GOLD EXPLAINED THAT HE WILL SPECIFY THAT HE WANTS TO CONTINUE TO TALK TO FBI AGENTS AND THAT MAIN REASON HE WANTS AN ATTORNEY IS THE EFFECT IT HAD ON HIS FATHER DURING SHORT TIME THEY THOUGHT GRAY WAS GOING TO HANDLE THE CASE. GOLD SAID THERE REALLY IS NOT MUCH USE IN HIRING AN ATTORNEY BECAUSE HE IS GUILTY. GOLD WILL BE QUESTIONED AGAIN TOMORROW AND SHOWN MORE PICTURES. NEW YORK IS REQUESTED TO REVIEW FILES AND SURVEILLANCE LOGS, TO DETERMINE IF ANY MANNERISM OR CHARACTERISTIC OF YAKOLEV IS CONTAINED THEREIN. N.Y. SHOULD ALSO DETERMINE IF ANYONE WHO CONTACTED YAKOLEV COULD BE INTERVIEWED. SUGGEST MRS. KASENKINA BE CONSIDERED IF SHE WERE IN U.S. DURING TIME YAKOLEV HERE.

For your information, the Warden of Holmesburg Prison, in which Harry Gold is presently incarcerated awaiting removal hearing, advised our Philadelphia Office that Harry Gold had requested that Special Agents of this Bureau come to the prison to continue interview with him. Gold had not been interviewed since his arraignment on the night of May 23 at Philadelphia.

Pursuant to Gold's request, Agents interviewed him today, at which time he stated that he desired the interviews to continue. Gold further stated that he has not as yet retained an attorney and, in the event he does retain an attorney, he will advise the attorney that he still desires to have interviews with Special Agents continue.

In view of the request of Harry Gold, we will continue to have him interviewed as long as he desires and until he retains an attorney. At such time as he retains an attorney, no further interviews will be conducted without the express permission of the attorney. In the event you disagree with this procedure, I would appreciate receiving your advice immediately.

SAC Cornelius of Philadelphia called and advised that Judge McGranery in Philadelphia had advised him that subject Gold had appeared before the Judge today at the request of Gold in order to have counsel appointed. The Judge advised Mr. Cornelius that he had been interviewed by five reporters and that he had told the reporters why Gold had appeared before him.

It appears that the United Press was not represented in this press interview of Judge McGranery and when the United Press learned of the press interview of the Judge they called the Judge for a statement and in the course of the statement the Judge had stated that Gold had said he would plead guilty. This information was obtained by SAC Cornelius from a newspaper contact in Philadelphia who had told him that when they received this information from UP they had stopped the presses in order to run this item.

Mr. Cornelius is making no comment in Philadelphia regarding the matter and no comment will be made here unless advised to the contrary.

ATOM SPY FROM 1200 SUSPECTS

The FBI arrested Harry Gold after sifting thru a list of some 1200 suspects, the United Press learned today.

Contrary to some reports, Gold's name was not given to the FBI by Dr. Klaus Fuchs, British scientist who confessed he spied for Russia and who transmitted information thru Gold.

The only substantial clue it got from Fuchs was a physical description which fit hundreds of persons. Dr. Fuchs did not know the name of his contact man.

The FBI search started last fall after it had determined someone had betrayed atomic secrets to Russia. This led to the arrest by Scotland Yard of Fuchs in England last February.

All the FBI got from Fuchs was this composite picture of the man it wanted:

A man about 40 years old, 5 feet 8 inches tall, weight 180 pounds, stocky build, Slavic appearance, receding forehead and a round face.

FBI'S BASIC FACTS

At the outset, the FBI was certain that the man it wanted was a chemist, engineer or bacteriologist—someone of superior intelligence and familiar with the complexities of atomic science. The FBI also knew Fuchs had been in Santa Fe, N. M., Boston, Cambridge, Mass. and New York City at certain times. It also proceeded on the theory the go-between for Moscow and Fuchs was someone connected with a laboratory.

Furthermore, the FBI set 1945 as the target year—the last year that Fuchs was in this country. The FBI pattern is to start with the latest date and work back.

On that premise the FBI went to work. First step was to find the names of companies which had been issued permits to buy chemical materials. There are several thousand such firms.

Next—it was known where Fuchs had lived in New York. So all tenants of the building were interviewed to determine if anyone knew of Fuchs' contacts.

THEN TO NEW MEXICO

Then the FBI worked back. It learned Fuchs had left New York in the summer of 1944 for the Los Alamos, N. M., laboratory where the first atomic bomb was being assembled. FBI agents went to Santa Fe and checked bus lines, airports, travel agencies, hotels and garages. Other agents reviewed FBI files. They came up with a list of about 1200 suspects.

One by one, the field was narrowed down—to several hundred, then to scores, then to 12, to six, to three and finally to one—a man named Harry Gold of Philadelphia.

About eight days ago, FBI agents started questioning Gold. He seemed to fit Fuchs' description: Short (5 feet 6 inches tall); 163 pounds; receding forehead; round face; a scientist (biochemist) of foreign origin.

FBI agents asked him to explain his activities over the years—what he had been; what he had done. This information was cross-checked by other agents throughout the country. They found inconsistencies in Gold's story.

Then came the clincher:

Gold denied ever having been west of the Mississippi River, when agents pointed out that he seemed to know a lot about Santa Fe. Gold broke.

Suddenly he blurted out to the agents that he was their man. (Early story on Page 1.)

How Spies Are Made

The case of Harry Gold provides further evidence of how Communist spy rings make good use of an ideological approach in recruiting espionage agents. "I felt that as an ally I was only helping the Soviet Union obtain certain information that I thought it was entitled to," Gold was quoted as telling the Federal Bureau of Investigation agents who arrested him for alleged espionage. Dr. Klaus Fuchs, convicted British spy employed by the Russians, made a somewhat similar explanation of his reason for betraying his government. This ideological motive for spying was stressed in the report of the Royal Canadian Commission on wartime espionage in Canada.

The commission found that most of the men and women recruited for the Canadian conspiracy experienced an inner struggle between loyalty to their native land and loyalty to the cause of communism. The Russian spy leaders succeeded in convincing these Communists or Communist sympathizers that loyalty to communism—which meant loyalty to Russia, too—should be given priority over all other loyalties. Once convinced of the rightness of this concept, it was relatively easy to induce the recruits to prove their supreme loyalty by serving the spy ring. It was so with Dr. Fuchs and it was apparently so with the man to whom Dr. Fuchs confessed delivering written and oral atomic bomb information. Gold had been under FBI surveillance for several years, because of his Red associations. The FBI later linked him with the activities of Dr. Fuchs, although it is said that the British scientist never named Gold to the FBI. His identification as Dr. Fuchs' contact man was the result of long and meticulous investigation.

The "John Doe" to whom Gold eventually handed the stolen secrets remains unidentified. Presumably he was a Russian agent, working under orders from Moscow. The chances of his being in this country now would seem to be quite slim. He would be running a big risk to remain here after the arrest of Dr. Fuchs and the "complete confession" of the latter. If there are others involved in this particular ring, through ideological or other motives, the FBI probably is on their trail. At least that is reassuring speculation, justified by the work which the professional investigation agency has done and is doing, without benefit of public hearings.

Chemist Aide of Spy Seized in Philadelphia

Congressional leaders today expected additional arrests to follow capture of Harry Gold, one of the contacts in this country of the British Communist spy, Dr. K. E. Fuchs. Rep. James E. van Zandt (R., Pa.) said the arrest "was probably the first of a series by the FBI."

Gold was arrested in Philadelphia. He was taken Monday and arraigned last night. The warrant said Gold and a "John Doe" conspired with Dr. Fuchs to slip A-bomb secrets to Russia during the war.

Gold thus became the first American to face the death penalty for spying on atomic secrets.

WHO IS 'JOHN DOE?'

It isn't known whether the "John Doe" named in the warrant is already in custody or not.

Rep. Van Zandt, a member of the Atomic Energy Commission which was apparently tipped off in advance about Gold's arrest, said the FBI was working on the case "for months."

Actually, the warning about Dr. Fuchs' activities was sent to this country and to Britain by the Canadian government in 1946. This was exclusively reported in this country in The Washington Daily News, March 10, 1950. The News received its story from the Canadian news weekly, The Ensign, which developed the exclusive story.

Despite the 1946 warning, Dr. Fuchs was allowed to work for four more years in the highest branches of atomic research in Britain, and to have access to top U. S. and British atomic secrets.

It was during those four years that he passed most of his atomic information to Russia for which he was sentenced.

ADDITIONAL SPYING

However, the arrest of Gold was for spy work done at an even earlier date: between 1940 and 1945. This is stated in the warrant for Gold, which was based on an information filed in Brooklyn, N. Y.

After The Washington Daily News and The Ensign printed the story about the Canadian Government's warning the United States and Britain about Dr. Fuchs' prompt denials of the story were issued in both Ottawa and London. The heads of the governments later said to reverse themselves and admit the story was true.

DOUBLE TALK

The Lord Chancellor, Viscount Jowitt, made the denial for England. The Minister of External Affairs, Lester B. Pearson, made the denial for Canada. The Lord Chancellor's denial, which was made in a statement to the House of Lords, was echoed by the Prime Minister, Clement Attlee, who said Britain had received no warning about Dr. Fuchs.

Then on April 3, the Lord Chancellor, Viscount Jowitt, reversed himself and admitted the story was right.

He had first said: "It has been said that the Canadian Government passed to our security services a copy of a diary containing the name of Dr. Fuchs, from which it might have been deduced that Dr. Fuchs was a spy. There is no truth whatever in that statement."

IN BOOK, AFTER ALL

Reporting Lord Jowitt's reversal, the British United Press said on April 5: "A notebook found on a man by the Canadian Royal Commission tipped off... that Dr. Fuchs... was a Russian spy."

The Lord Chancellor, Viscount Jowitt, said that Fuchs' name was found in the notebook... the notebook... and all relevant material was turned over to Britain."

The United States was also warned at the same time.

But Gold's and Fuchs' contacts were even earlier. In fact, the evidence of the arrest seems to contradict a public statement by Canada's Minister of External Affairs, Lester B. Pearson.

WAS HE HERE OR NOT?

Three weeks ago, in reversing himself and admitting that Fuchs' name had been found in a notebook belonging to one of the suspected spies, Mr. Pearson told the External Affairs Committee of the Canadian Parliament that "it did not arouse any interest at the time. Fuchs was then not in Canada—he had gone back to England many years before, about 1940 or 1941."

Actually, however, Gold, after his arrest last night, admitted having contacts in this country with Dr. Fuchs in 1944-45.

Apparently Mr. Pearson was not correct when he said Fuchs had gone back to England.

However, Mr. Pearson did admit that both the United States and Britain were warned, saying Fuchs' name "was included among a group many in the notebook... and were brought to the attention of the United Kingdom and the United States, thus reversing his earlier denial of The Ensign's story which appeared in Washington in The News."

Committee praised the FBI's efficiency in conducting its inquiry. Some committee members anticipated an early committee meeting at which additional details about the Gold case may be made public.

CONFESSES

FBI agents, who arrested Gold on Monday, said he admitted helping pass the vital A-bomb information to the Communists to help "a nation whose final aims I approved along the road to industrial strength."

Gold was born in Switzerland 39 years ago. His parents were born in Russia. His father's name was Golodnitsky. The parents changed it to Gold when they became naturalized Americans, and Gold, himself, claims derivative American citizenship.

Gold was arraigned last night in Philadelphia before Federal Judge James P. McGranery who set bail at \$100,000. The judge set a further hearing for June 12.

The chemist, a flabby, swarthy man barely more than five-feet tall, made no effort to raise the bail money and was taken to Moyamensing prison here under guard of six FBI agents.

KIN SHOCKED

He will remain in Moyamensing prison until the hearing next month unless bail is raised or he expresses willingness to return to New York where the Justice Department charge was filed.

The arrest came as a shock to Gold's brother, Joseph, 38, a civilian Navy employe with whom he made his home, and his 70-year-old father.

"To my knowledge my brother was never a Communist," said Joseph Gold. "My father was never a Communist. I myself hate Communism."

FACES DEATH PENALTY

Gold, first American arrested for atomic spying, was accused of violating the Espionage Act in wartime. It makes him subject to a maximum penalty of death.

"I was only helping the Soviet attain certain information that I thought it was entitled to," Hoover quoted Gold.

"Particularly was I taken with the idea that whatever I did would go to help make living conditions far more advanced along the road as we know them here in the United States," the FBI chief quoted Gold.

The complaint charged specifically that Gold acted on behalf of Russia.

MORE NAMES; MORE SPIES?

Pearson said more than 50 names were turned over to the two governments. It is possible that some of these names are those of additional suspects to which Rep. Van Zandt referred when he said today "We know there are others. It is just a question of the FBI getting them."

J. Edgar Hoover said Gold has readily admitted his contacts with Fuchs and that, like Fuchs, gave a detailed account of his activities.

FBI ROLE PRAISED

Fuchs was arrested in February in London on information furnished to the British by the FBI. He made a complete confession of his operations on both sides of the Atlantic.

Two FBI officials are now in England questioning Fuchs in an effort to obtain new leads. There were indications, however, that Gold's arrest stemmed from data Fuchs furnished earlier to Scotland Yard.

PURPOSE:

To reply to your inquiry as to the source of the \$500 paid by Gold to a United States Army noncommissioned officer in Albuquerque, New Mexico.

BACKGROUND:

You will recall that by teletype dated May 31, 1950, the Philadelphia Office advised Harry Gold stated that he saw Fuchs in Santa Fe, New Mexico, in June, 1945, and that he stopped at the Hilton Hotel, Albuquerque, New Mexico. Gold further stated that his reason for doing so was that he picked up information from a United States Army noncommissioned officer who was living in Albuquerque. This information, according to Gold, was of a general nature on "installations." He gave the Army man \$500 for this information.

Under date of June 2, 1950, Special Agent Richard E. Brennan of the Philadelphia Office telephonically advised the Bureau that Harry Gold, during the course of an interview, stated that he had only one meeting with the unknown soldier who lived in Albuquerque. Prior to going to Santa Fe, at which time he contacted the noncommissioned officer who lived in Albuquerque, Gold received the \$500 from Anatole A. Yakovlev, a Soviet consular official in New York on the occasion of a meeting in a bar in New York City. He told Gold to contact the man in Santa Fe but not to let that assignment interfere in any way with his contacting Fuchs. Gold saw Fuchs in Santa Fe and then returned to Albuquerque and tried to contact the individual whose name and address had been given to him by Anatole A. Yakovlev. Gold stayed over night and was able to contact the individual on the following day, at which time he learned for the first time that the individual whom he was to contact in Albuquerque was a soldier in the United States Army. Gold stated that it was obvious that the soldier expected the money and that the information received from him pertained to the physical setup of the atomic energy installation at Los Alamos.

There is some indication that the unknown soldier at Los Alamos may be one David Greenglass. An investigation is presently being conducted in an effort to either identify or eliminate him.

URGENT

To advise you of the background of Alfred Dean Slack, and of the information developed concerning him in connection with his identification by Gold as one of his espionage contacts in 1941 and early 1942.

BACKGROUND AND PERSONAL HISTORY

Alfred Dean Slack was born on August 6, 1905, at Syracuse, New York. He is a graduate of Syracuse University, and former student of La Salle Extension University, during 1928 and 1929. In January, 1927, he was employed by the Eastman Kodak Company, Rochester, New York. He remained with this company until September 16, 1942, at which time he accepted employment with the Holston Ordnance Works, Kingsport, Tennessee. In 1944 Slack worked at the Clinton Engineer Works, Oak Ridge, Tennessee. He remained with this company until the latter part of 1944, when he became associated with the Scripts Manufacturing Company, producers of pen points. On June 2, 1947, Slack was employed by Eyn Associates, Cranston, Rhode Island, a manufacturer of mechanical pencils. He was discharged December 13, 1947, due to a reduction in force. Alfred Dean Slack is presently employed at Supture Paint Company, 619 West Fayette Street, Syracuse, New York, and residing on a farm near Clay, New York. He is presently under physical surveillance.

RESULTS OF INVESTIGATION UNDER ATOMIC ENERGY ACT

Investigation of Alfred Dean Slack was initiated on September 27, 1947, by the Buffalo Field Office on the basis of information furnished in a letter from the New York Field Office dated August 12, 1947, advising that Miss Gwen Troughton and Miss Olga Troughton of New York City furnished information to the effect that Alfred Dean Slack, a boy friend of their sister, Ella Troughton, had exhibited a definite Communist attitude and favored the Russian form of Government; further, that he was a close friend of Richard Daniel Briggs, who was believed to be a Communist Party member and a leader in the Party in the Rochester, New York Section.

According to Olga Troughton, Slack advised her in about 1942 or 1943 that he was drafted from his job into the Army and worked in a civilian capacity on very secret work. In March of 1947 Slack stated that he was working on the Atom Bomb, and that the United States Government was going to send him to

... advised that Slack later told her that this trip was called because he knew too much about the secrets of the atomic bomb. She further stated that in 1940 or 1941, she and her sister were visiting on a farm of the Slacks in Webster, New York, and while there, an unknown individual came into the house and deposited a package in the ice box in the kitchen. Later that same day Slack and his friend, Richard Briggs, took the package from the ice box and became involved in an argument over the division of certain money. Slack's father indicated to the Troughton girls that the money, over which Slack and Briggs were arguing, was received from the Russians for information furnished them by Slack and Briggs.

As a result of the above complaint, an Atomic Energy Act investigation was instituted on September 27, 1947. This investigation reflected that Slack was employed by the Kodak Park Plant, Eastman Kodak Company, Rochester, New York, on January 17, 1927, as a chemist in the Research Laboratory. On September 8, 1942, he was transferred to the Holston Ordnance Works, Kingsport, Tennessee, which was operated by the Tennessee-Eastman Corporation. While Slack was employed in the Research Laboratory of the Kodak Park Plant from 1938 to 1940 his Supervisor in Charge was specifically instructed by the Assistant General Manager in about 1940 to remove Slack from his position in the Research Laboratory inasmuch as the management had received information that Slack was furnishing information concerning the formula for colored photography to a foreign government, namely, Russia.

In connection with the allegation made by the Troughton sisters, Gwen and Olga, another sister, Ella Troughton, Secretary and Assistant Treasurer of the Rochester Transit Corporation, Rochester, New York, was interviewed. She advised that she had no knowledge of the alleged Communist sympathies of Slack, and pleaded ignorance of Slack's connection with the Russian Government. She was questioned specifically concerning the alleged argument between Slack and Briggs over the division of money, and she recalled no such incident.

Concerning the statement that the management of the Eastman Kodak Company had received information that Slack was furnishing information to a foreign government, namely, Russia, investigation failed to disclose the original source of the above allegation. Persons contacted could furnish no information to substantiate the original allegations, nor was information furnished that would establish disloyalty on the part of Slack.

Mr. John LaFol Patterson, Chemical Engineer, Kodak Park Plant, Rochester, New York, advised that in the latter part of 1944, Slack worked

at the Clinton Engineer Works, Oak Ridge, Tennessee, and that in the course of performing his duties, Slack had access to restricted documents.

By report dated April 6, 1948, the Atomic Energy Act investigation of Slack was closed inasmuch as Slack had ceased his employment on October 9, 1945, under the Atomic Energy Program, and since no information was developed indicating a violation of the Atomic Energy Act.

Bureau files reflect that Alfred Slack was interviewed by Bureau Agents on February 27, 1948, at Cincinnati, Ohio, for the purpose of ascertaining the whereabouts of Robert H. Briggs, his brother-in-law. [REDACTED]

HARRY GOLD'S ALLEGATIONS CONCERNING SLACK'S ESPIONAGE ACTIVITIES

Harry Gold, confessed espionage agent, during an interview on May 22, 1950, advised that he met a man known to him as "Martin," once in Rochester, and probably once in Buffalo, New York, in late 1941 or early 1942. He furnished a description of "Harsh Martin," stating that he believed that "Martin" was a chemist or engineer by occupation, and that "Martin" was employed by the Eastman Kodak Company at Rochester, New York. He further stated that upon these occasions he obtained material from "Martin."

During the afternoon of June 1, 1950, Gold admitted that he was withholding the identity of Martin and that the person originally identified as Martin was actually Al Slack. Gold further stated that he himself had used the alias Martin when meeting Slack, and that he met Slack over a period of

years during 1942, 1943, 1944, contacting Slack six or seven times, obtaining information from him, and paying him each time. He began seeing Slack at Rochester, New York, while Slack worked for the Eastman Kodak Company. Later, Slack went to work at the Holston Ordnance Works, Kingsport, Tennessee, and still later at Oak Ridge, Tennessee. He saw Slack in Tennessee and obtained information from him on explosives.

Dear Sir:

Reference is made to Boston teletype dated June 7, 1950, requesting additional information in the New York Office files on PHILIP LEVINE who was interviewed by the Boston Office on June 7, 1950.

A review of the New York file entitled "PHILIP LEVINE; SECURITY MATTER - C" reflects that on December 5, 1944, a highly confidential source of the New York Office furnished a copy of the membership card of PHILIP LEVINE in the Sunnyside, Long Island Club of the Communist Political Association. This card bears number 36222 and lists LEVINE'S address as 4853 44th Street, Sunnyside, where as it has previously been stated, he later lived with HARRY GOLD. A photostatic copy of this membership card is being enclosed for the information and assistance of the Boston Office.

In February, 1949, inquiry by the New York Office at the above-mentioned address of LEVINE revealed that he was then living there in Apartment 1-L with his wife, EDITH, and a two-year-old daughter, PAULA. The superintendent at that address, one FRANK PATELLA, stated that LEVINE had been living there for several years and that he was a chemist. PATELLA stated that LEVINE and his wife were then friendly with another family in the building whom PATELLA believed to be "Communistically inclined", although PATELLA had no specific information concerning LEVINE'S Communist tendencies. In this connection, PATELLA pointed out that that particular section of Sunnyside, Long Island had then had "a very active group of Communist Party members".

A main file index card for Harry Gold is contained in the Bureau indices reflecting that he is a subject in the Gregory Case. However, Gold was only briefly investigated during the Gregory investigation. Gold became involved in that investigation when Abraham Brothman, who was interviewed by Bureau agents on May 29, 1947, stated at that time that he, Brothman, turned over blueprints to Jacob Golos, known Soviet espionage agent. Brothman said that after several visits from Golos, Golos introduced him to "Helen", who thereafter obtained the blueprints from Brothman over a dozen times during 1938-1939-1940. Brothman said that sometime in 1940 "Helen" stopped coming to his office and an individual named Harry Gold came to his office and said that he represented Golos. Gold visited Brothman's Office on numerous occasions during 1940 and 1941 and obtained blueprints from Brothman.

Gold was interviewed on May 29, 1947, concerning Brothman's statements and admitted obtaining blueprints from Brothman for Golos which he evaluated on a chemical basis but he denied that he had any financial agreement with Golos.

Inasmuch as Harry Gold has been identified as being identical with the unknown subject, with aliases [REDACTED], he is being considered the subject of Bureau file 65-57449, which was formerly carried as "Unknown Subject, [REDACTED] Espionage - R." On May 29, 1947, a signed statement was secured from Abraham Brothman following his interview by agents of the New York Office. In his signed statement Brothman stated that he owned and operated the Republic Chemical Machinery Company, which was associated with the Hendrick Manufacturing Company in 1938 or 1939. At that time he was approached by a man concerning contracts with the Russian Government. In order that he might obtain contracts from this man, Brothman stated that he turned over several blueprints which belonged to him. Subsequently, this unknown man appeared at Brothman's office accompanied by a woman named Helen, who represented the unknown man.

Brothman, after examination of photographs, identified the woman named Helen as the informant Gregory and the unknown man as Jacob Golos, a known Soviet Espionage Agent.

Between the years 1938 and 1940, Brothman stated that the woman "Helen" appeared at his office approximately a dozen times.

Brothman later became acquainted with Harry Gold, who contacted him and picked up various blueprints which were destined for Jacob Golos. Brothman stated that Harry Gold was employed as of the date of the interview at Brothman's Company as a chemist. According to Brothman's statement, Gold last picked up blueprints in 1941 or early 1942.

The above information concerning Brothman, Golos, Harry Gold and informant Gregory was set forth in a New York memorandum to the Bureau concerning Arthur Phineas Weber, a subject of an Atomic Energy Act - Employee investigation. It was set forth to show the nature of Brothman's activities concerning commercial espionage as reported in the Gregory Case.

Arthur Phineas Weber developed a close association with Brothman in February, 1941, when he was employed by the Hendrick Manufacturing Company, 30 Church Street, New York City.

A copy of the report of Special Agent Francis J. Gallant dated at New York, September 19, 1949, entitled "Abraham Brothman, Security Matter - C" has been removed from Brothman's main file and placed in Gold's principal main file, (65-57449.) This report reflects information obtained during an interview with Brothman by Bureau Agents on May 29, 1947, at which time he made mention of Harry Gold and in particular contains a signed statement obtained from Brothman on May 29, 1947. On page six of the February 13, 1950, issue of the "Washington Daily News," it is reflected that a bundle of photographs had been flown to London in an effort to jog Dr. Fuchs' memory regarding persons who may have assisted him. The article goes on to state that the package contained likenesses of many persons who had associated with Fuchs, and indicates the picture check was a precaution taken by the Bureau to make sure no such accomplice of Fuchs would slip through the Bureau's "dragnet."

Of the above it was stated that no package of pictures as such had been sent, although Mr. Whitson, while on route picked up a number of pictures in New York, including those of Abraham Brothman, Jules Korchien and Oscar J. Vago. It was also stated that there was going through the mail February 13, 1950, a series of three pictures on subject [REDACTED] suspects, namely Gerhardt Wollan, Martin Deutsch and Harry Gpld. Brothman during the period 1938-1942 operated a company known as the Republic Chemical Machinery Company which did designing work on chemical machines. In June 1942 Brothman severed his relationship with the Republic Chemical Machinery Company and became associated with Henry A. Golwynne and Arthur Phineas Weber in the operation of the Chemurgy Design Corporation at 420 Lexington Avenue, New York City. In August 1944 Brothman organized his own firm, Abraham Brothman and Associates, 114 East 32nd Street, New York City. He later moved his offices to 29-28 - 41st Street, Long Island City, New York, where he was located as of February 1950. Brothman first came to the attention of the Bureau as a result of the allegations of Elizabeth T. Bentley. Bentley stated that she was introduced to one Abe Brothman about May 1940 by Jacob Golos. From the early summer of 1940 through the fall of 1940, she met Brothman on about ten occasions when he delivered to her blueprints. She said Brothman was on other occasions contacted by Golos.

Sometime during the course of her various meetings with Brothman she learned from either Brothman or Golos that the blueprints which Brothman had been delivering to her pertained to a certain type of commercial vat.

During the fall of 1940, according to Bentley, Golos informed her that he was becoming disgusted with his dealings with Brothman and told her that he was going to turn Brothman over to someone else. She stated that she did not learn from Golos or anyone else to whom Brothman was then directed.

However, during an interview with Brothman by Bureau Agents in May 1947, he stated that he was contacted by Harry Gold following the termination of his association with Elizabeth Bentley. Gold informed Brothman that he had been sent to Brothman by Golos. Gold then, according to Brothman, began to pick up blueprints until the early part of 1942.

Although Gold did not pick up any blueprints from Brothman

subsequent to 1942, they remained in contact with each other and Gold was hired by Brothman in 1942 as a chemist. He was still presumably employed by Brothman as of February 1950. Brothman testified before the Special Federal Grand Jury in the Southern District of New York on July 22, 1947, relative to his associations with Bentley and Golos.

Gold was interviewed on May 29, 1947 by Agents of the New York Office. During his interview, Gold advised that he was born December 12, 1910, in Switzerland, the son of Sam and Celia Gold, natives of Russia. He said that he arrived in the United States in 1914.

Gold attended night school at the Drexel Institute in Philadelphia; the University of Pennsylvania; Columbia University; and Xavier University in Cincinnati, where he received a Bachelor of Science, Summa Cum Laude, Degree in 1940. From 1929 until the time he joined the Abraham Brothman Associates, Gold was employed by the Pennsylvania Sugar Company in their laboratories at Philadelphia, Pennsylvania.

Klaus Fuchs, according to information provided the Boston Office on February 9, 1950, described his contact in the United States as a person who is not a nuclear physicist, but one who has knowledge of chemistry and engineering. Fuchs stated that his contact was not inside the Atomic Energy Project. Fuchs further stated that his contact was age - about 40 to 45; height - possibly 5'10"; build - fairly broad; and face - round. Fuchs further stated that he felt that his contact was possibly the first generation American, but he could not establish his ancestry.

In this connection it was mentioned that it is likely that the contact referred to is identical with [redacted] but this is not conclusive as Fuchs may well have had more than one contact. (TS) b1

Mrs. Heineman stated that approximately two or three weeks before Klaus Fuchs visited her on February 12, 1945, she was looking out the window of her home at 144 Lakeview Avenue, Cambridge, Massachusetts. She noticed a man walking down the street, whom she did not know, and was, therefore, surprised when he came to her door and rang the bell. The time was just before noon and she would fix the time at sometime between approximately January 20, 1945, and the first days in February, 1945. She answered the door and the Unchem asked her if she were Mrs. Heineman, the sister of Klaus Fuchs. She responded affirmatively and thereupon introduced himself by stating he was a chemist who had worked with Klaus Fuchs and was anxious to see him.

Mrs. Heineman stated that the foregoing represented the facts of the visit and she was under the impression at the time, she believes, that the Unchem worked with Fuchs at Los Alamos, but she has no basis in fact in her recollection for this opinion.

In a further effort to identify Unchem, photographs of numerous individuals submitted by various field divisions, following the furnishing of the above information to the field by the Bureau, were exhibited to the Heinemans. One of the individuals whose photograph was shown the Heinemans was that of Harry Gold. Robert Heineman, husband of Mrs. Heineman, selected Avram Kisselgoff because of the shape of the latter's face and his hair line. Prior to his observation of Kisselgoff, however, Heineman had set aside for further consideration photographs of Joseph Greenspan, Morris U. Cohen, Harry Gold and G. L. Laserson.

Arthur Phineas Weber on March 3, 1950, was interviewed by an Agent of the Cincinnati Office. During the course of his interview, Weber stated he first met Frank Keppler (phonetic) in late 1943 when Keppler visited Brothman at Chemurgy. Gold attended night school in Drexel Institute in Philadelphia, University of Pennsylvania, and Columbia University. In June 1940 he received a B.S. degree from Xavier University, Cincinnati.

In February, 1946, he began work for A. Brothman and Associates, 85-03 57th Avenue, Elmhurst. During unknown periods, Gold worked for the Halbrook Manufacturing Company, Jersey City, and the Moormeir Dairy Company, Cincinnati.

Gold, according to Confidential Informant Gregory, acted on behalf of Jacob Golos, known Soviet Agent now deceased, in 1940 and 1941 in picking up blueprints from Abraham Brothman. Gold admits he did this in 1940 and 1941, making trips to Philadelphia and New York to see Brothman for this purpose. Gold stated that it was on Golos' instruction that he, Gold, evaluated these blueprints before turning them over to Golos. It is Gold's contention, however, that Golos showed no interest in these blueprints.

News flashes from various chapters of the North American Spanish Aid Committee reflected an item of information from Philadelphia wherein it was stated that the Delaware County Chapter at Chester, Pennsylvania was breaking into the local press quite frequently with news items, letters and editorials about the Medburo (Medical Bureau to Aid Spanish Democracy). The news flash indicated that the Delaware County Chapter was led by Dr. Gold and had raised about \$500. The same news flash indicated a meeting was held at the Friends Meeting House in Swarthmore, Pennsylvania at which Professors Manning and Anderson and Harold Laski spoke. At this same meeting Dr. Gold gave a talk on the Medburo.

Elizabeth Terrill Bentley, an admitted Soviet espionage agent and courier, stated that she became acquainted with Major Duncan Lee during the latter part of 1942, at which time Lee was employed in the Office of Strategic Services in an advisory capacity to General William J. Donovan. She alleged that after her first meeting with Lee he began supplying her with OSS information of a varied nature. She advised that she saw Lee at intervals in Washington, D. C. and about January, 1943, she met Lee at the Old Homestead Restaurant at 9th Avenue in New York City. Jacob Golos, the individual to whom Bentley furnished espionage information obtained by her, was also present at this meeting and was introduced to Lee. So far as Bentley could recall this was Golos' first meeting with Lee and she stated that Golos was usually introduced as John. She stated further that after this meeting Lee would call her at her residence and they would arrange to see each other in some restaurant in New York. She advised that her last meeting with Lee occurred probably in January, 1945, at the Longchamps Restaurant on Fifth Avenue at 12th Street. She related that when she first met Lee she introduced herself as Helen.

Duncan Chaplin Lee was interviewed by Bureau Agents on May 29, 1947, at which time he identified a photograph of Bentley as the person known to him as Helen. He recalled having met her in the Old Homestead Restaurant on 9th Avenue in New York City on one occasion, at which time she introduced him to an individual whom he knows only by the name of John. He could not recall whether he heard this individual's last name. He was asked specifically if it could have been Golos or Gold and he said he could not recall. He recalled having seen John only on one other occasion which was in the fall of 1943, in a restaurant located at 823 15th Street, N. W., Washington, D. C. He stated that he knew nothing concerning John's background except that John appeared to be a very good friend of Helen.

Lee testified before the House Committee on Un-American Activities in August, 1948, at which time he identified a photograph of Jacob Golos as a friend of Elizabeth Bentley and he stated he first met Golos at the 823 Restaurant on 15th Street in Washington, D. C. He testified that Golos was introduced under the name of John and Lee was unable to recall John's last name. He testified that some months later he again met John in New York City.

A memorandum to the Director dated February 15, 1946, from the El Paso Office entitled "CINRAD" reflected that a photographic copy had been obtained of reports and personnel data in the files of certain designated individuals formerly associated with the Los Alamos DSLI, Los Alamos, New Mexico. One of the files was that of Charlotte Serber. In her file was a memorandum for the Officer in Charge dated August 3, 1943, from John J. McLaughlin, Jr., Special Agent, CIC. 


