Cosmo

- Revocation hearing rescheduled to May 10 @ City Hall
- Still Open
- Main nights are Fri & Wed
- Hwd Vice unit has issued 30-35 citations (mostly CUP violations) & 1 physical arrest
- Last week, EDD conducted enforcement
- Have 50K in fines

- Neighboring business owner is willing to testify against Cosmo at hearing

Rusty Mullet

- Crime occurring at adjacent locations as a result of incident stemming from inside the bar.
- Refusal to comply w/ CUP's
- Hwd vice unit has been operating 2x's/month
- Several ABC violations
- On and off- duty ofcrs have been injured as a result of incidents stemming from the Rusty Mullet
- Property owner does not care about enforcement or revocation. ultimately wants the clubs/bars to get kicked out so he can "revamp" the entire block.
- 96 person capacity
- Coordinated Task Force in near future: Building & Safety, LA Fire, Hwd Vice, ABC & DSVD

Joseph's

- Owners completely own the property, thus they are rarely open at night
- Have been known to open early in the morning for an after-hours breakfast event
- Vice unit recovered AK-47 and dope from the location
- CUB expires in 2023

Playhouse

- Will fix problems when pointed out by the vice unit
- Willing to play ball with law enforcement

La Scorpion Bar

- Consistently out of compliance
- Owner of the bar (Martin Torres) is the problem with the location.
