The following is a recap of tonight's results. There will be two officers on overtime due to the arrest of one of the owners at Joseph's for having an AK-47 in his office. Officers are currently working on completing only the property report and well as face sheet of the arrest in order to book the guns, narcotics and ammunition. We are currently working on possibly getting a morning watch to book this evidence for us. We will complete the arrest report tonight in order to minimize overtime.

Here are the violations.

- Ø Valet at Sunset and Wilcox: Shut down due to lack of permits.
- Ø Boulevard 3: Building and Safety identified code violations.
- Ø Davey Wayne's: Cited for CUP violations including noise violations. Four security guards were cited for no guard card.
- Ø Joseph's: The owner at Joseph's was arrested for 30605 PC, possession of an assault rifle. The second owner was cited for various CUP violations and 347(b) PC, contaminated bottles.
