Sergeant Gonzales and I conducted a two-hour surveillance at Cosmo in order to monitor all activity related to this club. At approximately 0100 hours, we requested the fire department to respond and conduct a crowd count at both the "Project LA" and "Cosmo." It was determined that Project LA was at maximum capacity so they were advised not to allow any more patrons in. Security began clearing the lines and turning patrons away. Cosmo was not quite at capacity so there was no enforcement taken by FD. We continued monitoring the location until they closed their doors at 2 a.m. There were the usual crowding issues on the surrounding streets and sidewalks as a result. I had a PED unit respond and disperse the crowd.

An undercover operation was also conducted at Playhouse where we were able

to get a minor into the club as prior complaints had indicated. During the course of the operation, the minor was able to obtain alcohol service from all bartenders inside the location. As a result, the five bartenders were cited for 25658 B&P, furnishing alcohol to a minor. The manager Tommy Karahalios was cited for 12.29 LAMC, CUP violations of conditions number 12, 16, 22, 28, 29, 33, 42 and 44.

All reports will be completed and properly disseminated tomorrow in order to minimize overtime.
