Our Office plans to operate the function in order to gather additional evidence and ensure a revocation of the establishment CUP. In addition, the Officers of Hollywood Vice will continue to monitor business activity at the site and negotiate additional operations if the opportunity arises.

Currently "Cashmere" operations have all but ceased, as Investigating Officers found the location closed on the last two instances they responded to attempt operations of the business. Apparently operators have moved the previously promoted functions (Specifically the "My Castle" promotion) to the associated "Cosmo" nightclub (Located at 6364 Hollywood Blvd and operated by the same Licensee - Alberto Avila). On October 16th, 2015, after finding the "Cashmere" premises closed, Officers responded to the "Cosmo" location and negotiated an Undercover and Uniformed inspection of the site. The inspection resulted in the identification of multiple CUP and ABC violations and resulted in the arrest of 9 minor Suspects for violation - 25665 B&P (Minor in a public premises), one security guard (Kevin Rhey) for Violation - 7544.6 B&P (Acting as Security Guard without a State Guard Card) and the business manager - Conrad Straub (Who is also the manager for the "Cashmere" business) for Violation - 12.29 LAMC (CUP Condition Violation, Conditions No. 10 and No. 22). The occurrence was documented on a Complaint Application filed under DR No. 15-06-22543.
