1600 Argyle Avenue, The Argyle, occurred at NW corner Selma and Argyle outside of the club.

Date: 3/5/16

Day: Saturday

Time: 2311hours

Gang Related: No

Weapon Used: Fist

Victim: Unidentified male Hispanic, approximately 25-30, transported to Cedars Sinai by RA 27 and pronounced dead due Trauma to back of head.

Suspect: Prado, Ismael 5/30/92, from Merced, Ca (detained at Hollywood Station)

Additional witnesses at Hollywood Station.

Female witness says she was outside the club, when the victim grabbed her buttocks (sexual battery). Female tells victim don't do that. Suspect, with female, intervenes. Victim punches suspect. Suspect punches victim in face. Victim falls. Witnesses hears sound of head striking pavement. Victim suffered significant head trauma from ground and was not conscious when officers arrived. The suspect provided a voluntary statement to the first responding officers.

After review of the video and interview of the suspects we have determined that this homicide is justifiable. The video is very clear and supports the suspect and witness statements. The victim was the aggressor and the suspect appeared to reasonably.

An update on the earlier shooting/carjacking that occurred at 0335 hours:

The victim (Hispanic Male 25 yrs) was an Uber driver who had just dropped off a fare at the above location. The victim was smoking a cigarette when a light Grey or White Mercedes drove up to him. There were (3) Hispanic Males in the vehicle 18-20 yrs NFD. Two of the Hispanic Males exited the vehicle, one armed with a handgun. One of the suspects demanded the victim's property, while the other went into the victim's vehicle, which was running and attempted to take it. The victim went into his vehicle on the passenger side and attempted to prevent the suspect from driving away. The victim heard one shot, but continued to struggle with the suspect. The victim's vehicle struck the suspects' vehicle, then another shot was heard and the victim fell out of the vehicle. The suspects then drove away in the victim's vehicle and the Mercedes.

The victim suffered two gunshot wounds, one to the arm, and one to the upper body. He was taken into surgery and was listed in stable condition. The victim provided a brief statement to the responding officers.

One reasonable neighbor from that part of Hollywoodland told me that yesterday they got stuck in the gridlock along with an officer from LADOT. And that after a few cars backed down and cleared some space, the LADOT officer, who was coming down from the top of the canyon, simply drove away from the mess as soon as his car was clear rather than trying to clear the rest of the gridlock behind him. Is LADOT unequipped to deal with the problem? Maybe LAPD should get involved. After all, as we keep saying, it's not just a nuisance, it's a public safety issue.

Hello Sr. Lead Officer Irv Isabella,

You may know my wife, Deputy District Attorney Kaarin Axelsen Forester in the LA County DA's office; she visits LAPD Hollywood Division once a month to assist with case filings. She spoke with your sergeant last Thursday about excessive noise coming from the PA system at Madame Tussaud's Hollywood located at Hollywood and Orange. The sergeant gave me your contact information and suggested we ask for your assistance.

My company Trailer Park is the majority tenant in the building across from Madame Tussaud's (the address is in my signature below). The staff at Madame Tussaud's uses a PA system directed at the street to attract tourists to visit the museum and the volume is excessive causing disruption to our daily business activities which involve supporting the major motion picture studios. Over the last two years we have complained to them directly about the noise level and contacted LAPD numerous times yet the situation continues. The management at Madame Tussaud's recently requested that we report the excessive noise levels to them via a phone number and email address they provided us - duty.manager@merlinentertainments.biz or (213) 595-6231. They continually fail to remedy the situation and no longer respond to the emails or calls, the noise continues to be excessive. I am asking for your help in resolving this once and for all. It is a waste of our time to be reporting these issues to them and it is absolutely a terrible waste of LAPD's time to deal with this every time we call. Your team has so many "real" things to be chasing down. I want to point out that there are many businesses in the immediate area that depend on the tourist foot traffic; LA LA Land, Hooters, Wetzel's, Mrs. Garcia's, TCL Chinese Theater, Hard Rock Café are just a few that I can name but yet not one of them engages in the same behavior as Madame Tussaud's. We simply ask that they use the PA system at a reasonable volume that does not disturb the other businesses. If they cannot keep the PA system at a consistently acceptable volume then perhaps the only solution is to outright prevent them from using it at all, none of the other businesses in the area use one.

Dear Sir:

I hope this finds you well. I wanted to alert you to an issue I am having with the Hollywood Police Department. On this past Friday I was picking up my son at Montessori Shir Hashirim in Hollywood - I was parked in the driveway. I ran inside for 3 minutes as I do every day and have done for the past 2 years (and countless other parents who often leave their children in their car). I came back and realized my car would not start because the key was not detected - I looked over and realized I had my bags stolen with over 6k of stuff in it including 3 iPads, money, brand new merchandise from a shopping trip AND most importantly, my wallet with my license in it, my healthcare cards, a card showing I had a heart issue, my sons insurance cards AND all of my keys giving them access to my house and my car in the future.

The head of the school called the police - no one answered for at least 1 hour or so. They answered finally and told her they would not come out for it and to call a different number to which I proceeded to call for several hours - they did not answer. They did not answer the next AM so I finally drove over (my husband had to pick me and my frightened son up from school to take me round trip to Studio City/Valley Village to get my spare key and

get the car) and filed a police report - I told the officer I was most concerned because it was in the driveway of a nursery school meaning if that can happen so can anything else. She did what she could and filed it and told me someone would contact me when the case was assigned. It is now Tuesday and I have not heard from anyone. I have called several times over the weekend to find out if there was a detective assigned as I told them and left messages on Detective Ramirez's machine, there is a clear fingerprint on that side of the car and they can perhaps lift it to see if it matches any records - no response.

I am a New Yorker. I moved out here about 7 years ago. When living in a post 9/11 city I had my wallet stolen once at Bed Bath and Beyond. I called the NYPD and that evening they had two officers at my apartment and I didn't even have evidence! I am baffled by this non response mostly because someone now has my identity and with everything that could happen and all of the governmental complaints about people using other peoples IDs to do awful things and maybe even just cross borders, not to mention again that this happened in a nursery school driveway...this should be addressed - this should HAVE been addressed.

I can be reached at 917-535-5926. I would appreciate a response as soon as possible. You are my last effort to try and get this rectified.

As some of you may know, earlier this summer CD13 worked to establish the 6800 block of Hawthorn Avenue (b/w Highland and Orange) as a designated parking area for Tour Buses in Hollywood.
