**ADVISORY: O'FARRELL TO ADDRESS STATE OF NIGHTCLUB CULTURE IN HOLLYWOOD**

HOLLYWOOD - Los Angeles City Councilmember Mitch O'Farrell, joined by the Los Angeles Police Department, will make a statement regarding recent permit violations at a popular nightclub venue, while also encouraging other nightlife establishments to strive for a safer Hollywood that lives up to its world-class brand.

O'Farrell will comment on these recent permit violations, and dangerous incidents related to the nightclub culture, during a press event on Thursday, October 8, 2 p.m., on the southeast corner of Hollywood Blvd and Las Palmas Ave, Los Angeles, CA 90028.

The Councilmember will be joined by a representative from the Los Angeles Police Department [PLEASE CONFIRM], the Department of Building and Safety [PLEASE CONFIRM], and members of the Hollywood community.

When operating a club in the City of Los Angeles, establishments must receive a conditional use permit from the City. The permit dictates various guidelines for operation, which could include hours of operation, age

restrictions, alcohol and food sales, capacity, and promotions. Many clubs in Hollywood have been cited for violating these types of conditions.

In August 2015, a 20-year old male died at a Hollywood nightclub, and in a separate incident last Fall, investigators say a female college student was sexually assaulted.

Dan,

Attached is a spreadsheet that I put together with a list of dates and overages during the 2014 year (as well as Halloween 2013). I also attached a couple reports as examples of the documentation that the club keeps as to attendance and incidents (it includes the club name, date, age range). I pulled the dates/times/capacities from an SMS backup I performed on my phone in late 2014. The numbers were derived from the box-office staff texting the security managers hourly in-count's to monitor capacity. The one problem with this was that they would text a number that was over our capacity, but the Director of Security or GM would usually then take it upon themselves to over-ride the limit and let more people in. As they stated, as long as the patrons were able to move around the bar area, we would still let people in the building and onto the floor. Most of 2014 (thru May) was during a remodel period as well, which limited our capacity by having different area's cordoned off, thus the capacity issues would be exacerbated.

I also attached the video I received re: the EMT assault at the club recently as well as the email exchange I had with a patron of the club on April 05, 2015.

I included the Halloween capacity as a benchmark – since this date was a Thursday, and the club was 18+, it was quite busy, but I suspect that with Halloween being on Saturday this year, that the counts will be as great or higher. The club also closed at 3:00AM that night, Saturday's are "After-Hours" which will run until about 7 or 8AM this coming Halloween.

As you may know, on Sunday November 15th at 1:00 PM, the intersection of Hollywood/Highland will be upgraded to a "scramble" (diagonal) crosswalk. This new feature will separate pedestrian crossings from vehicular crossings, and allow pedestrians to cross in all directions all at once, including diagonally.

CITY HALL -- Los Angeles City Councilmember Mitch O'Farrell announced Wednesday that the City Council affirmed the Department of City Planning's (DCP) decision to revoke a conditional use permit (CUP) for a Hollywood nightclub because of multiple land use violations and criminal activity.

Cashmere, also known as The Day After, located on Hollywood Boulevard at North McCadden Place, has been the focus of numerous investigations by the Los Angeles Police Department (LAPD) and the Los Angeles Department of Building and Safety (LADBS). In August 2015, a 20-year old male DJ died while employed at the nightclub, and in a separate incident in 2014, investigators say a female college student was sexually assaulted.

"The incidents at Cashmere presented the City with an opportunity to streamline the process of bringing rogue nightclubs into compliance," said

Councilmember O'Farrell. "These events serve as an example of the brazenness of some club operators to thumb their nose at the the law and their utter disregard for the safety and security of their employees and patrons."

When operating a bar or club in the City of Los Angeles, establishments must receive a CUP from the City. The permit dictates various rules for operation, which could include hours of operation, age restrictions, alcohol and food sales, capacity, and promotions. Many clubs in Hollywood have been cited for violating these types of conditions.

"My office has created a task force consisting of the City Attorney's office, LAPD, DCP, LADBS, Los Angeles Fire Department, and Alcohol & Beverage Control to make sure scofflaw clubs like Cashmere comply with City permits: If they do not, we will shut them down as expeditiously as possible, so nothing like this can happen again. Let this send a strong message."

This news comes on the heels of the closure of another Hollywood nightclub, Supperclub, which had been cited for multiple violations of its terms of probation with the City Attorney's office, and whose conditional use permit expired last week.

The Council action today will revoke Cashmere's CUP at their address on Hollywood Boulevard, and if the owners continue to operate, law enforcement can shut them down immediately.

I have called the police several times as have many in my building. Tonight I've called twice and a neighbor says he's calling now.

I am a tax-paying homeowner with a j-o-b to go to in the early morning and am kept up AGAIN with booming music in the outdoors club below me. I am convinced it is not properly zoned to be an outdoors club. At the very least it is far past the ordinance allowing ambient noise.

I am seriously spending the time I can't sleep tonight because of this, laying in bed thinking of ways I can just be far better off to sell my condo and get out of here over this.

It's horrible and it makes for a horrible neighborhood. It's so unacceptable.

Hi Jacky,

My name is Rachel and I'm a homeowner at 6253 Hollywood Blvd. (the Lofts @ Hollywood and Vine).

The business behind my residence recently changed hands— it is now called Manor Nightclub at 1718 Vine Street. It has become a nightclub from a previous restaurant business (Asa Meza, then Tiffanys on Vine). It has an outdoor patio on which they nightly (and during the weekends starting at approximately 12pm in the afternoon) blast music from a DJ – basically it's a giant party on the back patio and I'm convinced it is not properly permitted to do that. I have seen no public notices or anything for it.

Basically, my home has become unlivable as EVERY SINGLE night until 2am, the music blasts – and far past the ambient level on my 7th level apartment unit when the windows are closed.

As I type I am incredibly frustrated as there is no number to call them (it's kind of supposed to be I think a 'secret' type club) to even call and ask them politely. I have today finally called the police and are awaiting

their response and have left a message for those handling nuisance noise complaints at LAPD.

This is now the fourth straight day/night of this. (they take a break on Mondays and Tuesdays). But since December it's been EVERY SINGLE night and it has been this loud and un-livable.

It's like having a neighbor who has an outdoor huge party everynight and you can't make it stop. I took a video tonight from just with my hand and phone outside of the window so you can see how loud it is.

It feels a direct violation of this ordinance:

**\*112.01(c) lamc- noise emitting from nightclubs\***

Any noise level caused by such use or operation which exceeds the ambient noise level on the premises of any other occupied property, or if a condominium, apartment house, duplex, or attached business, within any adjoining unit, by more than five (5) decibels shall be a violation of the provisions of this section.

Please advise on the best course of action. I am a relatively new resident to California... and just earlier this year purchased my condo in Hollywood. I came from New York City and have a very high tolerance for noise. This is just unbelievable.

> An update on the earlier shooting/carjacking that occurred at 0335 hours:

> The victim (Hispanic Male 25 yrs) was an Uber driver who had just dropped  
> off a fare at the above location. The victim was smoking a cigarette when  
> a light Grey or White Mercedes drove up to him. There were (3) Hispanic  
> Males in the vehicle 18-20 yrs NFD. Two of the Hispanic Males exited the  
> vehicle, one armed with a handgun. One of the suspects demanded the  
> victim's property, while the other went into the victim's vehicle, which  
> was running and attempted to take it. The victim went into his vehicle on  
> the passenger side and attempted to prevent the suspect from driving away.  
> The victim heard one shot, but continued to struggle with the suspect. The  
> victim's vehicle struck the suspects' vehicle, then another shot was heard  
> and the victim fell out of the vehicle. The suspects then drove away in
