Dear Sir:

This is to advise that the following information was made available to this office by a very confidential source, with reference to a contact had by MEYER on March 7, 1946 with BILL CAGNEY, a motion picture executive and brother of JAMES CAGNEY, screen star.

It was stated that MEYER had contacted CAGNEY with reference to some property which was suitable for studio space, on which it was thought that Twentieth Century Fox Studios might build. CAGNEY reportedly showed no interest in this particular matter and indicated that on March 6, 1946 he and five other individuals including SOL LASSER and LEO McCARTY, both motion picture executives, had closed a deal for a million dollars to purchase sixty acres of property in Culver City near the Metro Goldwyn Mayer Studios. CAGNEY indicated that this group did not desire to finance the building of a studio on this property themselves, but desired to do the financing through the RFC. At this time MEYER indicated that he was provoked with CAGNEY for not having been previously advised of the deal and that he and BONAARD HUGHES had not been cut in. MEYER told CAGNEY that he had many contacts in Washington, and that he could easily arrange the securing of the financing of the deal through RFC and also secure the necessary priorities. CAGNEY then agreed that MEYER would be retained to give assistance to the group in this matter, and MEYER was to discuss the plan with BONAARD HUGHES to see if he desired to be taken in. MEYER remarked that he could guarantee the deal being arranged within two weeks.



MEYER remarked that he had every angle there is in Washington under control.

During 1940 or 1941 MEYER became acquainted with EDWARD HUGHES and reportedly secured girls for HUGHES' parties. It was said that potential customers of EDWARD HUGHES were entertained at the parties and liquor and women were provided, which resulted in HUGHES obtaining orders for Hughes Aircraft.

MEYER left the Warner Bros. Studios of his own accord and took a position with EDWARD HUGHES as Public Relations Director for Hughes Aircraft Corporation.

MEYER'S ACTIVITY IN CONNECTION WITH HOWARD HUGHES:

Business

As previously mentioned in this report, MEYER first became acquainted with HOWARD HUGHES in 1940 or 1941 and was reported to secure girls for HOWARD HUGHES' parties. He then became Public Relations Director for Hughes Aircraft Corporation. As a result of his acquaintance with HUGHES, MEYER became associated with HENRY KAISER, the ship builder and industrialist

According to [REDACTED] HOWARD HUGHES, during the early part of 1945, gave an open house for a group of visiting Russians, whom he was attempting to interest in an experimental transport ship, then on the drawing board at Hughes Aircraft. HUGHES intended to sell the Russians an order on this experimental ship.

Through the use of a highly confidential source, information was obtained concerning personal papers maintained at the subject's residence, 1134 North Ogden Drive. Among these papers was a memorandum dated December 22, 1944, on the stationery of Hughes Productions, which stated that Hughes Productions had used up its quota of raw film and that unless a WFB order relaxing its quota could be obtained, the studio would not be able to release the picture "The Outlaw." Further, it stated it was necessary to obtain five and a half million feet of 35 mm. raw film and that United Artists were releasing this picture for HUGHES, and unless this amount of film was obtained, the release could not be made.

[REDACTED] advised on July 21, 1945 that HOWARD HUGHES was then ready to release the picture "The Outlaw" and it was indicated that the raw film must have been obtained by HUGHES through some other source than the WFB..

This source related as far as he knew there was no illegal juggling of priorities in connection with obtaining the film for "The Outlaw."

[REDACTED] on August 30, 1945, advised it was his opinion EDWARD HUGHES could not have stocked four or five million feet of film at the Romine plant, as it was too large an amount to have accumulated from other pictures, and that no one was astute enough prior to the war to store such a quantity of film.

A further review of the file reflects that MEYER has assisted EDWARD HUGHES in endeavoring to secure the services of SOL LEBOWITZ, United Artists, and HARRY GOLD, United Artists, to help in the handling of the release of the motion picture "The Outlaw." SOL LEBOWITZ apparently was not available to assist HUGHES and according to the "Variety" on December 12, 1945, HARRY GOLD, United Artists Eastern Sales Manager, resigned his position to become general manager of the world-wide distribution of EDWARD HUGHES' productions.

MEYER is also believed to have been assisting HUGHES in endeavoring to secure the services of FRANCIS FOULSON, noted Cleveland attorney, to aid HUGHES in getting "The Outlaw" passed by the censors of several states.

According to [REDACTED] racket Club in Palm Springs, California, [REDACTED] office made reservations for FRANCIS FOULSON and his son to stay at the club from December 15 through December 29, 1945. At the same time reservations were also made by HUGHES' office for former Governor BRICKER of Ohio. [REDACTED]

During the course of a surveillance made on August 20, 1945 at Los Angeles, it was noted that MEYER had lunch with JIM FRYE, President of U.A., and MISTRICH of Hughes Aircraft, Houston, Texas, at Romine's Restaurant in Hollywood. A portion of the conversation of these individuals was overheard and MEYER and FRYE were heard to discuss changes in the administrative personnel at Hughes Aircraft. FRYE and MEYER appeared

anxious to replace CHARLES PERELLI, Executive Vice President, Hughes Aircraft, in charge of production. MEYER particularly was insistent that PERELLI be replaced and discussed an interview with BUD GILLIES of Ryan Aircraft, San Diego, who was considered as a possible successor to PERELLI.

By physical surveillance it was learned that EDWARD HUGHES, together with MEYER, YVONNE DeCARLO and JIMMY THOMAS, visited the Florentine Gardens in Hollywood on September 19, 1945. During this visit to the night club HUGHES and MEYER were overheard to discuss the dismissal of CHARLES PERELLI. HUGHES advised MEYER confidentially that PERELLI would be replaced as soon as a suitable man could be found and that MEYER was to receive a raise.

The Los Angeles Times for January 9, 1946, reported that EDWARD HUGHES' Culver City plant was undergoing an administrative shake-up which was capped by the resignation of General Manager CHARLES M. PERELLI. HUGHES was reported to have said that he and PERELLI had disagreed over the manner in which the plant should be operated and related that he could not begin to tell all the disagreements which had occurred in regard to policy.

Through [REDACTED] it was ascertained that EDWARD HUGHES was planning to take a party of prominent Hollywood persons aboard the inaugural passenger flight of the Constellation from Los Angeles to New York and return. It was stated that MEYER was endeavoring to get such people as L. B. NAYER, JACK WARNER, DARRYL ZANUCK, CARY CRAFT, INGOLD BERGMAN and others to make the trip. 32/6

Through [REDACTED] it was ascertained that MEYER sent a wire to TUD SAUCIER, Waldorf Astoria Hotel, on February 5, 1946, stating that he appreciated SAUCIER's cooperation and would make a list which would be forwarded to the hotel as soon as possible. It is believed that this wire pertained to the making of the reservations for the group which was to go to New York in EDWARD HUGHES' plane. It was determined through [REDACTED] previously mentioned, that EDWARD HUGHES would pilot the Constellation which was to leave at midnight on February 14, 1946 with many Hollywood stars. 62/6 37c/0

From a review of the file, it is noted that such sources as [REDACTED] have frequently reported that the subject endeavors to become acquainted with the majority of the prominent movie actresses, and it is apparent that subject was endeavoring to become acquainted with certain actresses in order that he might be able to introduce them to HOWARD HUGHES. The subject reportedly endeavored to become acquainted with such persons as DIANA LYNN, JOAN LESLIE, GAIL RUSSELL, JEANNE CRAIN, BARBARA BATES and others.

The file further reflects that MEYER has, on numerous occasions, been in contact with FAITH DOMER, also known as FAITH DOMERELL, who resides in Hollywood. Miss DOMER was employed by Howard Hughes Productions and has been under contract to him for several years. Further, in the past, MEYER has been in frequent contact with WIA MICKLIS who, according to report of Special Agent [REDACTED] dated September 6, 1945 at Los Angeles, was picked up on August 25, 1945 and driven to [REDACTED] airport.

JOHN SMALL, CIVILIAN PRODUCTION BOARD

In a conversation with another individual Meyer is stated to have mentioned the name of John Small formerly under Julius Krug with the War Production Board and at present in charge of the Civilian Production Board, which handles all building materials. Meyer described Small as a "stumble bun," whom he had known for many years. Meyer also related that it was through John Small that he had been able to secure 8 million feet of movie film. Previous information in this case suggests that the reference to the latter film has to do with film needed by Edward Hughes for distribution of his picture, "The Outlaw."

[REDACTED] Sherry-Netherland Hotel, 5th Avenue and East 57th Street, New York City, advised that MEYER was instrumental in arranging for the reservations at the hotel for a party of approximately forty motion picture stars and their friends who had been guests of HOWARD HUGHES on a flight of his constellation plane from California to New York City on February 15, 1946. b7c

[REDACTED] also advised that MEYER had also been in charge of arrangements for the reception and entertainment of press reporters at the hotel who were assigned to cover the publicity relative to the flight, and also was apparently in charge of arranging details regarding the entertainment of HOWARD HUGHES' guests. [REDACTED] further advised that since MEYER's arrival at the hotel, he had occupied suite #19B, which consisted of a living room and two bed rooms at \$30 per day. He stated that the suite had also been occupied at various times by WALTER SANE, whom he described as a Hollywood agent, and also JOHN K. MASHIO, husband of CONSTANCE MOORE, who were members of the original constellation flight party.

Inquiry was made of [REDACTED] of the possibility of obtaining the telephone numbers which were called from the suite occupied by the subject, and he stated that this would be impractical due to the fact that the telephone service in suite #19B was in constant use and it would be impossible to determine the calls made by MEYER due to the continuous use of the suite by his room companions and other guests of the HOWARD HUGHES party.

An attempt was made to ascertain who had assumed the obligations of the hotel bill which was being incurred by the group. [REDACTED] advised that it was his understanding that it was being paid by a New York City advertising firm, but he declined to disclose its identity.

In regard to the subject's stay at the Sherry-Netherland, [REDACTED] said that the reservations for the group had originally been made to terminate on February 17, last, two days after the party's arrival, but these plans had been repeatedly changed. He stated that although the original party had been greatly reduced in number due to departures, HOWARD HUGHES and the subject continued to remain in the hotel, and it was not indicated at that time when they contemplated to depart. The Bureau by teletype dated March 14, 1946, advised that DANTON WALKER's Column "BROADWAY" on March 11th reported that ELLIOT ROOSEVELT would be a partner of HOWARD HUGHES. [REDACTED] failed to develop any information to verify the report in DANTON WALKER's column. [REDACTED] made arrangements to endeavor to secure information on this matter from subject MEYER.

On April 3, 1946, [REDACTED] had been in contact with MEYER and HOWARD HUGHES separately at the Bachelor Party given at the Clover Club, Beverly Hills, California, on March 31, 1946 and had questioned HUGHES as to the possible partnership with ROOSEVELT. HUGHES merely replied by "shrugging off the question" and making no comment. MEYER, when questioned, stated there was no deal and asked for the informant's source of the report, as he desired to see a copy of the column in which it was printed. It was this informant's opinion that he felt MEYER and HUGHES' reaction to the question meant nothing more than that they do not wish to discuss the matter.

The Bureau by teletype dated March 18th, advised that DANTON WALKER's column mentioned above for March 16th stated that HOWARD HUGHES was taking a group of movie stars to Washington, D.C., in connection with the Cancer Drive and would visit the President. With regard to the above mentioned matter, it was ascertained through L. S. FROST, Assistant to the Vice President, National Broadcasting Company, Hollywood, that tentative plans had been made for the T.W.A. to furnish the Constellation to take a group of movie stars, including BOB HOPE, SPENCER TRACY, CARY GRANT and others East on April 19, 1946.

The Los Angeles DAILY NEWS for April 22, 1946 carried an article regarding the Committee Rally scheduled for April 30th at Los Angeles opening the UNITED JEWISH WELFARE'S FUNDS FIVE MILLION DOLLAR FIGHT FOR SURVIVAL DRIVE. The rally will be held at the Shrine Auditorium and EDDIE CANTOR was named as Program Chairman. Also listed among those entertainers and speakers were BOB HOPE, EARL C. HARRISON, Dean of the University of Pennsylvania Law School, ELLIOT ROSEWALT and others.

In the referenced report of the writer dated March 18, 1946 information was set forth relative to the securing of raw film for the motion picture "The Outlaw." Since the release of this motion picture there has been considerable controversy relative to the advertising ethics used on the part of HOWARD HUGHES.

On April 12, 1946 the Los Angeles TIMES reported that the HUGHES' film "The Outlaw" was drawing fire of the Motion Pictures Association and that he had been summoned to appear before the Board of Directors to answer a charge of violating "standards of good taste" with newspaper, magazine and billboard advertisements. HUGHES was requested to appear before the Board to offer evidence at a hearing before the Board in New York on April 23rd unless before that date he discontinued use of all disapproved and unsubmitted advertising.

In an article dated April 23, 1946 in the Los Angeles TIMES, it was noted that HOWARD HUGHES was reported to have filed a five million dollar damage suit against the National Motion Pictures Association and announced his withdrawal from that association.

The Los Angeles DAILY NEWS indicated that the instant suit was filed in New York City and pertained to the charges made by the Motion Picture Association with regard to "The Outlaw." It was further stated that HUGHES stated that "a careful study of the Hays Office convinces me that the entire Hays Office in its very essential fundamentals is a group boycott in restraint of trade and in absolute violation of the Anti-Trust laws of this country." HUGHES' reference to the Hays Office is in fact to the Motion Pictures Association which is now headed by ERIC JOHNSTON. In regard to his above mentioned lawsuit filed in Federal Court in New York City, it is to be noted that JOHN HULLER departed from Los Angeles on April 19th and has been staying at the Sherry Netherlands Hotel from that date and not expected to leave New York until May 2, 1946. It is possible that his presence in New York was due to the proposed action taken by HOWARD HUGHES.

It is observed that Hughes' reference to the Hays Office is in fact to the Motion Pictures Association which is now headed by Eric Johnston.



MEYER'S ACTIVITIES IN CONNECTION WITH HOWARD HUGHES

The referenced report of the writer dated April 26th, last, reflects that MEYER departed by plane for New York City on April 17th and on arrival there registered at the Sherry Netherlands Hotel. According to information made available by [REDACTED] MEYER was still visiting in New York City as of May 8, 1946, and believed to be still registered at the Sherry Netherlands Hotel, where he has been in contact with HOWARD HUGHES. b2/

The New York Field Division by teletype dated April 29th, last, reported that MEYER had made reservations at the Sherry Netherlands Hotel for HOWARD HUGHES, who arrived in New York City on April 27th, last. Further, MEYER during the first part of April made telephonic reservations from California at that hotel for Mrs. STEPHEN CRANE, nee LANA TURNER, who arrived at New York April 13th and who was still in New York as of April 29th. It was reported by the New York Field Division that subject also made reservations for CARY GRANT, who was to arrive from Europe on May 5th. At the time the teletype was sent from New York it was reported that MEYER intended to remain at the Sherry Netherlands for approximately five or six days longer, after which he would fly to Brazil with HOWARD HUGHES. Regarding the trip to be made to Brazil with HOWARD HUGHES, it is noted in the referenced report of the writer that information was set forth indicating that trip was to be made to Rio de Janeiro and that reservations were made at the Copacabana Hotel at Rio. It was believed that the trip would include HOWARD HUGHES, MEYER and notable movie stars, such as CARY GRANT.

By teletype dated May 6, 1946, the New York Field Division reported the subject, accompanied by HOWARD HUGHES, flew to Louisville, Kentucky, May 4th to attend the Kentucky Derby, and reservations were made at the Henry Clay Hotel there.

On May 6th it was reported by the New York Field Division that JOE ROAN, who was identified in the referenced report of the writer as JOE ROAN of TWA, New York City, was occupying MEYER's suite at the Sherry Netherlands and had received a long distance telephone call from Mr. SHURR, Chestview 67723, Los Angeles. SHURR allegedly wanted MEYER to talk to HUGHES as "BOB HOPE wants an answer." ROAN advised SHURR that both MEYER and HUGHES were at the Derby but were expected back shortly and MEYER would call. With reference to Mr. SHURR, an examination of the Los Angeles telephone directory reveals that LOUIS SHURR, Chestview 67723, resides at 9537 Chareville Boulevard, Beverly Hills, and has an office listed as the LOUIS SHURR Agency, 327 North Rodco Drive, Beverly Hills.

It was noted in the "Variety" dated April 26, 1946, that the following article appeared:

"Justice Dept. cocks an ear for a beef from HUGHES.

"Washington, April 25.—If HOWARD HUGHES makes good his threat and asks anti-trust action in connection with the Motion Picture Association of America's wallop at his film, 'The Outlaw,' the Department of Justice will of course listen to the beef.

"However, the dope here is that if HUGHES does make such a proposal he will not get far with it. The Justice Department looks upon MPAAs as a trade body, one of whose purposes is to provide clean and fair censorship for the industry from the inside.

"Both the Justice Department and the FBI are now fighting growing juvenile delinquency and at least one Department official has expressed the opinion that 'The Outlaw' is the type of film to stimulate delinquency."

The "Los Angeles Times" dated April 26, 1946, reported that HOWARD HUGHES had retained JERRY GIESLER, noted Los Angeles attorney, to represent him in his fight against San Francisco's ban on "The Outlaw". GIESLER was reported to have left for San Francisco on April 25, 1946, to defend AL DUNE, theater manager there who was arrested for showing the film.

On April 30, 1946, the "Los Angeles News" reported that Superior Judge EDWARD P. MURPHY, San Francisco, had denied an application by HUGHES' attorney for a writ of prohibition which would have released the film for public showing pending a jury trial to determine whether the film was "indecent" in its display of Miss RUSSELL's charms.

The "Los Angeles Examiner" dated May 6, 1946, carried a news article written by WESTBROOK PEGLER entitled "HUGHES' Deals in War Aircraft Merit Scrutiny" as follows:

"There are several phases of ELLIOTT ROOSEVELT's activities and associations, in addition to his defaulted loans, which would be thoroughly investigated by appropriate committees of Congress if the Democrats were not in control.

"Certain operations of HOWARD HUGHES, the rich Houston (Tex.) and Hollywood manufacturer, motion picture producer and aviation magnate, would come under scrutiny were the Republicans returned to power in Congress.

"HUGHES and ELLIOTT ROOSEVELT are intimate friends. HUGHES is also a friend and might be called a protege of JESSE JONES of Houston, the former Secretary of Commerce. The JONESSES have known him since his childhood and regard him highly.

"In 1943, the Reconstruction Finance Corporation put up \$18,000,000 to enable HUGHES and HENRY KAISER to build three enormous wood and plastic cargo planes, more than twice the size of the B-29 and capable of carrying 650 persons.

"Construction began at Culver City, Cal., but KAISER withdrew when it developed that the \$18,000,000 would not produce even one of these ships.

"JONES, as head of the RFC, told HUGHES he himself would have to pay any excess cost and HUGHES carried on.

"The ship has not been completed, however, and it may never fly.

"The experience may be worth something to aeronautical science, but there is, of course, no standard by which to appraise the value of such information.

"The Army Air Forces had become interested in another HUGHES plane in 1939.

"General H. H. ARNOLD states that it seemed suitable for military use and that the design was highly interesting because duramold construction was to be used and the ship presented the promise of improvement in the aerodynamic and structural arts.

"Aluminum was scarce and General ARNOLD thought it might be possible to get quantity production in spite of the shortage.

"On July 8, 1942, President ROOSEVELT personally inquired about this ship which General ARNOLD describes as suitable for high-speed, long-range, high-altitude service.

"The next year, the Germans were knocking down many American photo-reconnaissance pilots in P-38s.

"We needed something that would do the job and outrun the German fighters," General ARNOLD wrote. "The British Mosquito



had proved itself, but we were unable to get Mosquitoes in sufficient quantities. The HUGHES airplane was the only one already designed which appeared entirely suitable and which could be produced in time to do any good."

"On September 3, 1943, General ARNOLD 'verbally' directed that 100 of these ships be bought from HUGHES. The aluminum shortage had passed and the wooden construction had been abandoned in favor of metal.

"The contract with HUGHES was terminated last September without the delivery of a single ship. The Army still expects to take two, however, for experiments.

"The 100 ships were to have cost \$48,000,000 plus a maximum fee of 4 per cent. Thus about \$66,000,000 of public money was committed to HUGHES projects which produced nothing.

"ELLIOTT ROOSEVELT returned from Europe in the autumn of 1943 and served for a period at the War Department as chief of the reconnaissance branch.

"He was head man and it was during this time that General ARNOLD gave his verbal order for the 100 HUGHES planes.

"For a number of reasons, technical and industrial, Major General O. P. SCHOLS had opposed the adoption of this plane to the end, but was overruled.

"Setting forth his position, General ARNOLD wrote that money was never a first consideration when American lives and American victory were at stake.

"I let contracts for anything which offered a probability of speeding victory. I would be the last to claim that this process was economical in dollars. In fact, I have never claimed that war is economical."

"When ELLIOTT ROOSEVELT, then a colonel in the Army Air Corps, returned from England on November 15, 1944, the Associated Press story said that JOHN E. MEYERS, 'public relations representative for HOWARD HUGHES,' was his host in New York, where ELLIOTT in those days generally stopped at the Waldorf on his visits to town. HUGHES also goes to the Waldorf and maintains an apartment there.

"He (ELLIOTT) was a guest of Mr. MEYERS at a party at the El Morocco night club last night," the A.P. said. "Mr. MEYERS said Colonel ROOSEVELT would go to Washington late today."

"Less than a month later, on December 3, when ELLIOTT married Miss FAYE EMERSON at Grand Canyon National Park, Arizona, the press accounts said MEYERS again was at his side to give the bride away and that JACK FRYE, the president of TWA, the big airline, was best man. HOWARD HUGHES owns the controlling interest in TWA.

"Last December, Pan-American Airways, generally regarded as the pioneer in transAtlantic navigation, petitioned the Civil Aeronautics Board to modify routes which had been allotted to itself, TWA and American Airlines.

"Pan-American's petition said the routes assigned would give TWA and American a monopoly of American-Flag air service to Italy and the Soviet Union and to most of France and Germany.

"We ask the board to reconsider whether it actually desires to be guilty of the gross favoritism to TWA," the petition said. Further it charged that the board had practically thrown Pan-American out of France and Ireland 'for the benefit of TWA.'

"SAM PRYOR, a prominent Eastern Republican and former national treasurer of the party, is one of the chief executives of Pan-American."

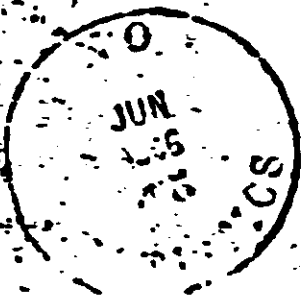

DETAILS

After having made telephonic reservations from Los Angeles, MEYER checked in at the SHERRY NETHERLANDS HOTEL, 59 Street and Fifth Avenue, New York City, on April 17, 1946. Shortly after arriving he reserved an additional suite for HOWARD HUGHES, whom he stated would arrive on April 27, 1946.

On April 13, 1946, LANA TURNER arrived at the hotel, accompanied by her child and governess. She registered under the name of Mrs. STEPHEN CRANE and her reservations had been made earlier by MEYER. None of the three suites occupied by HUGHES, MEYER or TURNER are adjacent or near each other. MEYER also made reservations at the hotel for CARY GRANT, who was to arrive on May 5. A day or two after MEYER'S arrival at the hotel, he was joined by JOE ROWAN, who moved into MEYER'S suite and has lived with him since. ROWAN is believed to be the publicity agent from the New York office of TWA.

On May 4, 1946, HUGHES and MEYER flew to Louisville, Kentucky, to attend the KENTUCKY DERBY. Before leaving, they made reservations at the HENRY CLAY HOTEL at Louisville, where they apparently stayed. Both arrived back at the SHERRY NETHERLANDS on May 7, 1946.

At the beginning of May MEYER'S bill at the SHERRY NETHERLANDS had reached \$1500. The Hotel Management, beginning to get uneasy approached MEYER and asked what his intentions were in reference to the bill. MEYER stated that he was very surprised that his bill had not already been paid by HUGHES. He told [REDACTED] that the bill would be paid by Mr. HUGHES. Up to the writing of this report neither HUGHES nor MEYER'S bills had been paid.

The New York Division in referring upon completion this case reports that when Lana Turner recently arrived in New York accompanied by her child and governess, she registered under the name of Mrs. Stephen Crane at the Sherry Netherlands Hotel, the registration previously having been made by Meyer. Meyer and Howard Hughes were also staying at the Hotel during this period. However, none of their rooms were near each other.

During this particular period Hughes was reported as remaining singularly inactive, spending most of the day in his suite and refusing to take any phone calls except from Lana Turner. He was described as going to her suite in the evening and taking her to the "El Morocco" for dinner returning with her thereafter to her suite in the early hours of the morning. He is believed to have spent almost every night with Lana Turner in her suite.

During Hughes' stay at the Hotel, [redacted] advised that he engaged in a lengthy long distance telephone call with Linda Darnell who was at Los Angeles. [redacted] reports that the conversation consisted principally of Hughes telling Linda Darnell how much he loved her and she in turn told him about her film work and further indicated that she was about to divorce her husband so that she might marry Howard Hughes.

In setting out Meyer's daily routine, New York states that while at the Hotel he stayed in his room until about Noon and after going out for lunch returned in the early evening staying there until late in the evening at which time he would attend a night club returning again to his hotel room in the early hours of the morning. He was frequently accompanied by a Miss [redacted] telephone number [redacted] and a [redacted] whose telephone number was ascertained to be [redacted].

[redacted] No additional background is available concerning these women.

It is also interesting to note that a detective by the name of [redacted] of the 17th Precinct, New York Police Department, located at 163 E. 51 Street, New York was a member of a group going to Meyer's suite early one morning during this period.

While this case has been closed, it is thought the above information might be of some interest to you.

The following data has come to my attention with reference to subject MEYER and HOWARD HUGHES, and is being forwarded as being a matter of interest.

Approximately one week ago, [REDACTED]

[REDACTED] an Assistant Counsel assigned to the KEALE INVESTIGATING COMMITTEE of the United States Senate, arrived in Los Angeles and recently was in touch with Special Agent [REDACTED] [REDACTED] voluntarily advised that he was here to conduct an investigation relative to HOWARD HUGHES.

HUGHES appeared before the Investigating Committee several weeks ago with reference to a hearing being held as to the use of the government money paid to the HUGHES COMPANY to build planes, and in which planes the government has spent approximately \$40,000,000.00. It was felt that the Committee had a good procurement case against the HUGHES COMPANY with reference to the money the government had invested to build planes on which there has been no delivery.

The Committee is desirous of securing evidence showing a relationship between HOWARD HUGHES and ELLIOTT ROOSEVELT, as it is thought ELLIOTT may have been instrumental in assisting HUGHES to obtain government contracts regarding the planes. It is hoped that information may be developed regarding subject MEYER's activities in connection with HOWARD HUGHES, so when MEYER is interviewed a "squeeze" may be put on him to furnish valuable information. There have been rumors to the effect that ELLIOTT allegedly received approximately \$75,000.00 from HOWARD HUGHES, but to date this information has not been substantiated.

For the present, inquiries are being kept as discreet as possible, but it is expected that more open inquiries will be made shortly, and when this is done, considerable publicity will follow. Further, if the investigation is successful, it is thought that the story may become one of the top news items of the year, and may end in an indictment of HUGHES, ELLIOTT ROOSEVELT and others.



Information has come to my attention from a confidential source which indicates that the Special Committee to Investigate the National Defense Program is conducting an investigation of the Howard Hughes Company.

Several weeks ago Hughes appeared before this Committee and gave testimony concerning the use of Government funds which had been paid to the Hughes Company for the purpose of plane construction. It is reported that the Government has expended approximately \$40,000,000 to the company for the purpose of building airplanes and that there has been no delivery by the company on these contracts. It has been indicated that the Committee has a good case against the Hughes Company, however, the nature of the evidence and the particular Federal violation, if any, has not been indicated.

The Committee is endeavoring to secure evidence to show a relationship between Howard Hughes and Elliott Roosevelt as it is believed that Elliott Roosevelt was instrumental in assisting Hughes in obtaining Government contracts. In order to establish this relationship it has been indicated that the Committee will contact John William Meyer, who is employed by Hughes in a public relations capacity. My personal and confidential memorandum to you of March 21, 1946, captioned "John William Meyer" furnished a summary of background information regarding this individual. During the interview with Meyer valuable information is expected to be obtained if sufficient pressure can be brought to bear on Meyer. There have been rumors to the effect that Elliott Roosevelt received approximately \$75,000 from Howard Hughes.

For the present time the Committee's inquiries are being kept as discreet as possible, but it is expected that more open inquiries will be made shortly and when this is done considerable publicity will follow. If the investigation of the Committee is successful it has been indicated that an indictment of Hughes, Elliott Roosevelt and others will follow.

For your information, this is to advise that this Bureau has not conducted any investigation of the Hughes Company in the past and there is no investigation pending regarding this company at the present time.

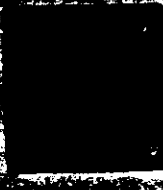

I want to call to your attention an item appearing in the Times Herald of August 8, 1947, indicating that the FBI was going to probe a "blackmail" feud. This item went on to state that according to International News Service, Senator Brewster, Republican, of Maine, indicated that the Attorney General had promised to investigate the "blackmail" charges hurled by Howard Hughes at the Senator. It was also indicated that Senator Brewster had invited the Justice Department's attention to the matter two weeks ago and that the Attorney General had told Senator Brewster that the charges would receive "attention" as soon as the inquiry into Hughes' war plane contracts had ended.

Although the article indicates that Brewster had invited an FBI probe into this matter of course the Bureau has not received any request from the Senator to engage in an investigation. I also want to point out that the Bureau has not received any request from the Department to engage in any investigation in this matter nor has any information been furnished to the Bureau that it is anticipated an inquiry may be made in the future into the activities alleged by Senator Brewster.

This is another instance in which reference is made to an inquiry allegedly to be conducted by the FBI when as a matter of fact no request has as yet been received. It is assumed that no consent has been given with reference to an investigation of the alleged "blackmail" charges by any representative of the Department of Justice but it does seem, according to the Times Herald of August 8, that "Department of Justice officials said two legal experts have been attending the hearings and would stay until their conclusion", and that the "dispute between the Maine Senator and the Hollywood plane builder will be further aired in a full scaled Justice Department investigation".

You will recall previous memoranda relating to premature releases have pointed out the difficulty with which the Bureau is confronted when such releases occur. I did not to present this situation to your attention because it does seem that some action in the Department of Justice has indicated an investigation may be made by the FBI into the charges related. This is the obvious impression one would obtain in reading the news items and as we have not as yet been requested to conduct any investigation nor have we been advised that such an investigation is contemplated at a later date I do feel that any comment relating to the matter by our Bureau official will be most action since it more difficult to perform its functions.

She advised that she was a very great admirer of Mr. Hoover and the Bureau and wanted to relate to him how she had been given the "run around" in attempting to reach Howard Hughes, the airplane manufacturer and moving picture producer who is a nephew of two very close friends.

[redacted] advised that she had attempted to reach Mr. Hughes in California telephonically but was advised that he could not be reached; that she tried to send a Western Union telegram to him which was not accepted at the local telegraph office inasmuch as she did not have his exact address; that she had called an individual at the White House who could not assist her and that she then called Senator Owen Brewster (R Maine) and that Senator Brewster's office advised on her first call that they had never heard of Howard Hughes and could not furnish the information regarding him. On a second call to Senator Brewster's office,

[redacted] advised an employee suggested she contact John Meyer at the Statler Hotel, Washington, D. C., however, she advised that this call was also unsuccessful in that she was informed Mr. Meyer had recently checked out of the Statler.

[redacted] stated the only reason she wanted to contact Howard Hughes was to invite him to stay with her while in town testifying before the Senate Committee. She related that Felix and Ruppert Hughes, uncles of Howard Hughes, were close friends of hers.

[redacted] was advised the Bureau could not be of any assistance to her in locating Mr. Hughes.

Aug. 23 (next day)—Jack Frye and Elliott Roosevelt party for nine people at Stork Club, \$94, and Ed Morocco, \$66; Chris Farmer to stop publicity of Elliott being in New York, \$50, and scarce nylon hose gifts, \$132.

Sept. 7, 1943—Meyer covered an \$83.15 bill of young Roosevelt at Jack and Charlie's.

Sept. 17, 1943—(Back in Hollywood)—Meyer was tabbed for \$11 for dinner, drinks and taxi for Faye Emerson, and \$116 for liquor from Schwab's drug store for "Doheny Drive," Hughes' home in Hollywood.

Sept. 20, 1943—(Still in Hollywood)—Meyer listed Ava Gardner for champagne charges of \$21 at Lamaze and \$24 at Macamba.

Elliott stopped at the Beverly Hills Hotel and bungalows in Beverly Hills, Calif., from Nov. 22, to Dec. 8, 1944. The room cost \$25 a day. He tallied up a bill during that period totaling \$576.23.

The bill was marked "mail to Hughes Aircraft, Culver City, Calif." On it was written "O.K." and signed Col. E. Roosevelt. It was initialed "J. W. M." Johnny Meyer's okay.

A little earlier, the late President's son ran up a huge hotel bill at the Waldorf-Astoria in New York, from Oct. 28 to Nov. 4, 1944. The bill totaled \$499.90. Among the charges was a cash C. O. D. for \$116.25. This bill similarly was marked "O. K. to pay. Charge H. A. C. (Hughes Aircraft Corporation)" and initialed by Meyer on Nov. 6, 1944.

One of the strange photostats is a check for \$159.41 made out on the Bank of America in Hollywood by Hughes Aircraft Corp. payable to a Paul Franklin. It itemized the following:

"Dec. 6, 1944, expenses Col. E. Roosevelt's wedding party. \$59.41.

"Four days pilot's time, \$100. Net amount, \$159.41."

During the time Elliott was at the Beverly Hills Hotel, Johnny Meyer itemized an expense for a weekend trip to Palm Springs. It lasted from Nov. 24 to Nov. 27, 1944. Cost totaled \$150, charged to Hughes Aircraft Corp.

Among the items were gas and oil (round trip) \$7; maid tip, (4 days at C. Morrison House) \$30; bars at Palm Springs, \$22; tips to bar maid and phone girl, \$10.

Guests were listed by Meyer thus: Col. Elliott Roosevelt, Lt. Col. John Hoover, Faye Emerson, Janet Thomas, Mr. and Mrs. William Powell (Diane Lewis Powell).

## Faye Emerson Entertained

After Elliott checked out of the Waldorf and before his trip to Beverly Hills, Johnny Meyer gave a party for Mrs. Anna Roosevelt Boettiger at Elliott's request. It was held in Waldorf-Astoria Tower apartment 37-C. All the liquor was bought outside and charged to the hotel bill.

The guests included top names in New York's who's who. It was held Nov. 19. Seven days earlier Meyer paid for two public stenographers for Elliott and Mrs. Boettiger, charges being \$15.

On Dec. 22, 1944, Elliott, who was back from California, was entertained together with his sister and brother-in-law, Mr. and Mrs. John Boettiger, in Washington. The Boettigers were listed in Meyer's itemized statement as living at the White House.

They went to the Troika, running up a bill for \$23; then to the Mayflower Hotel, \$29. A miscellaneous charge of \$7.50 was thrown in. Hughes Aircraft paid it all.

Before her marriage to Elliott, Faye Emerson seemed to be a popular figure and a frequent guest at Hughes' parties.

Between July 7-9, 1944, she was guest at a three-day party totaling \$341. This covered a visit to Caliente Race Track with bets costing \$150, and dinners, drinks and fuel charges. Along with Faye was Patricia Clark, Hughes and Meyer.

On Sept. 8, 1944, Meyer got a \$109.75 bill for two small lucite bags (\$90), two metallic brocaded wallets, \$30, from Carrie Munn, 640 Madison ave., New York.

A fortnight later, on Sept. 26, Meyer sent a letter to Miss Munn rejecting the metallic wallets, but accepting the lucite bags. Typed below his signature, was the following notation:

"These are to be charged to Hughes Aircraft as gifts for Miss Faye Emerson, 3345 Van Ness st., No. Hollywood, Cal. STAD 6-2354, and Miss Judy A. Cook, 1346 No. Harper st., Hollywood, Cal., GR. 2642."

# 'WallgrenCrap Game' Probe

## Appointee Denies He Won \$50,000

Sen. Cain (R) of Washington demanded an investigation yesterday of reports that Mon C. Wallgren won \$50,000 in a "crap game" with Johnny Meyer, a contact man for millionaire plane-builder Howard Hughes.

Cain raised the issue at the start of what he billed as a 18-hour Senate speech against President Truman's nomination of Wallgren, former Democratic governor of Washington, to be chairman of the national security resources board.

### Straggled Wife Present

Wallgren immediately branded the story "entirely false—there's not one word of truth in it."

He said he never won "a single dollar, not even a penny" from Meyer, and in fact "I know of no such crap game at Palm Springs at all."

Mrs. Cain, who recently filed a divorce suit against her husband in Tacoma, Wash., was among the gallery spectators who looked on with keen interest while Cain took off his shoes, put on a comfortable pair of carpet slippers, and began reading from a mountainous pile of documents.

The Washington Republican began by repeating previous charges that Wallgren is "soft" toward Communists and generally incompetent to hold the \$14,000-a-year defense post.

### Wants Pearson Called

Then he dropped his bombshell. He demanded that the Senate armed services committee subpoena columnist Drew Pearson to repeat under oath charges which Cain said he made in a telephone call March 4.

"Pearson told me that Wallgren won \$50,000 in a crap game from Johnny Meyer in Palm Springs, Calif., about three years ago," Cain said.

Meyer was the "public relations" man for Hughes whose alleged party-giving and favor-doing for high public officials figured two years ago in a Senate investigation of aircraft contracts awarded by the U. S. Air Force.

Cain quoted Pearson as saying the FBI had started and then dropped an investigation of the alleged crap game, and that some FBI officials thought it might have been "linked with an airplane contract."

Describing Pearson as a man with "a magnificent disregard for accuracy," he remarked:

Cain began to slow down. He opened his collar and fidgeted from one foot to the other. His secretary, Art Burgess, laid a note on his desk. In big scrawl it said:

"Slow down."

Referring to Wallgren's close personal friendship with President Truman, Cain said it is "time the Senate served notice that government by cronies must come to an end."

### Wallgren's Denial

Informed by telephone of Cain's speech, Wallgren said:

"I don't know where such stories come from. The entire thing is false. There's not one word of truth in it. I know of no such game. I didn't win a single dollar, not even a penny from Mr. Meyer."

Wallgren went on to say that he considered the whole thing part of Cain's "personal" attack on him.

"He's using every advantage and prerogative of his Senate office in this thing, and it's very difficult for me to answer all the charges as fast as he makes them," Wallgren said.

The committee will vote on confirmation of the nomination next Tuesday.

President Truman recently told a news conference that he regards Cain's opposition as merely a local political fight.
