Forgery Job Poor In 'Mormon Will'

The "Mormon will" jurors Thursday heard the object of their attention since Nov. 7 described by an FBI handwriting expert as a "very, very poor forgery — very poorly done."

Then they heard the good news: Spring vacation!

District Court Judge Keith Hayes recessed the probate trial for nearly two weeks, until March 29, the Wednesday after Easter.

The attorneys contesting the "Mormon will," who began presentation of their case Wednesday with the introduction of documents and the reading of depositions, will present their first witnesses when the trial resumes.

Scheduled as the initial contestants' witness is Nadine Henley, former secretary for Howard Hughes and now a director of Summa Corp., who testified briefly Jan. 25.

She was subpoenaed by Los Angeles lawyer Harold Rhoden, proponent of the "Mormon will" and substitute executor under it, as part of his case. He rested his case Wednesday after 34 witnesses testified and parts or all of 16 depositions were read.

So far 8,593 pages of transcript of the trial have been typed, on a daily basis. The court clerk has numbered 401 exhibits and there are 453 exemplars or samples of Hughes' writing.

"We're going to take some time off," Judge Hayes said in announcing the recess. He said he needs time to get caught up with other cases he is handling and it is "an appropriate point" for a break so the lawyers can "get things in order."

The only testimony Thursday was by deposition, with the words of FBI questioned documents examiner James E. Lile read to the jury by Los Angeles lawyer Paul Freese and Houston lawyer Clayton Lihenstern, both contestants.

Freese represents three second cousins of Hughes and Lihenstern, along with fellow Houston lawyer James Dilworth, is counsel for Annette Gano Lummis, 87, Hughes' aunt and closest living relative.

Lile, who has been with the federal agency 16 years, said the three-page handwritten "Mormon will" was "drawn — not written."

"These questioned writings," he said in his

deposition, "were not in the normal writing of the person who wrote them."

He examined the original purported will and the envelope containing it at the request of the Nevada attorney general's office, and then compared the writing with a collection of Hughes' exemplars as well as samples of writing by several persons suspected of forging the "Mormon will."

He said he could not determine if any of the possible forgers did the writing.

"What was your conclusion?" he was asked.

"That the questioned will and the inner envelope — the writings on them — were not prepared by Howard R. Hughes, but that they constitute a very poor attempt to simulate the writings of Howard R. Hughes — but we could not determine the person who wrote the writings."

Lile said he found one erasure on the will, on the seventh line of the first page. The first "as" of "Las Vegas" had been erased and written over, he said he discovered on examining the paper with oblique lighting.

He said he was unable in his examination to determine the age of the document.

He said he paid particular attention to exemplars of Hughes' writing dated around the same time as the "Mormon will," which was purportedly written in Las Vegas on March 19, 1968.

Asked if Hughes' writing "changed over his lifetime, Lile said he did notice changes beginning in about 1970 in "particular characteristics and letter forms."

He said he could not say if any of the changes could be due to Hughes being ill or getting old. "That's beyond my expertise," he said.

"There are a large number of things that can affect mental and muscular coordination, and they will vary widely depending on the individual," he went on.

"However," Lile said, "some handwriting characteristics will remain — regardless of the influences upon the writer."

The FBI expert said his study of the "Mormon will" showed "all the classic characteristics of copied or simulated writings, all the evidence of forgery, are present here."

ESTATE OF HOWARD HUGHES

At the Executives Conference this morning you requested me to handle a telephone call received for you from Charles Morgan at 11:25 a. m. I spoke with Mr. Morgan and he told me that he is associated with Jerris Leonard and other attorneys who are representing various interests claiming title to shares in the estate of Howard Hughes. He said that Jerris Leonard had organized a large group of lawyers and the respective shares of the claimants being represented by this group of lawyers have been identified and agreed upon. Morgan said that a 6.5 per cent interest in the estate is claimed by Avis Hughes McIntyre and Rush Hughes who are his clients. Morgan explained that Rupert Hughes, an uncle of Howard Hughes, had married a woman who had two children by a previous marriage. Although no formal adoption procedures were instituted, the two children assumed the family name "Hughes" from their infancy and under Texas equity law the claimants Avis Hughes McIntyre and Rush Hughes will be able to establish that they are in the position of adopted children and, therefore, heirs to the estate through the relationship of Rupert Hughes.

Morgan's request that the Identification and Laboratory examiners from the FBI be permitted to testify is based on his need to establish the invalidity of an alleged will that has been submitted for probate and which is identified by reference to Melvin Dumar.

There are two probate cases concerning this alleged will. The first case is pending at Las Vegas, Nevada, and the second case is pending in Houston. The FBI examiners appeared for depositions in Los Angeles, California, in connection with the case pending in Las Vegas. At that deposition, many of the interests were represented; however, the 9.5 per cent, ^{represented} represented by his clients' claims was not represented by counsel at the depositions and counsel for them have not

made an appearance in the Las Vegas case. Appearance in their behalf has been made in the Houston case. Because there was no representation at the depositions and there has been no appearance in the Las Vegas case where the depositions might be entered, the testimony given by our examiners at deposition in Los Angeles is subject to objection by the lawyers handling the Houston case.

I asked Mr. Morgan whether he intended to request our examiners to give a deposition for purposes of the Houston case. He said he had no such intention. His only request is that the examiners be available for testimony at trial.

Mr. Morgan's request, of course, presents complications because the Bureau has previously refused to authorize testimony in the Las Vegas case but testimony for purposes of depositions for that case was authorized.

This is to acknowledge your letter of October 25, 1977, in which you requested the presence of Mr. Quintus Ferguson and Special Agent (SA) James E. Life, as witnesses in a civil action involving the above-captioned matter.

In this regard, please be advised that this Bureau has received a subpoena from the Attorney for Defendant-Proponents seeking the same testimony you have requested. I have decided not to approve the appearances of SA Life and Mr. Ferguson at the aforementioned proceedings inasmuch as they have already testified extensively at depositions at which all interested parties were afforded an opportunity to cross-examine SA Life and Mr. Ferguson. Furthermore, their extensive testimony at the deposition hearings was given with the specific understanding that no further personal appearances at subsequent proceedings would be called for.

These characteristics are ~~common~~ occasionally found when a document has been subjected to steam ^{and} subsequently ^{manually} pressed to in an attempt to re-seal an adhesive seam. Additionally, the discoloration and brittle and fragmented edges of the envelope ^{could be explained by} ~~the~~ ^{the} envelope ^{being} ~~exposed~~ ^{exposed} under high temperatures, causing and gutting the major portion of the envelope, but leaving the edges exposed.

* Examination of the Q9 - all sheets of paper were limited to non-destructive methods. It was determined that the streaking of the ball-point ink writings on these sheets are the result of applying a solvent along the right edge, resulting in right-to-left smearing of the ink. Additionally, the location of these smears indicate that the solvent application occurred either while the three sheets were folded together or that the three sheets were folded while still wet, resulting in transferred writings and streaks at the folds.

* The postage meter stamp ^{impression} on the reverse side of the Q8 envelope lacks sufficient clarity of line detail to permit a determination of the date or meter number by microscopic and special photographic examinations, nor could it be determined whether that impression was actually made by

a mechanical postage meter stamp. However, the configuration, relative spacing of portions of the stamp, and general design conform to ~~those~~ those used on postage meters mfd by Pitney-Bowes, Inc., of Stamford, Conn. It was noted that the impression does not fluoresce under UV radiation.

The non-destructive examinations of the Q1 envelope, the Q2 note, the Q3 envelope, and the Q9 → Q11 sheets of paper failed to reveal any indented writings, watermarks, or other significant features which might be of assistance in determining either the source or the age of these documents.

You will be advised separately of the results of the examinations of the ink on Q8 → Q11 as well as the results of the examinations of these items for latent fingerprints. ~~Q8 → Q11~~ and the ~~Q8~~ FBI's net. at that time.

Pursuant to my telephone conversation this afternoon with Attorney General List, there are transmitted herewith the following original documents:

1) One-page "proxy" containing the original signature of Howard R. Hughes, dated November 14, 1970, witnessed by Levar B. Myler and notarized by Howard L. Eckersley. (This document is stamped and was utilized as defendant's Exhibit Q in the December 1970 court proceedings before Judge Howard Babcock.)

2) Two-page document consisting of 12 typewritten questions and handwritten answers thereto together with signatures and fingerprints of Howard R. Hughes. This document was prepared by Mr. Hughes during the middle part of January 1972. It was personally witnessed by Mr. Myler.

It is our understanding that both of the enclosed documents are needed by your office in connection with official matters and that they will also be the subject of superficial inspection by the Federal Bureau of Investigation Laboratory for purposes of handwriting and possibly fingerprint analysis. It is our further understanding that neither document will be subjected to any test which may affect or impair the document or its content in any way, and that both documents will be returned to us as soon as the State's requirements are satisfied.

Moreover, the second document, which is currently an exhibit in pending federal court proceedings in Salt Lake City, must be back in our possession in advance of the resumption of court proceedings which are now scheduled for the morning of Monday, January 24. I would appreciate your telephoning me at the above office this week or at my New York office thereafter so that we may arrange appropriate logistics for a timely return, at least as to the second document.

At the request of Mr. List, I am also attempting to obtain the release of the original 3-page "Dear Chester and Bill" letter which was originally used as an exhibit in the proceedings before Judge Babcock and which is currently an exhibit held by the U.S. District Court at Los Angeles in connection with litigation between Summa Corporation and Robert A. Maheu. Apparently, counsel for Mr. Maheu is unwilling to agree to the release of that document except pursuant to terms and formalities which will inevitably delay its release. As I have informed Mr. List, our handwriting expert, Lyndal L. Shaneyfelt, who was formerly with the FBI Laboratory until his retirement in 1975, has personally photographed the original document, and if it would be of any assistance, I would be happy to arrange for Mr. Shaneyfelt to provide a photographic copy for interim use.

I would appreciate your signing and returning the enclosed copy of this letter to acknowledge both your receipt of the enclosed items and your confirmation of the conditions and restrictions contained therein.



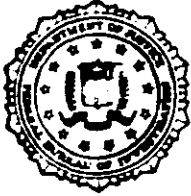

On 12-13-76, [redacted] Associated Press Reporter (AP), Los Angeles, California, [redacted] contacted me and advised that today a lawyer for Howard Hughes stated in court that the FBI had identified a fingerprint of Melvin Dummar on the envelope which contained the so-called "Mormon Will" of Howard Hughes. [redacted] wanted confirmation indicating he was referred to me by ASAC Ken Arnold, Las Vegas, Nevada. b7c

By letter dated 10-15-76, from the Office of the Attorney General, Carson City, Nevada, we were requested to process certain items pertaining to the "Mormon Will" and to compare any latents found with known fingerprints of Melvin Dummar. By report dated 11-9-76, we advised the Attorney General's Office, Carson City, Nevada, that a latent fingerprint developed on the envelope was identical to fingerprint of Melvin E. Dummar, [redacted]

After ascertaining the above facts, Bruce Greenhalgh, Chief Investigator, Attorney General's Office, Carson City, Nevada, was contacted and he was advised of the AP inquiry. He was advised that the FBI would respond to this inquiry as follows:

"The FBI has examined some material at the request of the Attorney General's Office, Carson City, Nevada, and the results of the examination have been furnished to that office. As this matter is currently under consideration in that office, it would not be appropriate for the FBI to comment concerning the results of the examination or the material examined."

ASAC Ken Arnold, Las Vegas, was advised to contact [redacted] AP, and furnish him with the above statement.

From press accounts it appears that Melvin Dummar is a gas station attendant who was named as a beneficiary in the "Mormon Will." Dummar claims he helped Hughes on one occasion by giving him a ride.

This matter was coordinated with Assistant Director Donald W. Moore, Jr., External Affairs.

Dear Mr. Attorney General:

I have received your letter dated January 3, 1978, relating to the probate action in Nevada concerning the estate of Howard Roland Hughes, Jr.

It has been the long-standing policy of the Federal Bureau of Investigation not to accede to requests for technical examinations or testimony at trials related to civil matters. The FBI has only limited technical resources and expert manpower, all of which are dedicated to criminal law enforcement, and could not possibly meet the demands which would result from entering into civil matters. As a result, the FBI has consistently refused all such requests.

Upon receipt of your letter I caused this policy to be reevaluated and studied. As a result, taking all facts of this matter into consideration, I have decided that my previous decision was appropriate and that I will not approve the personal appearances of Special Agent James E. Lile and Mr. Quintus Ferguson, Fingerprint Specialist, at the civil action in Las Vegas, Nevada. Attorneys for the Defendant-Proponent and for the Contestant were advised in previous correspondence of the decision not to authorize the personal appearances of these experts at the civil action.

Mr. McDermott has advised that on 1/12/78 he received a call from Brian P. Gettings whose law firm is involved in several different probate actions concerning the "Mormon Will" on behalf of contesting parties. Gettings was previously advised that the FBI would not authorize the document examiner and fingerprint specialist to testify at any civil trials, but that authorization was granted for providing depositions. (See letter from the Director to Gettings dated 12/20/77.) Gettings advised Mr. McDermott that an ink examiner of the Bureau of Alcohol, Tobacco and Firearms (ATF) Laboratory, Treasury Department, had testified to the results of his ink examinations of the will at the probate trial in Las Vegas. Gettings expressed his opinion that the Federal government was not being consistent in its response to requests for expert testimony relating to the will.

For information, the ATF Laboratory has established the most comprehensive ink reference library in the country and as a result is unique in its ability, in many instances, to date the manufacture of certain inks. In their examination of the ink with which the will was written they apparently determined that the ink was of a type manufactured prior to the purported date of preparation of the will. While this does not authenticate the will, neither does it prove it fraudulent.

In regard to the FBI's position in this matter, it has been long standing policy of the Laboratory not to examine evidence or provide testimony in strictly civil matters involving private individuals and not involving the Federal government. For many years requests of this nature have been denied. In this particular case the final decision was referred to the Department of Justice by Legal Counsel (see memorandum to the Deputy Attorney General from the Director, dated 10/28/77) pursuant to the provisions of Title 28, Code of Federal Regulations, Section 16.24(b) (1976), as amended by Departmental Order 693-77, effective 3/30/77. By letter to the U. S. Attorney at Las Vegas dated 11/2/77, Deputy Attorney General Flaherty advised that the Department had ruled that the document examiner and the latent fingerprint examiner need not testify at the civil trial at Las Vegas. By letter dated 11/9/77, the U. S. Attorney, Las Vegas, advised the attorney for the Defendant-Proponent that his request for FBI expert testimony was being declined. Similarly, by

The position and recommendation of the Identification Division in ^{this} this matter was previously set forth in addendum 12/5/77 to memorandum 12/1/77, Legal Counsel to the Director, captioned "Estate of Howard Hughes." ^{is} We recommend that FBI examiners be made available for depositions and/or testimony at trial in any legitimate civil proceedings in which they are needed ^{copy} and in which their testimony is relevant and germane.

We are not unmindful of Bureau policy not to examine evidence or provide testimony in strictly civil matters. By way of background, at the request of the Attorney General for the State of Nevada, the so-called "Mormon Will" of Howard R. Hughes, Jr., and related materials were examined by the Laboratory and Identification Divisions in connection with a state criminal investigation of Melvin Dummar for forgery and perjury. Dummar was named in the will as one of the beneficiaries. We have on previous occasions provided testimony in civil proceedings in cases where the civil action followed a criminal matter in which we had examined evidence. Thus, a decision to provide testimony in this matter would not be precedent setting.

The estate of Howard R. Hughes, Jr., involves billions of dollars. There are millions of dollars involved in Federal and state taxes. The Hughes estate matter has been clouded by mystery since the discovery of the so-called "Mormon Will." The enormity of this case, the staggering sums of money involved and the considerable public interest make it unique.

This is to acknowledge your letter of October 25, 1977, in which you requested the presence of Mr. Quintus Ferguson and Special Agent (SA) James Y. Lile, as witnesses in a civil action involving the above-captioned matter.

In this regard, please be advised that this Bureau has received a subpoena from the Attorney for Defendant-Proponents seeking the same testimony you have requested. I have decided not to approve the appearances of SA Lile and Mr. Ferguson at the aforementioned proceedings inasmuch as they have already testified extensively at depositions at which all interested parties were afforded an opportunity to cross-examine SA Lile and Mr. Ferguson. Furthermore, their extensive testimony at the deposition hearings was given with the specific understanding that no further personal appearances at subsequent proceedings would be called for.

I have forwarded the Defendant-Proponent's subpoena for testimony to the Deputy Attorney General, United States Department of Justice, Washington, D. C., for his final decision pursuant to the requirements of Title 28, Code of Federal Regulations, Section 16.24 (b), as amended by Department of Justice Order No. 693-77, effective March 30, 1977, delegating the authority in such matters from the Attorney General to the Deputy Attorney General.
