

During the period December 14 through 16, 1970, several [REDACTED] were observed in and around the Britannia Beach Hotel acting in a suspicious manner. At noon on December 16, 1970, I checked the front desk registration cards and determined that a couple of these men were registered into rooms 825 and 826, directly under the Hughes' suite, 925, 926 and 927. At the same time I observed a stake-out seated in a white [REDACTED] car parked in the far corner of the parking lot to the rear of the hotel. Several other men were observed relieving one another in the lobby of the hotel. Calls were made to Assistant Commissioner - Crime, John Crawley, and Assistant Commissioner - Special Branch, Courtney Strachan, who agreed to meet me at the hotel at 2:45 p. m.

At 3:00 p. m. Crawley, Strachan, Supt. Fields and I went to room 826, knocked on the door and were admitted, after identifying ourselves, by [REDACTED] from Los Angeles, California. Upon entering the suite [REDACTED] room three men were observed in the adjoining room, #825. Upon entering room 825, several pieces of what were later determined to be bugging equipment for illicit eavesdropping purposes were seen on the table in the room, along with cameras with telephoto lenses and binoculars. Photographs of these were taken by C. I. D.

One of the men in the room was [REDACTED] whom it was later determined runs an investigative agency called [REDACTED]. Another was [REDACTED] a former Department of Justice employee who admitted bringing the equipment into the Bahamas one hour previously. While Crawley and Strachan held the men in the rooms, Fields and I went to the pool, casino and parking lot and rounded up four additional men, making a total of eight men.

Questioning by C. I. D. determined [REDACTED] had hired the group through their [REDACTED]. They first stated that they were attempting to [REDACTED] a \$50,000 from Life Magazine for a picture of Mr. Hughes. When the [REDACTED] was not believed they next stated that they were hired to determine [REDACTED] he was alive and well.

After the interrogation I went into the bedroom in 826 with [redacted]. His suitcase was open and I asked him if I could look at the contents; he said to go ahead. In the suitcase I found two air navigation charts of the Florida and Bahamas area with pencil markings thereon, four water navigation charts of Nassau, Paradise Island and vicinity along with a Coast Guard book on boat handling [redacted] check book was in the suitcase and, with his permission, I looked at the entries. One entry was a check made payable to [redacted] in the amount of \$5,000 which had been voided [redacted] stated he erroneously made it out for \$5.00). Ditto marks under the name [redacted] indicated that a second check had been made out for \$5,000 [redacted] said that this check was in payment of a car he bought from [redacted]. More recently, another entry showed the name [redacted] and the amount of \$100.00 [redacted] indicated that he had paid [redacted] the \$100 on a football bet he had lost to him [redacted] admitted he was a friend of [redacted] but denied [redacted] was in any way connected with his reason for being in Nassau. Crawley, Strachan and Fields also examined the contents of the suitcase as well as the charts and check book entries. They were also present during his admissions concerning the check book entries.

Accompanied by [redacted] and with his permission, I looked through his shaving kit and in a side pocket found a badge case containing a badge which read 'Special Assistant, Office of the Governor, State of Nevada. [redacted] in the case was a plastic card showing the State seal and the same words [redacted] stated that the badge had been left by [redacted] (believed alias for [redacted] who had left the hotel that morning and that the badge had been given to [redacted] by [redacted]. After photographing the badge C. L. D. gave me permission to keep it and return it to the Governor.

Surveillance logs maintained by the group were confiscated by C. L. D. along with charts and telephone message slips; the charts and slips were given to me and forwarded to Las Vegas. C. L. D. called Immigration Officers who, after allowing the group to check out of the hotel, escorted them to the airport and deported them from the country on Pan American #410 at 7:45 p. m.

The individual [redacted] shown on the registration card along with [redacted] who gives his address as [redacted] and who made several telephone calls to [redacted] is believed to be [redacted] who gives his address [redacted] stated that this individual, whom he knew as [redacted] registered in on December 8, 1970, with him from the Emerald Beach Hotel, Nassau, and checked out on Wednesday morning.

There were two other men suspected of being a part of this group registered into room 525. These two men, whose names are on the cards previously forwarded to Las Vegas, were from Reno, Nevada, and departed hurriedly during the round-up of the others shortly after 3:00 p.m. on Wednesday.
