THE CLAY FOUNDATION HAS A CARRYOVER LOSS THAT STARTED IN 2004. THE LOSS WAS GENERATED BY THE CLAY FOUNDATION'S INVESTMENT IN WV MEDIA PARTNERS. WV MEDIA PARTNERS HAD LOSSES FROM 2004 - 2009. THE LOSSES TOTAL \$148,540.

ON THE 2010 TAX RETURN, THE CLAY FOUNDATION HAD INCOME FROM THE INVESTMENT IN WV MEDIA PARTNERS OF \$11,895. A PORTION OF THE LOSS THAT WAS GENERATED IN PRIOR YEARS, -\$11,895, WAS USED ON 2010 FORM 990-T TO OFFSET 2010 INCOME.

FOR THE 2011 TAX RETURN, THE CLAY FOUNDATION HAD INCOME FROM THE INVESTMENT IN WV MEDIA PARTNERS OF \$10,669. A PORTION OF THE LOSS THAT WAS GENERATED IN PRIOR YEARS, -\$10,669, IS USED ON 2011 FORM 990-T TO OFFSET 2011 INCOME.
