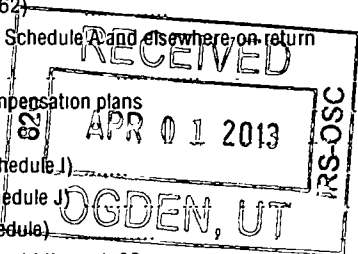

LINE 5 - ON THE ORIGINAL RETURN, ULMS REPORTED INCOME FROM TWO PASSTHROUGH ENTITIES. IT WAS DETERMINED SUBSEQUENT TO FILING THAT ONE OF THE ENTITIES WAS ACTUALLY A DISREGARDED ENTITY, SO THE NET INCOME SHOULD BE REPORTED ON LINE 7, NOT ON LINE 5. ALSO THE LOSS PASSED THROUGH FROM URBAN LEAGUE APARTMENTS AT COLMAN SCHOOL, LP, WAS \$29, PER THE AUDITED FINANCIAL STATEMENTS, INSTEAD OF \$41, AS ORIGINALLY REPORTED

LINE 7 - AS STATED ABOVE, THE NET INCOME FROM URBAN LEAGUE VILLAGE, LLC, WAS MOVED FROM LINE 5 TO LINE 7. ALSO, DURING THE AUDIT, AN ADJUSTMENT WAS POSTED TO CHANGE THE NET INCOME FROM A GAIN OF \$349,281 TO A LOSS OF \$279,669. THIS AMOUNT, COMBINED WITH THE \$66,204 LOSS ORIGINALLY REPORTED ON LINE 7 EQUALS THE \$345,873 LOSS ON LINE 7 OF THE AMENDED RETURN.

LINE 21 - THIS NOW INCLUDES \$357,866 OF DEPRECIATION FROM URBAN LEAGUE VILLAGE, LLC, IN ADDITION TO THE \$3,601 FROM ULMS ITSELF, FOR A TOTAL OF \$361,467.
