1. Headquarters holds the following significant information on Dino Vincent CELLINI, born on 19 November 1914, which is forwarded under Station's internal information only.

A. STATE DEPARTMENT DISPATCH NO. 1335 (HAVANNA)
DATE: 29 MAY 1959

b. Dino CELLINI is also mentioned in UFGW-157, 15 December 1960, but we have not been able to locate this document as of this date.

c. WAVE-3608, 13 February 1961, Source: AMOT-2, reported that Dino V. CELLINI worked at the casinos Tropicana and Riviera in Cuba before going to Haiti. Subject now residing at 12459 Key Stone Road, North Miami, Florida.

d. Reported in [redacted] dated 18 January 1961, stated that Dino CELLINI is a well known Washington (D.C.) gambler and is or was a close friend of Washington (D.C.) gambler Joseph Francis NESLINI. In 1955 he (CELLINI) operated a gambling casino in Havana, Cuba.
