- 4. THE DETAILS OF HOW HUNT BECAME WARREN CAN BE TRACED FROM DOCUMENTS ON FILE WITH THE SENATE WATERGATE COMMITTEE IN WASHINGTON. THE DOCUMENTS WERE PUBLISHED BY THE COMMITTEE AS PART OF THE TRANSCRIPT OF ITS HEARINGS.
- 5. ONE DOCUMENT ON FILE IS A PHONY NEW YORK STATE DRIVER'S
 LICENSE, WITH AN UPPER WEST SIDE ADDRESS. "THIS LICENSE WAS
 FORGED," SAID A DEPT. OF MOTOR VEHICLES SPOKESMAN. "IT WAS NEVER
