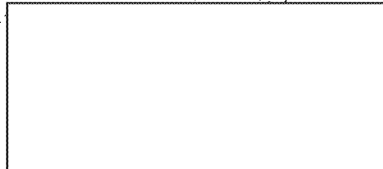

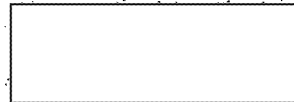

2. It is the conclusion of this office that you should also request a Covert Security Approval from the Office of Security to cover [redacted] who is also an American citizen residing in the United States.

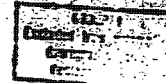

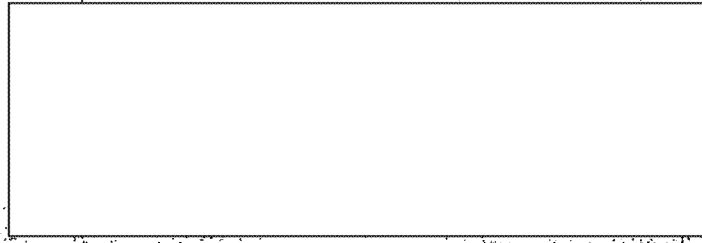

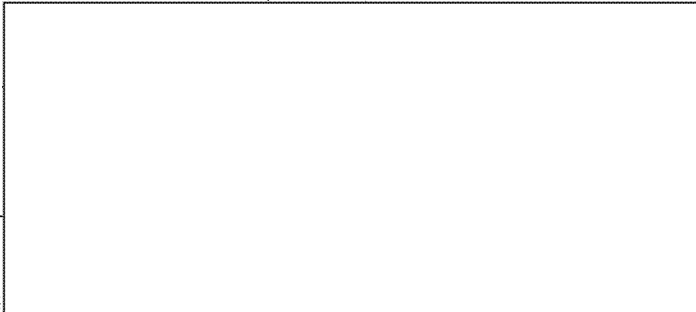
