

BERLIN AND WEIMAR, 1965

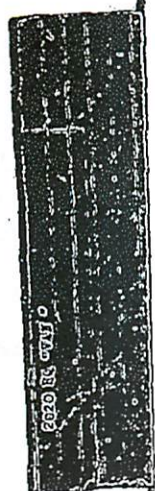
