**Interview:**

On 3/14/78 Staff Investigator Harold D. Leap interviewed Will Hayden Griffin, former FBI Special Agent stationed in Dallas, Texas from 1958 to Dec. 30, 1977 relative to the SCA investigation of the JFK assassination.

Griffin advised that he had never met or saw LHO, however he had interviewed Marina Oswald on several occasions after the assassination.

Leap asked Griffin if he was aware that he was alleged to have stated that Oswald was an FBI informant. Griffin stated that he was aware of the allegation and had been questioned by the Bureau concerning the accusations of Walter Jenkins. Griffin said there was no truth to the accusations and did not know where Walter Jenkins got the information. He said he knew the information did not come from Walter Jenkins' brother Bill, who is a FBI agent in Albuquerque, New Mexico.

Leap asked Griffin if he was censored as a result of the Bureau investigation of the allegations. Griffin
