> Investigators Robert Buras and L.J. Delsa met Mr. O'Sullivan at his place of employment in the company with Mr. Boylston. Mr. O'Sullivan stated that he knew Lee Harvey Oswald from Beauregard Junior High at 4621 Canal St. Because the names O'Suldivan began with OS they sat in the same home room. remembers Oswald dancing at intermission at school and how he held himself erect. This made him think that Oswald would be good in the CAP drill team. O'Sullivan talked three boys into being interested in the Civil Air Patrol: Joseph Thompson, Edward Voebel and Lee Oswald. O'Sullivan knew David Ferrie but can not say that he ever saw Ferrie and Oswald together. He doesn't remember Oswald from CAP activities. He could not find any documents with both of their names on them for the Warren Commission and he did check with Lt. Paul Dyer for Ferrie's plane at the airport. It wouldn't fly.
