'Evil alliance' of terror, drugs 'serve East bloc'

WASHINGTON — Senators charged Tuesday that evidence exists of an "evil alliance" of terrorists and narcotics traffickers serving Soviet interests, but a State Department official discounted any communist plot to undermine America with drugs.

Sen. Alfonse D'Amato, R-N.Y., appearing at a joint hearing on international terrorism of the Senate Foreign Relations and Judiciary committees, renewed charges that Bulgaria's official export agency sells arms to drug dealers, who pass them on to terrorists in exchange for heroin.

He said the federal Drug Enforcement Administration is convinced that such a link exists but is unable to turn up new evidence because of a lack of resources.

"The administration has been totally inept — inept and unwilling to admit the seriousness of the situation," D'Amato said.

Sen. Paula Hawkins, R-Fla., who testified with D'Amato, said she hopes the hearings will convince people of the existence of "narcoterrorism" — the link between narcotics trafficking and international terrorism.

Sen. Paul Trible, R-Va., who presided over the hearing, said evidence produced so far shows that government-supported terrorism is aimed at Western democracies.

"The sponsors of terrorist acts, in case after case, are clients of the Soviet Union or nations temporarily serving Soviet interests by fostering instability in strategic regions of the world," he said.

Trible said that particularly in Colombia and the Middle East, "violent terror and drug trafficking are wed in an evil alliance."

Deputy Assistant Secretary of State Clyde Taylor agreed that there are links between drug traffickers and terrorist groups, as well as "some indications of state-sponsored narcotics trafficking."

But he said illegal drug traffic throughout the world is dominated by people "governed only by their greed."

"Most of these groups cannot be called terrorists, or even political insurgents, nor do we have evidence of a communist conspiracy to use drugs to undermine Western democracies, or our own society in particular," Taylor said.

David Westrate, deputy assistant DEA administrator, said some drug traffickers have adopted terrorist tactics in fighting anti-drug drives.

This is most evident in Colombia, he said, where Minister of Justice Rodrigo Lara-Bonilla was assassinated on a Bogota street last year and where drug traffickers are believed to have been behind several bombings — including one just outside the U.S. Embassy.

Death teams put together by Moscow

West target in case of war, defector says

NEW YORK — Special Soviet assassination squads have been formed to kill Western political and military leaders if war broke out, a Red Army defector said in an interview published in a U.S. Army magazine.

The defector, who used the pseudonym Viktor Suvorov, said units of the special forces of the Soviet military-intelligence directorate, the GRU, and teams of KGB intelligence and security agents have preassigned assassination missions in case of war.

Suvorov said other units of the GRU would wreck nuclear installations, attack NATO command centers, disrupt communications and destroy key targets, such as air bases.

The defector's account appeared in the current issue of *Military Review*, published by the U.S. Army Command and Staff College at Leavenworth, Kan.

The article was a reprint from *International Defense Review*, said Lt. Col. William Arbogast, public-information officer at Fort Leavenworth.

A report on the article was published Sunday by the *New York Times*.

Suvorov said that because of their rigorous peacetime training and dangerous wartime duties, the GRU and KGB compete to recruit top athletes into the special units.

An editor's note in the journal said if Suvorov's claims are accurate, some of the potential assassins already have visited target areas in the West through invitations to sporting events.

The *Times* quoted a Western intelligence officer as saying that NATO's ability to cope with the special Soviet units "would rest on the effectiveness of local forces defending the home front."

The writer, a former Red Army officer who lives in Britain, has published two books. One describes life in the Soviet army, and the other is an account of his experiences during the Soviet invasion of Czechoslovakia in 1968.

Fingerprints:

The results of the latent fingerprint examination will be provided by a separate report.

Explosives and Explosive Accessories:

Submitted specimen Q1 is an Atlas "Gelmax" dynamite wrapper bearing date-plant-shift code "12264A2" which measures approximately 1 1/8" X 8". This wrapper and the dynamite in specimen Q2 were manufactured by the Atlas Powder Company, Joplin, Missouri, on December 26, 1984.

The length of brown colored safety fuse in specimen Q6 was identified as "Ailsa Thistle Brand" safety fuse which was manufactured by Nobel's Explosive Company, Stevenston, Airshire, Scotland a subsidiary of The Imperial Chemical Industries (ICI), Limited. This safety fuse is like the brown safety fuse in specimen K1.

Instrumental Analysis:

The submitted specimen Q2 was determined to be nitroglycerine based dynamite. The white powder in specimen Q3 and Q4 was identified as potassium chlorate which is a common ingredient in the clandestine manufacture of improvised low explosives. The brown substance in specimen Q5 was identified as lead azide which is a very sensitive high explosive and used in the manufacture of blasting caps.

Disposition of Specimens:

The submitted specimens will be retained in the Laboratory until final disposition is determined by your office.
