It is noted that the Pitt Machine Products, Inc., is the corporation that was owned and operated by JULIUS and ETHEL ROSENBERG. It is also to be noted that JULIUS and ETHEL ROSENBERG were recently indicted on charges of espionage.

Referenced report set forth a lead to interview the Randolph-Rand Company, 141 Wooster Street, concerning the above-mentioned purchases from Pitt Machine Products, Inc., and particularly to attempt to ascertain how the Randolph-Rand Company began to purchase items from the Pitt Machine Products, Inc., and whether any officers at Randolph-Rand knew JULIUS or ETHEL ROSENBERG, or DAVID or RUTH GREENGLASS personally.

A check of the address 141 Wooster Street revealed that the Randolph-Rand Company is no longer located at this address. It was ascertained that the Randolph-Rand Company formerly at 141 Wooster Street is now known as the Gainer Corporation located at 115 Cedar Street, New Rochelle, NY.

It is requested that the resident agent at New Rochelle, NY, contact appropriate officials at the Gainer Corporation, 115 Cedar Street and attempt to ascertain whether any of the officials of this company knew JULIUS or ETHEL ROSENBERG and DAVID or RUTH GREENGLASS.

Reference is made to the report of SA (A) GERALD J. VAN DORN at NY, dated 12/2/50 in entitled matter.

Referenced report set forth lead to interview Du-Fast Incorporated, 32 East 4th Street, New York City, concerning purchases from 5/19/48 to 7/5/49 from the Pitt Machine Products, Inc., in the amount of \$1437.29. It is noted that Pitt Machine Products Company is the company headed by JULIUS ROSENBERG.

Mr. THEODORE TOTTIS, Vice President and Treasurer of Du-Fast, Inc., 32 East 4th Street, NYC, advised that this corporation makes a sending attachment for electric drills. He stated at the present time this corporation has no defense contracts. Mr. TOTTIS further advised that in 1948 Air Corporation made a contract with Pitt Machine, Inc., to make a hardened steel ring and that this contract extended over a period from 1948 to the time the ROSENBERGS were apprehended. Mr. TOTTIS advised that he personally never met JULIUS or ETHEL ROSENBERG or DAVID or RUTH GREENGLASS.

He also advised that the Air Duct Installation Company is located at the same address. He stated that Air Duct makes a window ventilator hedge clipper and that this company also has no defense contract. He advised that he is President of Air Duct Installation Company.

Mr. TOTTIS stated that both Air Duct Installation Company and Du-Fast, Inc., first extended contracts to the Pitt Machine Company through the intercession of DAVID ROBBINS who is the President of Du-Fast, Inc.

It was Mr. TOTTIS' understanding that DAVE ROBBINS

first learned of the Pitt Machine Company when he was visiting the Metro Heat Treat Corporation at 466 Broome Street, NYC, and he happened to mention that he needed certain work done which the Pitt Machine Company could do. It was Mr. TOTTIS' understanding that some individual at the Metro Heat Treat Corp. recommended the Pitt Machine Corporation to DAVE ROBBINS.

Mr. TOTTIS also advised that in addition to the contract that Du-Fast, Inc. had with Pitt Machine the Air Duct Installation Company also made a contract in 1950 with the Pitt Machine Company to make a "hex driving pin."

Regarding the hardened steel ring contract that Du-Fast, Inc. had with Pitt Machine, Mr. TOTTIS advised that Pitt Machine in turn sub-contracted this work to the Beacon Metal Manufacturing Company, 375 Kent Avenue, Brooklyn 11, NY. In this regard, Mr. TOTTIS advised that the lawyer whose name Mr. TOTTIS did not know called Du-Fast, Inc. and attempted to have Du-Fast, Inc. make a check out in full to the Pitt Machine Company for the work contracted for. Mr. TOTTIS stated that instead of doing this he paid a certain amount direct to the Beacon Metal Company since Du-Fast, Inc. was very satisfied with the work Beacon Metal Company had done for them and that he, Mr. TOTTIS, feared that if an entire check was made out to Pitt Machine, Beacon Metal Company would never get paid for the work they had done since the ROSENBERGS were in custody. Mr. TOTTIS commented that the lawyer for the ROSENBERGS threatened a civil suit in this regard; however, he (Mr. TOTTIS) told the lawyer that he, representing the ROSENBERGS, had no room to talk about law suits since they were already in custody on charges of espionage, and it is very doubtful if Pitt Machines creditors would ever be paid.

Mr. TOTTIS stated that on August 7, 1950, ETHEL ROSENBERG came to their office personally and signed a receipt authorizing Air Duct Installation Company to pay Beacon Metal Manufacturing Company the sum of \$111.01 on the work sub-contracted to the Beacon Metal Company and authorized Air Duct to pay Pitt Machine the balance of \$173.74 which is payment in full.

Mr. TOTTIS furnished the receipt regarding this transaction, and a photostatic copy of this receipt is being submitted with this memorandum. Mr. TOTTIS could furnish no other information regarding ETHEL ROSENBERG.

DAVID ROBBINS, President of Du-Fast, Inc., 32 East 4th Street, was subsequently contacted, and he advised that both Du-Fast, Inc. and Air Duct Installation Company originally came to sub-contract work to Pitt Machine Company through the Metro Heat Treat Corp, 466 Broome Street. He advised that one day he was talking to DON KNOCH at Metro Heat Treat Corp., and he happened to mention the problem he was having in trying to sub-contract work, and Mr. KNOCH mentioned that the Pitt Machine Company did the type of work that Mr. ROBBINS was interested in. Mr. ROBBINS stated he cannot recall ever meeting JULIUS or ETHEL ROSENBERG and further he could not identify any of the aforementioned photographs of other ROSENBERG subjects. Mr. ROBBINS mentioned that one of his employees had made one or two visits to the Pitt Machine Company and that his name is Mr. THOMAS PANELAS, a draftsman.

THOMAS PANELAS, Draftsman for Du-Fast, Inc., 32 East 4th Street, advised in connection with the contracts that Du-Fast, Inc., and Air Duct had with Pitt Machine

He mentioned he had lunch on two occasions that he can remember with JULIUS ROSENBERG after his visit in connection with the aforementioned contracts. Mr. PANELAS further advised that ROSENBERG did not mention any of his personal activities to him and that most of their conversation concerned the contracts Pitt Machine had acquired with Du-Fast, Inc., and he also mentioned that ROSENBERG hoped to get additional contracts from Du-Fast. Mr. PANELAS could not recognize any of the other aforementioned photographs when displayed to him.

Warden E. F. THOMPSON of the Federal House of Detention was contacted by the writer on January 23, 1951 with reference to making arrangements to discreetly interview JEROME E. TARTAKOW during the pending trial of JULIUS ROSENBERG.

It was explained to Warden THOMPSON that TARTAKOW had been cooperating with Agents of the New York Office in furnishing information relative to JULIUS ROSENBERG and that it was desired that contact with TARTAKOW be maintained in connection with this matter during the trial of JULIUS ROSENBERG for any possible assistance or information TARTAKOW may be able to render. It was pointed out to Warden THOMPSON that the Bureau desired to conduct interviews with TARTAKOW as discreetly as possible inasmuch as he would be of no value or assistance should other inmates of the Federal House of Detention become aware of the fact that TARTAKOW was being interviewed by Bureau Agents.

Warden THOMPSON advised that TARTAKOW is presently in charge of the prison laundry records and that in connection with this, he calls at the front office two or three times each day. Warden THOMPSON stated that to him the best method of contacting TARTAKOW would be the most obvious one inasmuch as no importance is placed on TARTAKOW'S calls to the office. than the warden, Mr. FRANK KENTON, the Prison Parole Officer, and whatever guard happened to be on duty at the gate.

Warden THOMPSON stated that he thought the above means would be the best method of contacting TARTAKOW inasmuch as any deviation from the routine prison assignments was immediately commented on by all prison inmates.

The information relative to TARTAKOW was also furnished Mr. FRANK KENTON, the Prison Parole Officer, since his cooperation in interviewing TARTAKOW is necessary. Both Mr. THOMPSON and Mr. KENTON advised that the entire matter would be held in strictest confidence by them.

Mr. KENTON stated that one BYRON NIELSON, a former chaplain of the prison, has been interviewing ABRAHAM BROTHMAN regularly at the prison. KENTON stated that inasmuch as NIELSON is a minister and a former chaplain of the prison, he has access to interview inmates, but he has become suspicious of him lately because NIELSON'S interviews with BROTHMAN always last two or three hours. KENTON advised that he was furnishing this information for whatever value it might be. He stated that Mr. FRED KUETHER of the Council for Clinical Training, 2 East 103rd Street, New York City, would be able to furnish background information regarding NIELSON.

On 1/31/51, Mrs. RUTH ALSCHER, sister-in-law was interviewed at the U.S. Court House by the writer. Earlier, Mrs. ALSCHER had testified before the Grand Jury.

Mrs. ALSCHER stated she had no recollection of ever having had dinner at a bird in Hand Restaurant in NYC with MAX and HELENE ELITCHER. She also said she never knew any individuals named JOEL BARR, WILLIAM PERL or MUTTERPERL or JULIUS ROSENBERG. Photographs of these three individuals were shown to her but she failed to identify any of them. The photograph of BARR she said, was familiar but she could not identify it.

Mrs. ALSCHER was shown photographs of ALFRED SARANT, ETHEL ROESNBERG, DAVID GRLENGLOSS, MIKE SIDOROVICH, ANN SIDOROVICH, LOUISE SARANT, VIVIAN GLASSMAN, but failed to identify any of them.

She identified a photograph of MORTON SOBELL as an individual she had met about 9 or 10 yrs. ago in somebody's apartment in the Bronx, NY. She also said she knew SOBELL lived next door to her brother-in-law in Long Island.

Mrs. ALSCHER could not furnish any information about the circumstances under which she met SOBELL, nor did she recall, she said, whose apartment it was where this meeting took place.

MILTON KLEIN was interviewed on January 30, 1951 in the offices of the Air Force Material Command, 67 Broad St. N. Y.C. by SA's REX I SIRODER AND JAMES P. LEE.

KLEIN advised that he presently resides at 21-24 34 Avenue, Long Island City, New York. He formerly resided at 760 West End Avenue, having moved to his present location approximately two weeks ago.

KLEIN stated that sometime during 1940, he joined the U.S. Signal Corps in N.Y.C. Shortly after joining, he was sent to Philadelphia to attend a training school there. He departed New York by train, traveling with a number of other inspectors going to Philadelphia to attend the training school. When he boarded the train he sat across from a man and his wife who were also going to Philadelphia for the Signal Corps. These people were introduced to KLEIN as Mr. and Mrs. JULIUS ROSENBERG. Mrs. ROSENBERG was traveling with her husband and was the only wife present out of the entire group.

While at Philadelphia, KLEIN did not room in the same hotel as the ROSENBERGS, but did see JULIUS while attending classes.

After training school, KLEIN saw ROSENBERG sometime, he believes, during 1942 at the MORNI MANUFACTURING COMPANY in N.Y.C. KLEIN was there on official business for the Signal Corps for about eight months and ROSENBERG was also stationed there for about one week.

The next time KLEIN saw ROSENBERG, was during 1943, at which time the subject was employed at the GIBSON RADIO COMPANY, in New Jersey. KLEIN was employed as staff supervisor and in connection with official duties spoke with ROSENBERG on one or two occasions.

KLEIN recalls that he did not see ROSENBERG again until about 1945. Shortly after the Air Force set up their own procurement organization, and KLEIN came to work for them in N.Y.C., ROSENBERG called him at his office. He told KLEIN that he had been dismissed from his position with the Signal Corps because of his affiliations with the American Labor Party. He told KLEIN that he then had his own shop and that he was doing sub-contract work for the Air Forces. He asked KLEIN if he knew of any contracts that could be had and also if he had any ideas on how to obtain contracts. KLEIN knew of no such contracts and told ROSENBERG that the best way to get them was to go out and look for them. ROSENBERG asked KLEIN to come out and look over his machine shop. KLEIN accepted the offer and some time subsequent inspected ROSENBERG'S shop. He believes the shop was located on Houston St. He also recalled that while looking at the machinery, ROSENBERG told him he had just moved from another location. KLEIN recalled that the shop appeared to be new, inasmuch as it was still clean and things looked rather disorderly.

KLEIN advised that to the best of his knowledge this was the last time he saw ROSENBERG, although he may have talked to him on the phone subsequent to that time. He said that at no time did ROSENBERG question him relative to any classified information or make any reference to any specific contracts. He was not a social acquaintance of ROSENBERG'S and could offer no information concerning the subjects communistic activities. KLEIN was shown photographs of the below listed individuals but stated that none of them were familiar to him:

RUTH GREENGLASS telephonically contacted the writer today and advised she had contacted JEAN KELSCH and Miss KELSCH advised her she was going away over Lincoln's Birthday and if she liked the place she would stay a couple of weeks. Mrs. GREENGLASS said that based on this she thought that JEAN KELSCH was not going to be a defense witness.

Mrs. GREENGLASS said that the reason why she asked her brother-in-law LOUIS ABEL for \$100.00 from the package containing the \$4,000.00 at the time when she had \$500.00 in her possession was because she needed the \$500.00 to rent a summer place in the country and she wished to keep that money intact. At the same time she was obliged to purchase a wedding gift and some clothes to attend the wedding of a friend and she used the \$100.00 for that purpose.

Mrs. GREENGLASS stated that last week she received a telephone call from Mr. SCHAEFFER of the Jewish Daily Forward. SCHAEFFER said he had received a call from a Mrs. GREENGLASS who wanted to speak to him but RUTH GREENGLASS told him that she had not contacted him. RUTH GREENGLASS then contacted her mother-in-law TESSIE GREENGLASS and ascertained that TESSIE had called SCHAEFFER on the telephone when BLOCH'S office had instructed her that she was not to contact her daughter ETHEL ROSENBERG at the Woman's House of Detention. RUTH GREENGLASS said that TESSIE GREENGLASS did not speak to SCHAEFFER again.

TESSIE GREENGLASS also told Miss EPSTEIN of the foster home which is caring for RUTH GREENGLASS' children, about the efforts of JULIUS ROSENBERG and his attorney to keep her from visiting her daughter ETHEL. Miss EPSTEIN told TESSIE GREENGLASS that she would investigate this for her and she later told TESSIE that she had checked and found out that JULIUS ROSENBERG and his attorney were trying to keep all bad news from ETHEL ROSENBERG and for that reason they did not want TESSIE to visit her daughter. TESSIE has now decided that she will have nothing further to do with her daughter ETHEL.

With regard to the United States Attorney contacting Mr. Speaks, Mr. Hennrich wanted the following questions answered.

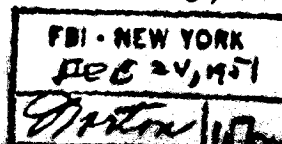
- (1) When will he arrive there?

On the afternoon of 2/13/51 SA's John A. Harrington and William F. Norton, Jr. conferred with USA IRVING SAYPOL, Chief Assistant USA MYLES J. IANE, Assistant U.S. Attorneys ROY M. COHN, JOHN FOLEY and JAMES B. KILSHEIDER. Mr. SAYPOL said that he intended to fly to Mexico City by way of Miami the week of 2/18/51 together with Mr. COHN. Mr. SAYPOL said that he desired to confer with the Legal Attache in Mexico City concerning the possibility of using Mr. MARTINEZ, who is a member of the Mexican Secret Police, as a possible rebuttal witness. Also, that he desired to have the Legal Attache in Mexico City arrange for the interview of certain potential witnesses in this case.

Mr. SAYPOL stated that in view of the fact that it is necessary to swear in a jury during the same time that the case is heard, the jury will be impaneled on 3/6/51 instead of 2/28/51, as previously indicated. He also stated that he had corresponded with the Department of Justice to advise them that he would not be bound by any commitment of the Department relative to the imposition of the death penalty upon these defendants. He said that he felt that this was his prerogative which he wished to exercise himself.

Officials of the Naval Records Management Center, Naval Supply Depot, Mechanicsburg, Pennsylvania, were contacted in an effort to obtain a photostatic copy of the entire file on STANLEY R. In view of the above, arrangements were made to obtain the original file on WILLIAM DANZIGER from the Naval Records Management Center to be forwarded to your office for photostating. This entire file is therefore being forwarded to your office by registered mail, under separate cover, direct from the Harrisburg Resident Agency, on instructions of the Special Agent in Charge.

Officials of the Naval Records Management Center requested this file be returned to them as soon as possible and further advised it is being loaned to the Bureau for purposes of photostating only. Under no circumstances should the original file be produced in court until such time as the proper subpoena is issued.

The proper person to subpoena to produce the original file in Court is JOSEPH WERTZBERGER, Director, Naval Records Management Center, Naval Supply Depot, Mechanicsburg, Pennsylvania, or his authorized assistant.

Since the above mentioned file was not reviewed by this office, an investigative report will not be prepared on the matter.

## Like Lightning

# Fast Pneumonia Attack Takes Life Of Boy, 7

Death in one of its rare but not unknown forms struck quickly in Phoenix Saturday to take the life of a 7-year-old.

Little Sheldon Tartakow, 715 West Taylor Street, had played a lot during the day. Life was fun. And it was better yet when, late in the afternoon, he had a candy bar at the corner grocery.

The candy gone, Sheldon turned on the water hydrant at the rear of the store and had a drink out of the spigot.

Everything was handy for a boy.

And it was late. Almost sun-

down. . . when he went home, apparently normal, he was well.

But shortly later, he did not feel so good.

He told his mother, Mrs. Rosalind Tartakow, he was sick.

Then . . . he collapsed.

That was about 7 p.m.

He was rushed to Good Samaritan Hospital. There a doctor and three nurses worked to save him.

But they lost.

At 8:05 p.m. Sheldon was dead. Bronchial pneumonia, the quick kind—doctors call it "fulminating" pneumonia because it strikes like lightning—had seized the lad.

It sometimes occurs in grown-ups, but not often.

Mostly it happens to children. SOMETIMES it happens at night, and folks say the child "smothered" while asleep.

But doctors know different. It's just a quick killer that strikes—and usually wins—in just a few hours.

In Sheldon's case it was less than two hours.

TARTAKOW, Sheldon, 715 West Taylor St., died Saturday at 8:05 p.m. Cause of death, bronchial pneumonia, according to Dr. S. S. Samuels, chief of staff, Good Samaritan Hospital, 1501 West Taylor St. Burial will be at the Phoenix Jewish cemetery.

On Monday, 2/12/51, the writer was informed by Parole Officer FRANK KENTON of the Federal House of Detention, that JEROME TARTAKOW, who has been interviewed at intervals by Agents of the New York Office relative to JULIUS ROSENBERG, had been advised by telegram that his son had been stricken with pneumonia and died in Phoenix, Arizona. KENTON stated that TARTAKOW was visited by his mother, father and sister on Sunday, 2/11/51, and that they were allowed a personal interview with TARTAKOW. TARTAKOW, who was very devoted to his wife and child, became very hysterical, threatened to hang himself, and apparently lost complete control. KENTON stated that because of TARTAKOW's excellent record at the prison and because of the fact that he has cooperated with Bureau Agents in various matters, he was granted a special parole to fly to Phoenix to see his wife. During the afternoon of 2/11, TARTAKOW's father and sister visited the Federal House of Detention the second time and brought with them two round-trip plane tickets to Phoenix, Arizona. KENTON stated that he had no knowledge of how these tickets had been obtained by the TARTAKOW family.

TARTAKOW journeyed to Phoenix, accompanied by a prison guard, and it is noted that all expenses incurred on the trip were paid by TARTAKOW including those of the guard. They returned from Phoenix on the afternoon of February 13th.

On February 15th, Parole Officer KENTON was again contacted with reference to TARTAKOW and he stated that TARTAKOW appeared to be in a state of shock but that he also appeared to be coming out of it and that he was taking the loss of his son in a reasonable manner. Accordingly, it was requested that permission be granted to interview TARTAKOW on Friday, February 16.

TARTAKOW was interviewed on February 16th and he appeared to be very upset and taking the loss of his son very heavily. He furnished a photostat of a newspaper clipping from

a Phoenix, Arizona, newspaper regarding the death of his son, which is attached to this memorandum. It is noted that this newspaper clipping reflects that the boy was stricken with fulminating pneumonia and that he died in one hour and five minutes after he was stricken. The boy was seven years of age. The writer expressed sympathy for TARTAKOW's loss of his son.

TARTAKOW furnished the information that when he suffered this loss his family was unable to help him inasmuch as his father is sickly and they have no funds whatsoever. He stated that the money for the plane tickets was loaned him by friends of his inside the prison. It is noted that these funds were made available to TARTAKOW's family between the morning and the afternoon of Sunday, February 11th.

After a short discussion with TARTAKOW relative to the status of his family and wife, the subject of his cooperation with the Bureau with reference to ROSENBERG was brought up. TARTAKOW stated that in the past several days he had thought a great deal about it and that he felt that inasmuch as there was nothing in it for him he saw no reason why he should continue his cooperation with the Bureau.

TARTAKOW stated that when he originally began discussing ROSENBERG with Agents of the New York Office, he did so with the understanding that any help or assistance he was able to furnish would be called to the attention of the U. S. Attorney with a view toward obtaining him a parole. TARTAKOW stated that during his last interview he brought up this subject to SAS William F. Norton, Jr. and John A. Harrington, and that he felt from their answer that he was not obtaining any satisfaction for himself. TARTAKOW stated that he in no way thinks that he has been misled but that inasmuch as he was asked to furnish information during the trial which starts on the 6th of March, and which will probably last from 30 to 60 days, he would be very nearly at the end of his sentence at that time anyway. It is noted that TARTAKOW has 114 days left to serve and that he will be released from the Federal House about the 11th of June.

TARTAKOW stated that he desired to drop his relations with the Bureau for two reasons: one, he stated that the death of his son has upset him very much and has caused him to be very bitter toward his prison sentence inasmuch as he had not seen his

son in about two years and that he only saw him for a few hours after he had died. He stated the second reason was that he had become a very intimate confidant of ROSENBERG. He stated that in his opinion he was as close to ROSENBERG as anyone could possibly get and that therefore he was in an excellent position to obtain information from ROSENBERG. He stated that he realized the importance of this case and that therefore he feels that any information he might obtain from ROSENBERG would be worth a great deal.

TARTAKOW stated that he will only continue furnishing information to the Bureau if arrangements are made to obtain a parole for him at the earliest possible date. He advised that he does not have any desire to remain in the prison and to furnish daily "cribs" to Bureau Agents with reference to ROSENBERG's reaction to points which are brought up in court during the trial each day. He stated that should a parole be obtained for him he would gladly voluntarily furnish the Bureau with all the contacts of ROSENBERG which he knows ROSENBERG will furnish him, and will perform any duties requested of him by the Bureau.

TARTAKOW proposed a second alternative wherein he requests that a special ten day parole be obtained for him prior to the beginning of the ROSENBERG trial on March 6th. TARTAKOW stated that he desired this parole in order to return to Phoenix to re-visit his son's grave and to assist his wife in moving back to New York City, which she has expressed a desire to do. He stated that if this special ten day parole were arranged, he would gladly return to the prison on or before March 6th and furnish the Bureau with anything and everything which comes to his attention during the ROSENBERG trial.

TARTAKOW stated that ROSENBERG had confided in him during the last two days that ROSENBERG expects two friends from South America to arrive in Miami who are to assist him in beating the rap in this case. According to TARTAKOW, ROSENBERG has given up all hope of beating the case in court and fully expects a conviction and a long sentence. TARTAKOW stated that ROSENBERG informed him of this plan regarding the two friends who are to arrive in Miami and talked about it in such a way as to give the impression that it was only a wild hope. ROSENBERG intimated that he expects to get out on bail subsequent to the end of the trial and to flee to Russia.

TARTAKOW stated that funds are arriving in ROSENBERG's account and specifically referred to an incident last week in which, according to the way it was related by ROSENBERG, a bonded messenger arrived at the office of WANNY BLOCK, ROSENBERG's attorney, with a package containing small bills in the amount of \$3,000 to \$5,000. This package allegedly came from a BUD WHITE, of Rutland, Vermont, and it also contained a note stating that the money was a gift and to be used for a civil liberties case at the discretion of BLOCK.

According to ROSENBERG, BLOCK wrote back saying that he intended to use the money in the ROSENBERG case inasmuch as he considers it one of the leading issues of civil liberties violation. This letter was returned to BLOCK marked "Unknown at this address." According to TARTAKOW, the money was deposited in ROSENBERG's bank account and the information concerning the letter and the bonded messenger was all set up as a hoax in order to establish the source of the money.

TARTAKOW stated that ROSENBERG informed him that if he were successful in obtaining a parole, he was to go to work for ROSENBERG and that he was to be furnished BROTHMAN's personal automobile, which is presently impounded by the Government, but that BROTHMAN's attorney has stated he will institute action to have it released.

TARTAKOW's attention was called to the fact that during a prior interview he informed Bureau Agents that ROSENBERG had been arrested in New York some years ago. It was pointed out to TARTAKOW that all efforts to locate a record of this arrest have met with negative results. TARTAKOW stated that he was positive that this information was correct and that he would determine from ROSENBERG more complete information with reference to the arrest in order to definitely establish it. He stated that he would furnish this information to the writer in any case, even though subsequent interviews are not held with him.

TARTAKOW was informed that his statements would be discussed at the office and brought to the attention of the U. S. Attorney and that he would be advised of decisions reached.

TARTAKOW requested an interview on Saturday, February 17th, and he was advised that he would be contacted.

JEROME TARTAKOW was interviewed on this date at the Federal House of Detention as requested by him on February 16, 1951. He stated that he had been considering the matter of cooperating with the Bureau with reference to JULIUS ROSENBERG and that he felt that unless he was granted the ten-days special parole which he had requested he would not furnish any further information to the Bureau.

He stated that he desired this parole in order to fly to Phoenix, Arizona, to assist his wife in closing their home at Phoenix and to move her to New York City. He stated that his wife's mother, Mrs. WEISS, is presently in Phoenix with his wife and that unless he can intervene, his wife will return to New York to live with her mother. TARTAKOW stated that this is a very undesirable situation for him inasmuch as he does not get along with his mother-in-law, and that since he expects to be released in June, he does not wish to face such a situation. He claimed that if he is allowed to journey to Phoenix he can bring his wife back to New York City and get her a job wherein she will be self-supporting and can live along until he is released.

TARTAKOW stated that his wife plans to fly from Phoenix on Wednesday, February 21st, arriving in New York City on Thursday, February 22d. He stated that if he were to be granted this special parole it would be necessary for him to leave New York City by at least Monday, February 19th.

It was explained to TARTAKOW that a special parole which he has requested would be very difficult to arrange and inasmuch as the time to arrange it in was so short, the possibility of his being granted such a parole was very remote.

It is noted that on the previous day when this demand was made by TARTAKOW the possibility of a special parole was discussed with Warden E. E. THOMPSON by the writer and Warden THOMPSON advised that during his years of service with Federal institutions he had not heard of such a thing. It was the Warden's opinion that it would be very difficult to arrange such a special parole.

TARTAKOW stated that he has no desire to continue his interviews with Bureau Agents and that he feels that he has too many responsibilities of his own and too much on his mind to assume any obligations with reference to reporting information concerning JULIUS ROSENBERG. He stated that unless some substantial consideration is made to him for such a service, he does not desire to pursue the matter any further. The question of monetary remuneration was not discussed with TARTAKOW inasmuch as it was felt that any suggestions made by him would be far in excess of any reasonable amount.

TARTAKOW advised that according to his promise he had reinterviewed ROSENBERG relative to an alleged arrest, and he stated that he learned the following information from ROSENBERG:

TARTAKOW stated that while ROSENBERG was a student at the College of the City of New York he was arrested during a riot or demonstration relative to the Ohrbach Department Store strike. He did not recall the year in which this occurred nor the specific date. ROSENBERG was allegedly single at this time.

Subsequent to the arrest he was freed on bail and on a later date was sentenced to two days in jail or \$50. fine. ROSENFERC and another student of City College, who was arrested at the same time, both accepted the two-days jail sentences in lieu of the \$50. fine at a court held on either Second Street or Second Avenue and served the two days' sentence in the Tombs.

It is suggested that in view of TARTAKOW's present state of mind due to the loss of his son he not be interviewed for a period of at least a week to ten days.

He said that in addition to the above listed duty it was also ~~expected~~ <sup>expected</sup> that he perform some evening and week-end work at the plant which was located at 370 E. Houston St., NYC, whereby he might familiarize himself with the machinery business.

Goldstein said that during the summer of 1947 he could not devote too much time to the business and for this reason the other partners decided to buy his interest in the G. & R. Engineering Co. He advised that the other partners without ever consulting him sent a notification via mail that the other partners have agreed to pay him for his share in the company and that his services are being terminated. He believed that he received this termination notice sometime during the latter part of 1947. He said that after being paid for his interest in instant concern, Rosenberg asked

could employ a full time accountant to take over the work. He stated that he served in this capacity for approximately six weeks at which time he severed all connections with the H & R Co. Goldstein further advised that he no longer has possession of any book or record pertaining to any phase of work conducted by the H & R Co.

Goldstein stated that at the time his services were terminated the H & R Co was not doing a prosperous business and Rosenberg decided to accept one David Schien as a new partner for the company in that it was reputed that David Schien was a wealthy individual. Goldstein said that he later learned that Schien replaced him <sup>(Goldstein)</sup> as a partner of instant concern. Goldstein further advised that he had never met David Schien.

Mr. Goldstein went on to say that during his association with Rosenberg & David Greenglass he never had reason to believe they were in any way connected with any subversive groups or particularly involved in espionage on behalf of the Soviet government.
