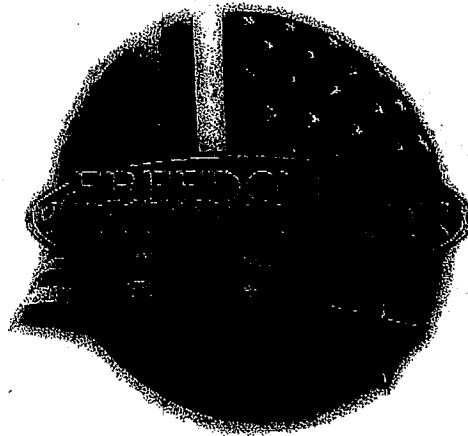

By letter dated Nov. 27, 1951 George P. Murdock, Professor of Anthropology, Institute of Human Relations, Yale University, submitted to this office literature distributed by the above captioned committee which listed its address as 17 Murray St., New York 7, New York.

This literature consisted of a letter which was dated Nov. 21, 1951 and which was signed, "WILLIAM B. HEUBER, Provisional Chairman" and was addressed, "Dear Friend". This letter requested contributions to be forwarded to the above mentioned committee and stated that the ROSENBERG case was likened to the Dreyfus and the Sacco-Vanzetti cases.

Attached to this letter, which was mimeographed, was a mimeographed statement which decried the conviction of the ROSENBERGS. Among the signers of this letter were Dr. JOHN MARSALKA and Dr. GENE WELFISH.

Dr. MURDOCK, in his letter of transmittal, advised that he knew Dr. MARSALKA slightly and mentioned that the only member of the Committee whom he knew really well was Dr. WELFISH. MURDOCK remarked that he had every reason to believe that WELFISH was a "confirmed Communist".

The New Haven Office is origin in the case entitled "JOHN PAUL MILES MARSALKA - IS-C". MARSALKA is National President of the American Slav Congress which has been cited by the Attorney General as coming within the purview of Executive Order 9835.

It is to be noted that the signature of Dr. JOHN MARSALKA was typewritten on this mimeographed release, while the names of the other seven individuals were mimeographed. It might be that Dr. MARSALKA is the person responsible for distributing these locally.

Enclosed for the information of the New York Office is the letter and the mimeographed release sent out by the above captioned Committee.

Informant advised today that he had been in touch with NAOMI BROTHMAN on 12/8/51. She advised him that she had sent a money order to EMANUEL BLOCH for \$100.00 under a fictitious name. She advised that she put a note in the envelope telling MANNY "This is part of money I promised [redacted] I would send you."

Informant called BLOCH and told him that he should expect the money order from BROTHMAN.

On 12/11/51, BLOCH told informant that he had received the money order from BROTHMAN and that he was putting the money in a legal fee fund and not in the fund being raised by the National Committee to Free the Rosenbergs.

On 12/12/51, informant went down to BLOCH'S house and BLOCH gave him a copy of his brief. BLOCH told him that he had collected about \$3,000.00 and that money was still coming in. He told informant that they had a headquarters in the Guardian Building, 17 Murray Street, New York City, with one full time employee.

BLOCH asked informant if he would be willing to spend about two nights a week helping to address envelopes and send out literature for the Committee. Informant stated that he would give as much time as he could. BLOCH advised informant that they had not as yet obtained a National Chairman for the Committee and that he was still looking around to find a reputable person.

One "Lena", apparently a sister, is heading up a group to distribute pamphlets on the Lower East Side.

Bernard Greenglass recently visited Ethel Rosenberg. Their conversation concerned the Rosenberg children for the most part. However, he told Ethel that he had a visitor who had formerly been "our very good friend". He is now making money "hard over fast" and stands ready to help in any way. Both Ethel and Bernard appeared very secretive during this part of the ~~conversation~~ and made a point not to mention this individual by name. ~~_____~~ considered this unusual for Bernard who has been "open and above board" in the past. In this connection during Bloch's visit with Julius

Rosenberg, Julius warned him several times not to antagonize "Bernie" as he may be very useful later on.

Informant advised that Mrs. ROSENBERG is living at Apartment 2A at 2436 Laurel Hill Terrace, in Washington Heights, New York City.

Informant stated that BLOCH told him that he had been very busy preparing for the argument of appeal of the ROSENBERG case and that was the reason that he had not been in touch with informant. Judge Irving Kaufman on January 28th turned over to me the attached letter received by him from Dr. Horace B. Davis, 4121 Forest Avenue, Kansas City 4, Mo., for such consideration as we deem appropriate.

At the same time Judge Kaufman informed me that Mr. Samuel Schneirson of 145 Central Park West, who is connected with the Jewish Welfare Board, informed him that during the time the Rosenberg children were being handled by this Welfare Board they appeared to be in a very maladjusted state of mind. The older boy particularly seemed to have developed a complex and allegedly stated that he was going to devote his life to avenging his parents. Judge Kaufman was wondering whether he ought to send for the boys and talk with them. I told him I would make a little check as to what we knew about these children and someone would get in touch with him later regarding this. I mentioned the above to Supervisor Granville who said he would take care of this.

On 1/21/52, informant advised that on Sunday, 1/20/52, he drove JULIUS ROSENBERG's mother to visit him at Sing Sing Prison. Mrs. ROSENBERG was alone. Informant advised that it was difficult to carry on a conversation with Mrs. ROSENBERG because she speaks very little English and can only speak Yiddish. He picked Mrs. ROSENBERG up about 11 a.m., left her at Sing Sing about 12:45 p.m., and returned and picked her up about 3:30 p.m. for the return trip to New York.

She advised informant that both JULIUS and ETHEL ROSENBERG appeared to be in good health and spirits. She advised informant that she had received a letter from JULIUS talking about [REDACTED] and how wonderful he had been to both JULIUS and ETHEL. She told informant that JULIUS wanted him to get in touch with EMANUEL BLOCH. She asked informant what he thought about the case and how soon did he think JULIUS and ETHEL would be released. Informant stated that the greater part of the conversation going to and from Sing Sing that Mrs. ROSENBERG engaged in was how soon the ROSENBERGS would be released from jail.

Informant advised that about 4:35 p.m., he arrived at Mrs. ROSENBERG's residence to see WILLIAM RAUBER, reporter for the "National Guardian", driving away from the house with the ROSENBERG children.

Informant was asked whether he had received any further information from BLOCH or any other source concerning BERNIE GRADSTONE, HERMAN GOLDFARB or IRVING and BEATRICE SAVLOWITZ. Informant stated that BLOCH has never discussed these people, and particularly no mention has been made of GOLDFARB, since his efforts last year to locate GOLDFARB and secure from him the \$1,000 that ABRAHAM BROTHMAN supposedly had given to GOLDFARB for the publication of "Retort" or other use for the ROSENBERGS.

Informant stated that during all his conversations with BLOCH concerning the publication of the articles in the "National Guardian" and the formation of the National Committee to Secure



He stated he believed that if BLOCH had intended to use any of these people on the Committee, he would have been advised of such fact. He stated, however, that in the event BLOCH does mention these people, this office will be promptly advised. He also stated that he intended to get in touch with BLOCH on the evening of January 21 or January 22.




