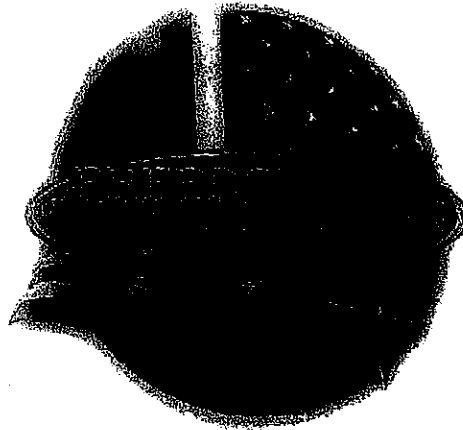

Subject has been a CP member since 1930 and has held numerous important party positions. Since approximately 1941 he has used the name JOHN LAVIN, in connection with his CP activities and is now a member of the CP underground apparatus. He is also reliably reported to be in charge of the CP disciplinary committee and counter-intelligence.

Confidential Source [redacted] advised that on 12/9/52 GERTRUDE LEVINE, 979 Hopkinson Avenue, Brooklyn, New York, wife of subject and an active CP member, was informed by an unknown man that it would be impossible for him to be with her that night, as he had been given "responsibility over something", and that night was the only time the work could be done. He stated "the other gal" also would not be there. This individual further stated that he considered the "ROSENBERG question" was being miserably mis-handled, and that a concrete obligation should be instituted for everyone that night, and that there should be one or two people who "will check every day in reference to Saturday night and Sunday". GERTRUDE LEVINE asked him what time it would start Sunday and the man said the train was at 10:30 and the cars should leave at 9:00, that "a mobilization" was planned for 9:00.

The man then informed GERTRUDE LEVINE that there would be a rally on the 18th and said that they must be guaranteed an organizer. He then instructed GERTRUDE LEVINE to spend at least half an hour that night on the matter of the rally "after the other business" had been concluded. In the opinion of this Informant, the "ROSENBERG question", referred to above, pertained to the Bureau case entitled JULIUS ROSENBERG, was ET AL ESPIONAGE-R.

This Source further advised that on 12/10/52, GERTRUDE LEVINE asked RUTH LINZER, 133 51 Street, Brooklyn, New York if she could get away the morning or the afternoon of 12/11/52 to go to the trials, apparently referring to the current trial of CP leaders, New York City. RUTH LINZER informed GERTRUDE LEVINE she had thought of going to the trial on 12/10/52, but would inform GERTRUDE on the morning of 12/21/52 if she could go to the trial on that date.

Judge IRVING KAUFMAN telephoned me, 12/29/52, to advise that he had, earlier on that date, talked with Assistant to the Director D. M. LADD relative to his mental alarm because of the terrific influx of mail and telephone calls in the ROSENBERG matter. Judge KAUFMAN stated that he, personally, had no fear and marveled at the composure of his wife but did think that it might possibly be desirable for the next several days to have increased alertness on the part of the New York Police Department in the proximity to his home, which he described as Apartment 5-A, 1185 Park Avenue. I discussed with Judge KAUFMAN the type of protection he felt he desired and indicated that of course Commissioner MONAGHAN would probably want to call him or have one of his officials call him relative to the type of protection to be afforded and might desire to even see the children so that the protecting police would recognize the youngsters when they saw them on the streets. Judge KAUFMAN stated he knew Commissioner MONAGHAN and would be very happy to talk to Commissioner MONAGHAN. We both agreed it was very essential that the entire matter be handled discreetly.

I telephonically contacted Mr. LADD and told Mr. LADD I could see no reason why I should not extend courtesy to the Judge and call Commissioner MONAGHAN. Mr. LADD agreed this was satisfactory.

I thereafter called Commissioner MONAGHAN and presented the situation to Commissioner MONAGHAN, emphasizing the necessity for the entire matter being handled discreetly. Commissioner MONAGHAN stated he would be more than happy to afford the Judge as much assistance as was desired. Commissioner MONAGHAN stated he would either personally get in touch with Judge KAUFMAN or have one of his officers get in touch with Judge KAUFMAN in the immediate future.

DEVELOPING A MOVEMENT
IN CANADA TO SAVE THE
ROSENBERGS.

EDITH ROSENBERG, member of the National and N. Y. State Committee of the Civil Rights Congress, [redacted] that "a strong movement" is being developed in Canada to help saving the lives of ETHEL and JULIUS ROSENBERG. She [redacted] that the National Committee (U.S.A.) to Save the Rosenbergs asked some trade unions and Jewish mass organizations in Toronto, Canada to start a movement in Canada to save the ROSENBERGS. The IKUP organization and the Jewish Peoples Fraternal Order of Canada "got busy" immediately and as a result of these activities a conference was held in Toronto, Canada on October 28, 1952.

Some 150 people representing different trade unions and mass organizations participated in the conference. The conference adopted a program of activities which included the visiting of all kind of organizations in Canada and asking them to join in the movement to save the lives of the ROSENBERGS; to mobilize public opinion for the ROSENBERG case; individuals and organizations from all over Canada will be urged to send telegrams to the U. S. Supreme Court and to President TRUMAN demanding a new trial for the ROSENBERGS and to set aside the death penalty.

The October 28th conference also decided to organize a large delegation of representatives of different organizations for the purpose of visiting the American Consul in Toronto demanding presidential clemency for the ROSENBERGS.

EDITH ROSENBERG [redacted] that the movement to save the ROSENBERGS "is now world-wide. This movement is now sweeping every country in the world. The Communist parties, the Federation of the World Trade Unions and many peace and cultural organizations throughout the world are responsible for the world-wide movement to save the ROSENBERGS."

Mr. Russo, reporter for the Sunday Herald, main office Bridgeport, Conn., called 1/7/53 to advise that he is the reporter for the aforementioned paper stationed at Stamford, Conn., telephone no. 486728. He stated that he was desirous of knowing the date and place of the arrest of Julius and Ethel Rosenberg. He then inquired as to whether or not the landlord had been interviewed. I asked him what landlord he had in mind and without answering my question he then said, "Well, Charles Cooper who owns a studio in Stamford, Conn., and has been a carp carrying Communist for years was telephoned by me recently in connection with the Rosenberg matter and as soon as I started talking to him about the Rosenbergs Cooper 'blew his stack' and didn't want to answer any questions or have any connection with the Rosenberg situation." I told Mr. Russo that I would see that he was called in response to his inquiry.

I thereafter talked with Mr. Wick in Mr. Nichols' office, apprised him of the above conversation, and suggested that inasmuch as the date and place of the arrest of the Rosenbergs was information which had previously been publicized I saw no reason why I should not answer Russo's inquiry. I told Mr. Wick however that inasmuch as the newspaper was located in the New Haven area I should advise New Haven first to see what they knew about the paper and more particularly Russo, second to ascertain if there was anything of any significance in the Rosenberg case that might be of interest to us and third, see that they watched this particular paper to see what articles might be appearing in the newspaper in the next several days that might be of interest to us. Mr. Wick concurred, stating that he thought in any event I should be the one to call Russo back and then suggested that I talk to Mr. Belmont. I talked with Assistant Director Belmont, apprised him of the above, and he concurred.

I then talked with SA Jack Powell, acting at the New Haven office. SA Powell recalled that the Sunday Herald, Bridgeport, Conn., is the scandal sheet of the State of Connecticut; that the office knows something of Russo and knows that they are always digging into sensational news. I asked Powell what he knew about Charles Cooper and he stated that he has a vague recollection concerning Charles Cooper so I suggested that he check their files and see if there is contained therein anything of significance concerning Cooper and that he should call me by 2:30 if there was anything of significance in their files inasmuch as I contemplated calling Russo by 2:30.

While talking with Powell, Mr. Wick called to advise that the Bureau's records reflected that in 1940 the Sunday Herald was considered to be the Daily Worker paper in Connecticut; that I should therefore be most circumspect in my conversation with Russo at the time I called him and he again wanted to be sure that I was the one to call Russo. I told Mr. Wick that I would furnish him only the date and place of arrest but that if any opportunity offered I would endeavor to find out what his interest was. Mr. Wick agreed that this would be satisfactory.

Shortly thereafter Mr. Powell again called from New Haven and stated that they have a [redacted], as does New York [redacted] (69486) on Cooper, indicating that Cooper was a [redacted] and admitted having been a member back in 1937; that he is a Security Index subject; that he owns the Peter Gale Studio, Stamford, Conn. In the interim SA Jack O'Brien, Section 0, NYO, advised that the Rosenbergs had lived at the Knickerbocker Village from 1942 to the time of the arrest.

I thereafter telephoned Mr. Russo, advising that Julius Rosenberg was arrested 7/17/50 at 40 Monroe St., Apartment GE 11, Knickerbocker Village, that Ethel was arrested in front of the US Court House 8/11/50. As soon as I had furnished the above information Mr. Russo said thanks, very much, that he appreciated the information; he said "Oh, in case you're interested and have a couple of minutes I would like to tell you that during the time the Rosenbergs were endeavoring to gain sympathy and also during the time that there was a lot of propaganda concerning the Rosenberg sentence of death, our newspaper received some letters to the editor from persons who obviously were sympathetic to the Rosenbergs, so I went out and interviewed some of these people, asking them how they could reconcile the detailed careful treatment being afforded the Rosenbergs in the US with the manner in which the persons being tried by the Communists in Czechoslovakia had been treated." Russo said that "some of the answers I got were quite interesting, one of them saying that there was no particular connection between the two cases." Russo then said "In any event the information I got from these interviews was sufficiently good for me to write a couple of articles which resulted in these people moving from where they lived." He said "of course we know where they moved to so it didn't make any difference anyhow." I thanked Mr. Russo for the information without comment.

I suggested to SA Powell while talking to him that the Sunday Herald be followed for the next several days for the purpose of determining whether any articles of interest to the NY office or the Bureau in the Rosenberg case might appear in said paper and to keep us properly advised.

and protest. This honorable demonstration by 1,500 marchers symbolized the arousal of the honest masses in the United States and of all nations, who demand that the murder of these two innocent parents of two small children, not be committed!

The author of these lines joined delegations which held conferences with the Congressmen from Ohio, Michigan and Pennsylvania.

With the exception of a few Congressmen, the greater majority listened to the delegations with sympathy and promised they would help influence the President to change the sentence. Finnegan, of Ohio, was the only Congressman who tried to engage in red-baiting.

The delegations from New York, Illinois, and other states had the same experience with their Congressmen.

The spirit of the Washington demonstration should now be spread to every corner of the land. Save the lives of these innocent victims of war hysteria!

On January 8, 1953, Dr. JOHN W. HOLLISTER, District Superintendent of the Methodist Church, 1580 Quarrier Street, Charleston, W. Va., furnished this office with a mimeographed letter which he had received from Sponsoring Clergymen, Box 136, Madison Square Station, New York 10, N. Y. Said letter also contained an enclosure identified as an open letter to the President which the recipient of the letter was to sign and forward to President TRUMAN. The Sponsoring Clergymen are apparently 11 in number and their names appear on the mimeographed letter received by Dr. HOLLISTER. Both of the above pieces of mail are enclosed herewith for the information of the New York Office.

On January 10, 1953, this office was in receipt of a note from WILLIAM VERNER NELSON, Pastor, First Christian Church, Arch and Montgomery Streets, Pittsburgh 12, Pa., which enclosed duplicate copies of the above-mentioned letters from the Sponsoring Clergymen.

Reverend NELSON advised in his note that the Sponsoring Clergymen were apparently duped into using their names for what appeared to them as a worthy cause. He stated that one of the Clergymen, ROBERT M. HOPKINS, was very well known to him and that he considered HOPKINS 100% American. The material furnished this office by Reverend NELSON is being retained in the Pittsburgh files since it is identical with the material furnished by Dr. HOLLISTER.

Civil Rights Congress Activities

Re: The Rosenberg Gleneney Train to Ossining.

The last figures which were given to me by MOLLY, bookkeeper for the N.Y. State and National Civil Rights Congress, show that 753 people participated in the Ossining, N.Y. demonstration for the ROSENBERGS.

The "Gleneney Train" for Ossining, N.Y. left the N.Y. Grand Central Station on the morning of Dec. 21st, 1952. 715 people paid the rail road fare of \$2.42. The rest, C.R.C. functionaries and some Negro "Captains" didn't pay any fare.

While on the train

Just the same this group was in a nervous tension. Different groups in it and in other cars of the "Gleneney Train" were talking and singing. Most of the songs were "working class" revolutionary songs.

Women were in the majority. About 3/4 were youth. There were about 50 Negro men and women. The Frank Women's Forum had some 25 members on the train. The Jewish Peoples Fraternal Order had a large number of members on the train. We were told on the train (by MEXX, a Negro train captain) that every I.W.O. National Group had representatives on the train. Every C.R.C. chapter in N.Y. and of the boroughs, New Rochelle, etc. had delegates on this train. Walking through the "car train, looking over the people, I saw many more than 100 members of the Communist Party.

The majority of the delegates in every car were members of the C.P. and the rest of them were left-wingers, C.P. sympathizers.

On the train W. BUTLER told the speakers that no one of them will be introduced. That one speaker will follow another and that he will be the last speaker. He told GUBREX GROSSMAN to leave the train as soon as it will stop and talk to the police to the order of the march to the prison. ELLIOTT ROSS, A. WALDICK and BESSIE MITCHELL were told to see that all those emerging from the train be lined up by the Captains in two's and when leaving the train to line up in four's.

When the train came to a stop at about 12:15 P.M. this order was observed. On the train the marchers noticed the "police horses" and groups of policemen at different streets and PATTERSON exclaimed: "Oh, Oh! There is our reception committee!" The marchers stopped before the "police horses" which barricaded the train off the streets and PATTERSON with GROSSMAN started negotiating with the Chief of Police. After some minutes of negotiations PATTERSON, through a police loud speaker, told the crowd the police wouldn't let the marchers go to the prison; that the marchers will have to stop at a barricade up the street, turn back and assemble at the square near the Railroad station where the meeting will be held. He asked the crowd to observe discipline, to be orderly, etc. The police barricades were removed and the march started. Half way before the last police barricade the marchers started singing The Star Spangled Banner and the Battle Hymn of the Republic and some other songs. The marchers also chanted "The ROSENBERGS shall not die."

From the train up the street to the police barricaded and back to the square the marchers were led by WM. PATTERSON, the speakers and C.P.C. functionaries carrying a large floral wreath with the inscription: "Greetings to JULIA and ETHEL ROSENBERG from the people." There were also a few small bouquets of flowers and a large banner with the inscription: "Save the ROSENBERGS."

The meeting started after the marchers gathered in the square near the Railroad station.

KAREN MORLEY said in her speech that the ROSENBERGS are not guilty. She demanded presidential clemency and stated that although the marchers were not permitted to go to the prison walls "the ROSENBERGS hear us and so does President TRUMAN" and the judges and the American people and the people of the world.

HOWARD FAST made a "strong" speech in which he called the administration of President TRUMAN "bloodthirsty." He declared that "No government as such a record of legal murders and legal lynchings as the U. S. Government in the past seven years." He said that he came here "to protest murder and terror which has become a policy of HARRY TRUMAN."

^{McGEE}
ROSALIE ~~McGEE~~ stated that the government knows that the ROSENBERGS are innocent; that the purpose of the conviction of the ROSENBERGS was to spread Anti-Semitism in the U. S. just as the conviction and execution of her innocent husband was to spread Anti-Negroism in the country. She called upon the people to fight for the ROSENBERGS until they are free.

WILLIAM PATTERSON told the meeting that "We gathered here to express our love to the ROSENBERGS." Also: "We have also a selfish reason for being here: the conviction and planned execution of the ROSENBERGS is putting in danger the safety of everyone in America. We came here to save the ROSENBERGS and the Bill of Rights." He also said that "while we are marching here to save the lives of the ROSENBERGS millions of people throughout the world are marching with us today. We are determined that the cold war crimes shall not take place." He also stated that the people of the U.S. have in their hands "not only the lives of the ROSENBERGS, but also the future destiny of this country." He told the meeting that it isn't the fault of the police that the demonstrators weren't allowed to march to the prison. He said that the police received orders to this effect "directly from Washington". The crowd sang Star Spangled Banner and a song of the Warsaw Ghetto. After the meeting a group of seven were taken in a police car to "present the flowers to the ROSENBERGS."

This group includes WILLIAM PATTERSON, KAREN WADLEY, ROSALIE McGEE, ABBEY CROSSMAN, ELLAINE ROSE, BESSIE MITCHELL and HOWARD PACT. When the delegation of seven returned to the square Mr. PATTERSON told the crowd: he left the flowers for the ROSENBERGS. Although we couldn't see the ROSENBERGS, I pledged on your behalf before the prison walls that we will continue our fight for the lives of the ROSENBERGS and for peace and democracy. This magnificent demonstration will lift the morale of progressive America." Because of the rain the crowd went into the waiting room at the railroad station, where they sang different songs, including "PATTERSON is our leader, we shall not be moved." For the return (to N.Y.) trip the railroad manager added 2 more cars to the "Clemency train." The train left for N.Y. at 2:40 PM.

On the train EDITH ROSENBERG (of the C.R.C.) proposed the appointment of committees for the purpose of selling tickets for the Manhattan Towers meeting which will be held on Dec. 23rd, 1952 "to greet the ROSENBERG delegation and to send off the Christmas delegation to visit Mrs. INGRAM." While selling tickets for this meeting the people should be informed that at this meeting movies of the ROSENBERG delegation will be shown. PATTERSON and the others agreed with this proposal. Each train was notified and committees were organized.

The committees were selling tickets for the Manhattan Towers meeting (24 tickets were sold); collecting money for the delegates to visit the political prisoners on the booklets of the "Holiday greetings" (11 dollars was collected) and collecting funds "to continue the fight to save the ROSENBERGS" (\$7.00 was collected).

Talking about the effect this demonstration will have on

the ROSENBERG's case, PATTERSON, GOODMAN and PAST expressed their belief that this demonstration will have a lot of publicity "bad or good one - the case will be brought to the people" and "spies and murderers are not being visited by a delegation of 500 people carrying flowers; the people will take notice of this fact" - EDWARD PAST. PATTERSON and others made favorable comments on the politeness of the police. PAST said: "No. They are brutal beasts." PATTERSON said: "WASHINGTON was afraid of a second Peekskill.", etc.

AUBREY GOODMAN told me that the National Committee for the ROSENBERGS did not (officially) participate in the Ossining Demonstration and it will not participate in the Dec. 23rd meeting (Vanbetta Towers). He said that many members of the ROSENBERG National Comm. are "confused on these and many other points and issues. They are afraid that this kind of demonstrations, etc. might have a bad effect on the Clarence plea."

CONGRESS ACTIVITIES

Re: Mass meeting to greet the "clemency train" delegation to the Rosenbergs.

The N. Y. State Civil Rights Congress held a mass meeting to greet the delegation to the Rosenbergs of Dec. 21st, 1952, at the Manhattan Towers Hotel in N.Y.C. on Dec. 23rd, 1952.

The chairman of the meeting was Elaine Ross, head of the N. Y. State C.R.C. She opened the meeting with a short report on the Rosenberg delegation of Dec. 21, 1952. She said that the people of the world "took notice" about the visit of 800 people to the Rosenbergs and that "we brought the Rosenbergs case to the people of America through the press which was compelled to tell the readers that 800 Americans came to greet the Rosenbergs with banners and with flowers." She said that "the Rosenbergs are lonely but they are not alone. Millions of people in this country and the world over are with them." She stated that "the Rosenbergs are innocent victims of the cold war" and that "the fight to save their lives will go on until the Rosenbergs will emerge from the prison as free people."

Leon Straus spoke of the war Korea "as an attempt by the wall Street imperialists to control or to destroy Korea." He said that "while Russia, China and the Eastern democracies are marching to freedom the reactionaries of this country are leading the march towards Fascism and war." He stated that "the same forces that killed Sacco and Vangetti are now trying to kill the Rosenbergs. These reactionaries are also trying to destroy the labor movement in this country." Straus declared that "the Rosenbergs are innocent victims of the Truman cold war" and he called upon the labor movement to "put all its energy during the next few weeks to save the lives of the Rosenbergs." He urged everyone to go to the shops, neighborhoods, etc., to talk about the Rosenberg case and make the people demand that the President should extend executive clemency to the Rosenbergs. "The people must be made conscious of the fact that the Rosenbergs are innocent and that the Jewish question has played a big part in the conviction of the Rosenbergs."

Emily Alman said that at this moment "we are interested only in the saving of the lives of the Rosenbergs. The question at the present moment is not their guilt or innocence. Their

lives are at stake and we must save their lives."

She outlined a program of immediate action which included: organization of mass meetings by all groups working to secure clemency for the Rosenbergs; advertising in newspaper; securing the cooperation of mass organizations and influential individuals in the fight for clemency for the Rosenbergs; to secure the participation of labor, religious and professional groups in the national clemency delegation to Washington on Jan. 5th, 1953; to secure the participation of people from every city and town in the 24 hour vigil at the White House starting on Dec. 27, 1952 until "we win clemency for the Rosenbergs"; to send delegations to every Congressman and Senator, to Governors, Mayors, Doctors, lawyers, etc; to organize large scale distribution of material on the Rosenberg case; door to door visits of all the neighborhoods and the solicitation of letters and telegrams to the President. She appealed to everyone to participate in all of these actions. "We still could save the lives of the Rosenbergs if we will put all our energy into this fight."

Chairman: calls upon everyone present at this meeting to go to the prison to sing Christmas carols to Elizabeth Flynn on Dec. 24th, between 4:45 and 6 p.m.

Chairman asked that all those that participated in the "clemency train" delegation should rise. About 50 people rose. They were greeted by handclaps. The same happened when she asked the Rosalee Ingram delegation of "12 women" to rise. (One of the Ingram delegates was Bell Sondin. She was the same person who chaired the C.R.C. conference on the Rosenbergs which was held at 23 W. 26 St., N.Y.C.).

Karen Morley read the speech to the jury on "Evils of War" made by Sacco during the trial of Sacco and Vanzetti. She told the meeting that this speech of Martears will always be timely." She told the meetings: It's too late to be afraid. We must fight reaction on every front."

Marilyn Morris (negro shop steward of local 65 Warehouse Union) said that "as long as the Rosenbergs are in jail none of us is free." She spoke about the war in Korea where "negro and white boys are dying for Wall Street" and "should the Rosenbergs be executed the next step will be the smashing of the labor movement and the 3rd World War will follow. This is the pattern of Fascism. For our own safety and for the

safety of the people of the world we must fight to free the Rosenbergs."

Carl Marzani said that "the fight for the Rosenbergs is a test of the power of the progressive movement in the United States. The world is watching us. We must not fail in this supreme struggle against Fascism in this country. He called for donations "to fight to save the lives of the Rosenbergs." The collection was \$511.25. (The money went to C.R.C. for paying of wages and some bills).

Betty Gannett said that "800 million people already have achieved the freedom we are fighting for today in our country" and she underlined that "our job today is to enlighten the people of our country; to tell them the truth about the real aims of this government." She said that "Washington would never care to go on with the war preparations if the people would start demanding peace. Our job is to make the people demand peace." She spoke about the trial of the N.Y. Communist leaders and she said: "Our trial will come to an end in the middle of Jan. 1953. We have no illusions about the outcome of the trial, but at the present moment we consider the Rosenberg case is of greater importance. Lets fight to save the lives of the Rosenbergs. Lets fight for peace. Lets fight against the Smith Act."

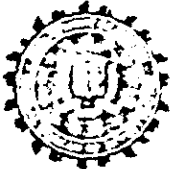
William Patterson repeated in most part the speech he made in (illegible) on Dec. 21st, 1952. He added some remarks that "the Rosenberg case carries the seeds of Fascism... The Rosenbergs symbolize the nature of the struggle we are in... We are in this fight (for the Rosenbergs) not for humanitarian reasons...the tempo of the will of our fight will decide the faith of democracy in our country...ours is a political struggle ...we fight for the Rosenbergs to save our democracy, to save the world from war and Fascism." He called upon all the people "negro and white" to participate in the vigil of Dec. 27 and "to come back and go again to Washington on January 5th and force Truman to extend executive clemency to the Rosenbergs. We must keep on fighting for the full freedom of the Rosenbergs because they are innocent."

Martha Schlamme sang the "Ghetto Song" and other songs.

Movies of the "clemency train" and of the (illegible) demonstration and march of the delegation of 800 to the Rosenbergs of Dec. 21st, 1952 were shown at this meeting by one

On January 22, 1953 Ralph Washington, Postmaster, Monticello N.Y. advised that he had received a signed letter from FANNY RUBIN, Monticello, N.Y. to receive the mail from General Delivery for the Emergency Committee of Sullivan County to Secure Justice in the Rosenberg Case. FANNY RUBIN signed this letter as a member of the Executive Committee of the Emergency Committee.

Mr. Washington also advised that he had a conversation with Alvin Benton, publisher of the Republican-Watchman, Monticello, N.Y. in which Benton admitted that he had received \$114.80 in cash for the advertisement. And that the adv. was placed by DAVID JAFFEE, of Glen Wild, N.Y. Mr. Washington said that prior to the printing of the full page adv. on Jan 16, 1953 that BENTON phoned him inquiring if the P.O. had a P.O. box that could be used for answers to an adv. Mr. Washington told him that it was not. BENTON then asked if General Delivery could be used and Mr. Washington told him that he knew of no rule against it. But BENTON never explained to him what was the purpose of the adv. Benton has now told Mr. Washington, since the printing of the adv., that JAFFE phone and bawled him out for using General Delivery, Monticello, N.Y. as the return address. BENTON claims that he has a recording of that conversation.

K. S. GINIGER, who stated he was General Manager of one of the subsidiary corporations of Prentice Hall Publishers, telephone 1/27/53, and stated that he had a "screwball idea" that he would like to present to me for such observations as I saw fit to make. He indicated that the ROSENBERG case had aroused tremendous national interest; that it would be a very useful thing if the ROSENBERGS confessed. He stated that if a book publisher were to make a substantial cash offer to the ROSENBERGS for exclusive rights to publish all their story, it might cause them to want to confess in order to have a means of financially assisting their children. He wondered what thought I might have on the matter.

I, of course, informed Mr. GINIGER that if the ROSENBERGS saw fit to confess, such statements they might make would be highly confidential and of course, could not be divulged outside of official circles until a complete investigation had been conducted and appropriate prosecution instituted as a consequence of the investigation; that only following such activity could there be any publication of anything the ROSENBERGS might say by way of confession. Mr. GINIGER stated he, of course, realized that but would merely desire, if they would put up a substantial sum of money to have exclusive rights, to publish at such time as such information was available for publication. I told Mr. GINIGER that I would be very pleased to discuss it with Bureau officials and subsequently advise him.

I telephonically contacted Inspector J. J. MC GUIRE, who stated that the FBI could in no way participate in such a plan since it would be contrary to the Bureau policy making such information available to all sources where the information is public information, as obviously a confession of the ROSENBERGS would be.

I telephonically contacted Mr. GINIGER, 1/28/53 and apprised him of the above. Mr. GINIGER stated that in the event Prentice Hall took any further action in the matter, they would keep us advised.

When this name was read, BERTHA LOHITT, a known Communist Party member, stated that GRETA OHLSEN had returned from Philadelphia and that she had seen her at the FOSTER meetings.

Confidential Informant [redacted] advised that on March 8, 1945 while at Communist Party headquarters in Rochester, New York, DON LISTER and FAY VEARD, both known Communist Party members in Rochester, discussed a meeting of the Professional Club of the Communist Party held on the previous night. Informant advised that FAY VEARD stated most of the time was spent on the Fund Drive and that the subject was in attendance at this meeting.

According to Confidential Informant [redacted] the subject attended a special membership meeting of the PCA of Monroe County held on June 6, 1945 in Parlor D, Powers Hotel, Rochester, New York. This meeting, according to the informant, consisted of a general discussion concerning the position of EARL BROADEN in the PCA.

Informant stated the supper was given in honor of HEROLD COLLINS, Jefferson School instructor from New York City. [redacted] stated the subject was present at the supper and dance which was sponsored by the CP, Rochester.

On a call from May Kessler, member of the Kingsbridge
(Bronx, N.Y.) Section Committee of the Communist Party [redacted]

[redacted] received a phone call late
in the afternoon on the same day in which she was informed
that a party (CP) demonstration for the Rosenbergs will take
place in Times Sq. (N.Y.) She was asked (by Irene, regional
C.P. director) to ask the members of the Kingsbridge Club to
be on the west side of Broadway and 45th St at 8 p.m. where
further instructions will be given about the participation in
the demonstration. [redacted]

[redacted] also received word about the demonstration and
that he was told to be at this place "for further instructions."
I saw a few more familiar faces of CP members and [redacted]

While waiting for "instructions" which
never came [redacted] remarked that he is "anoyed" to see "so many
pops. It seems that the police knew before me that a party
demonstration will take place here". Suddenly we noticed a
shower of yellow leaflets around the section of 44th St. After
a short discussion we decided to move in the direction of
44th St. and East side of Broadway. We were watching the
demonstration.

A few dozen "comrades" carrying in front of them
signs (sample enclosed) and chanting: "We demand clemency
for the Rosenbergs" were marching towards 45th St. I moved
forward 45th St; I watched a similar procedure on Broadway
and 46th and 47th St. on each of these blocks CP members
marched in circles while a voice came through a loud speaker
first from the East side of Broadway (Claridge hotel) and later
from the West side of Broadway (Astor Hotel) asking the people
to demand clemency for the Rosenbergs and the "the Rosenbergs
shall not die." While on the march the marchers gave out to
the public leaflets headlined by: "The court of appeals admits
Rosenberg trial unfair". (Sample enclosed). I saw that most
of the leaflets given to the people were thrown away by them
without even glancing on them. Very few people retained these
leaflets. I noticed Bernard Bender. (of Queens). He was
shouting the slogan "Clemency for the Rosenbergs and the marchers
kept on repeating this slogan.

At Broadway and 45th St. a policeman pulled out one of
the marchers from the line and pushed him into the side (45th)
Street.

[REDACTED] I asked him what he thinks of the demonstration. He said: "It's a fine demonstration. We figure that about 250 people participated in the demonstration."

I talked about this demonstration to [REDACTED]. He told me that the C.R.C. "as an organization" was not notified about this demonstration. He said it was "a strictly party affair" he said. He himself was notified about the demonstration in the office (on 26 St.) during the day of January the 10th. He told that he also participated in the demonstration. So did Edith Rosenberg who got a phone call on Saturday (10 th) at her home.

On my question to [REDACTED] if the Rosenberg Committee (National) participated in the demonstration he said that he is sure that "the committee as such" didn't participate in this demonstration. "I didn't notice any one of the Rosenberg Committee there, but it's possible that some individual members of the committee were in the march."

[REDACTED] said that he thinks that the demonstration was a success. "We carried the message of the innocence of the Rosenbergs to tens of thousands of people. This is of great importance at the present stage in the Rosenberg case."

I don't think the demonstration was a real success. The marchers were only a few; the public wasn't much interested; very few stopped to look over the marchers; some people who stopped for a minute or so just smiled and walked away. The police force was just watching. I consider that the only effective thing at the demonstration was the voice that came through the loud speaker.

This voice was heard for blocks away and people turned their heads towards the sounds that came through the loud speakers and I noticed many people stopped to listen. In each case the loud speakers (East and West on Broadway) came to an abrupt stop. The demonstration ended at about 8:50 p.m.

Gentlemen:

The following incident came to my attention on 4 February. A sense of humor warns me to classify it as the "Great Balloon Hoax". Since I have no means of checking on the veracity of the story I pass it on to you for what it may be worth.

Last evening I met my first class of the new Spring Semester in American Literature at Fordham University, School of Education, 302 Broadway, N. Y. C. Although I am attached here at the Academy I have been a visiting lecturer at Fordham for the past several years. One of my students, a Frederic J. Schaefer, who lives in Douglaston, Queens, asked if I would mind dropping him off at Douglaston since he knew from a previous course that I drove to Great Neck in my car. In the course of a conversation while driving, he told me of a "funny thing" that happened to him in the course of his day-time job at "the Continental-Casualty Company in New York". It seems that there had passed over his desk on that day the renewal of a policy for "Mrs. Rosenberg". When I asked him who that was, he identified her as "the Communist in Sing Sing". Upon my remarking that that was certainly strange, he said it was an accidental policy in the amount of \$100,000 for loss of life or mutilation on a "scheduled commercial airplane", beneficiary "husband Julius", \$120.00 annual premium. I need not emphasize how fantastic this sounded to me. Since Mr. Schaefer seems both young and voluble and was trying to impress me with the importance of his job, it may have been that to prove his importance he gratuitously identified a Rosenberg with the Rosenbergs. This is not at all impossible since he said he was "an underwriter", when it is obvious that his youth and inexperience would not qualify him as such. He seemed not at all to think his story fantastic, was quite positive of his identification, and is not aware that I am passing on this information.

On the morning of 2/10/53 Assistant Director A. H. Belmont telephonically contacted me to advise that Judge Irving Kaufman had called him to indicate that because of developments in instate case Judge Kaufman was again being subjected to telephone vilification and a certain amount of office bother which causes Judge Kaufman to again inquire of the Bureau as to its belief as to whether he should request police protection. I pointed out to Mr. Belmont that of course in connection with the Civil Rights discussion we were having with the NYC PD, as reported in the William J. Brennan case, the World Telegram, 2/10/53 issue, carried a headline reflecting disagreement and that as a consequence Commissioner Monaghan and Chief Inspector Rothengast were in Washington. I pointed out to Mr. Belmont that in view of that development it might be desirable to have SA Gus Micek make contact with the NYC PD in the event Judge Kaufman decides he desires police protection. Mr. Belmont stated that the matter would be presented to the Director and he would subsequently contact me.

At 3:35 PM Mr. Belmont called and requested that I contact Judge Kaufman and explain to him that while the FBI knows of no premeditated action of the Party to cause him or his family any harm it is entirely possible that some crank or crackpot may take the matter into his own hands and such a situation cannot be intelligently anticipated. I should point out to Judge Kaufman that Mr. Hoover states that after Judge Kaufman has carefully weighed the advantages and disadvantages of having police protection, if there is any doubt in Judge Kaufman's mind thereafter he should resolve in favor of requesting protection. Mr. Belmont said that in the event Judge Kaufman does so resolve that we should indicate that we will be more than pleased to make appropriate contact with the police to insure that he does receive adequate protection. Mr. Belmont stated that in his conversation with Judge Kaufman the latter indicated he had talked with CCA Judge Medina who had indicated that during the trial of the CP leaders Judge Medina had had police protection. Mr. Belmont said that I should specifically point out to Judge Kaufman the fact that Judge Medina did have FBI protection while Judge Medina was outside of the NYC limits; that should Judge Kaufman take a trip out of NYC and desire Agent protection we would be more than pleased to afford him the necessary protection. I indicated to Mr. Belmont that we would immediately make contact with Judge Kaufman. Mr. Belmont stated that the New York office should closely follow

this situation and in the event there was any indication that the Communists were threatening any of the prominent persons involved in instant matter we should immediately inform the Bureau concerning the full details.

Immediately upon the conclusion of my telephone call with Mr. Belmont I telephonically contacted Judge Irving Kaufman and apprised him that I had just finished talking with Mr. Belmont and that Mr. Belmont in turn had been talking with Mr. Hoover relative to Judge Kaufman's earlier conversation with Mr. Belmont. I apprised Judge Kaufman along the lines indicated above. Judge Kaufman stated that he sincerely appreciated the very careful consideration afforded his request and that he has decided that he will telephonically contact his wife this afternoon and if he decides he desires police protection he will thereafter contact me. It was decided between Judge Kaufman and myself that if Judge Kaufman desires protection that this office will make the necessary contact with the police authorities who in turn will then contact Judge Kaufman and arrange with Judge Kaufman for such protection as Judge Kaufman desires. I carefully pointed out to Judge Kaufman that should he leave the city and desire any protection he should telephonically inform me and the necessary arrangements to afford him protection will be consummated.

Pending the receipt of a telephone call from Judge Kaufman, no further action is being taken.

ADDENDUM:

Judge Kaufman called later on to advise that he had talked the matter over with his wife and they both desired police protection. I thereafter telephonically contacted 1st Deputy Commissioner Fristensky, advised him of the situation, and specifically requested that the fact that the police department is affording Judge Kaufman police protection should be kept entirely confidential so as to avoid newspaper publicity. Commissioner Fristensky stated that he was certain that publicity could be avoided and that he would personally telephonically contact Judge Kaufman as soon as we completed our conversation.

At 5 PM I telephonically contacted Judge Kaufman's chambers and inasmuch as Judge Kaufman was then on the telephone I inquired of Judge Kaufman's secretary whether he had as yet been contacted by the police department. She stated that he had already received a telephone call from the police. I told her to tell Judge Kaufman that if he had any difficulty whatsoever in making satisfactory arrangements to contact me further so that I could iron the whole thing out for him.

Judge Irving Kaufman telephonically contacted me at 1:30 PM and advised that in view of the decision of the Circuit Court of Appeals that the date set for the Rosenberg execution should be withheld until March 30th to permit the Supreme Court ample time for review, Judge Kaufman was of the opinion that he would not need the police protection being afforded him by the NYC PD. With that thought in mind Judge Kaufman had talked with Deputy Chief Neilson of the NYC PD and had remarked that he probably would not need the protection. Neilson, according to Judge Kaufman, stated that he felt Judge Kaufman should continue to receive the protection until the termination of the affair. Judge Kaufman stated that he had told Neilson that he would talk the matter over with Lee Boardman of the FBI before arriving at a final conclusion. Judge Kaufman then asked me what my views were. I told Judge Kaufman that of course in view of the Neilson observations it was very difficult for me to make a statement. I then discussed with Judge Kaufman various possibilities, pointing out that since the case had been delayed the pressure in the minds of the Communists was alleviated to a degree and it could be concluded that there was still hope for the Rosenbergs. I pointed out that persons thinking the matter out intelligently might therefore decide it would be disadvantageous to the Rosenberg cause to make any threats against the presiding Judge. I then pointed out to Judge Kaufman that of course the primary concern insofar as he was concerned would be on the part of crackpots or cranks who might not be prone to think things out in a logical manner. Judge Kaufman concurred and we both arrived at the conclusion that Judge Kaufman should take no precipitous action in the matter but should think it over for the next several days and thereafter decide whether he considered the personal inconvenience of being continuously accompanied by bodyguards outweighed the possible threat of injury to himself or members of his family. I told Judge Kaufman that in the final analysis the decision would have to be made by himself.

I thereafter telephonically contacted Assistant Director Al Belmont and apprised him of the above conversation. Mr. Belmont concurred with me that the Bureau should not place itself in a position of recommending that Judge Kaufman did not need police

Mrs. DAMIAS stated that she had received a letter from JULIUS and ETHEL ROSENBERG to write to the President for clemency. She advised that she received this letter on the day that President EISENHOWER denied the subjects clemency.

She further advised that late in the afternoon on 2/17/53 she was contacted at her home by certain individuals who identified themselves as the mother, brother, and sister of JULIUS ROSENBERG. The individuals asked her to intercede and to plead for clemency for JULIUS and ETHEL ROSENBERG. They also asked her if she felt sorry for the ROSENBERG children and whether or not she had any heart. I asked Judge KAUFMAN whether he had made these facts known to U. S. Attorney MYLES LANE. Judge KAUFMAN stated he had discussed it with MYLES LANE but that in his opinion, MYLES LANE was not affirmatively interested in view of his probable lack of tenure of office at this time. I asked Judge KAUFMAN if he desired that I bring his comments to the attention of the officials in Washington. He stated he didn't think it would be desirable for there to be any indication that he was taking an affirmative position in instant matter because of his judicial situation. He then stated "I think what I will do is go to Assistant U. S. Attorney KILSHEIMER and suggest the possibility to him that the U. S. Attorney's Office move aggressively in this matter."

Judge KAUFMAN then said actually, he had just been talking to me as a sounding board for his views and he then indicated that really, the purpose of his call was to ask me to contact the New York Police Department relative to protection.

I informed Judge KAUFMAN I would be more than pleased to contact Commissioner MONAGHAN.

At 10:30 AM, I telephonically contacted Commissioner MONAGHAN and informed him that Judge KAUFMAN had asked that I call him and indicate that he desires the presence of a uniformed police officer in front of Judge KAUFMAN'S apartment building and for the time being no further protection be afforded him. Commissioner MONAGHAN stated he would be more than pleased to comply with the Judge's wishes in instant matter.

AUSA KILSHEIMER telephoned me, 2:15 PM, 2/19/53, to state that Judge IRVING KAUFMAN had informed Mr. KILSHEIMER of Judge KAUFMAN'S conversation with me earlier today concerning the Circuit Court of Appeals' opinion. Mr. KILSHEIMER stated he felt he should, as a consequence, advise me the action taken by him as a consequence of the Circuit Court of Appeals' opinion. He said that (1) he had sent off, over MYLES LANE'S signature a strong letter to the Department, urging that the Department endeavor to vacate the opinion of the Circuit Court of Appeals or shorten the length of the appeal; (2) he had telephonically contacted the Department, in addition to writing the letter, and had orally apprised the Department that it was nottin the

best interests of the Government to let this matter delay. I thanked Mr. KILSHEIMER for calling me, without making any comment whatsoever concerning Judge KAUFMAN'S conversation with me.

The above information concerning my conversation with Judge KAUFMAN and AUSA KILSHEIMER was made known to Assistant Director A. BELMONT. I told Mr. BELMONT it was my opinion that the Bureau should make no representations to the Department or to anyone else in instant matter as I felt that probably Judge KAUFMAN might be making strong protestations in several directions and I felt the FBI should not get mixed up in any judicial squabbles since the entire matter was one without the scope of our authority. On Saturday, 1/10/53, night, I attended a mass demonstration to ask clemency for JULIUS and ETHEL ROSENBERG, at Broadway and 14 St., Times Sq.

At about 8:40 a whirring sound was heard coming from above the Camel sign we all looked up as smoke kept pouring out of the man's mouth and soon there was a blaring sound from an amplifier on the third or fourth floor of the Hotel Claridge telling us about a man and woman at this moment in the death house in Sing Sing, JULIUS and ETHEL ROSENBERG who were going to die this Thursday for alledge passing the secret of the atom bomb to Russia, the voice continued and pleaded for all to write or wire President Truman to commute their death sentence.

The voice continued time and time again to repeat the same words but still no sign from the demonstrators, we looked up in astonishment and pleasure at the hidden voice, coming out of the Hotel and then continued to walk on.

The people walking also looked up and the Police seemed taken by this rush, they did not expect such a thing.

At the first sign of the voice leaflets poured out of a window in the hotel and fluttered down into the street where the people gathered them up, some to read them and pocket them others to tear them in disgust.

A few people carried signs, "Clemency for the ROSENBERGS", and other distributed leaflets and we marched back and forth mingling with the crowd and this added to the confusion of the cops who when they were not tearing signs from the pickets, were trying to break up the demonstration which was not there when they turned around.

A few policemen were arrogant and fresh but they were handicapped because they could not distinguish between the ordinary passerby and

the demonstration.

We walked back and forth for a few minutes, the loud-speaker in the meantime had ceased to issue its plea and all was quiet except for the passing crowd, and then suddenly as before a whirring sound this time from the Hotel Astor on the top floor and then the same voice uttering the same plea and everyone again taken by surprise and we who knew feeling happy inward because of the ingenuity displayed by the Party to gain the attention of the people.

The voice repeated its plea several times and then in the midst of its plea was shut off and the window was closed.

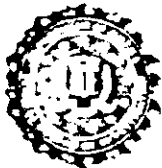

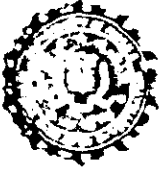

CIVIL RIGHTS CONGRESS
ACTIVITIES

A meeting of the Finance Committee of the Civil Rights Congress was held on January 15, 1953 at the Library at 23 West 26th Street, New York.

ED (EDWARD ROYCE) was chairman of the meeting. He opened the meeting with a few remarks in which he stated that this meeting was called for the purpose of "adopting a program of action to improve the finances of the C.R.C."

WILLIAM PATTERSON came to this meeting as the representative of the National Committee of the Civil Rights Congress. He said that "the country is at present going through a dangerous stage - economically and politically. Big capital is taking over the government and this means all one thing: Wall Street will do its utmost to get bigger profits. This will mean the lowering of the living standard of the American people; it means the breaking up of the American trade union movement. Having the full force of the government on its side monopoly capital will do everything possible to do away with all the economic gains labor and the people made during the last twenty years". He said that "we must be on guard against this attempt of Wall Street".

As far as the "political life of the nation", PATTERSON said, "the outlook is just as dark". He stated that "the Eisenhower government will not end the war in Korea without the strong voice of the people to do so. The cold war will continue because it brings untold profits to Wall Street. Eisenhower will not stop the witchhunt nor the Smith Act trials. The way I see the situation the new administration will strengthen the political and economic terroristic acts against the people. Terror became the pattern of the American government. Truman invented it and Eisenhower will try to improve upon it.". He underlined that "there is only one way to stop the advance of reaction, which is trying to destroy, through acts of terror, any opposition in the drive towards war, it's the organization of the people and especially of the labor movement to resist these attempts of reaction". He emphasized that

"the C.R.C. will have an important part in this political program - of organizing the people against terror, war or fascism".

He spoke on the Rosenberg case which he characterized "as a terroristic act of government" to silence the people." He said that the C. R. C. "played and is playing an important role in this case". He said that the "alchemy train" to Ossining helped to "dramatize the Rosenberg case" more than any other action to save the Rosenbergs and that this was done by the C.R.C.

WINTERHORN underlined that the C.R.C. is taking the lead in the development of many political actions but "the C.R.C. didn't learn as yet to exploit its campaigns for the raising of funds". Here, he said, is where the Finance Committee should take over. "we need money for our mass campaigns. Without funds we can not do our work". He outlined three immediate "political actions" of the C.R.C.

1. The Rosenberg case. "Saving the lives of the Rosenbergs will be a great victory of the American people against government terror.

2. The fight against the Smith Act and the fight for amnesty. In connection with the fight against the Smith Act he said that in the case of STEVE NELSON "terror of punishment almost equals the Rosenbergs case". In the NELSON case, he said, "we succeeded to raise some \$14,000", but that more funds must be raised for Pittsburg.

2. Mother's Day conference in Georgia. For the purpose of "dramatizing the INGRAM case". He said that "we learned a lesson from the delegation to Mrs. INGRAM: the delegation received a favorable reception (from Gov. Tolmidge) and I see the possibility of moving into the South".

"The enemy hopes to exhaust our resources. This is the aim of the enemy. Our business is to disappoint the enemy. We didn't fully exploit the ways open to us to raise funds. I believe the Finance Committee is in a position to devise ways and means of raising funds. Lets go to it". In the discussion on WINTERHORN'S "report" participated:

MELBA WICKENS. She said that "our orientation" on the question of raising funds should be based on:

1. Short term basis and
2. Long term basis

The raising of funds for immediate campaigns and planning for the raising of funds for the yearly budget of the National and State (N.Y.) organizations of the C.R.C. She said that in connection with this the functionaries and all of C.R.C. organizations should be involved.

EDITH FOSBERG reported that the National and State organizations must have a minimum of \$3,000 a month "to be able to function". ("This includes salaries, rent, phone, electricity, printing material, etc., but it does not include the special campaign of the C.R.C.") She said that "we managed to reduce the debt of the national office during 1952 by \$6,000. This was accomplished largely because of the work of the Finance Committee".

ED said that in connection with the raising of funds he sees the importance of reviving the issuing of the State Bulletin and that it would be a good idea "to start thinking and planning of publishing a C.R.C. monthly magazine".

AL said that he detected in PAT'S report a hint of accusation directed against the F.C. for not exploiting the C.R.C. campaigns for fund raising. He told the meeting that this criticism should be directed against the National and State functionaries of the C.R.C. He said that there is a lack of coordination between the work of the F.C. and the National and State staffs. He underlined that if the C.R.C. staffs would be responsible to the F.C. and the F.C. to the staffs; if the F.C. would be informed in advance about the undertakings and planning of campaign of the National and State (N.Y.) offices; if there would be some kind of coordination of the work of these organizations "we would be in a position to merge the campaigns, to utilize them for the raising of funds. As of today the picture is different: the National and the State committees will start campaigns and before the F.C. has a chance to start something in the way of raising funds - the campaign is over and its too late to do anything". As an example he told them that the "clewency train" campaign was planned by the three committees and that as a result of

this "coordination work" the C.R.C. made a few hundred dollars on this action.

PAUL LEVINE proposed that each member of the F.C. should organize a house party for raising funds for the C.R.C. and that letters should go out to all C.R.C. organizations and functionaries in N.Y. State to do the same.

ELMER ROSS proposed to organize "a political - cultural evening" for the "dramatic reading" of Allen Tate's play "Potiphar's House" and to organize a housewarming on the occasion of the moving of the C.R.C. to new quarters (6 E. 17th St., NYC)

Doctor HARRY GOLD proposed the organization of a "Spring Bazaar".

FRED JOHNSON and FELIX didn't participate in the discussions.

PATTERSON proposed to organize "on a later date" a dinner "in honor" of STEVE NELSON and he asked the F.C. to start "collecting" the "Bail bonds". He said that it is expected that the money on these bond certificates will be paid out sometime in May, 1953. He said that he agrees with the suggestions and the plans of the F.C. (as outlined above) and that he considers the remarks made by AL of real importance: "there should be closer cooperation between the National and State staffs and the F.C. There is a lack of coordination in our work".

The meeting adopted:

ELMER ROSS will represent the C.R.C. State Committee (N.Y.) at the meetings of the F.C. and will inform each of the plans and activities of the State organization.

WALTERSON or anyone else available will represent the National Committee of the C.R.C. at the F.C.

A number or members of the F.C. will have the right to participate

"once in a while" (because the members of the F.C. will have to do much work to do) in the staff meetings of the National and State Committees.

To organize the "cultural evening" (Potiphar's house" for February 6th, 1953 at the Yugoslav Hall in N.Y.

To have the C.R.C. housewarming on February 13th, 1953. To invite a "selected" number of guests (about 100 people who could afford to give donations of \$25 or more. There will be no charge. An appeal for donations to be made by CARL MORJAKI' if he is available.

To take over "The Big Fine" (the first evening of the opening of this show) for a benefit for C.R.C. on March 6th 1953.


To start planning "some kind of an affair" for STEVE NELSON in April. (possible in HOWARD FAST'S house)

To start working immediately on the organization of house parties.

Each member of the F. C. should have suggestions about the organization of a spring or early summer bazaar.

- Suggestion to National and State (N.Y.) committees to start a C.R.C. National fund drive. Above committees to discuss this suggestion and report on it as quickly as possible.

Suggestion: to concentrate on the "collection of the Bail bond certificates" which should be donated to the Civil Rights Congress.

SUSSMAN was interviewed on 2/24/53 for information he might have concerning
one DAVID ENGELS.

SUSSMAN advised that ENGELS was known at the time he first met him by the nickname of "HOOCH". SUSSMAN described ENGELS as short and stocky with a round face, a somewhat bushy head of hair, and a "tough chin". He recalls that ENGELS' wife was a large woman whom he would describe as a "housewife" type. SUSSMAN advised that he saw ENGELS a number of times during the years roughly 1935 to 1939.

In connection with the above referred to contacts with ENGELS, it will be recalled that SUSSMAN has advised that he originally joined the Young Communist League in the Brownsville Section of Brooklyn when the family resided in Brooklyn and upon moving to the Lower East Side of New York City he attended meetings of the Lower East Side Section of the YCL with headquarters at 44 Avenue C. SUSSMAN advised that at these meetings, which he recalls JULIUS ROSENBERG also attended, he first met ENGELS who he advised appeared to be the leader of this group. SUSSMAN advised that it is his recollection that ENGELS did not speak English very well nor was he generally considered well educated but that he was good at organizational work and could make a pretty good speech. Consequently ENGELS was prominent in East Side activities and in about 1935 or 1936 he was Section Organizer for the YCL. SUSSMAN also recalled that ENGELS had been a member of the Abraham Lincoln Brigade but SUSSMAN has no knowledge of activities on the part of ENGELS in the Communist Party in New York.

SUSSMAN advised that after approximately 1939 he did not see ENGELS again until roughly sometime during the year 1944 or 1945. In connection with this meeting SUSSMAN recalled it was at approximately this time that his wife was writing various papers in connection with her studies at Columbia University and she spent considerable time at the New York City Public Library. SUSSMAN at this time advised that he was working on 11th Avenue and at noontime he would meet his wife at the library. It was at the library that he last saw ENGELS and to the best of his recollection ENGELS was examining either a reference book or telephone directories for various cities throughout the United States maintained by the Public Library on the east side of the north reference room at the library. SUSSMAN cannot recall that there was any conversation between the two at that time but he does believe that they saw each other and perhaps spoke or nodded in greeting.

SA Paul Varity advised on 4-8-55 that when he interviewed
Susman on 1-17-55 Susman had no objection to revealing

SUSSMAN has advised that he has not seen ENGELS since that time and has no information as to his current activities or whereabouts or associates. He did advise, however, that there is no question in his mind that ENGELS knew JULIUS ROSENBERG and in view of the fact that they both attended YCL meetings at 44 Avenue C, the association between these two was undoubtedly more than mere acquaintanceship.

On 2/25/53, SUSSMAN was shown pictures of DAVE ENGELS and he positively identified these photographs as the DAVE ENGELS he had known in the late 1930's and who was known as "MOCKY" at that time.

SUSSMAN advised that the name MORRIS BEN ABID means nothing to him.

The following information is being noted as it pertains to SUSSMAN's current employment inasmuch as a copy of this memo is designated for his file. SUSSMAN advised that he is no longer employed by Telco Electronics, 37 East 14 Street, New York City, but that he is still at the above address and since approximately April, 1953, he has been employed with Ameco Electronics.

SUSSMAN advises that Ameco is at present engaged in the fulfillment of a contract with the U. S. Navy for some two dozen navigational trainers costing approximately \$14,000 each which are to be utilized by the Naval Air Training Station at Pensacola, Florida.

JEWISH PEOPLES FRATERNAL

A meeting of Branch 136 of the Jewish Peoples Fraternal Order was held on Jan. 9, 1952, at the headquarters of Shule (School) #9, at 3451 Giles Place, Bronx, New York.

About 50 members were present at this meeting. I saw at the meeting:

The chairman of the meeting was M. GROSSMAN, the newly elected president of Branch 136 of the Jewish Peoples Fraternal Order, I.W.O.

J. HOFFMAN read the names of the newly elected executive committee of branch 136:

- M. GROSSMAN, President
- M. RUBINACH, Vice President
- A. SINDLER is the temporary financial secretary. (The Branch is trying to get a new Finance Secretary. No one wants the job. SINDLER will hold the job for a while. Not filled is also the job of Protocol Secretary.)
- B. FRIT, executive secretary
- B. SWEIDIN, Treasurer
- M. WEISS, Hospitaler
- SOL SINGER, Director Culture Activities
- J. HOFFMAN, Literature director.
- Members of the Executive Committee: EVA GUIBOND, L. MYERSON and A. SOGAN.

SARAH GOODEMAN welcomed the newly elected executive committee in the name of the Bronx County Committee of the Jewish Peoples Fraternal Order. She said "the executive Committee of the branch is the general staff of the branch" but "a general staff is useless without an army" and she called upon the members to engage fully in the activities of the branch which "works not only for the good of the branch members but also for the benefit of the entire neighborhood community".

SARAH GOODEMAN stated that "we, and the American people as a whole, live in a time of dark reaction. Our responsibilities to our community and to the American people are great. We are a part of the great forces of the progressive movement. We are a part of the forces which stand in the forefront in the battle for freedom and peace and, like good soldiers, we must fulfill our duty. The general staff will direct us, instruct us, but we are the one to carry on the work which will lead to the destruction of the reactionary forces - the forces of fascism and war".

SARAH GOODMAN called upon the members to work not only for the benefit of the branch but "go into the community; talk to the people; educate the masses; talk to everyone about the great movement of the colonial people who are fighting against slavery; tell the people about the 800,000,000 people who are fighting for peace and democracy. It is up to us to wake up the people to the dangers of a 3rd World War. We must tell our new government that we want to stop the killings in Korea".

She remarked that "EISENHOWER was elected as President of the United States because he promised the people to go to Korea. By going to Korea it was understood that he will stop the war in Korea. He wasn't elected for the purpose of going to Korea to eat beans with a few American soldiers, make a pleasant trip back and tell us that he has new plans of how to continue the war in Korea. The people must be enlightened on this point. We must demand from the new President to stop the war in Korea immediately. No stalling on this point. We must demand a stop to the cold war. JOSEPH STALIN is willing to talk over the whole situation with EISENHOWER. Here is a chance for the new President to start working on the direction of world peace. If he wouldn't agree to do these things on his own it is our duty to force him to do the things which promised and which are best for the people of the U.S. and of the world".

SARAH GOODMAN called upon the members of the branch to engage "in the important work of organizing the people against reaction which breaks war and fascism.

M. GROSSMAN also spoke about the importance of "organizing the people in the neighborhood for the struggle against reaction and war". He underlined "that the ETHEL and JULIUS ROSENBERG case would not have happened if our country would not be engaged in a cold war against the forces of freedom, peace and socialism. The war mongers must have their victims and ETHEL and JULIUS are their first victims, who will be next? Should they die thousands of us will be next".

GROSSMAN called upon the people to demand executive clemency for the ROSENBERGS. He urged the branch members to visit everyone in the neighborhood and also the people to write to the President "demanding" executive clemency for the ROSENBERGS. He also pledged that the new executive committee of the branch will do everything possible to re-constitute all those who fell out from branch membership during the last 2-3 years.

A. SHULMANTER made an appeal for funds for the \$175,000 Morning Freiheit fund drive. The collection brought in \$340.00.

Sweets, coffee and cake was served after the meeting.
