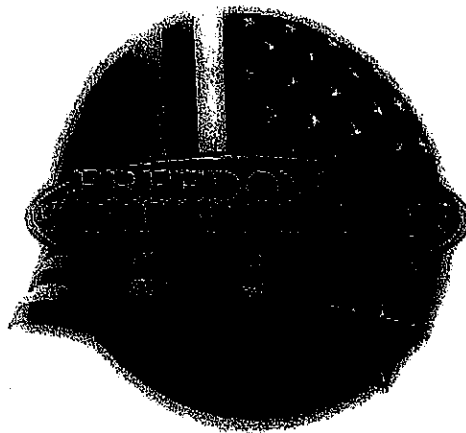

Mr. Edwin T. Preston, head of Administrative Engineering Dept. (Asst. <sup>Sgt.</sup> 1953) advised that there was <sup>(Early 1947)</sup> a guided missile study program known as "Sparrow I". He furnished the names of persons he recalled as having been associated with it. The personnel files were reviewed as to these persons in order to get such background as might be significant. 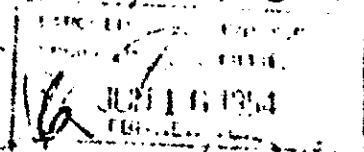
We have just been advised by the National Committee to Secure Justice in the Rosenberg Case (Julius and Ethel Rosenberg) that it intends to conduct a memorial or unveiling service at the graves of the Rosebbergs located in the Wellwood Cemetery, Pinelawn, Long Island, New York, at one o'clock on Sunday, June 20, 1954. We are notifying you of this communication because we consider it to be in the public interest to bring it to your attention.

We would like you to know that we have notified the National Committee to Secure Justice in the Rosenberg Case that it has a right to conduct any memorial or unveiling service, and further that the Committee has no right to exercise any authority or take any action with respect to the burial plot in question, since it was purchased from this Cemetery by fraudulent representations made to our salesman by a man who stated that the graves were intended for the burial of two sisters who had been killed in an automobile accident. It was on this basis that the sale was made. We did not learn that the graves were intended for the Rosenbergs until the funeral cortege arrived at the Cemetery.

Despite our notice to the National Committee to Secure Justice in the Rosenberg Case, it may well be that the members of the Committee will — as they have threatened to do — hold a memorial or unveiling service on Sunday at one o'clock. For that reason we deem it important to inform you of their expressed intentions.

SA John Harrington advised on 6/17/54 that there was an article in the "Daily Worker" on page 3 setting out that on Sunday, 6/20/54, at 1:00 PM, there would be an unveiling of a monument to the ROSENBERGS at Wellwood Cemetery, Section 1, Block 5, Row J, Pine Lawn, Suffolk County.

It was suggested that the police department at Nassau County, the State Troopers, the Long Island Parkway Police, and the police department covering the cemetery be alerted to this. It is contemplated that there would be considerable automobile traffic going to the unveiling.

SA Arthur Fuss was contacted at the Mineola Resident Agency and SA John P. Fay at Bay Shore and were so instructed. They subsequently advised that the respective police departments were alerted to the situation.

Dear Warden:

In reference to the article on page 3 in "The Worker" by Virginia Gardner, dated Sunday, June 27, 1954, which you brought to my attention, I wish to advise that I refused to grant the writer any interview whatsoever.

Miss Gardner did come to see me in my Synagogue study at 273 Halstead Avenue (this was referred to in her article as Halsted Street) in Hamaroneck, and if you recall, I mentioned her visit to me when I saw you the very next day, indicating my refusal to grant the requested interview.

Her entree into my study was a remark that she had been to see you re the Rosenbergs. After she was seated and indicated that she was a reporter for "The Worker" I told her that I had nothing to say since the Warden's office at Sing Sing was responsible for information regarding inmates, including the now deceased Rosenbergs. She mentions as I note, my hostility to her and "The Worker" in this respect. You can imagine my surprise and indignation when I read the alleged interview--in the few minutes that Miss Gardner was in my study, I stated most emphatically that she could not obtain any information and asked her to leave in a very firm manner. Perhaps the fraudulent article was her way of getting back at me, in a cleverly written supposed conversation.

Coincidentally, I had numerous opportunities offered by Life magazine, the New York Times, etc., to make myself available for interviews, articles, etc. all of which I consistently turned down. I have always felt that this execution was a closed matter and, that in any case, official reports should come from those responsible for the Public Relations of the Institution.

My sincerest thanks again for acquainting me with this matter.
