NO 425 on 12/23/47 furnished to this office, Monthly Dues Collection lists for 1379 IWO Lodges for the month of December 1946. Each list includes the Lodge number, name of the Secretary, residence address of the Secretary and the names of the Lodge members listed alphabetically. Next to each name is the birth year of the person. Where the name of the Secretary is missing, a file review has provided sufficient identifying data to fix the approximate location of the Lodge. The original lists bearing the date received and the holographic initials of Special Agent E. K. Deane, and Special Employee S. W. Jennings were sent to the Bureau on 1/10/49. These persons can testify to the legally admissible character of the exhibit. All of the materials relating to Lodges in the New York Field Division have been photostated, and are being routed to designated ~~xxxxxxx~~.exhibit.)

In some instances an additional identifying exhibit is being submitted herewith which reveals the address where the Lodge actually meets. Same should be placed in the appropriate ~~xxxxxxx~~.exhibit.

It is estimated that the Monthly Dues Collection Sheets exceed 80% of the IWO Lodge strength nationally, and represent a substantial portion of the IWO membership which was reported at 200,000 in June 1947.

Care should be taken to protect the source of this information. It is believed sufficient to refer to an individual as a member of Lodge # IWO as of December 1946 without specifically using the words Monthly Dues Collection List.
