REPORT

Re report of SA MORTIMER C. WATSON, Detroit, 7-3-51.
 Pittsburgh teletypes to Detroit 4-11-51 and 4-14-51.

Current Pittsburgh, Pa., telephone and city Directories fail to reveal the address 415 Whitney Street, Pittsburgh, Pa. However, it has been determined that this address exists in Wilkinsburg, Pa., which is located on the Eastern boundary of the city of Pittsburgh. A review of the cross telephone directory reflects that WALTER B. MORTON, JR., resides at this address. Referenced teletypes reflect that WALTER BENSON MORTON, JR., 415 Whitney Avenue, Pittsburgh, Pa., was a passenger in the car belonging to the subjects on April 7, 1951, when this car was involved in an accident on U. S. Highway, Route 30, near Irwin, Pa.

Postal Inspector GEORGE EVANS, New Federal Building, Pittsburgh, Pa., advised on July 27, 1951, that MORTON left a forwarding address with the Wilkinsburg, Pa., Post Office effective June 1, 1951, of 1019 Chelton Street, Philadelphia, Pa.

As indicated in referenced teletype of April 14, 1951, MORTON is the subject of a Security Index card in the Pittsburgh Office, Pittsburgh file 100-102080, Bufile 100-371516.

For the further information of the Detroit Office, MORTON and his wife REVA (RIZA) came to Pittsburgh in 1950 from Bethlehem, Pa., where he and his wife resided at 70 West Carson Street. A CNDI of the Philadelphia Office has identified both MORTON and his wife as active members in the Lehigh Valley Section, Communist Party, District 3, during their residence in that section. After their arrival in Pittsburgh, WALTER MORTON was employed by the Westinghouse Electric Corporation in East Pittsburgh, Pa., as a graduate student from July 1950, to January 5, 1951, when his employment was terminated because the U. S. Navy failed to grant a clearance for classified work. Investigation at Carnegie Institute of Technology, Pittsburgh, Pa., indicated that WALTER MORTON was admitted into the day school in the Department of Electrical Engineering in February, 1951. His file indicated that he was born July 21, 1926, at Birmingham, Alabama, and that he expects to become a candidate for a doctors degree. RUC

Detroit.

A review of referenced report fails to reflect that any leads were set forth therein for the Richmond Office. However, it is noted that in the last paragraph of page 9 of this report there is reflected that a collect call was made by subject ANNE SHORE from Richmond, Virginia, 29079 on January 30, 1950.

For the information of the Bureau and the Detroit Office, this telephone number is listed to the Slaughter Hotel, which is a Negro hotel in Richmond, Virginia. At the time this call was made it is known that subject ANNE SHORE was in Richmond in connection with the Martinsville Seven crusade and that a number of the individuals participating in this crusade both resided and met at the Slaughter Hotel.
