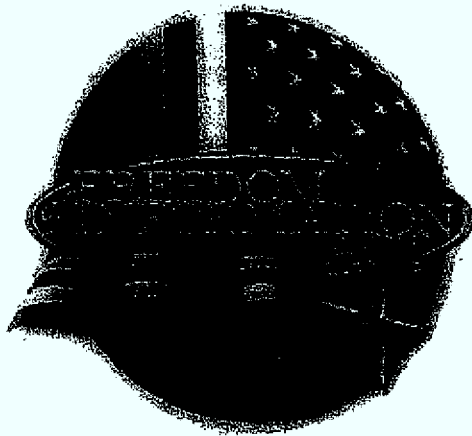

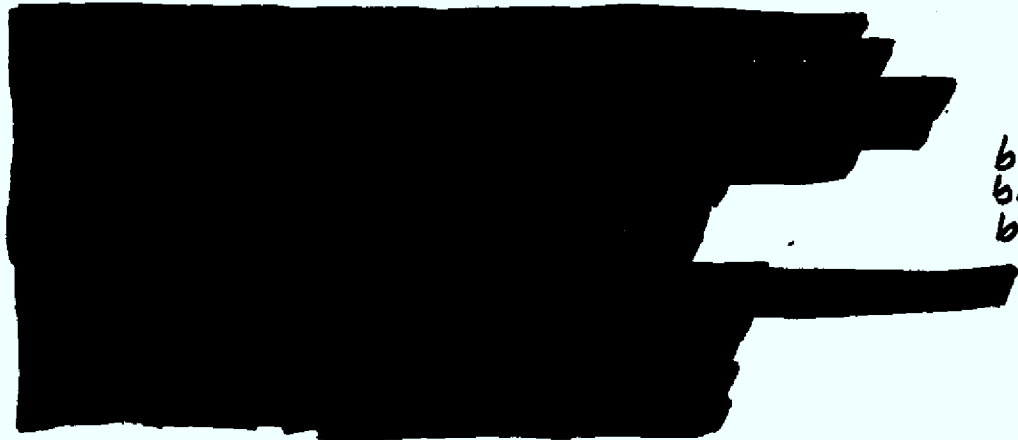

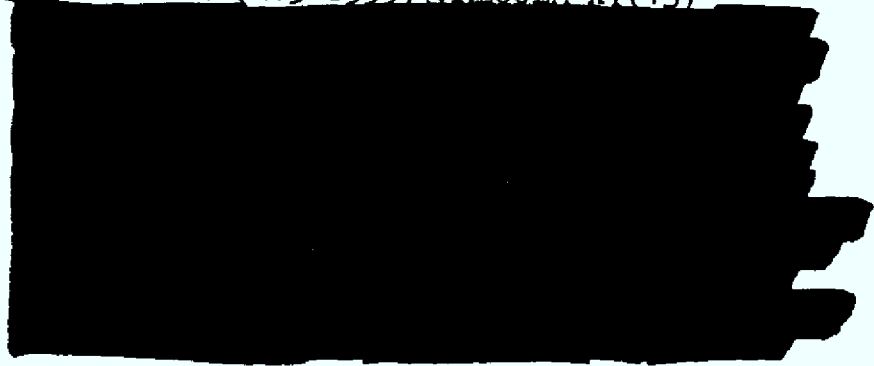

Memorial Tribute to MALCOLM X  
5/19/66

The Memorial Tribute to MALCOLM X started by a pilgrimage to Ferncliff Cemetery from the Hotel Theresa, 2090 7th Avenue, at 1:00 p.m. Then there was a youth program scheduled but the youth program was cancelled. So the members worked on the program for the night in the Skyline Ballroom. The program in the ballroom started about 9:30 or 10:00 p.m. There were about 270 to 280 people present. They busied themselves by listening to the speakers, who were: BILL EPTON, Harlem Progressive Labor Party Chairman; JOHN DAVIS, singer; ROBERT ANDERSON, poet; JIM HAUGHTON, Harlem Unemployment Center; Chairman LOUISE JEFFERS; folk singer and composer, Mrs. LORETTA LANGLEY, attended Dakar Festival in Senegal; KAY COMBO, poetess, Afro-American Institute; ROY ENNIS, President, New York CORE; Mrs. AUDLEY MOORE, President Harriet Tubman Association; Mr. LUBOTA, President, Pan African Students Association of the Americas, Inc.; Mrs. ELLA COLLINS, President, OAAU; OSEN JEMEN ADEFUMI; Yoruba Temple dancers and WILLIE KOSELSILE, South Africa.

Then the people listened to the OAAU singers and the Vikik Bo Five Drummers. There were newspaper people there too, Mr. EARL CALDWELL, NY Post.

Dinner was sold at \$1.00 apiece. The memorial tribute to MALCOLM X was over at 2:00 a.m.

The flyers are for Malcolm X Day which is on May 19, 1966. The flyers read "Malcolm X Day, May 19, 1966, pilgrimage to Ferncliff Cemetery leaving from Hotel Theresa, 2090 7th Ave., NYC, 11:00 a.m. (Donate your car to aid transportation to cemetery.) Memorial tribute to Malcolm X at the Skyline Ballroom, Hotel Theresa, Thursday, May 19, 1966, 8:00 p.m. Contribution \$2.00. Entertainment, Speakers, Youth Program, 4:00 - 6:00 p.m. Art show - dinner served. African Diplomats invited. Partial list of sponsors: Organization of Afro-American Unity, Inc., Mrs. ELLA COLLINS President, A.W.O.A., Miss RASHEDA ABUBAKAR (President NY Chapter), Harlem Unemployment Center, Harriet Tubman Association, Hearts of Africa Committee, Joint Organizations Mobilized for Action, New York Congress of Racial Equality, Pan African Students Organization of the Americas, Harlem Progressive Labor Party."

On the back of the flyer is an ode to a crucifixion: "Ahh, let me sleep perchance to dream, for dreams are what men are made of. While in this world of consciousness few men knew thoughts of love. Man dreams of worlds to conquer and they form a real grand plan then blast their plans asunder to remain an 'also-run'. What use to follow leaders? Why plan to forge ahead? When caused by someone's plunder a man can buy you dead! But still do dream, do walk ahead do strive to regain your throne -- and when you live 'u jamar' you will not walk alone. Do think, do dream, do move ahead, let your heritage shine again and when you strike, that's if you strike -- make sure it's not a friend!! Copyright 1966, San Huger."

Then at the bottom of the of the flyer are some words by JAMES HENDERSON. " 'Brothers and sisters,' Malcolm had said in the next few seconds, he lay dead. 'We have killed him' his enemies cried, but their hearts knew that they had lied. Our oppressors now think that all is right and well but the ghost of Malcolm is like a demon from hell. Up from the slime he rose like fire. His heart aflamed with a strong desire to see the black man, woman and child stand up free, tall and proud. All through Africa he put forth his hand, our brothers reached out across the land, Unity! Unity! was his resounding cry, these words I know shall never die. But life without freedom is death; and he dwelled in death until he cried. And he who never really lived, swiftly and suddenly died. His wife had a warning about that day, but lion brave he could not stay. Desire in his heart, he took no heed; and the hands of death took back its deed. His soul like fire jumped and burned climbing higher--higher; infinitely high; reaching forth majestically towards the glow of freedom's sky. But it is a sorrow and a shame, that a world so lovely and so strange, could hold the evils both far and near which fills the world with foolish fear. Some men he made angry, his voice they tried to ban, but when they measured Malcolm, they really measured a man."

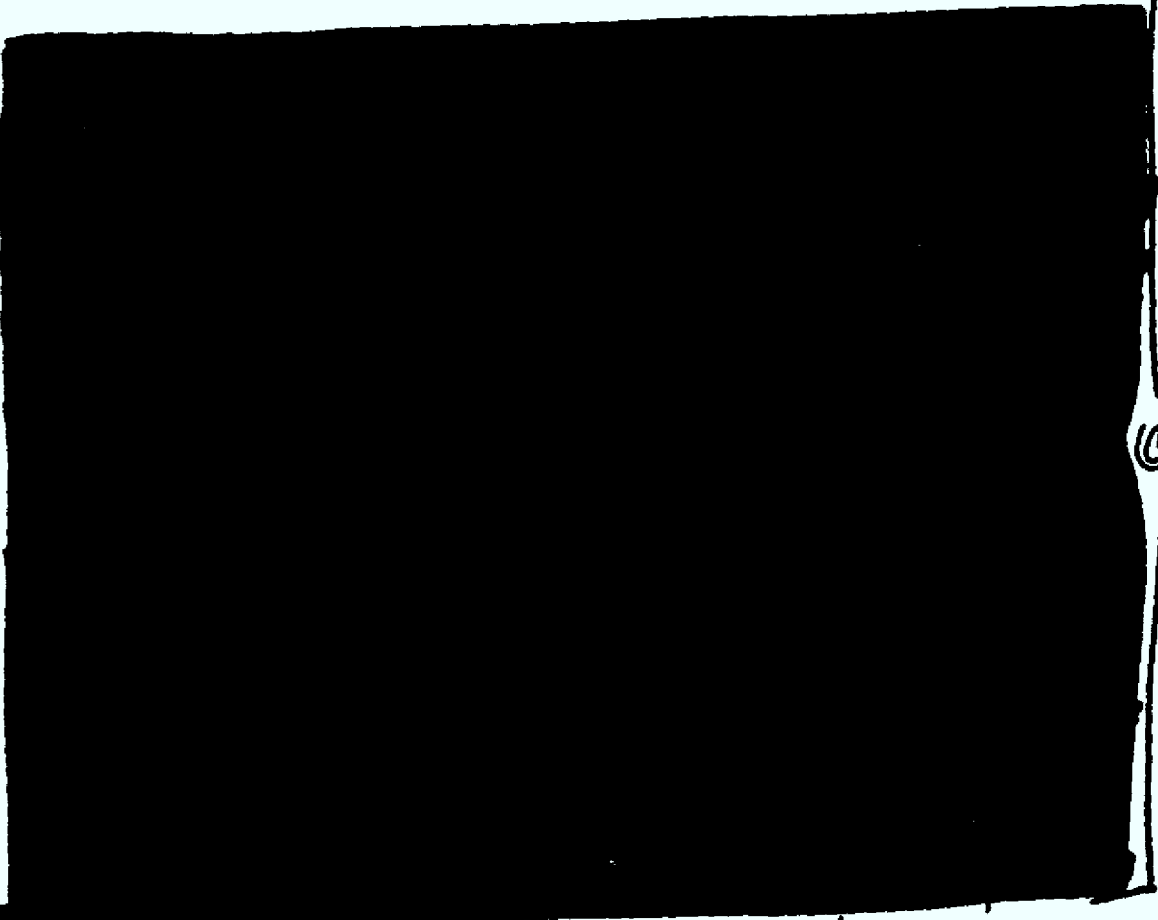

About 80 people marched in this parade. A few other people were picked up enroute and at the Audubon Ballroom for a total of 104 people.

Among the marchers were drummers from the Yoruba Academy dressed in colorful African costumes. An Ethiopian flag was carried. It was a large banner. To cover the law an American flag was also displayed but it was minature in size.

CORE and NAACP were not represented as advertised, and it appeared that many other sponsors were not represented.

At the Audubon Ballroom the group was refused entrance. The marshal WACHUKU called for a boycott of the ballroom. He then eulogized Malcolm X saying that he gave his life for the Negro and had consecrated that ballroom with his blood.

AUDLEY MOORE (Queen Mother) a black nationalist leader also spoke. She too asked that the ballroom be boycotted. She then called for secret organizations of black nationalist groups. She said that all meetings should be secret and no mass meetings should be held. She added that in this way the black nationalists could take over world leadership. The meeting ended at 1:15 pm.

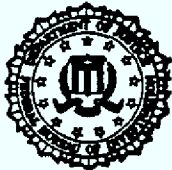

At 4:30 PM this afternoon, I took a telephone call, in your absence, from Mr. VINCENT DERMODY, Assistant District Attorney, New York County, who requested that the following comments be brought to your personal attention:

Mr. DERMODY said that today, in connection with the trial of the alleged murderer of MALCOLM X, DERMODY "had the pleasure" of putting on the witness stand as a cooperative witness for the State SA [REDACTED] (Bureau had previously approved SA [REDACTED] testifying in this case as [REDACTED] was one of two Agents who recovered one of the murder weapons from a witness to the shooting. We turned this gun over to the PD on Bureau instructions to do so.)

Mr. DERMODY said SA [REDACTED] was a wonderful witness, using also the word "terrific" to describe his testimony and demeanor on the witness stand. He said SA [REDACTED] reflected great credit on the FBI. Mr. DERMODY also said he wanted to convey his deep appreciation to the NYO for its cooperation with the NYCPD and the District Attorney's office in this case. Mr. DERMODY said that the cooperation from the beginning had been "terrific," and said this was a perfect example of real effective cooperation.

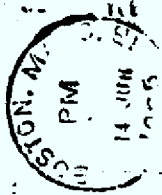

# How The Late Malcolm X Misrepresented Himself And the Divine Messenger

PART I OF A 3-PART SERIES

While preparing to undertake a journey to Africa and the Middle East a couple of months ago, I found myself one day receiving a bit of "good, sound advice" from an Eastern Muslim well-wisher: "Before you go, Abdul Basit, be sure to equip yourself to meet the hostility that awaits you at home..."

"Hostility? ... Awaiting me?" I asked my learned brother, in candid amazement.

"It's all due to the late Malcolm X" he proceeded to explain.

"When he was residing in the Middle East last year, he had waged a rather relentless and, of course, uncontested campaign of vilifying the (so-called) Black Muslim movement."

"Then, with a broad grin, he added, 'And that includes you, Abdul Basit. You are considered an inseparable part of the U.S. Islamic phenomenon.'"

"But where does the 'hostility' come in? What, exactly, did Malcolm say about me...?"

Responded my friend and well-wisher: "In a closed (private) meeting with a group of prominent Eastern Muslims, Malcolm had misrepresented your avowed admiration and open support for the Nation of Islam as the work of a... scholar forced by unfavorable economic circumstances in the United States to turn a hired writer for (the Honorable) Elijah Muhammad..."

The "news" did not, of course, take me by surprise. Having known Malcolm X as long and as well as I had,

I recognized that he was fully capable of making the most unkind remark my "Eastern" brother attributed to him.

Believing in an ancient Persian (Iranian) adage that "silence is the best means of rebutting a fool," at first I wanted to ignore this whole matter. Besides, my ill-informed critic was dead now and I didn't see what I would gain from defending myself before a mass of flesh and bones decaying under tons of earth. However, I also realized that to leave Malcolm's accusation unanswered would be tantamount to "admission of guilt" and hence, perhaps, a potential threat to my professional reputation. I also felt that I simply had to repudiate Malcolm—in the interest of the Nation of Islam itself, if not my own.

Consequently, for several days that followed, I pursued the matter with considerable vigor, attempting to elucidate the extent of Malcolm's callous outbursts. I wrote scores of letters to my contacts abroad, especially among the Muslim journalists, inquiring of what they possibly knew of Malcolm's malicious propaganda in the Islamic East.

I perused as many foreign newspapers and periodicals as I could secure, seeking additional clues to the late Mr. Little's campaign of ill-will. I also discussed certain aspects of Malcolm's extended stay in the Middle

East with several knowledgeable African and Asian personalities in New York and at the United Nations—representatives of "Eastern" Muslim governments.

Then, about two weeks ago, I received the first overseas publication — WORLD MUSLIM LEAGUE (dated April, 1965), published in Singapore, Malaysia — that contained an article which reported, in some detail, the overseas doings (or misdoings) of the "former fiery spokesman of the Nation of Islam."

While it mentioned nothing derogatory about me or even about my respected brother, Honorable Elijah Muhammad, its contents proved me less distasteful. In the first place, it called Malcolm X "the leader of the Black Muslims in America" (which, indeed, he was not). Second, the article referred to "... the Muslim Mosque establishment headed by him, and its efforts in unifying the ranks of Muslims..."

Now, just fancy that! An individual who was undoubtedly guilty of causing what a white writer (friend of Malcolm X) had once described as the "first major crack in the hitherto solid wall of Muslims' unity..." was being lauded for his efforts in behalf of unity!

My investigations later revealed that the brief WORLD MUSLIM LEAGUE article had been written "solely on the basis of Malcolm's own claims and contentions..." thus proving that, in a desperate attempt to gain support from foreign Muslims, Malcolm X had had not only about his own former mentor (Honorable Elijah Muhammad) but also about himself. HARRY RING

Many whites who are strongly sympathetic to the Freedom Now Movement are generally critical to the section of the movement known as the black muslims or black nationals. I think this is due in good measure to lack of unbiased information as to what those described as black nationalists really stand for. I think this lack of accurate information is the product of a deliberate policy to distort and misrepresent by the general news media. I think, for example, that one of the most misrepresented in the line of public figures in this country today is MALCOLM X, leader of the Muslim Mosque and Chairman of the Organization of Afro-American Unity. Because I feel that his views have been so badly distorted, I have invited MALCOLM X to be my guest on this program to ask him some questions to gather what he really believes. Minister MALCOLM, it is just a year since you have been associated with ELIJAH MUHAMMAD and his Nation of Islam. Have your views changed since then? If so, could you indicate in what way they have changed?

MALCOLM X

No, my mind, I have been travelling, and my scope has broadened. For one thing, I believe in the religion of Islam, which automatically teaches us the brotherhood of man, whereas as a follower of ELIJAH MUHAMMAD, I said that I believed in the religion of Islam, but his teaching or version of it was not based upon the brotherhood of man. It was against people just on the basis of their color, but my beliefs now are 100 per cent against racism and against segregation of any form and I also believe that in the religion of Islam, as I now understand it, that we don't judge a person by the color of his skin, but rather by his behavior, by his deeds, and we think that this is justified.

HARRY RING

Let me ask you a question about a problem that disturbs many white supporters at least of the Freedom Now Movement. Why do you reject the concept of non-violence?

MALCOLM X

Well, we think when one violence is taught to the Klu Klux Klan or the White Citizens Council, or those other elements that are inflicting extreme brutality against blacks in this country, then we would accept it. If we are dealing with a non-violent enemy, then we would be non-violent too. But as long as our people in this country have to face the continued acts of brutality on the part of the racist element in the North, as well as in the South, then I don't think that we should be called upon to be non-violent. When they get non-violent, then we'll get non-violent.

HARRY RING

A week or so ago Police Commissioner MURPHY asserted that the recent warnings of danger of a new outbreak in Harlem could only provide the fuel for such an outbreak. Now I know that you are one of those who recently made such a warning. What would you say about what MURPHY had to say?

MALCOLM X

Well, Police Commissioner MURPHY's attitude is one of the things responsible for much of the ill feeling among the racists, especially in the black community as Harlem, Bedford-Stuyvesant, and other places. When he says, when he warns against anyone mentioning that there is a great chance for continued advance this summer, what he is doing is trying to stick his head in the sand. His attitude is the same as the American attitude toward the existence of China. The general American attitude is that Americans are supposed to pretend that 700,000,000 Chinese do not exist and that a little island off the coast of China is China. Well now, Commissioner MURPHY has the same attitude toward the conditions that exist in the black community. These conditions are so explosive that it is impossible for them to continue to exist and not

be violent explosions. Instead of Police Commissioner MURPHY involving himself in some kind of work that will eliminate the causes of these explosions, he wants to condemn the people who are pointing toward the continued existence of these explosions and who at the same time are warning that the continued existence of the causes are going to create the explosions. So, I think that the Police Commissioner reflects probably the best example of an imbecile. I hate to use this kind of word on your program, but he actually has a very imbecillic approach to the problems that exist in the black community and his continued mouthing of this type will do nothing to better the conditions rather, it makes the condition worse.

HARRY RING

One question that I wondered about. In several of your lectures, you stressed the idea that the struggle of your people is for human rights rather than for civil rights. Could you explain a bit what you mean by that?

MALCOLM X

Yes. Civil rights actually keeps the struggle within the domestic confines of America. It keeps it under the jurisdiction of the American Government which means that as long as our struggle for what we are thinking is labeled civil rights, we can only go to Washington, DC and then we rely upon either the Supreme Court, the President, or the Congress, or the Senators. These Senators, many of them are racists. Many of the Congressmen are racists. Many of the Judges are racists, and sometimes the President himself is a shrewdly camouflaged racist. So, we can't really get meaningful redress for our grievances as we are depending upon these grievances being redressed just within the jurisdiction of the United States Government. On the other hand, human rights goes beyond the jurisdiction of this Government. Human rights are international. Human rights are something that a man has by right of his having been born, and the labeling of our struggle in this country under the title of civil rights during the past 12 years has actually made it impossible for us to get outside help. Many foreign nations,

many of our brothers and sisters on the African continent, who have gotten their independence, have refrained from becoming vocally or actively involved in our struggle for fear that they would be violating United States protocol, that they would be accused of getting involved in America's domestic affairs. On the other hand, when we label our struggle human rights, this internationalizes the problem and puts it at a level that makes it possible for any nation or any people anywhere on this earth to speak out on behalf of our human rights struggle. So, we feel that by calling it civil rights for the past 12 years, we've actually been barking up the wrong tree, that ours is a problem of human rights, plus, if we have our human rights, our civil rights are automatic. If we're respected as a human being, we'll be respected as a citizen and in this country, the black man not only is not respected as a citizen, he is not even respected as a human being, and the proof of which you find in many instances, people come to this country from other countries. They can come to this country from behind the Iron Curtain and despite the fact they come here from these other places, they don't have to have civil rights legislation to be passed in order for their rights to be safeguarded. No new legislation is necessary for foreigners, who come here. They have their rights safeguarded. The Constitution is sufficient. But when it comes to the black man, who was born here, whenever we are asking for our rights, they tell us new legislation is necessary. Well, we don't believe that. The Organization of Afro-American Unity feels that as long as our people in this country confine their struggle within the limitations and under the jurisdiction of the United States Government, we remain within the confines of the vicious system which has done nothing but exploit and oppress us ever since we have been here. So, we feel that our only real hope is to make known to the world that our problem is not a Negro problem

or an American problem, but rather it has become a human problem, a world problem, and it has to be attacked at the world level. At the level at which all segments of humanity can intervene on our behalf.

HARRY RING

Now, in the recent debate on the Congo in the United Nations, a number of spokesmen for the African nations condemned United States intervention in the Congo and they likened the rule of the United States in the Congo to the treatment of the black people in Mississippi. One reporter, at least, I believe for the "New York Times," said that you were in large measure responsible for the African delegates taking this stance.

MALCOLM X

Well, I have never voiced responsibility or credit for the stance taken by the African nations. The African nations are today represented by intelligent statesmen and it is only a time when they would see that they would have to intervene in behalf of the 22,000,000 black Americans who are their brothers and sisters, and this is a good example that our problem must be internationalized. Now that the African statesmen are speaking out and linking the problem of racism in Mississippi with the problem of racism that's in the Congo, also the problem of racism in South Viet Nam. It is all racism. It is all part of the vicious system that the Western powers have used to continue to degrade and exploit and oppress the people in African and Asia and Latin America for centuries and as these people in these different areas begin to see that the problem is the same problem and the 22,000,000 black Americans also see that our problem is the same problem as those that are being oppressed in South Viet Nam, in the Congo, and in Latin America, then the oppressed people of this earth make up a majority, not a minority, and we approach a solution to our problem then as a majority that can demand not as a minority that has to beg.



HARRY RING

Now I noticed that you mentioned the problem of Viet Nam. Generally you are associated with concerning yourself with the problems of black people. How do you see the problem of U.S. intervention in Viet Nam as related to the problem of your people.

MALCOLM X

It is a problem in which the United States can come up with so many alibis not to get involved in Mississippi and at the same time get involved in the Congo and involved in Asia and South Viet Nam. Why that right there should show our people in this country that the Government which is incapable of exercising the type of action necessary to solve the problem of black people in this country, but at the same time, she has her nose stuck into the problems of others everywhere else. Plus, we see where the problem in South Viet Nam is the problem of the oppressed and the oppressor. The problem in the Congo is the problem of the oppressed and the oppressor. The problem in Mississippi and Alabama and New York is the problem of the oppressed and the oppressor. The oppressed people all over the world have the same problem and it is only now that they are becoming sufficiently sophisticated to see that all they need to do to get the oppressor off their backs is to unite and realize that it is one problem, that our problems are inseparable and then our action will be inseparable. Our action will be an action of unity and the unity of the oppressed people is actually the strength and the best strength of the oppressed people.

HARRY RING

To get back to Harlem, I noticed that a group of Harlemites, who had been without heat and hot water for over a week, went down to City Hall and sat down in the Mayor's Office. Two days later, I read that the Housing Commissioner had decided that the city would

make repairs on buildings that required it and bill the landlord for it, and he made it known, I had never known it before, that a law has been on the books for many years permitting the city to do this. They had done it a few times during the depression, but has never used it since. Now it seems to me that this action by these Harlem tenants brought this about. Do you think that more effective gains can be made through this kind of action.

MALCOLM X

Yes. Whenever our people are willing to take any kind of action necessary to get results, it will get results. They will never get results as long as they play according to the ground rules that have been laid down by the power structure downtown. It takes action to get some action, and this is what our people have to realize. We have to organize and become involved in well coordinated action, which will involve any means necessary in order to bring about complete elimination of conditions that exist that are actually criminal, not only unjust, illegal, but they are criminal.

HARRY RING

Well, we have time for one more brief question. You've said that your attitude on many questions has changed in the past. How about your attitude toward the various established civil rights organizations?

MALCOLM X

I am for whatever gets results. I don't go for any organization, be it civil rights or any other kind that has to compromise with the power structure and has to rely upon certain elements in the power structure for its financing, which makes them automatically become in a position to be influenced and controlled all over again by the power structure itself. I am for anything that they are involved in as long as it gets meaningful results for the benefit of the masses of our people, but not for the benefit of a few handpicked Negroes at the top, who get prestige and credit and all that, while the masses' problem remains unsolved.

HARRY RING

But would you support concrete activities of these organizations if you feel they go in the right direction?

MALCOLM X

Yes. We will, I and the Organization of Afro-American Unity, will support fully and without compromise any activity by any group that is designed to get meaningful, immediate results.

HARRY RING

I'm sorry, but that's all we have time for. It's been a pleasure to talk to you and I want to wish you every success in your efforts.

MALCOLM X

Thank you.
