On 1/20/64, Mrs. L. MARGOLIS, who stated she represents the Hebrew Christians of Bridgeport, 151 Prospect St., Stratford, Conn., stated that [REDACTED]

[REDACTED], had been sending literature of the National Renaissance Party to the Hebrew Christian organization at Bridgeport. She said that articles in the public press have indicated that this party is a "hate group" directed toward Negroes and Jews, and have identified the party as having guns and ammunition.

She said her reason for bringing this to the attention of the FBI is because she felt that the FBI should be aware of the apparent program of the group. She said she has no personal fear concerning the group or any of its members.

She has been advised that her information would be made a matter of record.

Literature made available to the FBI by Mrs. MARGOLIS is attached hereto for New York, and no further action is contemplated by New Haven at this time.

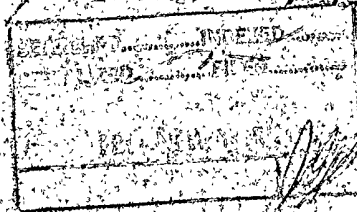

The following information was provided on January 23, 1964, by a confidential source who has furnished reliable information in the past.

A usually reliable source reported on January 3, 1964, that the NRP and the ANP and other unidentified racist groups planned to consolidate all groups under the leadership of James Madole of the NRP and planned to buy property in the Newburgh, New York area in order to hold meetings and conduct training there. The liaison man for that area was to be Frank Birdsall, who was alleged to own a fence company and to be in a position to employ approximately five members.

(Characterizations of the ANP and NRP appear in the Appendix hereto.)

The first source mentioned above stated that the files of a state investigative agency disclosed the following information:

Files of the New York City Police Department, Bureau of Special Services, on January 3, 1964, revealed that Frank Birdsall, together with Betty Shepherd, William Hoff, John Maher, Jr., and Ian Lehr were sponsors of the New York Committee to Defend Floyd Simpson, Post Office Box 191, New York 28, New York.

Files of the New York State Department of Motor Vehicles (NYSDMV), Albany, New York, disclosed the following information:

Frank D. Birdsall, 96 Overlook Place, Newburgh, New York, born July 27, 1936, white, male, 5'11", brown eyes. 1963-66 Chauffeur's Renewal License #B-09652-66338-934953; issued May 16, 1963, expires May 31, 1966.

NYSDMV files contained a registration for a 1948 green Studebaker pickup truck bearing Commercial Registration Number 736-489 (1963) Tab Number 9188046. This vehicle was registered to Birdsall with the business address 102 South Lander Street, Newburgh, New York.

Also registered to Birdsall was a 1956 red and black Ford sedan bearing 1963 registration DOC-23, Tab #1102239. This registration reflected Birdsall to be self-employed, Post Office Box 2272, West Newburgh, New York; Mastic Tile Corporation, North Montgomery Street, Newburgh, New York.

Arrest records on file at the Bureau of Identification, Troop "K", New York State Police (NYSP), Hawthorne, New York, on January 13, 1964, revealed that Birdsall was arrested on May 30, 1959, [REDACTED] for burglary third degree. They were convicted of unlawful entry and petty larceny. Birdsall was sentenced to six months in the county jail, sentence suspended and placed on probation. Also, Birdsall was indicted and arraigned for attempted extortion on November 8, 1959. This indictment was dismissed on a motion of the District Attorney on February 19, 1960.

Investigation disclosed that Post Office Box 2272 was listed to Frank D. Birdsall 96 Overlook Place, Newburgh, New York, believed to be the owner of the Superior Fence Company at the same address.

The Orange County Credit Bureau, Liberty Street, Newburgh, New York, reported that Birdsall is a partner with one Walter R. Staples in the Superior Fence Company, Post Office Box 2272, Newburgh, New York. These records disclosed Birdsall is married to Sylvia Birdsall and has had a number of unfavorable credit accounts. These records also disclosed the following employments for Birdsall:

Kempler Metals, Inc.  
Newburgh, New York; 1960,

Arundel Fence Company,  
Newburgh, New York, 1961;

Mastic Tile Company,  
Newburgh, New York, 1962.

On an unspecified date in early January, 1964, Frank Birdsall called at the Newburgh, New York, Barracks of the NYSP, at which time he was interviewed by a representative of the NYSP. At that time, Birdsall advised that [redacted] and another individual known as Paul (believed to be Paul Joachim) had contacted him on January 5, 1964, at which time he accompanied them to the New Paltz, New York area where they looked at a farm house containing approximately fifteen rooms. The other three individuals spoke to the owner in the house while Birdsall remained in the car. When the three re-entered the car, in subsequent conversation they indicated they would not purchase the house and property because of the price. Birdsall asserted he could not determine the location of the farm nor the owner. He stated the three individuals returned to New York City and had not been in contact with him since that time.

Birdsall was requested to advise the NYSP at Newburgh, New York if these three persons should contact him again. This he refused to do.

Birdsall declared he is not a Nazi but described himself instead as a segregationist. He declared that if racist groups should locate in the Orange County, New York area, he will give jobs to approximately five of them in his fence company during the summer months when business picks up.

Birdsall said he goes to meetings in [redacted] apartment at [redacted] about five times a year. He admitted going to ANP Headquarters in Arlington, Virginia, about one year ago with one John Maher, a former employee residing in the Newburgh area. Birdsall said he was there for about twenty minutes and received a cold reception when he mentioned something about the ANP Commander (George Lincoln Rockwell) and his friend, John Patler, who at that time had split with Rockwell and formed his own party in New York City known as the American National Party. He continued that Patler subsequently rejoined the ANP and was presently serving with Rockwell at Arlington, Virginia.

Birdsall stated he had sent a donation of \$20.00 to Patler as a Christmas present. He expressed a desire to become more active in racial activities but said he was limited because of his occupation and residence.

The usually reliable source, mentioned previously, expressed the opinion that Birdsall had telephoned [redacted] following his interview by the NYSP representative because a representative of the ANP in New York City thereafter said that the location for a headquarters at New Paltz, New York was definitely out and that the group would probably go Upstate again. It was indicated that a location either in Newburgh, New York or some place south of there would be more favorable.

## APPENDIX

### AMERICAN NAZI PARTY OF THE WORLD UNION OF FREE ENTERPRISE NATIONAL SOCIALISTS, ALSO KNOWN AS THE GEORGE LINCOLN ROCKWELL PARTY

In his book "This Time the World," copyrighted in 1961, George Lincoln Rockwell identified himself as Commander, American Nazi Party of the World Union of Free Enterprise National Socialists (ANP - WUFENS), Arlington, Virginia.

The April 4, 1963 issued of "The Richmond News Leader," a Richmond, Virginia daily newspaper, reported that George Lincoln Rockwell had, on the previous day, again applied for the American Nazi Party to be chartered in the State of Virginia, but this request was turned down by the Virginia State Corporation Commission. This action was taken pursuant to an act of the 1962 Virginia Assembly which prohibits the use of "Nazi" or "National Socialism" in a Virginia charter. This article further pointed out that Rockwell's party is presently chartered in the State of Virginia as the George Lincoln Rockwell Party.

On August 19, 1963, a source advised that the ANP - WUFENS was organized by George Lincoln Rockwell at his residence in Arlington, Virginia on February 26, 1959 as an international "National Socialist" movement based on the German Nazi Party headed by Adolf Hitler. He added that Rockwell is the dominant force and personality in this party; that he is espousing a "line" of hatred against the Jews and Negroes; and that he is seeking, through speeches, distribution of literature, and picketing, to establish a cohesive and dominant political party in the United States and in foreign countries.

On December 13, 1963, this source advised that in about September, 1960, the ANP initiated the Fighting American Nationalists (FAN) as a front group for the ANP although it has never been a separate organization. The source said the

FAN name is merely used on occasion instead of the ANP name and there are no separate officials for FAN, the FAN officials being identical with the ANP officials. He stated that George Lincoln Rockwell has informed him the FAN name was originally used as a device to attract supporters to his organization who might rebel at the use of the swastika and at being labeled as a Nazi.

He added that the ANP has operated under the FAN name throughout the country with the exception of a group operating under the FAN name in Baltimore, Maryland. He said the FAN group in Baltimore is now, and always has been, a separate organization and not a part of the ANP.

On October 3, 1963, [REDACTED]

[REDACTED] advised that the Baltimore FAN, which was organized in the Spring of 1961, has no official connection with the ANP although until December, 1962, it received all its literature from George Lincoln Rockwell's ANP.

According to the "Stormtrooper's Manual," an official publication of the ANP, the phases of ANP struggle for power are fourfold, namely, first "to make ourselves known to the masses"; second, "the dissemination of our program and the truth about the Party"; third, "organizing the people who have been converted to our propaganda" and fourth, "the attainment of power through the votes of the newly-won masses."

## APPENDIX

### NATIONAL RENAISSANCE PARTY (NRP)

On April 2, 1959, a source who has furnished reliable information in the past advised that the NRP was an anti-Semitic, anti-Negro, neo-fascist organization with activities generally confined to the New York City area. It was founded in 1949 by James H. Madole, who is in complete control of the Party. The Party's main function is distribution of the National Renaissance Bulletin on a monthly basis and distribution of pro-Arab literature obtained from official Arab establishments in New York City.

The Un-American Activities Committee of the United States House of Representatives in a preliminary report dated December 17, 1954, stated, "NRP activities and propaganda are clearly subversive and un-American."

The handbill entitled "Appeal for John Patler" was furnished to the New York State Police by the New York Office of the Bureau. Accordingly, the New York Office is requested to advise the Bureau, Richmond and Albany of the significance of the reference in the New York State Police report to PATLER.

The New York Office is also requested to identify the subscribers to the phone numbers listed for New York State as set out in the original letterhead memorandum of 2/3/64.

On February 27, 1964, [redacted]  
[redacted] Bureau of Special Services, New York City  
Police Department (NYCPD), advised that on February 26,  
1964, approximately 200 persons demonstrated in the  
vicinity of the Brooks Atkinson Theater, 246 West 47th  
Street, New York City, where the United States premiere  
of the play "The Deputy" was presented.

The purpose of the demonstration was to protest  
the presentation of "The Deputy" which criticizes the  
late Pope Pius XII because of his alleged failure to  
condemn the Nazi Government in Germany for its persecution  
of millions of Jews.

[redacted] advised that the demonstration  
began at about 6:45 PM on February 26, 1964, and the  
last of the demonstrators had left the area by  
approximately 8:15 PM.

American Nazi Party

[redacted] stated that the 200 demonstrators included the following:

The American Nazi Party (ANP) comprised of Matt Koehl, Schuyler Ferris, David Peterson, Alan Meyer, Harry Blair, and Gerald Lynne, all from ANP headquarters in Arlington, Virginia, who had traveled to New York City in Ferris' automobile. Roy Frankhouser and Nelson Pelp, from Reading, Pennsylvania, picketed with the ANP.

Picketing with the American Nazi Party of New York (ANP, NY) were George Lincke, John D. Ryan, Dan Burros, Aristotle Moshos and Douglas Kaye.

[redacted] advised that all of the aforementioned ANP members wore uniforms of khaki shirt and trousers with red armbands bearing white swastikas.

In addition to the above, [redacted] stated that John Hassan of the ANP, NY, appeared at the picket site wearing a black coat, black bib and Roman collar and Charles Mullready appeared wearing a trench coat with black bib and Roman collar. Neither Hassan nor Mullready were permitted to picket on the grounds they did not have sufficient identification with them.

[redacted] stated that John Burke, Dave O'Donnell and Edward Warren Powell, all associated with the ANP, NY were on hand to distribute a leaflet "I Am An American Nazi" published by the ANP, Arlington, Virginia. However, they had no opportunity to distribute this literature since they were placed behind barricades which had been set up by the NYCPD, to contain the pickets and protect them from any hostile onlookers.

It is noted that on February 24, 1964, a confidential source, who has furnished reliable information in the past, advised that on February 22, 1964, while discussing plans for the demonstration at the Brooks Atkinson Theater on February 26, 1964, [redacted] stated he would use the name [redacted] when he picketed on February 26, 1964. [redacted] stated that [redacted] was apparently prevented by [redacted] from picketing with the ANP group because he, [redacted] was underage.

The Ad Hoc Committee to Protest "The Deputy" was comprised of 150 pickets, 75 of whom appeared to be anti-Castro Cubans. This group was under the announced leadership of [redacted] but Luke Donmer and [redacted] both of whom are former members of the now defunct Nationalist Party (NP) appeared to be the actual organizers and leaders of this group.

Approximately 20 members of the Kings County Council of Veterans of Foreign Wars picketed in the vicinity of the Brooks Atkinson Theater.

In addition to the above, six unidentified persons, who showed no affiliation with any group or organization, demonstrated in favor of "The Deputy" proclaiming the presentation was upholding the Constitutional right of "free speech".

On February 27, 1964, a second confidential source, who has furnished reliable information in the past, advised that on February 26, 1964, George Tonsarides, Tillson, New York, demonstrated with the Ad Hoc Committee.

He did not demonstrate with the ANP group in uniform because he stated he was "out on bail" and feared he would jeopardize his case if he were to openly picket with the ANP group.

This second source advised that also observed in the vicinity of the picketing were Edward Cassidy of the National Renaissance Party (NRP), Oliver Safirescu, who has at times associated with the ANP, Emerencia Lincke, mother of George Lincke, leader of the ANP, NY, and Jim Bogen of the ANP, NY.

[redacted] previously mentioned, advised that all of the aforementioned picketing groups were kept behind police barricades away from each other and away from the entrance to the Brooks Atkinson Theater.

In his book "This Time The World", copyrighted in 1961, GEORGE LINCOLN ROCKWELL identified himself as Commander, American Nazi Party of the World Union of Free Enterprise National Socialists (ANP - WUFENS), Arlington, Virginia.

The April 4, 1963, issue of "The Richmond News Leaders", a Richmond, Virginia, daily newspaper, reported that GEORGE LINCOLN ROCKWELL had, on the previous day, again applied for the American Nazi Party to be chartered in the State of Virginia, but this request was turned down by the Virginia State Corporation Commission. This action was taken pursuant to an act of the 1962 Virginia Assembly which prohibits the use of "Nazi" or "National Socialism" in a Virginia charter. This article further pointed out that ROCKWELL's party is presently chartered in the State of Virginia as the George Lincoln Rockwell Party.

On August 19, 1963, a source advised that the ANP - WUFENS was organized by GEORGE LINCOLN ROCKWELL at his residence in Arlington, Virginia, on February 26, 1959, as an international "National Socialist" movement based on the German Nazi Party headed by ADOLF HITLER. He added that ROCKWELL is the dominant force and personality in this party; that he is espousing a "line" of hatred against the Jews and Negroes; and that he is seeking, through speeches, distribution of literature and picketing, to establish a cohesive and dominant political party in the United States and in foreign countries.

On December 13, 1963, this source advised that in about September, 1960, the ANP initiated the Fighting American Nationalists (FAN) as a front group for the ANP, although it has never been a separate organization. He said the FAN name is merely used on occasion instead of the ANP name and there are no separate officials for FAN, the FAN officials being identical with the ANP officials. He stated that GEORGE LINCOLN ROCKWELL has informed him the FAN name was originally used as a device to attract supporters to his organization who might rebel at the use of the Swastika and at being labeled as a Nazi.

He added that the ANP has operated under the FAN name throughout the country with the exception of a group operating under the FAN name in Baltimore, Maryland. He said the FAN group in Baltimore is now, and always has been, a separate organization and not a part of the ANP.

[REDACTED] advised that the Baltimore FAN, which was organized in the Spring of 1961, has no official connection with the ANP, although until December, 1962, it received all its literature from GEORGE LINCOLN ROCKWELL'S ANP.

According to the "Stormtrooper's Manual", an official publication of the ANP, the phases of ANP struggle for power are fourfold, namely, first "to make outelves known to the masses"; second, "the dissemination of our program and the truth about the party"; third, "organizing the people who have been converted to our propaganda"; and fourth, "the attainment of power through the votes of the newly-won masses."

On June 13, 1963, a source advised that GEORGE LINCKE had been designated by GEORGE LINCOLN ROCKWELL, leader of the American Nazi Party (ANP), Arlington, Virginia, to establish in New York City the American Nazi Party, New York (ANP, NY).

According to the source the ANP, NY, will promote, in the New York City area, the policies of the ANP which call for the migration of Negroes to Africa and the trial and execution of all Jews guilty of Communist and Zionist treason.

On December 12, 1963, the above source further advised that the ANP, NY, which formerly had its headquarters in the basement of 214 East 85th Street, New York City, had established new headquarters in apartment 2W, 319 East 93rd Street, New York City, on December 7, 1963. The existence of the new headquarters, in which LINCKE was to take up residence with his mother and two other ANP, NY members, will be known only to trusted members of the ANP, NY.

NATIONALIST PARTY (NP)

On June 28, 1963, [redacted] Bureau of Special Services (BSS), New York City Police Department, advised that the Nationalist Party (NP) was formed on September 21, 1961, and although it has no actual headquarters, maintains a "mail drop" at 507 5th Avenue, New York City.

[redacted] further stated that LUKE DOMMER controls the activities of the NP even though he is not listed as an officer of the NP and that even though NP activities consist of anti-Communist demonstrations, individuals who participate in NP activities have in the past exhibited anti-Semitic tendencies.

On November 5, 1963, LUKE DOMMER, NP leader, advised the NP was then "out of business" for the past several months because the "rise of conservatism" in the United States had negated the need for such an organization.

On November 18, 1963, a source, who has furnished reliable information in the past, advised that [redacted] stated that the NP was completely disbanded and has been defunct for the past several months.

NATIONAL RENAISSANCE PARTY

On July 16, 1963, a source stated that the National Renaissance Party (NRP) is an anti-Semitic, anti-Christian, anti-Negro and neo-Fascist organization, with activities generally confined to the New York City area. It was founded in 1949, by JAMES H. MADOLE, who is in complete control of the party. The party's main function is distribution of the National Renaissance Bulletin on a bi-monthly basis and distribution of pro-Arab literature obtained from official Arab establishments in New York City.

The source further stated that the headquarters for the NRP is located in the residence of JAMES H. MADOLE, at 10 West 90th Street, New York City.

The Un-American Activities Committee of the United States House of Representatives in a Preliminary Report dated December 17, 1954, stated NRP activities and propaganda are clearly subversive and un-American.

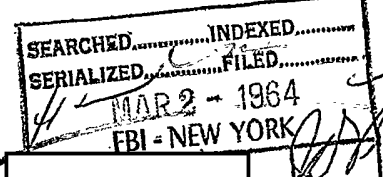

It is noted that on 11/10/62, [redacted] and [redacted] both then members of the now defunct American National Party, appeared outside the Vanderbilt Estate, Route 9, Hyde Park, NY, adjacent to the burial site of Mrs. ELEANOR ROOSEVELT, and displayed signs reading "Good Manners to Red Eleanor" and "Ship Her Smelly Corpse Back to Moscow".

They were arrested by the NY State Police on charges of disorderly conduct and committing an outrage to public decency. On 11/10/62, they pleaded guilty and were sentenced to 90 days in jail and a fine of \$100.

As a consequence of PATLER's arrest, fine and incarceration "An Appeal For JOHN PATLER" was printed listing FRANK BIRDSALL as Treasurer, Appeal for PATLER, PO Box 2272, Newburgh, NY.

The reference to JOHN PATLER, made by the NY State Police in its report, apparently is to show BIRDSALL's connection with him.

It is noted that PATLER is currently associated with GEORGE LINCOLN ROCKWELL's American Nazi Party in Arlington, Virginia.

It is further noted that information has been previously furnished to the Bureau concerning GEORGE TSONTARIDES, mentioned above, and his connections with the American Nazi Party of NY.

WILLIAM HOFF, mentioned above, is known as the NY representative of the National States Rights Party (NSRP), an organization which has no actual office or membership in this area.

NYO does not contemplate any further action with regard to what was set forth in Albany letter, 2/3/64.

JAMES H. MADOLE, leader of National Renaissance Party (NRP), continues to maintain NRP headquarters at residence 10 West 90th Street, New York City. MADOLE and seven others indicted by Bronx County Grand Jury, Bronx, New York, August, 1963, on charges of advocating criminal anarchy, attempted riot, carrying firearms and carrying weapons. Charge of attempted riot dismissed and new indictment charging riot returned December, 1963. Trial currently set for March 30, 1964. Sources advised very little NRP activity since summer of 1963, except for three speeches by MADOLE at African Universal Church, Bronx, New York, 11/63, 12/63, and 1/64. MADOLE in speeches advocated separation of white and black races. Partial contents of various pieces of literature printed by NRP of anti-Negro and anti-Semitic nature set forth. July-October, 1963, issue of "National Renaissance Bulletin" official organ of NRP carries MADOLE's statement "it is impossible for any honest American patriot to defend his own race and nationality adequately without being violently anti-Jewish". August 15, 1963, issue of "Intra-Party Confidential Newsletter" published by the American Nazi Party (ANP) referred to NRP members arrested in July, 1963, as "being unjustly persecuted".

I. LOCATION OF NATIONAL RENAISSANCE  
PARTY (NRP) HEADQUARTERS

On November 8, 1963, NY T-1 advised that JAMES H. MADOLE, leader of the NRP, continues to reside at 10 West 90th Street, New York City, which address also serves as NRP headquarters.

A characterization of the NRP is contained in the appendix of this report.

On December 31, 1963, NY T-2 advised that a meeting was recently held in New Paltz, New York, which was attended by TONY WELLS of the American Nazi Party (ANP); WILLIAM HOFF of the National States Rights Party (NSRP) and JAMES H. MADOLE and PAUL JOACHIM of the NRP. According to the source about fifteen people in all attended this meeting, the exact time and place of which was unknown to the source.

NY T-2 advised that the purpose of the meeting was to discuss the purchase of a farm which would be used as headquarters for all racial organizations and where MADOLE and others would reside. The source stated that MADOLE has frequently expressed a desire to get out of New York City.

The source was unable to furnish the location of the farm mentioned above.

Characterizations of the ANP and NSRP are contained in the appendix of this report.

On January 23, 1964, NY T-3 advised that a usually reliable source had reported to him on January 3, 1964, that the NRP, the ANP and other unidentified racist groups plan to consolidate all groups under the leadership of JAMES MADOLE of the NRP and plan to buy property in the Newburgh, New York, area in order to hold meetings and conduct training there. NY T-3 was unable to furnish any more specific information.

The indictment which was made available by District Attorney ISIDORE DOLLINGER to SA BYDLON on August 16, 1963, in the first count, states that the defendants, acting together, on or about July 13, and 14, 1963, by word of mouth and through the use of literature, advised and taught the duty, necessity and propriety of overthrowing the organized Government by force and violence.

The defendants reportedly advised Detectives subsequent to their arrest, that their purpose in passing out pamphlets and literature was to convince the public of their (NRP) objectives and after convincing the public, they would have the Government adopt their resolutions. These resolutions, were in part, the deportation of the Negro from the United States and the confiscation of property and property rights of the Jewish people.

Assistant District Attorney FARRELL, mentioned above, advised SA BYDLON that a Government adopting such resolutions could only come about through force and violence and therefore, according to FARRELL, the activities on the part of the defendants could be construed as criminal anarchy under the laws of New York State.

On January 9, 1964, [REDACTED] Bureau of Special Services, New York City Police Department advised that on a motion made by the attorneys for the aforementioned eight defendants, the charge of attempted riot was dismissed in the New York State Supreme Court and on December 16, 1963, a new indictment was returned against all the defendants charging them with riot under Section 2090 of the Penal Law of the State of New York.

On March 18, 1964, [redacted] previously mentioned [redacted] advised that with the possible exception of [redacted] and MADOLE, none of the individuals mentioned above can be considered NRP members.

[redacted] stated that DAN BURROS, mentioned above, is now and has been known as a member of the American Nazi Party of New York (ANP, NY) for the past several months and that [redacted] was never known to be a member of any other organization than the ANP.

[redacted] further stated that the NRP appears to have no membership of consequence other than [redacted] and another individual called [redacted] who has been associated with MADOLE for a number of years.

On March 20, 1964, [redacted] stated that the trial of the above individuals which had been postponed and delayed on numerous occasions is now scheduled to take place on March 30, 1964, in Bronx Criminal Court, Bronx, New York.

A characterization of the ANP, NY is contained in the appendix of this report.

### III. ACTIVITIES OF THE NRP

On November 8, 1963, NY T-1 advised that since his arrest during the summer of 1963, MADOLE has held no public meetings of any type and has had very little activity.

On November 18, 1963, NY T-4 advised that on Sunday, November 17, 1963, a meeting addressed by JAMES H. MADOLE, NRP leader, was held from 3:00 PM to 6:00 PM at the African Universal Church, 3802 Third Avenue, Bronx, New York, a Negro church. According to the source MADOLE appeared at the invitation of the members of this church and was one of the persons who appeared as speakers.

ADDISON who was dressed in nun's garb and who is the wife of Bishop ADDISON, WILLIAM HOFF, self-identified New York State representative of the NSRP, and Doctor JOSEF BEN JOCHANNAN, reportedly an authority on African history.

The audiences consisted of about 35 to 40 Negroes and about 25 white people.

In his speech MADOLE advocated strongly the separation of the black and white races and stated that the Negro was inferior to the white man.

On December 11, 1963, NY T-1 made available a mimeographed sheet captioned "Mass Rally to support Racial Segregation and Black Nationalism". This rally was scheduled to be held at the African Universal Church, previously mentioned, and JAMES H. MADOLE, NRP leader was to speak on "A united national front against race mixing and domestic communism".

On December 16, 1963, NY T-5 advised that JAMES H. MADOLE appeared as a speaker at a panel discussion at the African Universal Church, Bronx, New York, on December 15, 1963.

NY T-5 stated that MADOLE's speech consisted of heavy criticism of the Jews who he stated, through passage of the Federal Reserve Act and income tax law, have gained complete control over the operations of the United States Government. MADOLE also advocated complete separation of the white and black races.

NY T-5 stated that other speakers at this meeting were identified with the African Nationalist movement and advocated that the United States Government should pass legislation to give them grants of money so that they might return to Africa to establish their own government.

NY T-5 stated that there were about forty people in attendance at this meeting evenly divided between white and Negro.

On January 21, 1964, NY T-4 advised that on Sunday, January 19, 1964, from 3:00 PM to 7:00 PM a rally to support racial segregation and black nationalism was held at the African Universal Church, Bronx, New York. There were about 25 white people and 25 to 30 Negroes in attendance, with about 12 of the latter group being children of grammar school age. Included among the speakers in addition to JAMES H. MADOLE, NRP leader, were Archbishop CLARENCE C. ADDISON "foremost black segregationist in America", and JOHN GRAVES, attorney for JAMES H. MADOLE.

The source stated that the speeches consisted of anti-Semitic attacks on "Jew-dominated organizations" which were seeking "to destroy and mongrelize both the black and white races" and also urged those in attendance to support racial segregation and black nationalism.

On March 20, 1964, [redacted] stated that NRP activities since MADOLE's arrest in July, 1963, have been confined to the aforementioned appearances of MADOLE at African Universal Church, Bronx, New York.

#### IV. NRP LITERATURE

On August 16, 1963, Mr. JOHN E. METCALF, 166 Locust Street, Garden City, New York, furnished the following pieces of literature, all of which bear the notation of the NRP, 10 West 90th Street, New York City, and all of which he received unsolicited through the mails:

Pamphlet captioned "Who is the Real Enemy?"

NY 105-6112

According to this pamphlet the Jews strive for complete control of the press, radio, motion picture and television industries so that they can bring about complete enslavement of the white race. The pamphlet states that if "white Gentiles are to save themselves from being herded to the slaughter like docile sheep the time is long overdue to organize against our real enemy". The pamphlet goes on to state that if we do not recognize the Jew as our enemy "our race of people will disappear from the earth".

A leaflet captioned "Join NAACP Today". This pamphlet ridicules the National Association for the Advancement of Colored People (NAACP) and states that the "Jews push integration" and that the Communist Party (CP) is behind "race mixing".

A leaflet captioned "Blacks Seen Drowning in Own Tears of Self-Pity", which is authored by one MARY WINSLOW CHAPMAN. This pamphlet states that the Negro rather than helping himself to advance like the white man did thousands of years ago is a "parasite" seeking everybody's pity.

A pamphlet captioned "Youth Movements". This pamphlet states that all youth movements calling for the mixing of Negro and white children, established by Jewish, Christian, political and labor organizations are for the purpose of destroying "the civilized world for communism by mating your White innocent with the loathsome Negro".

On September 18, 1963, Mr. WILLIAM H. SCHULZE, Vice-President, Grey Advertising Incorporated, 430 Park Avenue, New York 22, New York, made available the May-June, 1963, issue of the "National Renaissance Bulletin", official organ of the NRP, which he stated he had received anonymously and unsolicited through the mails.

This issue contains an article by JAMES H. MADOLE in which he states that "America is suffering internally from a cancerous disease known as 'liberal democracy' and the deadly bacilli which spread this evil contagion are classified as Jews".

On November 18, 1963, NY T-1 made available the June, 1963, issue of the "SE Guard" official publication of the Security Echelon (SE) of the NRP. This issue devotes itself to praising the SE which "covered itself with glory" in battling the press of the Jewish War Veterans who reportedly attacked JAMES H. MADOLE during an NRP street rally held on May 25, 1963, in the Yorkville Section of New York City.

On November 18, 1963, NY T-1 made available the July-October, 1963, issue of the "National Renaissance Bulletin". In this issue, JAMES H. MADOLE refutes the statement of "ISIDORE DOLLINGER, the Jewish District Attorney of Bronx County..." "that NRP members distribute literature which calls for the extinction and deportation of various minority groups."

MADOLE goes on to state that the NRP has never advocated the extinction of any racial minority group either in its program, its literature or by word of mouth. According to MADOLE the "major Jewish organizations are using DOLLINGER to legally harass the NRP."

In the same issue MADOLE states "Western Civilization was transplanted from Europe to the North American wilderness in 1492, by Nordic and Anglo-Saxon people. Our nation owes no part of its racial heritage to African aborigines or Jewish usurers. Basically the influence of America's Jewish community has been placed in the service of breaking down all racial barriers and flooding our nation with non-assimilable, culturally alien minority groups. For this reason all NRP members are forced into the position of total hostility towards Jewish goals and ambitions. It would be impossible for any honest American patriot to defend his own race and nationality adequately without being violently anti-Jewish."

This issue of the National Renaissance Bulletin also states that the racial nationalists realizes that a cultural gap of 200,000 years exists between the black and white races.

V. CONNECTION WITH OTHER ORGANIZATIONS

On August 20, 1963, NY T-6 advised that the August 15, 1963, issue of the "Intra-Party Confidential Newsletter" a publication of the ANP, 928 North Randolph Street, Arlington, Virginia, points out that JAMES H. MADOLE and several members of the NRP were recently arrested in New York City and "although we are in sharp disagreement with the NRP on ideological and tactical points, we will never hesitate to go to bat for any fighters for the white race when they are being unjustly persecuted".

1.APPENDIXAMERICAN NAZI PARTY,  
NEW YORK (ANP, NY)

On June 13, 1963, a source advised that GEORGE LINCKE had been designated by GEORGE LINCOLN ROCKWELL, leader of the American Nazi Party (ANP), Arlington, Virginia, to establish in New York City the American Nazi Party, New York (ANP, NY).

According to the source the ANP, NY, will promote, in the New York City area, the policies of the ANP which call for the migration of Negroes to Africa and the trial and execution of all Jews guilty of Communist and Zionist treason.

On December 12, 1963, the above source further advised that the ANP, NY, which formerly had its headquarters in the basement of 214 East 85th Street, New York City, had established new headquarters in apartment 2W, 319 East 93rd Street, New York City, on December 7, 1963. The existence of the new headquarters, in which LINCKE was to take up residence with his mother and two other ANP, NY members, will be known only to trusted members of the ANP, NY.

In his book "This Time The World," copyrighted in 1961, GEORGE LINCOLN ROCKWELL identified himself as Commander, American Nazi Party of the World Union of Free Enterprise National Socialists (ANP - WUFENS), Arlington, Virginia.

The April 4, 1963, issue of "The Richmond News Leaders," a Richmond, Virginia, daily newspaper, reported that GEORGE LINCOLN ROCKWELL had, on the previous day, again applied for the American Nazi Party to be chartered in the State of Virginia, but this request was turned down by the Virginia State Corporation Commission. This action was taken pursuant to an act of the 1962 Virginia Assembly which prohibits the use of "Nazi" or "National Socialism" in a Virginia charter. This article further pointed out that ROCKWELL'S party is presently chartered in the State of Virginia as the George Lincoln Rockwell Party.

On August 19, 1963, a source advised that the ANP - WUFENS was organized by GEORGE LINCOLN ROCKWELL at his residence in Arlington, Virginia, on February 26, 1959, as an international "National Socialist" movement based on the German Nazi Party headed by ADOLF HITLER. He added that ROCKWELL is the dominant force and personality in this party; that he is espousing a "line" of hatred against the Jews and Negroes; and that he is seeking, through speeches, distribution of literature and picketing, to establish a cohesive and dominant political party in the United States and in foreign countries.

On December 13, 1963, this source advised that in about September, 1960, the ANP initiated the Fighting American Nationalists (FAN) as a front group for the ANP, although it has never been a separate organization. He said the FAN name is merely used on occasion instead of the ANP name and there are no separate officials for FAN, the FAN officials being identical with the ANP officials. He stated that GEORGE LINCOLN ROCKWELL has informed him the FAN name was originally used as a device to attract supporters to his organization who might rebel at the use of the Swastika and at being labeled as a Nazi.

He added that the ANP has operated under the FAN name throughout the country with the exception of a group operating under the FAN name in Baltimore, Maryland. He said the FAN group in Baltimore is now, and always has been, a separate organization and not a part of the ANP.

On October 3, 1963, [REDACTED]

[REDACTED] advised that the Baltimore FAN, which was organized in the Spring of 1961, has no official connection with the ANP, although until December, 1962, it received all its literature from GEORGE LINCOLN ROCKWELL'S ANP.

According to the "Stormtrooper's Manual," an official publication of the ANP, the phases of ANP struggle for power are fourfold, namely, first "to make ourselves known to the masses"; second, "the dissemination of our program and the truth about the party"; third, "organizing the people who have been converted to our propaganda"; and fourth, "the attainment of power through the votes of the newly-won masses."

NATIONAL RENAISSANCE PARTY

On July 16, 1963, a source stated that the National Renaissance Party (NRP) is an anti-Semitic, anti-Christian, anti-Negro and neo-Fascist organization, with activities generally confined to the New York City area. It was founded in 1949, by JAMES H. MADOLE, who is in complete control of the party. The party's main function is distribution of the National Renaissance Bulletin on a bi-monthly basis and distribution of pro-Arab literature obtained from official Arab establishments in New York City.

The source further stated that the headquarters for the NRP is located in the residence of JAMES H. MADOLE, at 10 West 90th Street, New York City.

The Un-American Activities Committee of the United States House of Representatives in a Preliminary Report dated December 17, 1954, stated NRP activities and propaganda are clearly subversive and un-American.

NATIONAL STATES RIGHTS PARTY (NSRP)

On November 26, 1957, a source advised that the United White Party (UWP) was organized at a convention held in Knoxville, Tennessee, on November 10, 1957. An article in the November 26, 1957, issue of the "Greenville Piedmont", a newspaper of Greenville, South Carolina, reported "the recent formation of a new political party, to be known as the "United White Party". According to the article, the party was formed at a recently held meeting in Knoxville, Tennessee at which many klansmen were represented. The UWP was reported as being opposed to all "race mixing organizations and individuals".

The July, 1958, issue of "The Thunderbolt", self-described as the "official Racial Nationalist Organ of the National States Rights Party" (NSRP), reported that rank and file "States Righters" had merged with the UWP under "the banner of the National States Rights Party" with national offices at Post Office Box 261, Jefferson, Indiana.

In November, 1958, a source advised that the NSRP is composed of past members of klan-type organizations and notorious anti-Semites.

Issue Number 19, dated June, 1960, "The Thunderbolt", announced the address of the headquarters of the NSRP had been changed from Jeffersonville, Indiana, to Post Office Box 738, Birmingham, Alabama.

On June 17, 1960, a source advised that Edward R. Fields, the Information Director of the NSRP, is the individual who "runs the NSRP".

"The Thunderbolt" continues to publish articles attacking Negroes and persons of the Jewish faith.

There is no record of JAMES or MADELINE MADOLE in the files of the Sacramento Retailer's Credit Association, the Telephone Company, the Sacramento Police Department or the Sacramento County Sheriff's Office.

On March 24, 1964 PATRICK ARMSTRONG, 5302 Whitney Avenue, Carmichael, advised that JAMES and MADELINE MADOLE have resided at 5248 Whitney Avenue for approximately 12 years. She stated that JAMES MADOLE is approximately 70 years of age and his wife is approximately 65 years of age. Neither of them are employed and have not been employed since residing on Whitney Avenue, Carmichael. In conversations with MADOLE, ARMSTRONG has learned that JAMES has been retired from the United States Coast Guard for many years, probably during World War II. They were living in southern California at the time of his retirement and subsequently lived in Grass Valley, California, prior to moving to Sacramento.

# Nazis on Trial— —In the Bronx

By ANTHONY MANCINI

The child of 5 had etched a bold black swastika in his kindergarten notebook.

"That was the first time I got into trouble for my Nazi sympathies," recalls Daniel Burros, ex-security chief of the Neo-Nazi National Renaissance Party.

Now 22 years later, the man of 27 is in more serious trouble. He and seven associates face a possible 4 years' imprisonment on charges of conspiracy, riot and violation of the Sullivan Law for allegedly inciting a riot at a racially-embattled White Castle diner in the Bronx last July.

The ex-paratrooper continued reminiscing about his life-long ties with American fascism.

"I've either belonged to or worked with every radical right-wing organization in existence. I became really active after Little Rock when they used bayonets against white people."

## Enter the Fuehrer

Burros pensively attacked his cheeseburger. The defendants were lunching at the Stadium Restaurant near the Bronx courthouse where their trial is in progress.

"Here comes the Fuehrer," said 18-year-old Edward Cassidy, munching a Virginia ham sandwich (on Jewish rye). He brushed back a lock of his duck-tailed hair.

James H. Madole, 36, balding leader of the Renaissance Party and a co-defendant, made his grinning entrance. The Fuehrer was accompanied by John Graves, defense attorney for Madole, Burros, Cassidy and Peter Krauss, a fourth de-

fendant.

Graves, a self-styled "civil

rights lawyer of the right" greeted the party members: "I keep telling that judge I'm not a Nazi. I'm a Mayflower descendant of William Bradford."

Burros interjected, "This trial is funnier than a comedy show. I have to bite my tongue to keep from laughing."

The trial, entering its fourth day, has been punctuated by frequent outbursts by the four defense counsels. Asst. DA Joseph Cerbone is attempting to establish that on the night of July 13, 1963, the defendants had gone to the White Castle diner at the intersection of Bruckner Blvd and Soundview Av. in a truck loaded with arms and anti-Semitic and anti-Negro literature; and that their intention was to provoke CORE demonstrators.

The 4 other defendants are Anthony Wells, 6, Paul Joachim, 35, John Corrigan, 20 and Ian Lehr, 21.

Lehr is Jewish. The bespectacled, graying Graves sipped his mug of beer: "They're trying to create a situation where it will be against the law to be anti-Semitic. Well, this will never be so... never."

The hands of the clock edged toward 2:15. Lunch recess was almost over. The men left the restaurant and filed back into the courtroom where Supreme Court Judge Irwin Davidson was already at the bench.

## Nazi Denies Provoking Violence at Rights Protest

James H. Madole, leader of the neo-Nazi National Renaissance Party, has ascended a new soap box—the witness stand.

Madole, 36, testified in his own defense at the Bronx Supreme Court trial yesterday in which he and seven others are charged with conspiracy, Sullivan Law violations and inciting a riot during a civil rights demonstration at a White Castle diner in the Bronx last July.

"Our intention was not to provoke the pickets but to recruit new members," Madole testified. "We had reason to believe the

demonstrations would attract large crowds opposed to enforced integration."

Madole swore he knew of no weapons.

The other defendants are Dan Burros, 27, John Corrigan, 20, Paul Joachim, 35, Anthony Wells, 26, Edward Cassidy, 18, Peter Krauss, 18, and Iran Lehr, 21.

# Nazi Trial Hears Jewish Defendant

By ANTHONY MANCINI

The mother of a Jewish neo-Nazi paced the corridor outside the courtroom.

Behind the wood-panel doors, Mrs. Anna Lehr's son, Ian, faced Asst. DA Joseph Cerbone. His fingers drummed a nervous staccato on the arm of the witness chair. His face betrayed conflicting emotions.

"Have you ever been a member of the American Nazi Party?" questioned Cerbone. "Never," came the clipped reply.

Lehr, 21, took the stand yesterday in the Bronx Supreme Court trial in which he and seven others connected with the neo-Nazi National Renaissance Party are co-defendants.

They are charged with conspiracy to incite a riot at a CORE picket line at a White Castle diner in the Bronx last summer.

"I'm not a Nazi but I am a radical right-winger," said Lehr during a short recess. He continued with a quiet smile: "I'm not a member of the NRP but I believe in what it stands for."

The boy's face suddenly darkened as his mother approached.

"I can't talk now," he said, almost inaudibly, and went off to join her.

Although he faces a possible prison term Lehr was recently

married ("I thought it was a good idea at the time"). He and his wife, Mary, whom he describes as "non-political," live in a small apartment in Brooklyn.

Perez Rosenthal, Lehr's lawyer, shook his head sadly. "He's a sick kid," he said. "Just before this happened he'd been under psychiatric care at the Jewish Family Service."

"He went along with this group because he needed someone to go along with—not because he agreed with their philosophies." He nodded toward the other defendants who were milling around the corridor, talking and joking.

There was James Madole, 36, leader of the party; Dan Burros, 27, security chief; Edward Cassidy, 19, a major in the security guard; Peter Krauss, 18, a self-proclaiming gunsmith; Anthony Wells, 26, long-time associate of Lincoln-Rockwell; Paul Joachim, 35, "a loyal American"; and John Corrigan, 20, who "just went along for the ride."

A court attendant shouted, "Case on trial."

Cigaretts were stomped out. The defendants shuffled back into the courtroom.

**Eight Convicted in Bronx Rioting Last July 14**

Eight alleged members of the neo-Nazi National Renaissance Party were found guilty yesterday in Bronx Supreme Court of inciting a riot in connection with a civil rights demonstration last July 14.

A jury of five women and seven men returned the verdict of guilty on 32 of 40 counts after 26 hours of deliberation. The trial had begun on May 7.

At the time, Negroes were picketing the diner for alleged racial discriminatory practices. When two of the eight defendants complained to the police that the demonstrators had damaged their station wagon, detectives who investigated found a cross-bow, guns and knives in the vehicle.

A disorder involving the pick-

ets, and the defendants resulted in riot charges against the eight men. During the trial, the police testified that the group sought to incite to violence the Negroes who were demonstrating and to use the weapons in the station wagon against the pickets then if the police did not act.

The station wagon was parked near the scene of the demonstration, a White Castle Diner at Soundview Avenue and Bruckner Boulevard, the Bronx.

The jury found the group's leader, James H. Madole, 36

years old, of 10 West 90th Street, and Paul Joachim, 35, of 10 Downing Street, and Edward Cassidy, 18, of 348 West 49th Street, Brooklyn, guilty on all five counts.

Anthony Wells, 23, of 541 East 20th Street; Daniel Boros, 26, of 152 West 42nd Street, and Peter Krauss, 18, of 72-14 66th Road, Middle Village, Queens, were found guilty of riot, a felony.

John J. Corrigan, 20, of 330 West 30th Street, and Ian Lehn, 21, of 630 Schenectady Avenue, Brooklyn, were found guilty of unlawful assembly, a misdemeanor.

Justice Irwin C. Davidson set July 16 for sentencing and also ordered psychiatric and probation reports on the eight men.

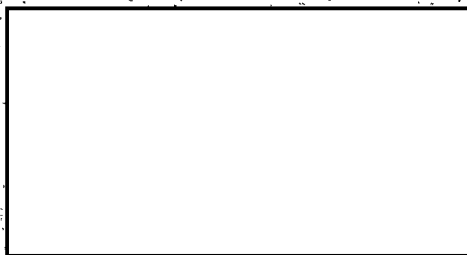

By letter, dated June 8, 1964, the Office of Special Investigations (OSI) made available literature which had been addressed to John D'Angelo, 2006 N.E. Highland Street, Portland, Oregon.

This literature was forwarded by his mother to D'Angelo in Ankara, Turkey where D'Angelo is currently serving in the United States Air Force.

The literature consisted of five 3x5 slips of paper on which was printed a message containing several vulgarities and apparently addressed to people of Italian extraction. The message is rambling and incoherent and appears to accuse the "Jews" and "the Catholic Church" of engaging in some form of conspiracy against people of Italian extraction citing as an example "the Catholic Church officially OK'd the Untouchables as a good program."

The literature exhorts the reader to join the "Renaissance" or "States Rights Party" and pass the literature on to other Italians. It also refers to "the Jew" as "the mortal enemy."

Also enclosed with this literature were postcards addressed to "NSRP, Post Office Box 783, Birmingham, Alabama" and printed "Please send me free of charge your latest issue and literature" with instructions for the reader to print his name and address on these postcards.

On November 15, 1963, Mr. R. J. Hickey, Postal Inspector in Charge, Post Office Department, New York 1, New York, furnished the New York Office of the Federal Bureau of Investigation with the identical literature which had been received unsolicited through the mails by Mr. Michael Russo, 213 Union Avenue, Staten Island, New York, during October, 1963. Mr. Russo had turned this literature over to Mr. Hickey as a possible postal violation and Mr. Hickey in turn had furnished it to the New York Office of the Federal Bureau of Investigation.

## National States Rights Party

In November, 1963, [redacted] Bureau of Special Services, New York City Police Department, advised that his department was aware of such literature being circulated through the mails and stated that it was obviously the work of a "demented and disturbed person" whose identity was unknown.

[redacted] who is familiar with the activities of such organizations as the National States Rights Party (NSRP), and the National Renaissance Party (NRP) stated he is certain that this literature has not received the sanction of either the NSRP or NRP because of the incoherent manner in which the literature is printed and because the NRP and NSRP have not attempted any membership drives in the New York City area.

[redacted] stated that he is convinced that the person responsible for the printed literature is the same individual who is responsible for circulation in 1961 in the New York City area of an anti-Semitic letter addressed "Dear Wop" which appeals to the reader to fight the Jews by sending contributions to the American Nazi Party (ANP) in Arlington, Virginia.

[redacted] stated that in all instances the literature was unsigned and was addressed to people of Italian extraction whose names and addresses were probably secured by searching through telephone directories for persons of obvious Italian extraction.

[redacted] further advised that literature written by the anonymous individual has been turned over to the New York City Police Department Laboratory for examination but no suspects have been developed.

[redacted] stated that the New York City Police Department is of the opinion that the above-mentioned literature is the work of a lone person who is a "mental case."

National States Rights Party

On July 8, 1964, [ ] stated there has been no further development with regard to establishing the identity of the sender of such literature and there has been no evidence of it in the New York City area in recent months.

According to the source the ANP, NY, will promote, in the New York City area, the policies of the ANP which call for the migration of Negroes to Africa and the trial and execution of all Jews guilty of Communist and Zionist treason.

On December 12, 1963, the above source further advised that the ANP, NY, which formerly had its headquarters in the basement of 214 East 85th Street, New York City, had established new headquarters in apartment 2W, 319 East 93rd Street, New York City, on December 7, 1963. The existence of the new headquarters, in which LINCKE was to take up residence with his mother and two other ANP, NY members, will be known only to trusted members of the ANP, NY.

On November 26, 1957, a source advised that the United White Party (UWP) was organized at a convention held in Knoxville, Tennessee, on November 10, 1957. An article in the November 26, 1957, issue of the "Greenville Piedmont," a newspaper of Greenville, South Carolina, reported "the recent formation of a new political party, to be known as the United White Party." According to the article, the party was formed at a recently held meeting in Knoxville, Tennessee, at which many klansmen were represented. The UWP was reported as being opposed to all "race mixing organizations and individuals."

The July, 1958, issue of "The Thunderbolt," self-described as the "official Racial Nationalist Organ of the National States Rights Party (NSRP), reported that rank and file "States Righters" had merged with the UWP under "the banner of the National States Rights Party," with national offices at Post Office Box 261, Jeffersonville, Indiana.

In November, 1958, a source advised that the NSRP is composed of past members of klan-type organizations and notorious anti-Semites.

Issue Number 19, dated June, 1960, "The Thunderbolt," announced the address of the headquarters of the NSRP had been changed from Jeffersonville, Indiana, to Post Office Box 783, Birmingham, Alabama.

Issue Number 54, dated November, 1963, reflects the mailing address of the NSRP is still Post Office Box 783, Birmingham, Alabama.

On December 12, 1963, a source advised that EDWARD R. FIELDS, the Information Director of the NSRP and Editor of "The Thunderbolt," is the individual who "runs the NSRP."

"The Thunderbolt" continues to publish articles attacking Negroes and persons of the Jewish faith.

## Four Neo-Nazis Get Jail Terms

Four members of the neo-Nazi National Resistance Party will serve state prison sentences of from one to two years for rioting at a civil rights rally in the Bronx last Summer.

Labelling two members "hate-mongers," Justice Irwin Davidson yesterday sentenced James Madole, 36, of 10 W 90th st, and Daniel Burros, 26, of 152 W. 42d st., for their part in a riot at the White Castle diner, Soundview ave. and Bruckner blvd.

Paul Joachim, 35, of 10 Downing st. and Anthony Wells, 25, of 541 E. 20th st. got similar sentences but a fifth prisoner, Edward Cassidy, 18, of 348 W. 49th st., was sent to Elmira Reception Center because of his youth. Peter Krauss, 18, of 72-14 66th rd., Middle Village, Queens was given a six-month sentence for conspiring to commit riot—a misdemeanor.

### SIX GET JAIL TERMS IN BRONX DINER CASE

Six men convicted of attempting to start a riot at a civil rights demonstration in the Bronx last July were sentenced to paid terms ranging from six months to two years yesterday in Bronx Supreme Court.

Two leaders, James Madole, 36 years old, and Daniel Burros, 26, were sentenced to two-year terms and characterized as "hate mongers" by Justice Irwin Davidson. He excoriated them for recruiting "for their malevolent purposes young men whom they succeeded in injecting with their own virus of hate." The demonstration in which the men took part was staged at a White Castle Diner.

The defendants were members of the neo-Nazi National Renaissance party. Two other members also received two-year sentences. They were Paul Joachim, 35, and Anthony Wells,

25. Edward Cassidy, 19, was sentenced to one to two years in the Elmira Reception Center, and Peter Krauss, 18, was sentenced to six months in city jail. Alan Lehr, 21, and John J. Gorman, 20, who were also convicted, received suspended sentences.

All were accused of taking a station wagon with an assortment of weapons to the diner at Soundview Avenue and Bruckner Boulevard on July 13, 1963, where civil rights groups were protesting the hiring practices of the diner.

## 4 'Nazis' Sent To Prison for Bronx Rioting

By EDWARD DILLON

Four members of the neo-Nazi National Renaissance Party were sentenced to one to two years in state prison yesterday for sparking a riot at a civil rights demonstration in the Bronx last summer.

In passing sentence, Justice Irwin Davidson lashed out furiously at two leaders of the hate group,

James Madole, 36, of 10 West 90th St., and Daniel Burros, 26, of 152 W. 42d Street.

Calling them "hate mongers," Justice Davidson said they "did not hesitate to recruit for their malevolent purposes young men whom they succeeded in injecting with their own virus of hate."

The two leaders took six other would-be storm troopers in a station wagon to the White Castle diner at Soundview Ave. and Bruckner Blvd., where civil rights groups were picketing, and commenced distributing anti-Negro literature.

### Gets Six Months

Violence flared, and, when police searched the car, they found several guns, a switchblade, rifle, a cross-bow and other weapons.

Madole and Burros were convicted June 1 of riot, a felony, as were Paul Joachim, 35, of 10 Downing St., Anthony Wells, 25, of 541 E. 30th St. and Edward Cassidy, 18, of 248 W. 49th St.

Joachim and Wells were given one-to-two year stretches in state prison. Cassidy, because of his youth, will serve the same time in Elmira Reception Center.

Peter Krauss, 18, of 72-14 66th Road, Middle Village, Queens, was sentenced to six months in the city penitentiary for conspiracy to commit riot, a misdemeanor.

Ian Lehr, 21, of 630 Schenectady Ave., Brooklyn, received a suspended sentence and was placed on probation for three years on the same charge.

John J. Corrigan, 20, of 230 E. 30th St., was given a suspended sentence and placed on probation for three years for possession of a switchblade knife.

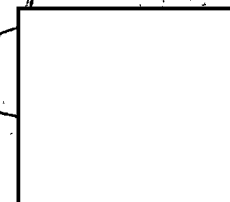

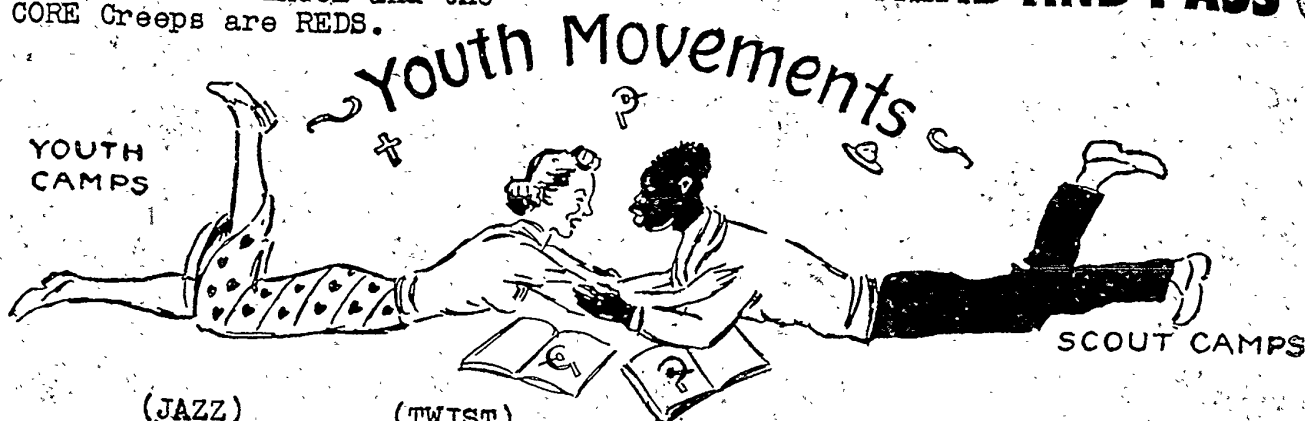

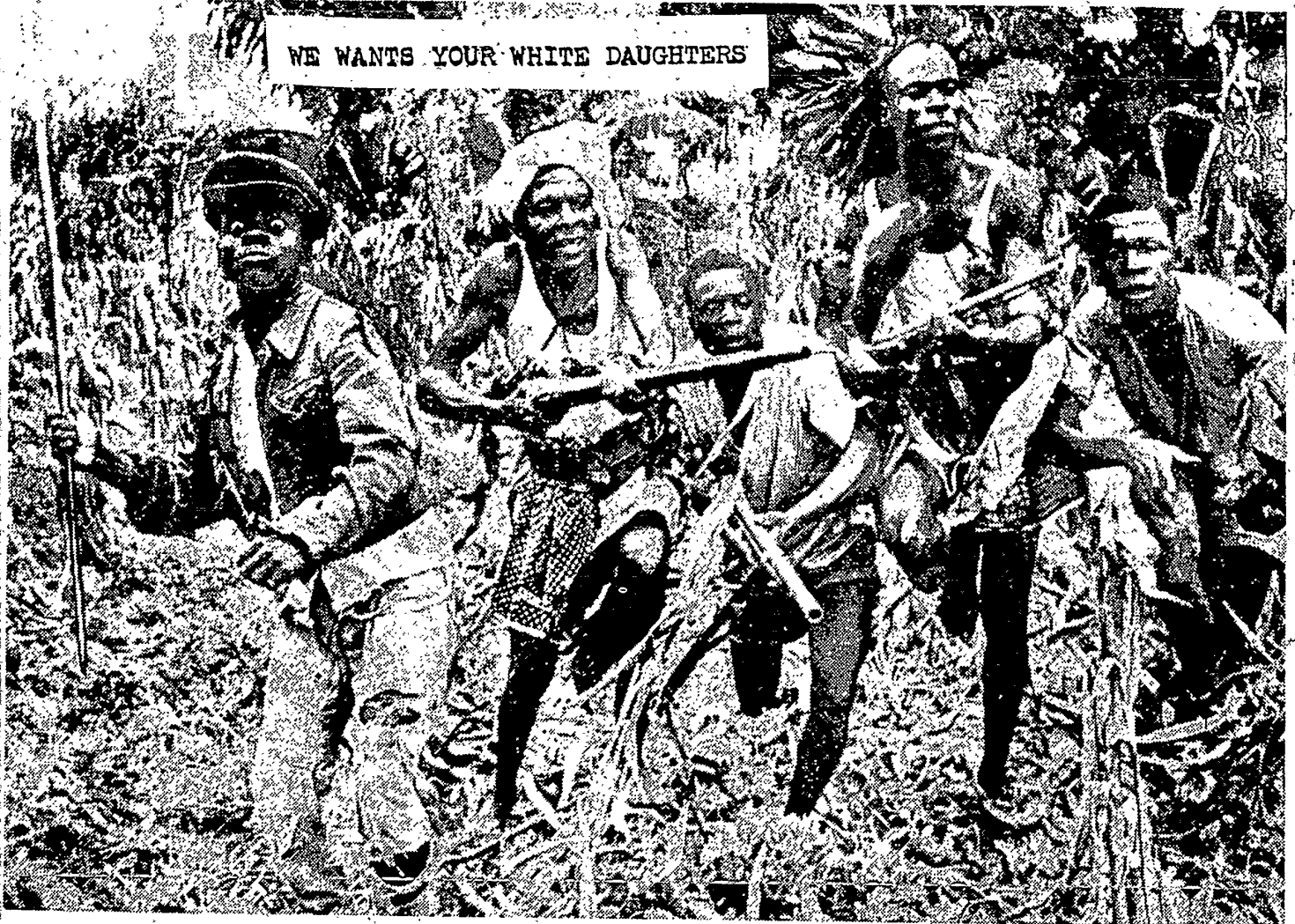

# Blacks Seen Drowning In Own Tears Of Self-Pity

Complaints about the plight of the Negro in America ring forth these days with the mournful regularity of a monotonous bell-buoy, but some of them out-"dong" the rest. In particular is this true of the utterances of James Baldwin, which drip with such paranoiac self-pity that they seem more suited to publication in a medical journal than in *Time* and the *New Yorker* where they now appear. A persecution complex is one of the best-known symptoms of mental illness. When we see it being exploited by sensation-hungry publishers and encouraged by an emotional public, we may deduce a not-too-healthy state of mind in the country as a whole. It is not too soon to suggest a return toward reality, to administer to fantasy the sure antidote of fact—in this case, facts well known, but intentionally detoured, such as the following:

Slavery neither began nor ended South of the Mason-Dixon line. It has existed since the beginning of history and still exists behind the Iron Curtain. It has nothing to do with race, creed, or color. There were many white slaves in America, but they left no distinguishing mark upon their descendants. *The Negro's problems are not due to the fact that he WAS a slave, but that he IS a Negro!*

The natives of Africa were in no sense being persecuted when they were brought to this country in

chains. That was strictly a business proposition and they were the only people so primitively helpless as to allow themselves to be driven aboard the slave ships like cattle, a procedure made infinitely easier by the help of their own countrymen who did not hesitate to betray their fellow Negroes for a price. This lack of loyalty to their race is still evident in their descendants and will show up in any serious study of the Negro in this country. Statistics published since the first of the year indicate that the Negro's high crime rate (six to one as against the whites) consists to a large extent of acts of violence against members of his own race.

Once transplanted to this country, the Africans tended from a physical standpoint to flourish. At its best, when the slave fell into good hands, his material well-being was superior to anything he could have dreamed of at home and at its worst, it must still be compared to his former life in a region where culture was at the cannibal stage.

In the failure to make this comparison lies the root of most of the American Negro's troubles today. He feels inferior because he is being made to measure himself not against his own African background, but in the brilliant light of European history. He is being taught that he is cheated not because he has been robbed of his

own, but because he does not instantly fall heir to the sum total of another man's inheritance. The result of these mistaken attitudes is a flood of piteous tears—his own and everybody else's—in which he is likely to drown if not soon rescued.

For America's compassion is easy to arouse. We are proud to consider ourselves the most tender-hearted people in the world. But we would be blind not to recognize that, even in our case, this is a fairly recent development. We do not have to look back many years to find a totally different set of feelings about cruelty and pain. The history of our own civilization is dark with man-made suffering of all kinds including various episodes of slavery. At the time thousands of years ago, when our ancestors were at the cultural stage now represented by the primitive Africans, their condition was infinitely worse than anything existing today. There was no UN to boost their ego and no foreign aid to dispense hand-outs. They suffered and endured and worked through long millenia to create this wonderful civilization of West-

ern man, which is now so busy showering its benefits upon the backward peoples of the world.

But while largesse is being poured out upon the Negroes abroad and sympathy upon the ones at home, there is one thing we must all bear in mind: *That material riches can indeed be passed from man to man, but character cannot!* It is the non-transferable fruit of long generations of patient effort, the effort which the Negro himself will have to make before he can fully benefit from the opportunity now offered him. And if in America he wants to become something more than a whining parasite upon the white man's civilization, he will have to pull himself together, stop making excuses, and get on with the job of being a responsible and valuable citizen.

For one thing is crystal clear—the more he seeks the limelight of everybody's pity, the less worthy will he seem of anyone's respect and the farther will he be from what he claims to desire most — full recognition as an equal and a fellow man.



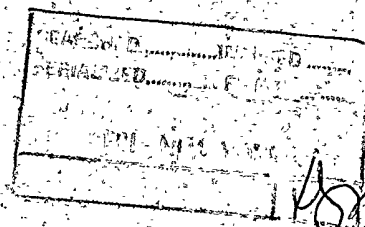

It was founded in 1949, by JAMES H. MADOLE, who is in complete control of the party. The party's main function is distribution of the National Renaissance Bulletin on a bi-monthly basis and distribution of pro-Arab literature obtained from official Arab establishments in New York City.

The source further stated that the headquarters for the NRP is located in the residence of JAMES H. MADOLE, at 10 West 90th Street, New York City.

The Un-American Activities Committee of the United States House of Representatives in a Preliminary Report dated December 17, 1954, stated NRP activities and propaganda are clearly subversive and un-American.

For the information of the Bureau, relet dated 9/29/64, contained information from [redacted] reflecting that all activities of the National Renaissance Party ceased on 7/16/64, on which date MADOLE was sentenced to two years in jail. This source further advised that although MADOLE had been set free on bail pending an appeal of the above conviction, the National Renaissance Party would not be reactivated by MADOLE pending the outcome of his appeal, and that it was unlikely that it would ever be reactivated by MADOLE even if he should win his appeal. In view of the information furnished by [redacted] the NYO case file on the National Renaissance Party was placed in a closed status.

# Racist Group's Use Of Courthouse Hit

Mrs. Gwendolyn Scott Sayles, chairman of the newly organized, Newburgh Taxpayers League, led a fight today to prevent use of the Orange County Courthouse in Newburgh by an extreme right-wing organization.

Mrs. Sayles said she was shocked to receive an unsolicited call from a representative of the National Renaissance Party in Newburgh, urging her to attend a Jan. 29 meeting at the courthouse as a "10 per cent blue blood Aryan American."

Mrs. Sayles said the call came from Robert Burros of 215 First St., Newburgh, regional director for the party. She said she told him she had never heard of the party, and questioned him about its philosophy. She quoted him as saying that the party was against Communism, but not against Nazism or Fascism.

Contacted by THE EVENING NEWS today, Mr. Burros denied that he had made such a statement concerning the Nazis or Fascists, "We can take no stand on them because they no longer exist," he said.

In Goshen, Smith Barnes, superintendent of buildings and grounds for the county, said that he had an appointment to meet Mr. Burros in Newburgh this afternoon to discuss the Jan. 29 use of the court building.

Mr. Barnes said it was possible that a janitor had given tentative approval for use of the building, which is generally made available for political and educational groups. But if there is any question about the nature of the organization, the permission will be withdrawn, he added.

Mrs. Sayles quoted Mr. Burros as advocating the shipment of Negroes to Africa. She said she retorted: "What is the matter with you, anyway? How would you like to be shipped back to the countries your people came from? What is your descent?" She said his reply was "I'm half Russian and half German descent, but I'm an American."

ending in a brawl. Another one was held in June at the same place, the Washington report stated, and in July, a cache of arms was found in New York and three NRP members were arrested on charges of violation of a New York anarchy law.

Mr. Burros said today that he was a native of Newburgh but had done considerable traveling during the past few years. He said he was in the exporting business.

Mr. Burros noted that his organization has 30 members in Orange County and hopes through meetings to be able to swell these numbers to many more with the ultimate aim of "coming to power" in the United States government. He said

this would eventually be accomplished "through the vote."

"Our goal is a return to the constitutional republic, the preservation of national sovereignty by means of an iron military defense against Asiatic barbarism, and the establishment by means of the ballot the regime based on the principles of social justice, economic traditionalism and racial nationalism," he said.

The NRP official said that in his organization's opinion the world will someday be divided into several racial blocs. The United States, Canada, Western Europe and the White Russian parts of the Soviet Union, would form one of these.

Another bloc would include

the Mongolian yellow racial groups, including all the Asiatic nations and all the Mongolian parts of the Soviet Union. The third racial bloc, he said, would be the African nations.

"The Latin American nations would be the object of imperial dispute among the three racial blocs," Mr. Burros said, "because those nations are divided and hemorrhaged by chaos, anarchy and general political confusion. There is too broad a proliferation of political parties in that continent."

The organizer declared that his group was an "American First" collection of Americans of all creeds and color with one single purpose—to fight Communism.

Mrs. Sayles said the caller told her the party headquarters were in New York City but that leaders felt that Newburgh would be a good operating base for upstate recruiting.

Mrs. Sayles said she called the courthouse and learned that a custodian had given Mr. Burros permission to use the building. She also noted that two supervisors to whom she talked both thought the Renaissance party was some kind of art society because of its name.

Mr. Burros, in a telephone interview identified himself as international secretary of public information and propaganda for the National Renaissance Party, which he said was organized in 1949 by James Madole, formerly of Beacon and now of New York City.

In Washington, the Gannett News Service reported that the National Renaissance Party is currently not on the Attorney General's Office's list of subversive organizations, but the party had been cited by a House Subcommittee on Un-American Activities in December 1954 as a neo-Fascist organization and described as clearly subversive and un-American.

The report said that at that time, Madole operated the organization out of his apartment at 10 W. 90th St., New York City. Party members, it said, wore black and brown uniforms with a thunderbolt insignia. The organization apparently emerged from Yorkville where a rally was held on May 26, 1963.

## Courthouse Use Denied To Group

Albert C. Howell, chairman of the Orange County Board of Supervisors, today denied the request of the National Renaissance Party (NRP) to use the Orange County Courthouse at Newburgh for a meeting this Friday night. 1/29/65

Robert Burros of 215 First St., Newburgh, regional director for the extreme right-wing organization, immediately said the NRP's attorney "will question the constitutionality" of the decision. He said the American Civil Liberties Union and the Civil Rights Commission in Washington have been alerted to the situation.

The fight to prevent the NRP access to the courthouse was led by Mrs. Gwendolyn Scott Sayles, chairman of the newly-organized Newburgh Taxpayers League.

Mr. Burros said that since the meeting can't be held at the courthouse, where it was to have been open to the public, it will be held at a member's home and closed to the public and press.

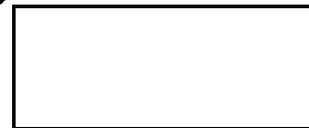

## **Renaissance Rally**

Freedom of speech and freedom of assembly are precious to the American, democratic form of government. In fact, there are constitutional measures to protect such freedoms.

However, the question does arise occasionally as to whether public buildings and taxpayer-supported facilities should be available to all, and under any circumstances.

Great Britain, from whom we took many of our principles in this respect, including the Magna Carta wrung from King John, has a place where orators can speak freely in Hyde Park, and attacks are permitted there upon even the government which protects the practice.

Newburgh and Orange County are confronted with a problem now, concerning whether an organization known as the National Renaissance Party should be permitted to use the county courthouse in Newburgh for a meeting on Jan. 29.

The Party is not on the attorney general's list of subversive organizations, but it does bear a substantial indictment at the hands of the House Committee on Un-American Activities. Some of the principles described by its local spokesman bear the stamp of racism and the aura of alleged Aryan supremacy so strongly disapproved by most Americans.

There may be some superior Aryans, just as there may be some superior Semites and other Whites, and some superior members of the Yellow, Black and Red Races. There also are some inferior members of all those races, and a great many, good, ordinary people.

Objections to use of the county courthouse by such a group look virtually as valid as those which might be raised with respect to its use by Communists.

Such use of public facilities could be construed by many persons as some sort of public approval for the assembly. There is also the likelihood that the legitimate objections of other groups could make it necessary for law enforcement officials to intervene, with violence and injuries.

The Supreme Court has held that the right of free speech cannot be extended to include the right to cry, "Fire" in a crowded theater.

Yet there is the dangerous alternative that denial of the right to assemble peacefully and speak publicly can force those so denied into clandestine meetings and activities wherein the light of truth and reason may be withheld.

This matter involves rights and privileges precious to us all. Perhaps the answer is for county officials to make sure public facilities are not used for potentially disloyal and treasonable activities.

Of course, there are laws which define disorderly conduct and these laws have teeth in them. If any group misbehaves in public and violates such laws, there should be no reluctance to make the necessary arrests and provide fair and speedy trials.
