## **Don't Support the Preachers Who Support the Rumford Act**

The social program of the the National Council of Churches and that of the Communist Party are now largely the same. The California churches shepherded by the pro-Rumford Act preachers support the National Council of Churches. The preachers have adopted numerous social policies first advocated by the agents. The churches of these preachers pay no taxes to help support the welfare relief load which a colored invasion increases, and yet they favor forcing integration by Rumford Acts and by busing white children into Negro areas to balance the races. Don't support these preachers with **your money**.

If not checked, the unwed colored mothers on relief will soon produce a permanent imbalance—until the Whites are absorbed.

## **Not Only Treatment But the Quality Of the Treated Is a Factor**

A characteristic of the body of a parent acquired through use, such as strength of arm or education of the brain, is not inherited by offspring. There is no mechanism for the transmission through the genes of an environmentally produced modification of a part of the body of the parent to the same part of the body of the child. An educated brain does not send a picture of itself or telephone instructions to the gene stream for reproduction in the next generation.

Education alone, therefore, cannot increase the capacity of the Negro to be educated for moral and intellectual achievement. Strict selection of the more intelligent as parents through a thousand generations would be required to change the Negro brain to equal that of the white man.

Heredity determines capacity for culture; culture has no effect on heredity.

there is no bad seed, that seeds of the individuals of a species are all equal is a Communist dogma, known as Lysenkoism, which the pro-Rumford Act Christian preachers, though they may deny in words, accept in practice. They lead their followers via taxation to subsidize the more rapid reproduction of colored people.

Whoever believes that the different races are equal should compare Europe with Africa, and the parts of Africa where Europeans are or have been in control with the areas where there are no Europeans.

Equality for unequal achievement is injustice.

If religion is whatever prevents the free exercise of the intellect, racial equality (blind brotherhoodism) is today the world religion, and telling the truth of racial differences is the supreme blasphemy.

If the levelers, the anti-discriminators, are not defeated, they will destroy quality. Under the leadership of the pro-Rumford Christian preachers and Communist agents, the white race cannot be saved from absorption by the already more numerous and more rapid-breeding colored masses.

Most of the Whites campaigning against repeal of the Rumford Act, against Proposition 14, live in segregated areas; when Negroes move in, they move out, hypocritically shouting as they run, "Justice!", "Humanity!", and "Decency!", and "Down with Hate, Bigotry, and Bias!".

Preferring one's own kind as neighbors and associates has not heretofore in America been declared a criminal act.

Private property is the basis of Freedom. Without it there is no effective resistance to domineering government officials.

Denying a citizen the legal right of freedom of choice in the sale or renting of houses or apartments largely deprives him of ownership—except in the paying of taxes.

#### The Real Issue

That racial differences are not at issue in this repeal contest is a transparent pretense.

The Rumford Act makes blockbusting easy for undesirable types. Once they gain entrance, property values sharply decline.

Family busting will follow—as soon as the preachers and the agents train the Whites to accept it.

When Negroes enter a community, their percentage on the welfare rolls soon exceeds that of the Whites; and, through geometrical increase in more rapid reproduction, especially of unwed mothers on relief, they eventually overcome and absorb the Whites.

A few preachers and agents mildly oppose the begetting of illegitimates; they are silent concerning the low quality of the begotten—an evil of far greater social consequences.

On taking over a white residential area, Negroes convert it into a slum. Such people cannot maintain a civilization; they can only destroy.

The immigration of Negroes into white neighborhoods from slums, which they have made, will not solve the problems of the slums but will create new problems for their new neighbors: cries will arise — “More police!”, “More lights!”, “More locks!”, and when the sun is down, Fear shall freeze them to their homes. Crimes of violence will increase.

The percentage of Negro criminals is proportionally several times that of Whites, especially in crimes of violence — assault, robbery, rape, and murder.

In most interracial crimes, the victim is lighter than the criminal. The pupils in the difficult schools in our large cities, those who have been expelled from the regular schools for anti-social conduct, are nearly all colored.

It is social madness to let loose among civilized people a rapid-breeding people mentally qualified for jungle life. Indiscrimination inevitably debases the better human types.

Most Negroes of distinction are mulattoes more white than black. When next you read a news item of a “Negro” appointed to high office, illustrated with his picture, see for yourself.

Don't let the Christian preachers and the Communist agents train you to feel guilty of the crimes of your ancestors, to feel responsible for the slave trade and slavery. (Most of the Blacks brought to America would have suffered a worse fate in Africa. Some of them would have been eaten by cannibals and their women and children would have been traded as livestock, as is done to this day in the areas where there are no Whites.)

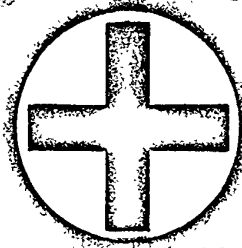
Civilized nations do not, in their laws accept the barbaric dogma of inherited guilt now propagated by the preachers and the agents.

A confidential source, who has furnished reliable information in the past, advised on December 18, 1965, that from 12 Noon to 2:00 PM on that date, the National Renaissance Party (NRP) picketed the British Empire Building, Rockefeller Center, 50th Street and 5th Avenue, New York City.

The following NRP pickets participated, and with the exceptions of Robert Burros and [redacted] these pickets were dressed in Nazi-type uniforms:

The purpose of the picketing was to support the regime of Ian Smith in Rhodesia, Africa. Placards were carried which stated "Keep Rhodesia Under White Rule" and "Race Mixing Breeds Mongrels". There was also a placard which stated "Support Your Local Police" and some leaflets were passed out which urged support for local police and disclaimed allegations of police brutality.

According to the source, the picketing was orderly and there were no arrests or incidents.

A characterization of the NRP is attached hereto.

NATIONAL RENAISSANCE PARTY

On May 19, 1965, a source stated that the National Renaissance Party (NRP) is an anti-Semitic, anti-Christian, anti-Negro, and neo-Fascist organization with activities generally confined to the New York City area. It was founded in 1949 by James H. Madole, who is in complete control of the Party. The Party's main function is distribution of the "National Renaissance Bulletin" on a bi-monthly basis and distribution of pro-Arab literature obtained from official Arab establishments in New York City.

The source further stated that the headquarters for the NRP is located in the residence of James H. Madole at 10 West 90th Street, New York City.

On March 4, 1965, Robert Joseph Burros, 215 First Street, Newburgh, New York, advised that he is the National Secretary of the NRP and as such is second in command to James H. Madole, National Director. Mr. Burros stated that the NRP is a fascist organization but that it operates openly. He stated that the NRP advocates the use of the ballot in order to win a national election and take over the government. If the NRP should gain power it would then proceed to change the constitution in a legal way in order to give it the right to use militant means in dealing with those who would seek to overthrow this democracy such as the Communist Party.

The Un-American Activities Committee of the United States House of Representatives in a Preliminary Report dated December 17, 1954, stated that NRP activity and propaganda are clearly subversive and un-American.

On September 29, 1964, a second source advised that on July 16, 1964, James H. Madole, National Director of the NRP, was sentenced to two years in jail following his conviction on a charge of riot.

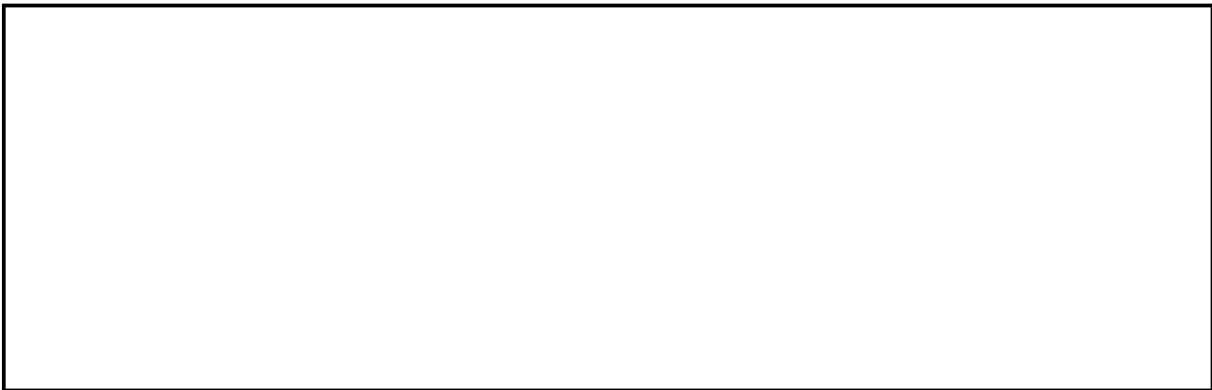

NATIONAL RENAISSANCE PARTY

Subsequent to July 16, 1964, all activities of the NRP appeared to have been suspended. As of September 29, 1964, James H. Madole was free on bail pending an appeal on his conviction and sentencing on July 16, 1964. This source advised that the NRP would not be reactivated by Madole who feared that such reactivation might jeopardize his appeal.

By letter dated January 3, 1966, Mr. RALPH A. ULVELING, Director, Detroit Public Library, Detroit, Michigan, advised that within days after his name appeared in the "New York Times" about two months ago regarding a brief item in which the child's jingle "Ten Little Niggers" was mentioned, he began receiving periodically Negro hate literature.

Mr. ULVELING furnished this literature to the Detroit Office and it is noted that it apparently was received in five separate envelopes, only one of which had a return name and address, that being the one of captioned subject. However, all five envelopes appear to be from the same source. The envelopes had contained leaflets issued by "The National States Rights Party" and the "National Renaissance Party", as well as copies of the newspaper "The Thunderbolt".

This office assumes that your office is already aware of the existence of this literature and it will be retained in Detroit for a period of thirty days, after which it will be destroyed.

## Supreme Court Decision

# Courthouses Open to NRP

BY MICHAEL KRAWETZ

Supreme Court Justice Leonard J. Supple Friday gave the nod for the National Renaissance Party, to use the Orange County courthouse in Newburgh for public meetings.

He has ordered Orange County to issue a usage permit. James H. Madole, national director of the neo-Nazi NRP immediately announced that he will apply to use the Newburgh courthouse for a meeting Feb. 12.

On that date, Robert J. Burros, of Newburgh, regional director of the National Renaissance Party, is expected to announce his candidacy for assemblyman on the extremist NRP ticket.

In handing down his decision on a show cause order by the NRP against the Orange County Board of Supervisors and county officials, who previously had denied the neo-Nazi unit the courthouse for meetings, Judge Supple confirmed that the NRP was a "party espousing Nazi-like principles, including some which the court and all counsel unalterably oppose."

But Justice Supple stated his declaration in allowing the NRP use of the Newburgh courthouse was not an approval of the unit's extremist activities but instead, was intended to end unconstitutional means that had been used to thwart NRP activities in this area.

In his decision, Supple held that the NRP meets a legitimate public objective insofar as election procedures are concerned.

Judge Supple wrote that the board's regulations, denying the unit use of the Newburgh courthouse, were unconstitutional and in violation of Article One, Section 11, of the state Constitution. That document states "no person shall be discriminated because of his civil rights, race, color, creed or religion."

Thomas Hadaway, Orange County attorney, who represented the Orange County Board of

Justice Supple also noted in his decision that there was no finding of evidence that the board's restriction was dictated for reasons of economy, and noted that by authorizing the unit use of the courthouse, there was no possible danger to persons or property.

He then ordered the issuance of the permit provided the NRP complied with the procedures specified by the county and upon payment of the required fees.

Last June, the Orange County Board of Supervisors adopted rules and regulations restricting

off-hours usage of buildings to political parties as defined by election law and for public meetings. The board had denied the NRP's request to use the Newburgh courthouse on Oct. 16, while three other NRP requests to use the courthouse were also denied.

## Denial unconstitutional

## Judge permits neo-Nazis courthouse use

By RAYBURN F. HESSE

GOSHEN

The Supreme Court Friday declared Orange County's rules governing use of county court houses to be unconstitutional, and ordered the county to issue a usage permit to the neo-Nazi National Renaissance Party (NRP).

James H. Madole, NRP national director, immediately announced he will apply to use the Newburgh courthouse for a meeting Feb. 12 at which NRP Regional Director Robert J. Burros of Newburgh will announce his candidacy for assemblyman on the NRP ticket.

County officials seemed surprised at the decision rendered by Justice Leonard J. Supple in the Article 78 proceeding brought by Madole against the county, but made no comment pending discussion of the ruling next Wednesday at a meeting of the buildings committee.

The introduction of a neo-Nazi, anti-Semitic, anti-Negro party's candidate into county politics sparked a spirited repartee between William E. Doulin and B. Sears Hunter, Republican and Democratic county chairmen, but brought no denouncements of either Burros or the NRP.

## Use restricted

Madole instituted the test case after Buildings Superintendent Smith Barnes, citing regulations adopted by the board in June, denied NRP's request to use the Newburgh court house on Oct. 16. Three previous NRP requests had also been denied, one in March by a 30 to 4 vote of the supervisors. In June, the board adopted rules and regulations restricting off-hours usage to political parties as defined by election law and for public meetings, hearings, or other functions sponsored by local, state and federal agencies.

The NRP has never fielded a gubernatorial candidate and thus does not meet the definition of political party contained in the election law. Under the county regulations, therefore only Republicans, Democrats, Liberals, and Conservatives, upon payment of a \$10 fee, can use the court houses.

Attorney Jeremiah S. Gutman of the American Civil Liberties Union argued in Madole's behalf in a December hearing before Supple that the county's sole reason for denying NRP usage was the antipathy with which the defendants regarded the views and opinions of NRP.

He said the board adopted the new regulations to prevent NRP from freely assembling and expressing its thoughts and to harass and hinder NRP's legitimate political activities.

Gutman emphasized, in conversation with Times Herald-Record reporters, that he was not in sympathy with the views of NRP leaders but was defending their freedom of speech.

The petition alleged that NRP advocates the preservation of American national sovereignty, racial nationalism, and the establishment by constitutional means of a government composed of an intellectual, managerial and military aristocracy.

## Constitutional issue

Supple took judicial notice that NRP is a party espousing Nazi-like principles, including some which the court and all counsel unalterably oppose.

However, Supple held that the issue presented is not approval of NRP's objectives but whether government had used unconstitutional means to hamper NRP activities.

Supple held that the election law's regulations, insofar as election procedures are concerned, meets a legitimate public objective.

In the NRP case, Supple wrote, the court "searches in vain for the legitimate public objective which is to be served by limiting off-hours use to the four political parties."

The judge noted there was no finding or evidence that the board's restriction was dictated for economic reasons, that possible danger to persons and property was not involved, and that there was nothing to suggest the four political parties usually conduct peaceful meetings whereas smaller parties do not.

In conclusion, Supple held that the board's regulations, insofar as they deny NRP use of the court house, were unconstitutional and in violation of Article One, Section 11, of the state constitution which says no person shall be subjected to any discrimination of his civil rights because of race, color, creed or religion.

He ordered the issuance of a permit upon application by NRP in compliance with the procedures specified by the county and upon payment of the required fee.

Burros was not available for comment on Madole's announcement that he would seek election from the Assembly district now represented by Republican Daniel Becker.

Madole said he, Burros and other party leaders would speak at the meeting. Madole also indicated NRP would be politically active in opposition to the 30 supervisors who voted against the party in March.

Becker said he doesn't know whether he will be a candidate for re-election in November but, if he is, he would be very happy to run against Burros.

Hunter said the Republican-controlled board made Burros a martyr by denying him use when it could have ended the matter by letting him speak. Hunter acknowledged that NRP's philosophy is insulting to veterans and to those who suffered under Nazi Germany but said NRP, no matter how offensive, has a right to speak.

## Would destroy party

Hunter said all extremist groups are a detriment to the nation's political life. The only purpose of such groups is to destroy the Democratic party, he said, asserting his belief that Conservatives, the NRP, and others infiltrate the Republican Party so that they can be the power that defeats the Democrats.

Taking umbrage at references to the Republican, Doulin said, "If Hunter is going to say that, then I'm going to say Hunter and the Democrats put them up to this suit to embarrass the board's Republican majority."

About Burros, Doulin said, "That's fine. I hope that's all the opposition Becker has."

Hunter said the mature course for the major political parties would be to ignore Burros and the NRP.

## Supple to Sign NRP Order

GOSHEN — Supreme Court Justice Leonard Supple is expected to sign an order Wednesday which would permit the National Renaissance Party the right to use Orange County Courthouse at Newburgh or Goshen for political meetings.

County Atty. Thomas R. Hadaway said he had received a notice of the date for settlement of the order which will be based on an opinion given by Justice Supple last week.

Mr. Hadaway said he might file a notice of appeal in the decision but would leave any action on such appeal to the County Board of Supervisors for a final decision.

Until such decision the use of the courthouse would be limited to the board's rulings of last June 1. At that time the

supervisors voted to limit the use aside from regular court purposes, to federal, state and county agencies and to bona fide political parties as defined under the election law.

The state election law requires that the party, in order to be recognized, must have obtained 50,000 votes in the state at the last election.

The proposed order to be submitted by the NRP for Judge Supple's signature next week states that the rules of the board as of last June 11 are deemed in violation of the state constitution. The order would decree that the county be ordered to issue a permit for use of either courthouse on the filing of a new application by NRP and the payment of the required fee.

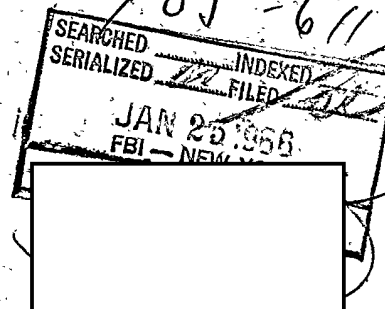

## Orange Told to Issue Permit To NRP for Use of Courthouse

GOSHEN — Supreme Court Justice Leonard J. Supple, in an order filed Monday, directed Orange County to issue a permit to the National Renaissance Party — upon its filing of a new application and fee — for use of the county courthouse at Newburgh or Goshen.

Justice Supple had handed down an opinion on the subject earlier and the NRP, an extremist group, had sent \$10 and an application to Smith Barnes, Orange County superintendent of buildings.

Since there was no court order at the time, Mr. Barnes returned the money.

The county had denied a similar application last year and subsequently the Board of Supervisors adopted rules limit-

ing the non-court use of the two courthouses to federal, state and county purposes and to political parties which qualify under the definition of such by state law.

Justice Supple accepted a broader definition of political parties and ruled that the county's rules and regulations for use of the courthouses was deemed in violation of the state constitution.

The court's order apparently did not rule out the supervisors' entire regulation since it specified that the petitioner receive

the right to use the courthouse upon "payment of the required fee in compliance with the procedures specified in the aforesaid rules and regulations."

The action was brought by James H. Madole for the NRP, against Mr. Barnes; Albert C. Howell, chairman of the Board of Supervisors; Lester J. Roosa, board clerk, and the board itself. The party was represented by Jeremiah S. Gutman, counsel for the New York Civil Liberties Union. County Atty. Thomas R. Hadaway appeared for the county.

A threat Wednesday by the National Renaissance Party to charge Orange County Attorney Thomas P. Hadaway with contempt of court order at least was nullified within the hour by the NRP's attorney, who quickly apologized to Hadaway.

NRP regional organizer Robert J. Burros called The Times Herald-Record Wednesday morning.

saying "illegal" documents, which would cite Hadaway for contempt of court if he did anything to prevent the NRP's Feb. 12 meeting, would be served on the county attorney Wednesday afternoon.

Attorney Jeremiah S. Guttman of the American Civil Liberties Union, who successfully prosecuted the case against the county giving the neo-Nazi anti-Negro anti-Jew party the right to use the Newburgh Courthouse, quickly denied ever contemplating such action.

### Deplores policies

Guttman, who privately deplores NRP's policies, said Burros was "out in left field" and apparently attempting to "incite the county."

He said he would immediately call Hadaway and offer an apology.

Hadaway declined comment on Burros' statement. He did say he had been served by Guttman with a copy of the Supreme Court decision which held the county's regulations on courthouse usage to be unconstitutional and which ordered the county to approve an application for use by the NRP.

The county attorney, who is holding the NRP application, said Wednesday he would file a notice of appeal sometime today.

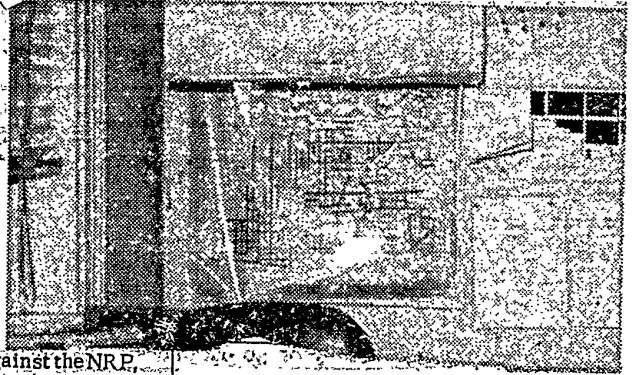

# NRP attorney vetoes contempt threat

BY RAYBURN F. HESSE

GOSHEN

A threat Wednesday by the National Renaissance Party to charge Orange County Attorney Thomas P. Hadaway with contempt of court was nullified within the hour by the NRP's attorney who quickly apologized to Hadaway.

NRP regional organizer Robert J. Burros called The Times Herald Record Wednesday morning, saying legal documents, which would cite Hadaway for contempt of court if he did anything to prevent the NRP's Feb. 12 meeting, would be served on the county attorney Wednesday afternoon.

Attorney Jeremiah S. Guttman of the American Civil Liberties Union, who successfully prosecuted the case against the county giving the neo-Nazi, anti-Negro, anti-Jew party the right to use the Newburgh Courthouse, quickly denied ever contemplating such action.

## Deplores policies

Guttman, who privately deplores NRP's policies, said Burros was "out in left field" and apparently attempting to "incite the county."

He said he would immediately call Hadaway and offer an apology.

Hadaway declined comment on Burros' statement. He did say he had been served by Guttman with a copy of the Supreme Court decision which held the county's regulations on courthouse usage to be unconstitutional and which ordered the county to approve an application for use by the NRP.

The county attorney, who is holding the NRP application, said Wed-

nesday successfully deferring the NRP meeting, arose Monday when Hadaway said he would hold the application and file the notice of appeal, seeking a stay of the Supreme Court order at least until the board of supervisors votes on appeal at its meeting Feb. 11.

If Hadaway obtains a stay, which Guttman says he will oppose, the thing would work against the NRP, even if the supervisors voted against appeal.

Burros said the NRP was preparing the contempt papers on "our own initiative in anticipation of any attempts by Mr. Hadaway to prevent our meeting."

Asked if he did not recognize the county's right to appeal, Burros said that right expired Tuesday and that any action hereafter would be in contempt of court.

Burros said the Democrats and Republicans in range represent divergent groups -- "Jews, Negroes, labor" which pull in opposite directions. He said that whereas the county represents "inferior, racial, minority groups," the NRP represents only the country.

## County Appeals NRP Ruling

GOSHEN — County Atty. Thomas R. Hadaway filed a notice of appeal Wednesday to a Supreme Court judgment directing Orange County to issue a permit to the National Renaissance Party for use of a county courthouse if it makes a new application.

The so-called extremist group already has applied again to Smith Barnes, county building superintendent, for use of the Orange County Courthouse at Newburgh for Feb. 12, and has sent the required \$10 fee.

Mr. Hadaway, however, said it was his opinion that the filing of an appeal to the Appellate Division, stays the execution of the judgment. The attorney said he has advised Mr. Barnes not to issue the permit to the NRP pending disposition of the appeal.

Before following through to the higher court with the appeal, however, Mr. Hadaway said he expects to leave the action up

to the Board of Supervisors. He said he will offer a resolution at the board's Feb. 11 meeting, authorizing him to prosecute the appeal.

If the board decides to drop the issue, Mr. Hadaway said he will discontinue his appeal and advise Mr. Barnes to issue the permit.

The judgment in favor of the NRP came in a decision and order from Justice Leonard J. Supple with a finding that the supervisor's rules regarding use of the courthouse by political parties was unconstitutional.

The board had ruled last spring that only federal, state or county bodies and political parties as defined by state law, could use the courthouse for other than court purposes. Since the NRP does not qualify under the state law which requires 50,000 votes in the last general election, the county had turned down its application.

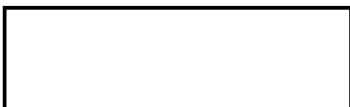
Mr. FITZGERALD, United Federation of Teachers, St John's

Based on information set forth in instant report, it is apparent activities of the NRP do not come within the provisions of Section 122A, Manual of Instructions, which prescribes the basis for investigation of hate-type organizations. 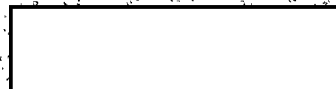

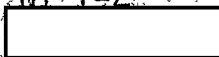

## Synopsis:

National Renaissance Party (NRP) headquarters continue to be maintained at 10 West 90th Street, New York, NY. Objectives of NRP and its program for establishing a Racial Nationalist State by constitutional means set forth. JAMES MADOLE, National Director of NRP, remains in complete control of party. There are currently known to be 21 members of the NRP with activities confined to New York City area, but with progress being made in efforts to establish a chapter in Orange County, New York, under ROBERT BURROS, Regional Director and Organizer for Orange County. With sentencing of JAMES MADOLE on 7/16/64 on a charge of Riot, activities of the NRP became limited. MADOLE has appealed this conviction but as of January, 1966, there has been no hearing on this appeal. Since February, 1965, activities of the NRP have increased. From 2/11/65 to 1/13/66, the NRP held 54 meetings and also street rallies and demonstrations in New York City. Information regarding finances and hate-type literature being disseminated by the NRP through the mail is set forth.

I. ORGANIZATIONAL STRUCTURE

Headquarters

The NRP continues to maintain its national headquarters at 10 West 90th Street, New York, New York, which address is also the residence of JAMES MADOLE, National Director of the NRP.

Objectives

On March 4, 1965, ROBERT BURROS advised SAS [redacted] and EUGENE R. NOBLE that the NRP is a fascist organization but that it operates openly. He stated the NRP advocates the use of the ballot in order to win a national election and thereby take over the government. After the NRP gains power it would then proceed to change the Constitution in a legal way in order to give it the right to use militant means in dealing with those who would seek to overthrow this democracy such as the Communist Party. He stated that the NRP differs from the John Birch Society only in the way in which it would deal with the Communists and those who would seek to destroy our democracy. He noted that the John Birch Society does not advocate the use of militant means in dealing with these individuals. The NRP after gaining power through the ballot, would then resort to militant means which would then be legal in dealing with these individuals. BURROS stated the NRP has no plans which advocate any militant means for obtaining power in this country. The NRP only advocates the legal takeover of this government through the use of the ballot.

As of May, 1965, the NRP was an anti-semitic, anti-Christian, anti-Negro, and neo-fascist organization with activities generally confined to the New York City area. It was founded in 1949 by JAMES MADOLE, who is in complete control of the Party. The Party's main function is distribution of the "National Renaissance Bulletin" on a bi-monthly basis and distribution of pro-Arab literature obtained from official Arab establishments in New York City.

NY T-1 advised on November 12, 1965, that on October 21, 1965, JAMES MADOLE distributed to NRP members copies of the then recently printed "Program of the National Renaissance Party". This program, with the announced purpose of establishing a "Racial Nationalist State", sets forth the objectives of the NRP, some pertinent portions of which are set forth below:

Racial Program

1. Enact and rigidly enforce legislation to restrict the benefits of American citizenship to mentally and genetically sound members of the caucasian race.
2. Enact legislation to prohibit intermarriage between whites and non-whites.
3. The Jewish race, which constitutes the motivating financial and intellectual backbone of the left-wing revolutionary activity in the United States, as manifested in the so-called "Negro civil rights movement", shall be deprived by suitable legislation of their American citizenship and shall henceforth be prohibited from holding any professional, political or educational posts within the Racial Nationalist State. The Jew constitutes an alien virus in our national blood stream and as such he must be purged from our cultural, economic, and political life.

4. Enact legislation to hasten the repatriation of American Negroes to the newly independent black nations on the African continent under the auspices and guidance of black nationalist leadership in the United States.

5. The establishment of a selective immigration policy whose primary purpose is to attract the best European racial stock to the ~~North American continent~~ in order to utilize their vast energy and talent in the task of creating a dynamic, expanding White Empire capable of withstanding the encroachments of the primitive, colored world led by the oriental colossus, Red China.

#### Economic Program

This program contains 18 proposals for economic reform, some of which are as follows:

1. Nationalization of the federal reserve and private banking system under reliable gentile leadership. This measure will take the issuance and evaluation of currency and the extension of bank credit and federal loans out of the hands of private financiers, where it was placed in defiance of the Constitution in 1913, and place the power to coin and evaluate American currency in the hands of the Racial Nationalist State for the benefit, protection and enrichment of the masses of white American citizens. Such an act would smash forever the Jewish stranglehold on the financial structure of the Western World.

2. A system of land reform whereby the ownership of commercially and industrially zoned land will be assumed by the Racial Nationalist State for the benefit of the white people of America. The majority of this land is today in the hands of totally unscrupulous Jewish speculators as is most of the property in our major cities.

3. Massive public works programs including low-cost housing, with architectural design of an individual nature for white American workers.

Foreign Policy

1. The NRP supports the political and economic union of Canada and the United States into one White Empire stretching from the Arctic Ocean to the Gulf of Mexico for the purpose of bringing about a renaissance of Western civilization on the North American continent.

2. Unity of all European peoples, including the Slavic elements of the Soviet Union, within the frame work of a united Europe to act as a mighty bulwark against the colored hordes of Asia.

3. The NRP favors American support for the progressive force of Peronism throughout South and Central America as a militant antidote to CASTRO's brand of Communism. We favor the militant retention of the Monroe Doctrine which shall prevent foreign states from invading our southern neighbors and thus pose a threat to North America.

4. The NRP would support a United Arab Republic in order to create the same unity of mind and spirit in the Middle East that a United Europe would bring about in Western peoples.

5. The NRP supports a policy of "Africa for the Black Africans" to be pursued in those areas of Black Africa lying south of the Sahara Desert which are not included within the Portuguese or South African orbit.

6. The NRP supports a policy of "Asia for the Asiatics" in order that the various Asian nations may develop their own political, racial, and cultural identity without interference by the white race.

7. The NRP supports all national regimes, regardless of race, creed or color which seek to liberate their people from the vicious stranglehold of Jewish finance.

#### Social Program

This section of the program sets forth provisions for the free state-- sponsored college education for every American child with proven capacity to learn; free hospitalization for all needy Americans; yearly war veterans bonuses of \$100; a \$1000 bonus for every healthy white child produced in the United States in order to raise the white birth rate; free nursing home care for the needy.

#### Governmental Program

1. The NRP advocates the calling of a Constitutional Convention to ratify the necessary amendments in order to carry out the foregoing program for the establishment of a strong, centralized Racial Nationalist State on the North American continent.

2. All American youths between the ages of 10 and 19 should be enrolled in a patriotic National Youth Organization whose purposes will be to instill a fanatical attachment to the heritage and achievements of the white race and the American nation.

3. The NRP advocates that all organizations, publications, and media of communication which seek to present ideals hostile to the maintenance of a pure race and a strong and healthy nation should be suppressed for the protection of the people.

#### Officers

JAMES MADOLE, who founded the NRP, continues to serve as its National Director. ROBERT BURROS, prior to November 4, 1965, served as the National Secretary and also

Concerning the NRP attempts to obtain use of the Orange County Courthouse, the "Times Herald Record", a Middletown, New York, daily newspaper, dated November 2, 1965, on page 5, contains an article captioned "Hate Group To File Show Cause on Newburgh Courthouse Use". This article states that the National Renaissance Party, 4-times denied use of the Newburgh Courthouse for public meetings, will file a show cause order this week against the Board of Supervisors and the County officials who have denied their requests. JAMES MADOLE, National party leader, said in an affidavit that the reason the party has been denied use of the courthouse is the "antipathy with which the respondents regard the views and opinions of the NRP", according to HENRY DI SUVERO, Staff Counsel, for the New York Civil Liberties Union, which is representing the NRP.

"The Evening News", a Newburgh, New York, daily newspaper, page 1B, Column 5, dated January 8, 1966, contained an article captioned "Supreme Court Decision", Courthouse Open to NRP". According to this article, Supreme Court Justice LEONARD J. SUPPLE, on January 1, 1966, gave the order for the NRP to use the Orange County Courthouse in Newburgh for public meetings. He ordered Orange County to issue a Usage Permit. JAMES MADOLE immediately announced that he will apply to use the Newburgh Courthouse for an NRP meeting on February 12, 1966. Justice SUPPLE stated his declaration in allowing the use of the Courthouse was not an approval of the NRP extremist activity but instead was intended to end unconstitutional means that had been used to thwart NRP activities in this area

III. ACTIVITIES OF THE NRP

Status of the NRP

Since JAMES MADOLE was sentenced to two years in jail on a charge of riot on July 16, 1964, all activities of the NRP were suspended. The source had received unconfirmed information that MADOLE, leader of the then defunct NRP, was then currently free on bail pending an appeal of his conviction and sentencing on July 16, 1964. The source stated, however, that the NRP would not be reactivated by MADOLE who felt that such reactivation might jeopardize his appeal.

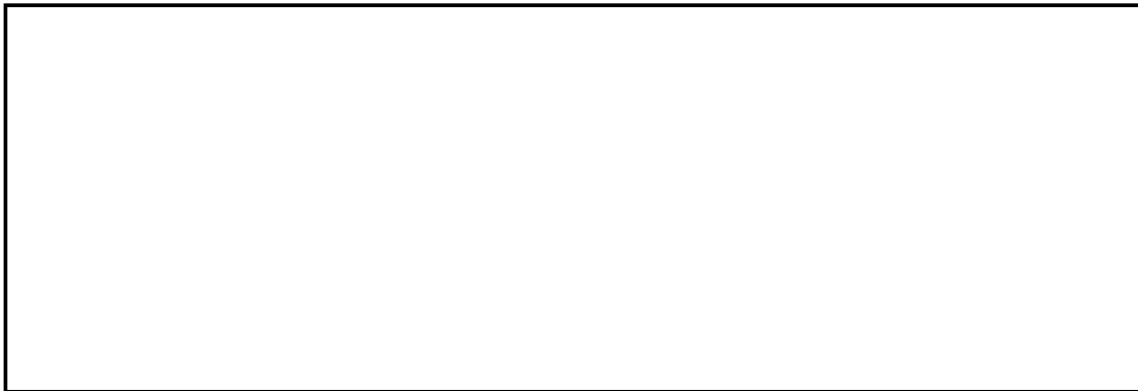

Public Gatherings and Demonstrations

On October 26, 1964, Special Agents (SAs) of the Federal Bureau of Investigation (FBI), observed a peak member of 250 individuals demonstrating on Eighth Avenue between 50th and 51st Streets, New York, New York, from 6:30 p.m. to 9:30 p.m. This demonstration was in protest of a political rally for Senator BARRY M. GOLDWATER, which was to be held that date at Madison Square Garden, 50th Street, and Eighth Avenue, New York, New York. The demonstrators carried placards identifying themselves as affiliated with the Downtown, Queens College, City College of New York, New York City, Bronx Chapter of the Congress of Racial Equality (CORE). In addition, some of the demonstrators distributed literature and carried signs showing their affiliation with the W.E.B. Du Bois Clubs of America, Incorporated, and Youth Against War and Fascism (YAWF). Placards carried by these demonstrators called for the defeat of GOLDWATER in the Presidential Election.

The W.E.B. Du Bois Clubs of America, Incorporated, and the YAWF are characterized in the appendix.

At the above-demonstration from 7:45 p.m. to 8:15 p.m., JAMES MADOLE, Leader of the NRP, together with six other individuals distributed pro-GOLDWATER literature bearing the NRP name and the address 10 West 90th Street, New York, New York. This literature was distributed at the corner of 49th Street and Eighth Avenue.

A confidential source furnished leaflets which had been passed out by the NRP demonstrators at the above-mentioned demonstration. One leaflet was captioned "To Hell Now with the Cursed Oder-Neisse Line, My Dear Nasser". This pamphlet states that at the termination of World War II, America should have invited to our shores the thousands of skilled German scientists. Instead, we allowed ourselves to be swayed by the Jewish gospel to hate everything German and, consequently, the best scientific minds of Germany were forced into the arms of our mortal enemy, the Soviet Union. In addition, 600 German scientists have been forced into exile in Cairo, Egypt and by virtue of the friendship existing between the various Asiatic powers, they have now contributed to the building of an atomic bomb by Red China.

A second NRP pamphlet distributed was captioned "Urgent Appeal". This pamphlet urged some civil rights for white Christians in America. It also urged a vote for the GOLDWATER - MILLER ticket in November and support for Mr. PAOLUCCI for the United States Senate on the Conservative Party Ticket, since ROBERT KENNEDY and KENNETH KEATING appeared to be running for a seat in the Israeli Knesset, rather than the the United States Senate.

The NRP picketed the annual May Day Rally sponsored by the Greater New York Labor Press Club (GNYLPC) which was held May 1, 1965, at Union Square, 17th Street and Broadway, New York, New York, from 2:50 p.m. to 4:40 p.m. Eight individuals representing the NRP conducted this picketing. They carried signs bearing the following slogans and the same slogans were periodically shouted by the NRP pickets:

"Down with Communism"

On July 24, 1965, from 12:00 noon to 2:00 p.m., four individuals representing the NRP held a demonstration at the headquarters of JOHN LINDSAY, Candidate for Mayor of New York City, at 42nd Street and Fifth Avenue, New York, New York. Three of these individuals were dressed in uniforms resembling those worn by HITLER's Army in Nazi Germany. These demonstrators carried signs which read as follows:

"Join the National Renaissance Party"

"Black for Lindsay, White for Buckley"

The demonstrators passed out literature which bore the caption "John Lindsay is a Political Tool and Will Organize Racial Minority Groups". The leaflet urged white Americans to vote for the Conservative candidate, WILLIAM J. BUCKLEY, for Mayor of New York City.

On October 9, 1965, NRP members distributed leaflets on the northeast and southeast corners of 86th Street and Third Avenue, New York, New York. While passing out leaflets to pedestrians, the three NRP members shouted "fight Communism and race mixers". These leaflets urged white American patriots to be on the corner of Second

Avenue and 84th Street, on the evening of October 11, 1965, at which time JAMES MADOLE would address the people in attendance.

[redacted] Bureau of Special Services, New York City Police Department, advised on October 12, 1965, that on October 11, 1965, from 7:55 p.m. to 9:05 p.m., the NRP held a street rally, known as a "Civil Rights for Whites Rally", at 84th Street and Second Avenue, New York, New York. There were approximately 1400 spectators and eight NRP members in attendance. The first speaker, ROBERT BURROS, NRP member, stated the NRP is in favor of white supremacy which is on the decline because of the liberal politicians. He further stated that it was the white man who brought civilization to this country. At this point in his speech, the spectators began booing and the rest of his speech became inaudible.

A confidential source advised that when JAMES MADOLE began to speak at the above-mentioned street rally, members of the Jewish War Veterans who were present in the audience started to sing "God Bless America". It was virtually impossible to hear any of the speakers and at one point several eggs were thrown at NRP members.

On October 16, 1965, three NRP members distributed leaflets on the corner of 86th Street and Third Avenue, which leaflets announced an NRP street rally to be held on October 18, 1965.

On October 18, 1965, from 7:30 p.m. to 9:00 p.m., the NRP held a street rally at 84th Street and Second Avenue, New York, New York. JAMES MADOLE, New York Director of the NRP, during his speech stated that the government must change its programs which favor organized Jews and Negroes in the United States. As a result, MADOLE stated, the Jews are robbing the people and the Negroes form drunken mobs and riot on weekends. MADOLE denounced integration on the basis that it breeds mongrels and due to this mongrelization people are not pure any more. There were approximately 1,000 spectators who booed and hissed and threw eggs and tomatoes during MADOLE's speech, however, no arrests or incidents took place. There were five members of the NRP present three of whom were dressed in Nazi-type uniforms.

On December 4, 1965, the NRP held a street rally in the vicinity of the British Empire Building, Fifth Avenue and 50th Street, New York, New York, in order to protest British policy toward the Government of Rhodesia in Africa. "Support your local Police"

"No Civilian Review Board"

"White Government for Rhodesia"

Nine NRP members participated. Some pedestrians shouted derogatory remarks, at NRP members, however, there were no disorders.

On December 11, 1965, twelve NRP members held a street meeting in Times Square, New York City, from 10:30 a.m. to 2:00 p.m. The purpose of this street meeting was to call attention to and protest the anti-Viet-Nam demonstrations which had then recently taken place in New York City and elsewhere in the United States. NRP members carried signs which contained the following slogans:

"Down with the Peace Creep"

"Long Live America"

"Send the Peace Creeps to Viet-Nam"

Some of the NRP members were shouting slogans such as:

"Burn Peace Creeps in Acid, Kill the Peace Creeps"

The police officer who was present instructed the NRP to tone down such slogans because there was fear that such actions might produce disorders.

IV. FINANCES

On March 4, 1965, ROBERT BURROS, who was then serving as National Secretary of the NRP, advised SAS [redacted] and [redacted] that both the National Organization and the Orange County Chapter of the NRP are broke. He stated the National Organization is operating from the apartment of JAMES MADOLE, 10 West 90th Street, New York, New York, and that he, as Regional Director in Orange County, does not receive any salary.

V. PUBLICATIONS AND LITERATURE

Beginning in January, 1965, the New York Office of the FBI had been in receipt of a large volume of mail which came direct from individuals as well as by referral from the United States Post Office. In all instances, these letters forwarded literature which had been received unsolicited and which, in most but not all cases, contained the return address of JAMES MADOLE, 10 West 90th Street, New York, New York.

The individuals forwarding the above literature expressed indignation and requested that the mailing of such literature be stopped by the post office. The individuals who registered a complaint with the post office were advised that it was regretted the mails are used from time to time for the dissemination of matter critical of religions, races, and political views, however, there was no violation involved under current postal laws, particularly when sent under cover of envelopes with nothing derogatory appearing on the outside thereof.

The above letters were all postmarked in New York City, and were mailed to various sections of the country to college students, educators, business executives and politicians. The literature enclosed in these letters is described below:

1. A seven page pamphlet captioned "Who is the Real Enemy?", which is self-identified as a publication of the NRP. According to this pamphlet, the Jews strive for complete control of the press, radio, motion picture and television industries so that they can bring about complete enslavement of the white race. The pamphlet states that if "white gentiles are to save themselves from being herded to the slaughter like docile sheep, the time is long overdue to organize against our real enemy". The pamphlet goes on to state that if we do not recognize the Jew as our enemy "our race of people will disappear from the earth".

2. A one page leaflet captioned "Youth Movements", which is self-identified as a publication of the NRP. This leaflet states that all youth movements calling for the mixing of Negro and white children which are established by Jewish, Christian, political and labor organizations, are for the purpose of destroying "the civilized world for Communism by mating your white innocent with the loathsome Negro".

3. A two page leaflet captioned, "Christian Preachers and Communist Agents oppose the Repeal of the Rumford Act", which is self-described as a publication of the NRP. This leaflet deals with the Rumford Act, which outlaws discrimination in the sale or rental of houses and apartments in the State of California. This leaflet states that to claim that racial differences are not at issue in this repeal contest is a transparent pretense. The Rumford Act makes block busting easy for undesirable types and once they gain entrance, property values sharply decline. This leaflet further states that it is social madness to let loose among civilized people a rapid-breeding people mentally qualified for jungle life. Indiscrimination inevitably defaces the better human types.

4. One page leaflet captioned, "Integration", which is self-identified as a publication of the National States Rights Party (NSRP). This leaflet contains pictures of a [redacted] and their child as an example of racial intermarriage which produced a mongrel child. This leaflet states that "Integration, degeneration, mongrelization, call it what you will, is the deliberately forced social association of white people<sup>and</sup> racially inferior Negroes the purpose of which is racial intermarriage and the production of a race of simple minded, docile mulattoes who will be obedient to their Jewish masters.

5. A one page leaflet which is captioned, "Communist Party behind Race Mixing", which is self-identified as a publication of the Christian Youth Corps. This leaflet bears the slogan "Communism is Jewish". This leaflet states that only the Christian young men of this nation can save it from the Jew - Communist conspiracy. Prepare yourselves for this battle for CHRIST, when the CHRIST hating Jews unleash their Red Communist hordes upon us.

On May 10, 1965, NY T-1 furnished a copy of the "National Renaissance Bulletin", Volume 16, Numbers 1 - 2, dated January - February, 1965, which is self-described as the official publication of the NRP. This 12 page bulletin contains a feature article by JAMES MADOLE entitled, "Will Asiatic Hordes Submerge the Light of Western Civilization?"

The above article states that the twilight of Western civilization is fast approaching as one billion Asiatics and Africans gird themselves for world conquest of the white race. Although this war draws closer, our Liberal and Jewish "leadership" in Washington, London, Tel Aviv and Bonn does not allow us to think, much less to speak or act, in terms of race. This article states that the American people must form a United White Alliance in opposition to the colored hordes of Asia and Africa and cast off the mental yoke of Jewish thinking skillfully imposed on their minds by captive political, clerical and labor czars as well as the communications media of the United States.

On October 15, 1965, NY T-1 furnished a copy of the "National Renaissance Bulletin" Volume 16, Numbers 3 - 5, dated March, April, May, 1965. This eight page bulletin contains a continuation of the feature article by JAMES MADOLE which appeared in the above-mentioned January - February, 1965, issue of the "National Renaissance Bulletin". In addition, there is an article captioned, "Canadian Government Seeks to Suppress the National Renaissance Party."

This article alleges that the NRP has been prohibited from mailing its literature to Canada, because the January - February, 1965, issue of the "National Renaissance Bulletin" attacked WINSTON CHURCHILL. VI. MISCELLANEOUS

Indictment of NRP Members

Bureau of Special Services, New York City Police Department, advised SA  that on June 10, 1964, eight individuals who were either members or associated with the NRP were found guilty by a Supreme Court Jury in Supreme Court, Bronx, New York. The following six individuals were convicted of incitement to riot, a felony:

Judge ERWIN C. DAVIDSON, who presided at the trial of the above individuals, ordered psychiatric and probation reports on all convicted and set July 16, 1964, for sentencing.

On July 16, 1964, [redacted] Bureau of Special Services, New York City Police Department, advised SA [redacted] that on that date, the above-mentioned individuals appeared before Judge DAVIDSON, Supreme Court, Bronx, New York, and were sentenced as follows:

JAMES MADOLE, [redacted] PAUL JOACHIM, and DANIEL BURROS were sentenced to serve not less than one year and not more than two years in State Prison for riot.

[redacted] was sentenced to serve not less than one and nor more than three years in Elmira State Penitentiary, Elmira, New York, on a charge of riot.

[redacted] and [redacted] were each sentenced to three years of probation for unlawful assembly.

"The New York Times", a New York City daily newspaper, dated June 11, 1964, contained an article captioned "Eight Convicted for Bronx Rioting Last July, 14". This article stated that eight alleged members of the Neo-Nazi National Renaissance Party were found guilty on June 10, 1964, of inciting a riot in connection with a civil rights demonstration last July 14, 1963. At this civil rights demonstration, Negroes were picketing a diner because of alleged racial discriminatory practices. When two of the eight defendants complained to the police that the demonstrators had damaged their station wagon, detective who investigated found<sup>a</sup> cross-bow, guns and knives in the vehicle. A disorder involving the pickets and the eight defendants resulted in riot charges against the eight men. During the trial, the police testified that the group sought to incite to violence the Negroes who were demonstrating, and to use the weapons in the station wagon against the pickets had not the police acted.

On January 6, 1966, Detective [redacted] Bureau of Special Services, New York City Police Department, advised SA [redacted] that JAMES MADOLE and other individuals convicted with him, with the exception of DANIEL BURROS who is now deceased, appealed their conviction of July 10, 1964. These individuals are still free on bail and as of January 6, 1966, no date had been set for a hearing on the appeal.

GREATER NEW YORK LABOR PRESS CLUB

A source advised on December 6, 1962, that the Greater New York Press Club (GNYPC) was formed during February, 1961, by LOUIS WEINSTOCK, when he was General Manager of "The Worker," by obtaining members who would contribute funds, subscribe to and work for "The Worker," and also to hold social and cultural affairs.

The source stated that in the Spring of 1962 [ ] was [ ] of "The Worker." [ ] announced at a press club meeting at Adelphi Hall, New York City, held on April 26, 1962, the formation of a new press club known as the "City Press Club Executive Board" (CPCEB). The purpose of this new club was to coordinate the work of all the borough press clubs in the New York City area; to strengthen the work of the press clubs; to organize new press clubs; and to draw in people who were not members of the Communist Party, United States of America (CPUSA). The source stated that the basic purpose was to raise funds for "The Worker" and increase the circulation of that publication. Persons not members of the CPUSA could be members of the new club, but leadership in the club was limited to members of the CPUSA. The name of the CPCEB was later changed to "Greater City Press Club" (GCPC), which club became the successor of the GNYPC.

The source continued that in July, 1962, LOUIS WEINSTOCK again became General Manager of "The Worker" and the GCPC again became known as the "Greater New York Press Club" and was commonly referred to as the Greater New York Readers' Club, Greater New York Readers' Clubs, Greater New York Readers' Conference, Greater City Press Club, and the City Press Club by personnel responsible for preparation of notices and literature regarding meetings and activities of the clubs. The source advised at that time that the GNYPC had no office or headquarters and used the mailing address of "The Worker," 23 West 26th Street, New York City.

"The Worker" is an east coast Communist newspaper.

A second source advised on August 15, 1962, that the Greater New York Readers' Club was formerly known as the "Three Boro Readers' Club."

GREATER NEW YORK LABOR PRESS CLUB

The first source advised on May 28, 1963, that the GNYPC holds no membership meetings and that the officers had ceased to function for the GNYPC. The source advised that LOUIS WEINSTOCK was responsible for using the name of the GNYPC in conjunction with the activities of the Readers' Conferences at "Worker" functions. The organization of the GNYPC no longer functions.

The first source advised on April 21, 1964, that on March 31, 1964, about 50 members of the CPUSA met at the Hotel Woodstock, 127 West 43rd Street, New York City. At this meeting JOE BRANDT, the Business Manager of "The Worker," advised that after consultation with the Editorial Board and other officials of "The Worker," it was decided to rebuild the GNYPC and to rename it the Greater New York Labor Press Club (GNYLPC). Those present at the meeting, without a dissenting vote, approved this decision.

A third source advised on April 29, 1964, that on the same date ERIC BERT, the Managing Editor of "The Worker," said that the GNYLPC is a group of individuals who, as volunteers, help support "The Worker" and aid in its distribution and circulation.

A fourth source advised on March 18, 1965, that on March 17, 1965, at a meeting of the GNYLPC held at the Hotel Woodstock, JOE BRANDT said that the main purpose of the GNYLPC is to increase and build a greater circulation for "The Worker."

NATIONAL STATES RIGHTS PARTY (NSRP)

On November 26, 1957, a source advised that the United White Party (UWP) was organized at a convention held in Knoxville, Tennessee, on November 10, 1957. An article in the November 26, 1957, issue of the "Greenville Piedmont", a newspaper of Greenville, South Carolina, reported "the recent formation of a new political party, to be known as the United White Party." According to the article, the party was formed at a recently held meeting in Knoxville, Tennessee, at which many klansmen were represented. The UWP was reported as being opposed to all "race mixing organizations and individuals."

The July 1958, issue of "The Thunderbolt", self-described as the "official Racial Nationalist Organ of the National States Rights Party" (NSRP), reported that rank and file "States Righters" had merged with the UWP under "the banner of the National States Rights Party", with national offices at Post Office Box 261, Jeffersonville, Indiana.

In November, 1958, a source advised that the NSRP is composed of past members of Klan-type organizations and notorious anti-Semites.

Issue No. 19, dated June 1960, of "The Thunderbolt" announced the address of the headquarters of the NSRP had been changed from Jeffersonville, Indiana, to Post Office Box 783, Birmingham, Alabama.

Issue No. 69, dated July, 1965, of "The Thunderbolt" announced the address of the new headquarters of the NSRP as Post Office Box 184, Augusta, Georgia.

On August 4, 1965, a source advised that Edward R. Fields, the Information Director of the NSRP and Editor of "The Thunderbolt", is the individual who actually controls the NSRP.

A source has advised that on October 26-27, 1963, a conference of members of the Communist Party (CP), including national functionaries, met in Chicago, Illinois, for the purpose of setting in motion forces for the establishment of a new national Marxist-oriented youth organization which would hunt for the most peaceful transition to socialism. The delegates to this meeting were cautioned against the germ of anti-Soviet and anti-CP ideologies. These delegates were also told that it would be reasonable to assume that the young socialists attracted into this new organization would eventually pass into the CP itself.

A second conference of over 20 persons met in Chicago on December 28-29, 1963, for the purpose of initiating a "call" to the new youth organization and planning for a founding convention to be held in June, 1964.

A second source has advised that the founding convention for the new youth organization was held from June 19-21, 1964, at 150 Golden Gate Avenue, San Francisco, California, at which time the name W.E.B. Du Bois Clubs of America (DCA) was adopted. Approximately 500 delegates from throughout the United States attended this convention. The aims of this organization, as set forth in the preamble to the constitution, are, "It is our belief that this nation can best solve its problems in an atmosphere of peaceful coexistence, complete disarmament and true freedom for all peoples of the world, and that these solutions will be reached mainly through the united efforts of all democratic elements in our country, composed essentially of the working people allied in the unity of Negroes and other minorities with whites. We further fully recognize that the greatest threat to American democracy comes from the racist and right wing forces in coalition with the most reactionary sections of the economic power structure, using the tool of anti-Communism to divide and destroy the unified struggle of the working people. As young people in the forces struggling for democracy, we shall actively strive to defeat these reactionary and neo-fascist elements and to achieve complete freedom and democracy for all Americans, thus enabling each individual to freely choose and build the society he would wish to live in. Through these struggles we feel the American people will realize the viability of the socialist alternative."

W.E.B. DU BOIS CLUBS OF AMERICA

The constitution further states that this new organization shall be a membership organization open to individuals, or if five or more people so desire, a chapter can be formed which shall in turn be guided by the policies and principles of the parent organization.

As of October, 1965, the headquarters of the DCA was located at 954 McAllister Street, San Francisco, California.

Over the Labor Day week end, 1965, the DCA held a conference in Chicago, Illinois. According to a third source, a new slate of national officers was elected at this conference, which included Chairman HUGH STERLING FOWLER, II, (who, according to the third source, attended a CP cadre encampment held at Camp Midvale, New Jersey, in June, 1965, and following his election as Chairman of the DCA, attended another national CP cadre youth conference held on September 9-12, 1965, on a farm located in Northern Indiana, according to a fourth source); Director of Publicity CARL ELLENGER BLOICE (who was elected to the San Francisco County Committee CP in April, 1964, according to a fifth source); Educational Director MATTHEW "DYNAMITE" HALLINAN (who in June, 1964, was stated to be the Youth Representative on the Northern California CP District Board, according to a sixth source); Organizational Secretary TERENCE "KAYO" HALLINAN (who, according to a seventh source, met in June, 1965, with the District Staff of the Illinois CP to discuss the proposed DCA Midwest Summer Project), and Treasurer SUSAN PHYLLIS BORENSTEIN (who, according to an eighth source, has attended meetings of the Youth Club of the CP of Illinois during 1965, in connection with the DCA Summer Project).

YOUTH AGAINST WAR AND FASCISM

A confidential source advised on March 29, 1965, that the Youth Against War and Fascism (YAWF), formerly known as the Anti-Fascist Youth Committee, was established by the Workers World Party (WWP) in the summer of 1962, to bring college and high school youth into the periphery of WWP activities and thereby gain recruits for the organization.

A second confidential source advised on October 23, 1964, that a flyer distributed by the YAWF describes that organization as a militant organization of young workers and worker-students for combating war and fascism.

The first source advised on March 29, 1965, that the YAWF maintains an office in Room 1214, 1123 Broadway, New York City, and publishes a magazine called "The Partisan."

# NRP again denied, will fight county

GOSHEN

There will not be a meeting of the neo-Nazi National Renaissance Party (NRP) in the Newburgh Courthouse on Feb. 12.

NRP national director James H. Madole accepted that fact Monday but immediately served notice that the cancellation is, in his opinion, only temporary.

Madole said he would lead an NRP delegation to Goshen on Feb. 12 in an attempt to persuade the board of supervisors to abandon its appeal of Supreme Court Justice Leonard J. Supple's decision which holds the county's regulations on courthouse use to be unconstitutional, insofar as they bar the NRP, and which orders the county to approve NRP's application.

The NRP application was returned unapproved last weekend by county buildings superintendent Smith Barnes on the advice of County Attorney Thomas R. Hadaway.

Pending a final determination Feb. 11 by the supervisors, Hadaway last Wednesday filed a notice of appeal from Supple's decision.

An amendment effective last September to the civil practice law automatically grants a stay of judgment to the county when appealing from a decision in an Article 78 proceeding.

Attorney Jeremiah S. Gutman of the American Civil Liberties Union, who successfully prosecuted the NRP's case against the county in December, said last week a stay was not automatic and the county must subsequently move for a stay which he would oppose.

However, Madole conceded Monday that Hadaway was correct in saying the stay was automatic, thus permitting the county to once again deny NRP's application.

With or without this concession, the county could have blocked the Feb. 12 meeting, even if the super-

visors voted to discontinue the appeal. The Friday-Saturday timing element would not have been sufficient for a withdrawal of the notice of appeal and approval of application.

If the supervisors vote to pursue the appeal, a hearing in the Appellate Division, second department, is not probable for 60 days.

Madole's reaction to the situation Monday was more restrained than was his Lieutenant, Robert J. Burros, last week when the NRP first realized that Hadaway's notice of appeal could block the Feb. 12 meeting.

After two denials early last year by Barnes, Burros appeared before the supervisors to request permission to use the Newburgh Courthouse but, in the opinion of many supervisors, did his cause more harm than good.

The supervisors voted, 30 to 4, against granting permission.

The supervisors subsequently adopted new usage regulations which limit access to recognized political parties and governmental agencies. A political party, as defined by election law, is a political organization polling 50,000 or more votes in the next preceding gubernatorial election.

The NRP, which has yet to nominate candidates in New York state, does not fit that description, and, after another request was denied on the basis of the new regulations, filed suit.

Supple's decision challenged the county's right to so discriminate in its regulations.

Although the NRP's anti-Jewish, anti-Negro, militaristic philosophy is abhorred by the supervisors, and even by Gutman, the county has yet to argue the question on those grounds and will not at the Feb. 11 meeting.

Hadaway's review at that meeting will be confined to a legal discussion of the county's prerogatives in controlling use of the two courthouses.

## Neo-Nazis Win Right To Meet in Schools

City Counsel Tells Board It Must  
Grant Use Under Education Law

The Board of Education has no right to bar the National Renaissance party, a neo-Nazi extremist group, from meeting in the public schools after school hours, Corporation Counsel L. Lee Rankin has notified the school board.

He did so in response to a request for a ruling from the board, which had shelved a request from the organization to meet in the Robert Wagner JHS, on E. 76th St.

The board had feared the proposed meeting might cause violence or disorder.

The National Renaissance party is a neo-Nazi anti-Semitic organization, but, according to Rankin, the board nevertheless must let it use school buildings on the same basis that it permits their use for "social, civic, recreational and political meetings and entertainment," under the education law.

Arnold Foster, general counsel to the B'nai B'rith Anti-Defamation League, assailed Rankin's ruling.

He challenged the NRP's claim to being a "political party" within the meaning of the education law, asserting that it is a group of trouble-makers with "a scant baker's dozen members."

"Gutter groups had better be left in the gutter," he said, rather than be permitted to use school for their meetings.

Lloyd K. Garrison, president of the Board of Education, said that under the ruling the board would have to grant applications of the NRP to meet in schools, but would give advance notification to the police.

## County Appeals NRP Court Order

GOSHEN—Three leaders of the National Renaissance Party, denied speaking privileges, heard the Orange County Board of Supervisors Friday authorize an appeal from a court order that would grant use of a county building to the NRP.

The representatives of the radical group found no sponsoring supervisor who would ask the privilege of the floor for them.

Burton C. Cosman, R-Newburgh Town, board majority leader, said the only question was authority for the appeal and he recommended that all comments be limited to supervisors or the county attorney.

Sitting quietly on the sidelines, where they had been since noon for the 1:30 p.m. meeting, were James H. Madole, 10 W. 90th St., New York, a director of the party; Robert J. Burros, 215 First St., Newburgh, liaison

officer and chief of the Orange County branch, and Martin Thomas, New York, security echelon guard of the uniformed section of the party.

Mr. Thomas did not wear his uniform, however. He said he was advised that it might have an adverse effect on the supervisors' reception. The guard leaves Wednesday to join the U. S. Marine Corps.

Seated elsewhere, along three sides of the supervisors' chambers were Sheriff Horace A. Ketcham and three deputies. Another silent spectator was Bernard Berman of Monroe, Orange County commander of the Jewish War Veterans.

After the board's action, sixth on an agenda that followed a 90-minute hearing on an airport lease, Mr. Madole told reporters he was prepared to wait for use of the county courthouse in Newburgh.

He might, however, call a street meeting and produce an even bigger crowd, the party director said.

Mr. Madole said it was too bad the Orange County taxpayers were spending money on an appeal but he was happy to say it was costing him nothing. His case is handled by the American Civil Liberties Union.

Thomas R. Hadaway, county attorney, explained the county's position in the appeal.

About a year ago, he said, Board Chairman Albert C. Howell received a letter asking the use of the courthouse in Newburgh for an NRP meeting. Area objections were expressed but Mr. Howell turned to the board with a resolution which was defeated in March.

Mr. Burros promptly began a Supreme Court action to compel the board to grant per-

mission. But before the county attorney submitted an answer, Mr. Burros withdrew his action.

At the board's June 11 meeting, upon recommendation of the Buildings Committee, a set of rules was adopted denying courthouses at Newburgh and Goshen to any but federal, state and county agencies and political parties as defined in the state election law (with 50,000 votes in the last gubernatorial election).

Mr. Madole applied Aug. 29, 1965, to Smith Barnes, county superintendent of buildings, for use of the courthouse at Newburgh, Oct. 16. This was denied on the ground the NRP was not a political party under state law.

Mr. Madole began a court action, Nov. 5, against Mr. Barnes, Chairman Howell, Board Clerk Lester J. Roosa and the entire board to com-

pel them to grant permission to use the courthouse on a convenient Saturday in December, 1965.

The Board of Supervisors elected Nov. 26 to oppose the application. The case was heard before Supreme Court Justice Leonard J. Supple in Newburgh, Dec. 6.

Justice Supple granted Mr. Madole's application and entered judgment, Jan. 24. The order found that the board's June rules were deemed unconstitutional in limiting the definition of a political party to the election law. The court directed the county to issue the permit.

Mr. Hadaway on Jan. 26, filed a notice of appeal, thereby staying enforcement.

Yesterday's resolution said it was the "consensus of opinion of the board that said appeal be perfected and prosecuted." The vote was unanimous.

## City to Let Neo-Nazi Party Use Public Schools for Its Meetings

The City Corporation Counsel has informed the Board of Education that it must allow the National Renaissance party, a neo-Nazi, anti-Semitic group, to use public-school facilities during after-class hours for its meetings.

The board's Bureau of Community Education last summer turned down the party's application for use of a school auditorium, on the grounds that "the proposed meeting might tend to cause dissension or provoke disorder."

The party had sought to hold an evening meeting at Robert Wagner Junior High School, 220 East 76th Street.

Replying to the board's request for a legal opinion on its actions, Corporation Counsel J. Lee Rankin said that the bureau had acted improperly in denying the application.

Lloyd K. Garrison, president of the board, transmitted copies of the opinion to the board members and said in an accompanying memorandum:

"I assume that we will proceed to give a permit to the National Renaissance party, with advance notification to the Police Commissioner of the time and place of any meeting."

### State Law Cited

In his opinion to the board, Mr. Rankin said that Section 414 of the State Education Law provided that school boards might, subject to the adoption of regulations, permit the use of school facilities when they are not needed for educational purposes for "social, civic, recreational and political meetings and entertainments."

The National Renaissance party was organized in 1949

and, according to last reports, maintained headquarters in a one-room apartment at 10 West 90th Street. It claims a worldwide membership of 2,500 persons, but the police and others here scoff at the claims. The group is not connected with the American Nazi party, headed by George Lincoln Rockwell.

Mr. Rankin's opinion was assailed yesterday by Arnold Foster, general counsel of the Anti-Defamation League of B'nai B'rith. He asserted that the National Renaissance party did not qualify under Section 414.

"The regulations aside," he continued, "common sense leads inevitably to the conclusion that gutter groups are best left in the gutter, rather than given the facilities of the city schools. The National Renaissance party is a group of street-corner hoodlums with a membership of a baker's dozen. To accept this lunatic-fringe clique's definition of itself as a political party is to pervert the meaning of the term."

### Previous Violence Noted

In its request for a legal ruling, the board asserted that previous outdoor meetings of the party had "generally ended in violence, injuries and arrests of both bystanders and members of the National Renaissance party."

It also noted that James H. Madole, the founder and leader of the party, had been convicted of conspiracy to riot; of riot, and of criminally possessing firearms and a switchblade in an incident involving civil rights demonstrators. He is now on bail, pending an appeal from his conviction and sentence to one to two years in state prison.

# Neo-Nazi Issue Disturbs Board

Suit May Test  
Rankin Ruling  
On School Use

Some members of the Board of Education are profoundly disturbed at the prospect of the neo-Nazis National Renaissance party holding meetings in public schools after school hours. Privately, they fear violence.

However, they have apparently conceded—for the present, at least—the party's right to do so, because of a corporation counsel's ruling.

Questioned at last night's meeting of the board, members refused to comment individually on an opinion by Corporation Counsel J. Lee Rankin that the party, an extremist group, has a legal right, under education law, to meet in schools.

This tight-lipped attitude was in contrast to vigorous discussion of the issue earlier in the board's closed-door informal session.

## Wants Court Decision

Privately, one board member said he hoped the question would be settled in the courts, where Rankin's opinion could be upset.

Originally, the board had denied a request by the party to meet in the Robert Wagner JHS on E. 76th St. on grounds that such a meeting might result in disturbances, since the organization is known for its anti-Negro and anti-Semitic views. Then the board asked Rankin for an opinion.

Rankin in reply, said the party must be allowed to use the school building on the same basis that such use is permitted for "social, recreational and political meetings, and entertainment" under education law.

## Drops '600' Tag

At its meeting last night, the board officially dropped the designation "600" for its schools for disruptive pupils. Instead, enumeration of these schools will be merged with all other schools. That way, school officials explained, the public will have no method of identifying these schools and stigmatizing their pupils as problem youngsters.

The board also dropped its plans for a new \$11.5 million vocational high school for maritime and food trades at W. 50th St. and 10th Ave.

Instead, it voted to draw up plans for a new 3,000 student comprehensive high school, which would include instruction in the food trades. The architectural firm of Skidmore, Owings and Merrill was designated to design the new school.

Superintendent of Schools Bernard E. Donovan said the maritime trades would be included in the new West Side HS, also to be built in Manhattan as a comprehensive school.

## Other Board Action

In other action, the board:

① Approved the hiring of part-time substitute teachers to help relieve the teacher shortage.

② Ratified a collective bargaining agreement covering psychologists and social workers with the Child Guidance Chapter of the United Federation of Teachers.

③ Appointed Louis Cenci, now an acting administrative assistant at McKee VHS, Rich., as executive secretary of the school system's Advisory Board for Vocational and Extension Education at \$16,000 a year. Cenci succeeds Mrs. Betty H. Donnelly, retired.

④ Authorized another series of workshops in the city and in Puerto Rico for study of school problems. The board allocated \$8,140 for a joint enterprise with the National Conference of Christians and Jews, the University of Puerto Rico and the Department of Instruction in Puerto Rico.



# Allen May Decide Use of Schools By Nazi Group

ADL Scores Education Board's  
Decision to Grant a Permit

The Anti-Defamation League of B'nai B'rith today prepared to take action to stop the Board of Education from allowing the National Renaissance Party, a neo-Nazi group, from meeting in a school auditorium on Friday, March 18.

An ADL spokesman said that the organizations lawyers are conferring to determine just which course to pursue—an appeal to State Education Commissioner James E. Allen, or a court injunction to halt the board from turning the school property over to the NRP for a meeting.

"We think it outrageous that a public school building should be misused for the purposes of a hate-mongering outfit such as the NRP," said the ADL. "Since the NRP is neither a political organization nor serves any worthwhile civic or social function, it has no valid claim to use the tax-supported public schools to disseminate its poison. We are studying the law to determine action to be taken to oppose this ruling of the city authorities."

## School Board Acts

A formal request for use of the auditorium of Robert Wagner JHS, at 220 E. 76th St., the evening of March 18, was submitted to Dr. Clare Baldwin, head of the school system's Division of Special Services, yesterday.

Baldwin turned it over to Superintendent of Schools Bernard E. Donovan who discussed it at an informal meeting with the Board of Education. The board later put out a statement explaining its action in granting the Nazi group's request.

One school official explained that the board had no choice but to grant the request of the NRP because of an opinion by Corporation Counsel J. Lee Rankin that it had to do so.

## Board Divided

It was learned that the nine-member board is sharply divided over whether Rankin's decision was correct and whether the board did the correct thing by allowing the meeting on school property.

A previous request for use of the school auditorium by the NRP last August resulted in a turn-down from Baldwin's office. With its cause championed by the American Civil

Liberties Union, the NRP asked the board to get a ruling on the matter from the Corporation Counsel.

When the school system turned the NRP down last summer it acted on the ground that a meeting of the NRP, which has a record of anti-Semitism and anti-Negro actions and statements, would result in violence possible injury and damage to school property.

However, Rankin agreed with the Civil Liberties Union that the NRP is a political party which has a right to meet and be heard in school buildings. He held that the school system could not deny the group the use of school property in anticipation of violence.

# Lindsay Asks His Staff to Look Into Nazis' School Use

Jewish Teachers Carry Protest  
Both to Board and City Hall

The Jewish Teachers Assn. has "vehemently protested" to the Board of Education against its decision to allow the National Renaissance Party, a neo-Nazi group, to meet in a public school building.

The JTA also carried its protest to Mayor Lindsay and other city officials.

When Lindsay was questioned about the matter at a press conference yesterday, he said he would have his staff "look into the protest."

Mayor Says "No"

Asked whether he approved of letting such a group as the NRP meet in public schools, he answered: "No."

In its letter to the Board of Education, the JTA asked the board to amend its bylaws so as to deny use of school buildings for meetings of the NRP.

The teachers pointed out that the school board in July, 1951, adopted a resolution banning the use of schools to specific organizations listed as totalitarian, fascist, communist or subversive.

When was it Spawned?

Declaring that the NRP "evidently had been spawned" after that date, the JTA asked the school board to amend its resolution to include that so-called party.

Under an opinion handed down by Corporation Counsel J. Lee Lankin, the school board by a divided vote decided to permit the NRP to meet in the Wagner JHS on March 18.

Rankin held that the National Renaissance party, like other political parties, should be permitted to meet in school buildings after hours.

The Anti-Defamation League of B'nai B'rith is already planning legal action either in the courts or by appeal to the State Education Commissioner to prevent the meeting in a school building.

In a letter to Lloyd Garrison, president of the school board,

Martin Dodell, JTA president, emphasized that his organization members "proudly proclaim our American heritage of free speech and assembly."

'Beyond the Realm'

"But to let the enemies of our democratic system declaim their avowed subversive aims in our own public schools is beyond the realm of free expression," the letter stated.

The JTA, in a telegram to Mayor Lindsay, asked if he would permit "an invitation to Hitler's heirs to expound their program of genocide" in a public school building.

"If the National Renaissance party is to be granted a forum, may we suggest that the date be Nov. 11, and the site not a city school but rather Dachau or Arlington," the association wrote.

Copies of the letter and the telegram were sent to Frank D. O'Connor, president of the City Council; to Comptroller Mario A. Procaccino, and to every member of the Board of Education.

The board agreed after being told by the Corporation Counsel last week that it could not legally refuse to allow the party to use school facilities during after-school hours while granting this privilege to other organizations.

School authorities had turned down the party's original request last August, asserting that the meeting "might tend to cause dissension or provoke disorder."

An official of the Anti-Defamation League of B'nai B'rith said his organization would seek to prevent the meeting.

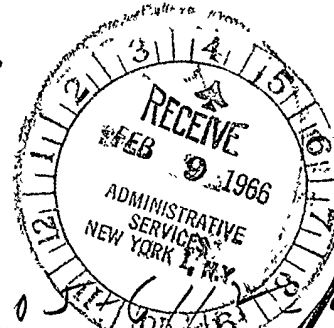

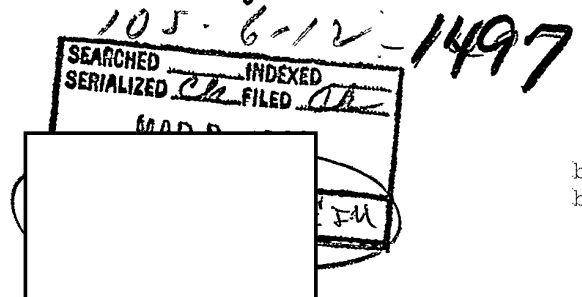

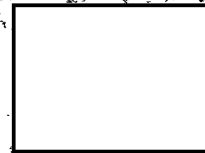
