Robert Burros' Attempted Candidacy for  
the New York State Assembly

Robert Burros, Regional Director of the National Renaissance Party, 10 West 90th Street, New York, New York, for Orange County, New York, is planning to run for the New York State assembly on Election Day, 1966. He is being sponsored by the NRP.

He is being supplied with printed matter and manpower for distributing this literature by the NRP. The literature was to have been distributed on February 12, 1966, at a public meeting of the NRP in the Orange County Court House, Newburgh, New York. The meeting was called off temporarily.

Burros has several petitions being circulated throughout Newburgh, by various storekeepers and merchants. He is planning an active campaign this year.

## Rankin Urged to Alter Ruling on Nazi Group

The American Jewish Committee today urged Corporation Counsel J. Lee Rankin to reconsider his ruling that the Board of Education must permit the National Renaissance Party to hold a public meeting in JHS 167, Man. The NRP is a neo-Nazi group.

Rankin held that the NRP is a "political party" and as such is eligible to meet in a public school building after hours.

Calling the NRP "an avowedly anti-Semitic and anti-Negro organization with membership believed to number less than 25," the AJC asked Rankin not

to be influenced by the fact that James Madole, chairman of the NRP, "calls himself 'a party.'"

Reaffirming its support of freedom of expression and inquiry, the committee asked:

"When, in the long and painful struggle to establish and protect freedom of speech, did the preachment of hatred on any platform, anywhere, become a political meeting?"

### NATIONAL RENAISSANCE PARTY

On May 19, 1965, a source stated that the National Renaissance Party (NRP) is an anti-Semitic, anti-Christian, anti-Negro, and neo-Fascist organization with activities generally confined to the New York City area. It was founded in 1949 by James H. Madole, who is in complete control of the Party. The Party's main function is distribution of the "National Renaissance Bulletin" on a bi-monthly basis and distribution of pro-Arab literature obtained from official Arab establishments in New York City.

The source further stated that the headquarters for the NRP is located in the residence of James H. Madole at 10 West 90th Street, New York City.

On March 4, 1965, Robert Joseph Burros, 215 First Street, Newburgh, New York, advised that he is the National Secretary of the NRP and as such is second in command to James H. Madole, National Director. Mr. Burros stated that the NRP is a fascist organization but that it operates openly. He stated that the NRP advocates the use of the ballot in order to win a national election and take over the government. If the NRP should gain power it would then proceed to change the constitution in a legal way in order to give it the right to use militant means in dealing with those who would seek to overthrow this democracy such as the Communist Party.

The Un-American Activities Committee of the United States House of Representatives in a Preliminary Report dated December 17, 1954, stated that NRP activity and propaganda are clearly subversive and un-American.

On September 29, 1964, a second source advised that on July 16, 1964, James H. Madole, National Director of the NRP, was sentenced to two years in jail following his conviction on a charge of riot.

# A FEW FACTS ABOUT THE KLAN

"I'll bet you will find more good Americans in the Ku Klux Klan than in the A.D.A. (Americans for Democratic Action)." — Edwin A. Walker.

After silence had fallen over the bloody battlefields of the Civil War, came an era in American history so black with human misery and despair that even the passing of a century has been unable to erase this turning back the clock of human progress. From this era, as every honest American knows, the Ku Klux Klan rose to assume the leadership of the Southern people and enable them to regain their rightful places in society.

By 1877, order had been restored in the South, and the Ku Klux Klan was dissolved by proclamation, but with the condition that if ever needed, it could be brought to life once again to engage any and all enemies of the South or this Great Nation.

On Friday, March 26, 1965, President Lyndon Johnson warned every Klansman to get out of the Ku Klux Klan and to join a "decent" society as the Klan was going to be investigated and destroyed. Subsequently, the House Committee on Un-American Activities, of which Rep. Edwin Willis is Chairman, began closed hearings on Klan activities and scheduled open hearings for October.

However, more than a month before LBJ's public statement on "getting the Klan," Louisiana State Senator Jesse Knowles, Chairman of the Louisiana Joint Legislative Committee on Un-American Activities, received this letter, dated February 19, 1965:

"Since reading an article in the Shreveport Times last Saturday, February 13, under dateline Washington and AP, I have been somewhat perplexed. It concerned an investigation of the Ku Klux Klan, a general term, along with three other organizations.

"Now, Mr. Knowles, I have invited Mr. Edwin E. Willis, whom I understand you know, and have welcomed an investigation of United Klans of America, Inc., and have requested that the findings of HCUA be published.

"By virtue of your relationship with the Joint Legislative Committee on Un-American Activities, I also invite your committee to investigate our organization also and make public your findings.

"If you would be so kind as to encourage Mr. Willis to investigate us and publish his findings, I would appreciate it very much.

The Louisiana Joint Legislative Committee on Un-American Activities took Mr. Edwards up on his invitation to investigate

his organization, and on July 26, 1965 they released Report #7. — "Activities of the Ku Klux Klan . . .", based on hearings held on June 16, 1965 at Baton Rouge.

The Louisiana Committee found that there is no such thing as "The Klan." According to their report, there are about 14 different groups using the name "Klan," operating in the Southern and Central United States. The Legislative Committee investigated the four Klan groups which are active in Louisiana.

Of these four Louisiana Klan organizations, the largest is known as "The Original Knights of the Ku Klux Klan." The head of this latter organization is Murray Martin, who furnished the Legislative Committee with a policy statement containing "50 reasons why you should be a member of the original Ku Klux Klan." Here are a few sample reasons:

"20. Because it believes that Judaism is not the religion of the Bible, but that it is a set of principles for the purpose of elevating the Christless Jew beyond the White races.

"40. Because it is unalterably opposed to the Zionist Jew program.

"41. Because it is opposed to the Anti-Defamation League in all respects.

"42. Because it knows the United Nations Charter has usurped the Constitution of these United States, and we are trying to get the United States out of the U.N."

The three other Louisiana Klan organizations are known as The United Klans of America, Inc., The Louisiana Ku Klux Klan, and The Original Ku Klux Klan of America, Inc., led by Houston Morris. Mr. Morris submitted a policy statement to the Louisiana Legislative Committee which said in part:

"The Original Ku Klux Klan is not and never has been the enemy of the Negro people. However, it does oppose and will continue to oppose all so-called Negro 'civil rights' organizations, Communists, and all others who sow the seeds of discontent throughout our great Nation, pitting one race against the other, attempting to mongrelize the races . . .

"The White race has always been the only true friend to the Negro in America, but they are now being misled by the wild promises of the Zionist Jew who know that these promises can never be fulfilled, but are using the passions of the Negro as a tool for their own enrichment.

"The Original Ku Klux Klan always has been and always shall be opposed to Communism in all its forms . . .

"No Zionist Jew may ever obtain membership in the Original Ku Klux Klan of America because we accept only those who profess and practice the tenets of Christianity. Christ is the Klansman's criterion of character, and such would be incompatible with the Zionist Jew's religious convictions."

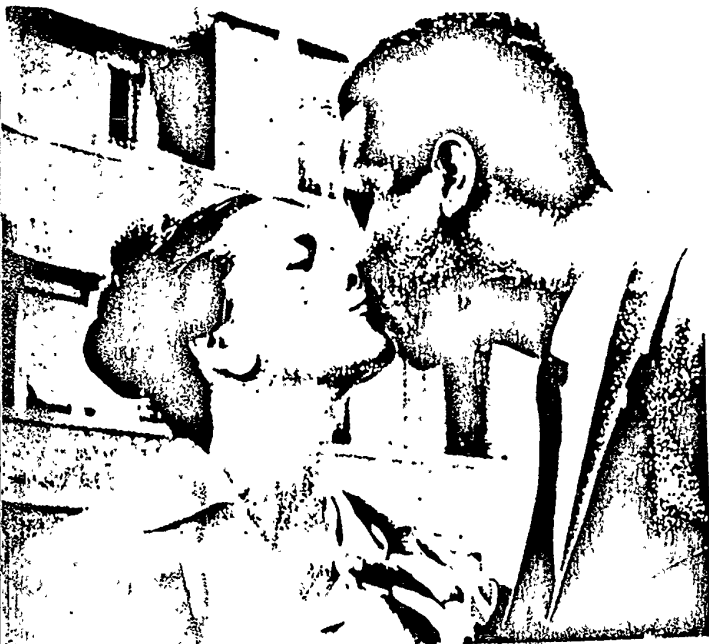

# Meter Probe Extended

A Valley Stream family was startled at the dinner table last night by the sight of a burning cross on their front lawn. Police said it apparently had no racial overtones and was believed to be the work of a prankster.

Samuel Barton of 81 Carroll Ave. was at the dinner table with his wife, Lillian, and two sons, Stephen, 19, and Arnold, 12. They told police they heard a noise outside at about 7 p.m. and looking through the window, saw the flaming cross.

The cross was 3 feet long and 2 feet wide and was crudely made, police said.

Police said Barton is not a member of any civil rights group or any controversial organization.

"I'm not mixed up in anything," police quoted Barton as saying, "and I'm just amazed. I can't figure out any reason why they should pick on me."

Barton is a mailman. His family has resided in Valley Stream for 10 years and no unpleasant episode has occurred during that period.

## Valley Stream Jewish Family Finds Cross Burned on Lawn

Valley Stream—A crudely-fashioned cross was burned last night on the front lawn of a Jewish family here which had never experienced any persecution before.

Samuel Barton, who lives with his wife and two sons at 81 Carroll Ave., said that his son Stephen, 19, heard a noise at the front of the house at about 7 PM and when he went to the door he saw the blazing, three-foot-high cross stuck into a chain link fence on the lawn. Barton, a letter carrier who works in New York City, asked what might have caused the incident, said: "We are Jewish and this is a cross. I wish I knew the answer. I don't know whether it's pranksters or something else. We've lived here 11 years now and none of us have had any trouble before." Barton said there is one other Jewish family in the neighborhood. Police refused to conjecture on the cause of the incident pending further investigation.

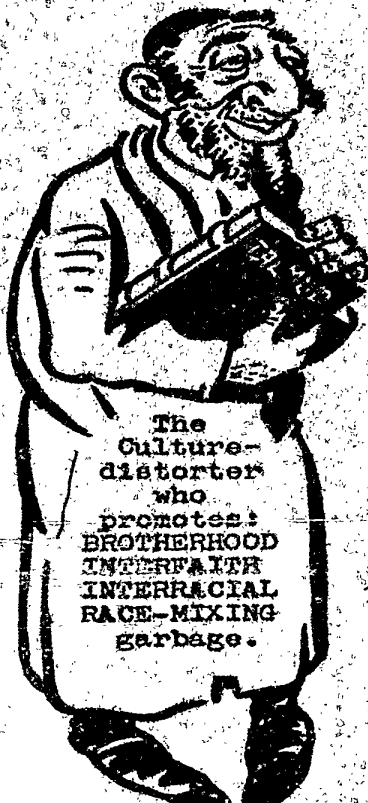

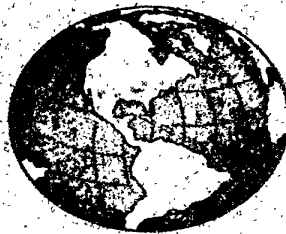

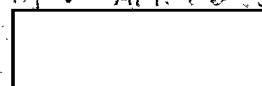

# A FEW FACTS ABOUT THE KLAN

"I'll bet you will find more good Americans in the Ku Klux Klan than in the A.D.A. (Americans for Democratic Action)." — Edwin A. Walker.

After silence had fallen over the bloody battlefields of the Civil War, came an era in American history so black with human misery and despair that even the passing of a century has been unable to erase this turning back the clock of human progress. From this era, as every honest American knows, the Ku Klux Klan rose to assume the leadership of the Southern people and enable them to regain their rightful places in society.

By 1877, order had been restored in the South, and the Ku Klux Klan was dissolved by proclamation, but with the condition that if ever needed, it could be brought to life once again to engage any and all enemies of the South or this Great Nation.

On Friday, March 26, 1965, President Lyndon Johnson warned every Klansman to get out of the Ku Klux Klan and to join a "decent" society as the Klan was going to be investigated and destroyed. Subsequently, the House Committee on Un-American Activities, of which Rep. Edwin Willis is Chairman, began closed hearings on Klan activities and scheduled open hearings for October.

However, more than a month before LBJ's public statement on "getting the Klan," Louisiana State Senator Jesse Knowles, Chairman of the Louisiana Joint Legislative Committee on Un-American Activities, received this letter, dated February 19, 1965:

"Since reading an article in the Shreveport Times last Saturday, February 13, under dateline Washington and AP, I have been somewhat perplexed. It concerned an investigation of the Ku Klux Klan, a general term, along with three other organizations.

"Now, Mr. Knowles, I have invited Mr. Edwin E. Willis, whom I understand you know, and have welcomed an investigation of United Klans of America, Inc., and have requested that the findings of HCUA be published.

"By virtue of your relationship with the Joint Legislative Committee on Un-American Activities, I also invite your committee to investigate our organization also and make public your findings.

"If you would be so kind as to encourage Mr. Willis to investigate us and publish his findings, I would appreciate it very much.

United Klans of America, Inc."

The Louisiana Joint Legislative Committee on Un-American Activities took Mr. Edwards up on his invitation to investigate

this organization, and on July 26, 1965 they released Report #7 — "Activities of the Ku Klux Klan . . .", based on hearings held on June 16, 1965 at Baton Rouge.

The Louisiana Committee found that there is no such thing as "The Klan." According to their report, there are about 14 different groups using the name "Klan," operating in the Southern and Central United States. The Legislative Committee investigated the four Klan groups which are active in Louisiana.

Of these four Louisiana Klan organizations, the largest is known as "The Original Knights of the Ku Klux Klan." The head of this latter organization is Murray Martin, who furnished the Legislative Committee with a policy statement containing "50 reasons why you should be a member of the original Ku Klux Klan." Here are a few sample reasons:

"20. Because it believes that Judaism is not the religion of the Bible, but that it is a set of principles for the purpose of elevating the Christless Jew beyond the White races.

"40. Because it is unalterably opposed to the Zionist Jew program.

"41. Because it is opposed to the Anti-Defamation League in all respects.

"42. Because it knows the United Nations Charter has usurped the Constitution of these United States, and we are trying to get the United States out of the U.N."

The three other Louisiana Klan organizations are known as The United Klans of America, Inc., The Louisiana Ku Klux Klan, and The Original Ku Klux Klan of America, Inc., led by Houston Morris. Mr. Morris submitted a policy statement to the Louisiana Legislative Committee which said in part:

"The Original Ku Klux Klan is not and never has been the enemy of the Negro people. However, it does oppose and will continue to oppose all so-called Negro 'civil rights' organizations, Communists, and all others who sow the seeds of discontent throughout our great Nation, pitting one race against the other, attempting to mongrelize the races . . .

"The White race has always been the only true friend to the Negro in America, but they are now being misled by the wild promises of the Zionist Jew who know that these promises can never be fulfilled, but are using the passions of the Negro as a tool for their own enrichment.

"The Original Ku Klux Klan always has been and always shall be opposed to Communism in all its forms . . .

"No Zionist Jew may ever obtain membership in the Original Ku Klux Klan of . . . profess and practice the tenets of Christianity. Christ is the Klansman's criterion of character and such would be incompatible with the Zionist Jew's religious convictions."

On April 4, he received a letter which contained four pieces of literature. Thermofax copies of the enclosures sent to Carrier Barton, who incidentally is a member of our organization, are attached hereto for your perusal. The copy of the envelope is marked A; the contents of that envelope are marked B, C, D and E. You will note that on the reverse side of attachments B, C and E, there is additional printed matter.

The envelope which was addressed to Carrier Barton and containing the material described above, bore the return address of James Madole, 10 West 90th Street, New York, N. Y.

Also attached hereto are thermofax copies of newspaper accounts (marked F and G) of a cross burning episode that took place on the front lawn of Carrier Barton's home. I realize that this is a police matter, however, I am submitting the accounts of it to you so that you may have the entire file.

Mr. Barton has authorized me to submit this case to you for immediate investigation since the material sent to him in the mail is, in my opinion, contrary to law. Should there be need for additional information, or if you wish to see the originals which Carrier Barton showed me today, he would be more than happy to meet with you at any time that is convenient to you or someone you would designate.

We have had previous complaints concerning the material being mailed by Madole and the National Renaissance Party.

We are taking the liberty of forwarding your complaint to the Special Agent in Charge, Federal Bureau of Investigation, 201 East 69th Street, New York, N. Y. 10021, for his consideration.

On 4/27/66, [REDACTED] Bureau of Special Services, New York City Police Department, advised that he had been in touch with various leaders of "peace groups" in the New York City area in order to determine which groups will take official part in the May Day Rally in Union Square, NYC, on Saturday, 4/30/66.

[REDACTED] stated that he had ascertained that the Youth Against War and Fascism (YAWF) and the Catholic Worker are the only organizations to date that have officially publicized their participation in it. [REDACTED] stated that undoubtedly many other individuals who are members of various groups will participate in the rally but will do so as individuals and not as members of any organization. [REDACTED] stated that he has no knowledge of the number of individuals from YAWF or the Catholic Worker will participate in the rally.

[REDACTED] further advised that about 15 representatives of the National Renaissance Party (NRP) will counter-demonstrate. About 12 of these NRP members will be in uniform. [REDACTED] stated he obtained this information from JAMES MADOLE, NRP leader.

# Nazi Regalia in Queens

## ARSENAL AND FLAGS

When two U. S. marshals crashed into Donald Swan's slightly shabby Queens Village home yesterday, they were looking only for merchandise gathered in an elaborate mail fraud.

Instead they found Nazi regalia—flags, a sword, a dagger, a German soldier's helmet—and an arsenal of weapons.

They found, too, the baby-faced Mr. Swan leaning his shoulder against the door to block their entrance. And they found, they said, "several thousand dollars" worth of merchandise he had ordered by "using the mails to defraud."

They loaded all the material into a postoffice truck and they took Mr. Swan to a U. S. Commissioner's office in Brooklyn where he was held in \$2,500 bail.

The marshals didn't know it, but research turned up later the fact that Mr. Swan had been active nine years ago in a group that was trying to organize a chapter of the segregationist White Citizens Council in the Nassau suburbs.

A reporter interviewed him then, and found him a neat and polite young man who, at one point, commented calmly

that "Negroes should not be permitted to vote—at least not under the present Electoral College system."

The marshals said that for several years, Mr. Swan, 31, had been sending for mail order merchandise under 100 fictitious names but always to his own home, a two-story brown shingle house badly in need of a coat of paint at 88-42 209th St., Queens Village.

Marshals William Gallinaro and Ben Butler sat watching the house for an hour or so yesterday. There was some one inside, they were convinced. But no one answered when they knocked on doors and windows and then stood on the porch and shouted, "If you don't open that door, we'll break it down."

Silence from inside.

They telephoned assistant U. S. Attorney J. Leonard Theberge, who was in charge of the case. That's right, he said, break the door down.

Mr. Gallinaro, wrapping a handkerchief around the butt end of his service revolver, smashed a pane of glass in the front storm door and another in the inside door. By this time, the marshals had called for help and five police squad cars had converged on the quiet, tree-lined residential street.

### SHOVING MATCH

As they tried to open the door, the marshals said, Mr. Swan leaned against it from the inside. A 5-foot-11 crew-cut 170-pounder in a gray sweatshirt and khaki slacks, he shoved the door out as they shoved it in. But once they got inside, they said, he offered no resistance.

And then they found the Nazi material and the arsenal. The material included, they said, a carbine, six clips of carbine bullets and 10 boxes of .45-caliber bullets.

The Federal men found, too, they said, several transistor radios, records and books. The complaint against Mr. Swan listed the Book of the Month Club as among the victims of his alleged mail fraud.

The alleged fraud amounted to about \$400 a week, the Federal agents said. He identified himself as a free-lance research writer earning \$100 a week.

The Federal men did not say how Mr. Swan was supposed to have converted mail-order merchandise into money, nor did they explain why he might have ordered the stuff sent to his own home address. The origin of the weapons and the Nazi paraphernalia was not explained either, but authorities did say that every room in the house except the kitchen was lined with bookshelves and that there were hundreds of anti-Semitic, anti-Negro and anti-Catholic tracts on the shelves.

### BAIL OF \$2,500

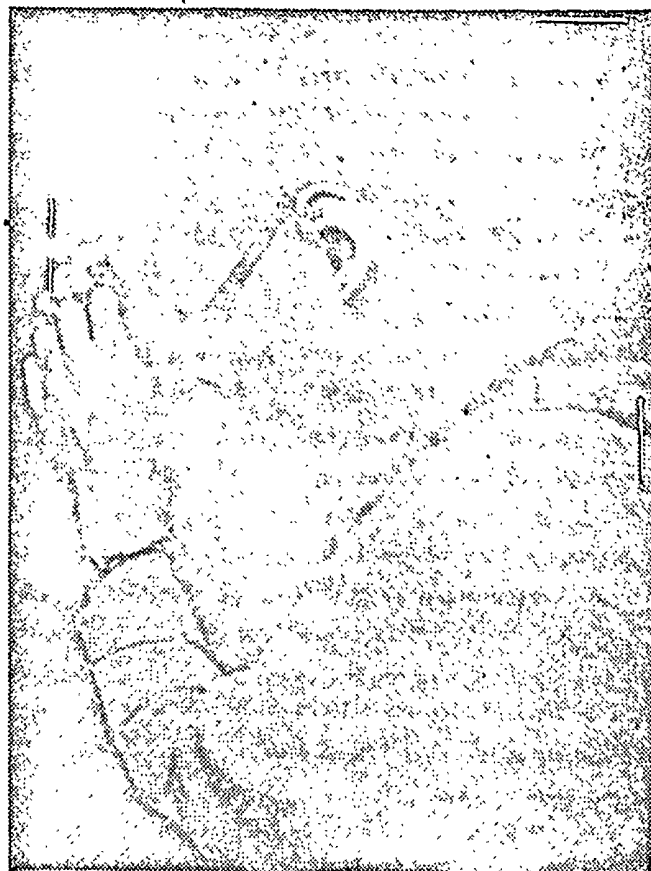
At his arraignment before U. S. Commissioner Max Schiffman, Mr. Swan produced a bankbook showing deposits of some \$7,000 in a bank in Hudson County, N. J. He also had a passport which showed that he had visited recently in France, Italy and Argentina.

Mr. Theberge suggested that the passport showed Mr. Swan had few local roots and he asked bail of \$5,000.

Mr. Swan said he had lived with his mother at the same address since 1939.

The Commissioner set bail of \$1,500 and Mr. Swan was led away in handcuffs.

On his home block in Queens Village, not an adult neighbor could be found who knew much more than that

he was a pleasant young man. Neighborhood children said, though, that they had been frightened of him.

"Once," said a 9-year-old in a beige windbreaker, "we were just walking up the street. We weren't even making any noise and this guy comes out of his house and just for nothing he grabs my brother by the jacket collar and smacks him in the face."

A 10-year-old in a hooded plaid mackinaw chimed in: "Last winter, this guy we know dropped a nickel in front of the house and he was looking under the leaves for it. He wasn't messing up nothing. Then this guy comes running out of the house with a broom and makes him sweep up the whole front of the house. He must be nuts."

The reporter talking to the children wrote down his notes and prepared to leave.

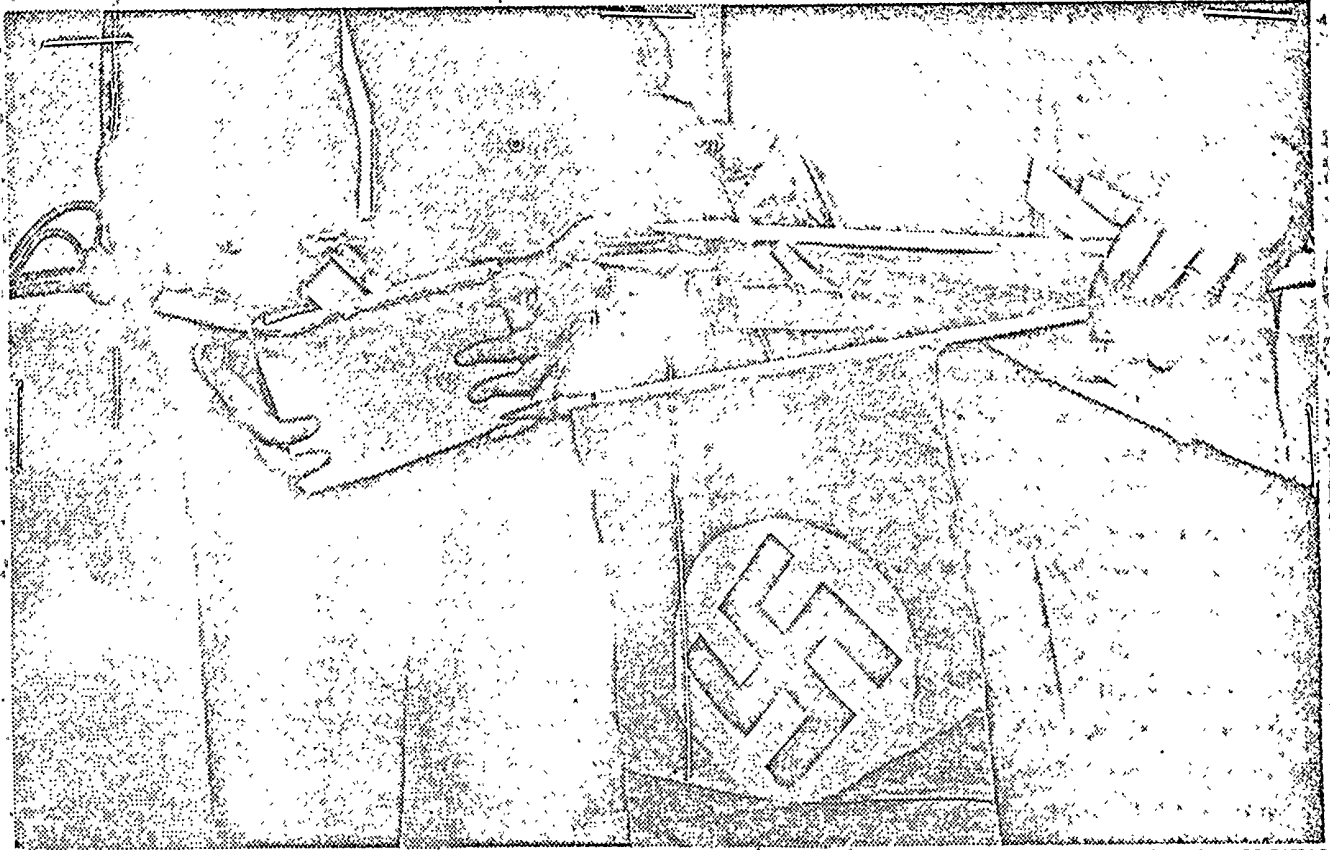
"What happened to this guy, anyway, mister?" one of the boys asked.

"He was arrested. Do you have any idea what for?"

"Sure," said one of the children, "he was a Commie."

"No," said the reporter, "he was a Nazi."

The 9-year-old and the 10-year-old pondered as the reporter got into his car. Before he drove off, one of the boys walked over to him. "Hey, mister," he said, "what's a Nazi?"

# 'YOU NEVER KNOW...'

## Uncover Strange Past of Neo-Nazi

By PETER BERNSTEIN

"You never know," said a neighbor of Donald A. Swan. "You never know what goes on behind the curtains of some homes."

And in the case of Donald A. Swan, 31, few people, perhaps not even his mother, Daisy, were aware of what went on behind those curtains until U.S. marshals raided his Queens Village home Tuesday and confiscated truckloads of Nazi regalia among items allegedly obtained illegally.

The raid by federal agents, resulting in Swan's arrest on mail fraud

charges, uncovered a past too strange to believe for many of the people who knew him as the "clean-cut college kid next door."

Swan was identified yesterday as a mainstay of neo-Nazi and arch-segregationist causes ever since he was a student at Queens College.

While a student at Queens College in July, 1957, he participated in a "segregationist cell" that was trying to organize a White Citizen's Council in Nassau County.

The "cell"—led by a merchant seaman named Rob-

ert Vincent L'Hommedieu—was founded to effect a complete separation of the white and Negro races in the United States.

In an interview with reporters, L'Hommedieu introduced Swan, then 22, as the "theorist" of the group.

Swan has also been linked with the neo-Nazi National Renaissance Party. The link was brought into the open yesterday by the Anti-Nazi League, whose headquarters are in Manhattan.

Swan attended several of the neo-Nazi party's meet-

ings in Yorkville from 1956 to 1959, according to James H. Sheldon, administrator of the league.

Sheldon also identified Swan as a speaker at a series of meetings called the Racist Forum, sponsored by the late Charles Smith, editor of the magazine, "The Truth Seeker."

DURING this period, Swan used a variety of aliases—Thor Swenson and Donald Walker, among others, said Sheldon, because the youth wanted to shield his family from these activities.

Swan, who lived in Queens Village since he was three years old, is the product of a broken home. His parents were divorced when he was a child, and his father has since remarried.

MRS. DAISY SWAN, a slender woman with dyed red hair, expressed disbelief at her son's arrest yesterday.

"It comes as a shock to me," she said in a thick English accent.

"I can't tell you a thing about it. I wasn't home when my son was arrested. I don't know what it's all about," she said.

When federal agents raided the small weather-beaten home at 88-42 209th Street, Swan defied arrest and barricaded the door.

His mother returned from her job as a babysitter yesterday morning to find shards of glass from the front door scattered on the stoop.

Bookcases which once held thousands of books and phonograph records — allegedly never paid for by her son — had been confiscated by federal agents. Also taken from the house were several Nazi helmets, armbands, Nazi flags, a carbine rifle, and nine boxes of 45-caliber shells.

THE HOUSE must have seemed barren, except for a photograph of Swan and George Lincoln Rockwell, fuhrer of the American Nazi party. The picture, federal agents said, was hanging in Swan's bedroom.

Swan, considered a brilliant student as a youngster, attended P.S. 135, just two blocks from his home, and Jamaica High School. He graduated from high school when he was 16.

Professors at Queens College, from which Swan

graduated, recalled that during the college's 1952 mock political convention, he rushed into the convention hall waving a Confederate flag. Then he let out with a Confederate yell.

One professor, interviewed when Swan was active in the White Citizens Council, summed up his personality thus:

"He's an exhibitionist and a bitter non-conformist. If he was supposed to be wearing a jacket and tie he'd wear a bathing suit. If he was supposed to wear a bathing suit, he'd wear a tux."

HIS READING, judging by the books confiscated by postal authorities, ranged from a German edition of Hitler's "Mein Kampf" to studies of sex relations in marriage.

He took summer courses in the school of arts and sciences at New York University in 1954 and 1958.

More recently, he travelled to Virginia and Mississippi, and abroad to Italy, Germany and Argentina, according to Asst. U.S. Atty. Leonard J. Theberge.

AT THE time of his arrest, he told authorities that he was doing "research work" at home.

Neighbors said their only contact with him was an "hello" and "goodbye" when they passed him on the street.

"The only time I ever saw him," said one woman, "was when he was out mowing the lawn or shoveling snow."

"He seemed like a nice boy," said another. "Quiet and studious—like his mother. She's from Liverpool in England, you know. She told us once that she liked to hike and camp-out. I think she said she was a

Girl Scout leader at time."

ONE NEIGHBOR, ever, who has lived in Queens Village as long as the Swans, remembering having ruffled the hair of Donald Swan when he was only three years old.

"This is a shock to it is to everyone else."

"I guess," the woman said, "the things that are never done are the open. But I have been fighting against him. He did anything to hurt."

"He seemed nice. But I never know. You just know what goes on behind the curtains of these homes."

The Recordak film which is enclosed was partially reviewed by the NYO and of the names reviewed in NY indices, there was no positive identification made which would enable a determination to be made as to the connection of the individuals listed on this form or the apparent purpose of this list.

On 4/12/66, SAS [redacted] and LEWIS GREY BROCKMAN and [redacted] were provided three file draws by US Marshal BENJAMIN BUTLER of the Special Services Squad, US Marshal's Office, Brooklyn, NY. He advised these three file draws contain 3 X 5 cards of names and address which were apparently produced by an addressograph type printing system, and that these cards were secured from the possession of DONALD A. SWAN whom he had arrested on a ~~Post Office~~ violation at SWAN's residence 88-42 209th Street, Queens Village, NY. He stated that this arrest had been made on 4/5/66. He stated at the time of SWAN's arrest, they located numerous items indicating a rather extensive filing system of names and addresses, many items of which indicated an association with some type of neo-Nazi activity.

He further advised that DONALD ARTHUR SWAN was born 3/8/35, in New Jersey, is a white male, 5'9" tall, having brown hair, blue eyes, and US Marshal's arrest number 3958, dated 4/5/66. He further advised that at the time of SWAN's arrest, SWAN had in his possession US carbine caliber 30 M-1, apparently made at the Universal Factory, Hialeah, Florida, which had a serial number of 2817. He stated that underneath the barrel was the number 01X and on the top of the barrel it had Rock, Oklahoma. He further stated that there were about 270 rounds of 30 caliber M-1 ammunition with five clips loaded.

He stated there were six boxes of 45 caliber ammunition which had the marks of "WCC 56", three boxes of 30 caliber M-1 rifles containing 50 cartridges each from the Western Cartridge Company showing ammunition lot number WCC 6295 and showing "repacked" E.C. 9-44. There were 50 cartridges of caliber 45 ammunition showing M-1 9111 with lot number WCC 6590 and two boxes of 45 caliber pistol ball ammunition with lot number 6561, and four boxes with lot number 6530.

A review of New York indices failed to develop any information pertinent to the US carbine caliber 30 M-1, serial number 2817. The US Marshal further advised that on the person of DONALD SWAN was a list of telephone numbers and addresses which appeared to be of importance to SWAN according to the US Marshal.

The list as provided is shown below and the names listed with these numbers were secured through a check of the New York Telephone Street Directory for individuals at the indicated telephone number or street number.

It is pointed out for the office of origin that a review of the New York indices for some of the names secured from this telephone list did not provide sufficient information to make any identification as to the connecting reason or the common interest of the people on this list. The list is as follows as provided on 4/8/66 by US Marshal BUTLER:

US Marshal BUTLER further advised that House Un-American Activities Committee [redacted] had made inquiry as to SWAN's activities since SWAN's arrest. Further, that SWAN has photographs in his possession taken by one [redacted]. Also, that SWAN used the alias of DONALD WALKER in 1958. Further, that SWAN had some photographs which on the back side were marked E. DEMAREST PETERSON, 12 Hillarie Lane, Glenbrook Hills, Richmond, Virginia, as the photographer.

On 4/6/66, the NYO received an anonymous telephone call advising that one H. KEITH THOMPSON, in the printing business on Wall Street, was connected with DONALD A. SWAN. A search of NYO indices for H. KEITH THOMPSON revealed information that one H. KEITH THOMPSON, JR. was a young New York job printer and a registered agent in the US of the Socialist Reich Party.

A review of NYO indices on DONALD A. SWAN developed information indicating that DONALD SWAN with aliases DONALD WALKER and THOR SWANSON was apparently active in several neo-Nazi groups in the past, such as the Nationalist Youth League in 1958 and the American Nazi Party, also, the Committee for Freedom of Choice.

The above information as well as the Recordak film and all the names and addresses that were in possession of SWAN as secured by the US Marshal's Office on 3 X 5 cards are being provided to the office of origin for their review and consideration for any possible

logical leads which might be deemed feasible or further action which might be productive in this matter. It is pointed out that from the initial partial search of names in the NYO, there is no conclusion as to the purpose of this extensive list although there are earmarks of possible association of a common interest with these people. This determination will be left to the office of origin. The Recordak film as provided to the office or origin need not be returned to New York.

It is further pointed out that a search for the serial number of the above mentioned carbine 2817 was not sent to the Bureau which the office of origin may desire to so do if there is an interest in determining if this weapon may have come from a shipment which could possibly have been distributed to other members of neo-Nazi oriented organizations. According to the US Marshal's Office, they developed no stolen report on this serial number. Again it is pointed out this determination was not made by the NYO through the Bureau.

No further action on the above matter will be taken by the NYO at this time. NY will report results of court action scheduled to be taken May 16, 1966 against GEORGE LINCOLN ROCKWELL in Part 2B, Criminal Court, NYC.

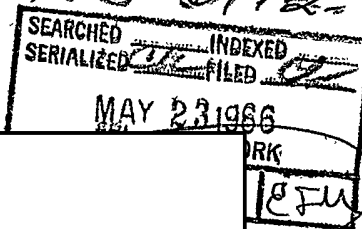

A confidential source, who has furnished reliable information in the past, advised on May 22, 1966, that from 4:30 p.m. to 6:30 p.m. on May 21, 1966, ten members of the National Renaissance Party (NRP) picketed on the corner of 50th Street and Park Avenue, New York, New York, which is the location of the Waldorf Astoria Hotel. The NRP had planned to picket on the Lexington Avenue side of the Waldorf Astoria Hotel, however, upon their arrival at that location they were directed to the Park Avenue location by the New York City Police Department.

This source advised that the purpose of the picketing was to demand that Rhodesia be kept under the rule of white people, and also to express opposition to the views on Rhodesia expressed by the United States Ambassador to the United Nations, Arthur Goldberg, who resides at the Waldorf Astoria Hotel.

The above pickets carried placards with the slogans: "White Government for Rhodesia", "Kick Goldberg out of U.N.", "Civil Rights for Whites", "Zionism is Communism" and "Join the N.R.P."

This same source advised the above picketing was peaceful and there were no arrests or disorders.

Subsequent to July 16, 1964, all activities of the NRP appeared to have been suspended. As of September 29, 1964, James H. Madole was free on bail pending an appeal on his conviction and sentencing on July 16, 1964. This source advised that the NRP would not be reactivated by Madole who feared that such reactivation might jeopardize his appeal.

On May 18, 1965, [redacted] Bureau of Special Services, New York City Police Department, advised that on May 15, 1965, he had been informed by James H. Madole that his appeal would be heard sometime in early September, 1965. Madole further stated future activities of the NRP would depend on the outcome of that appeal. Should he win his appeal, Madole stated there could be an expected increase in NRP activities. Should he lose, there will not be any activity since he will be sent to jail. Madole stated there will be no real NRP activity until the status of his appeal is determined in September, 1965.

JEWISH CULTURAL CLUBS AND SOCIETIES

A source advised on April 27, 1954, that the former leaders, including GEDALIA SANDLER, Executive Secretary, of the Jewish People's Fraternal Order (JPFO), Jewish nationality section of the International Workers Order (IWO) had established a committee at 1133 Broadway, New York, New York. Through this committee they were organizing cultural clubs and societies based on JPFO lodges which had been dissolved on December 15, 1953, in the course of proceedings by the New York State authorities culminating in the liquidation of the IWO.

A second source advised on March 15, 1961 that a meeting of the National Groups Commission of the Communist Party, United States of America, was held on March 2, 1961, in New York City. GEDALIA SANDLER was among those present and spoke of his experiences in maintaining the Jewish lodges after the dissolution of the IWO, which, to avoid prosecution, have no national name or organization.

SANDLER stated that these lodges "lived" as clubs and societies by maintaining their cultural, fraternal and civic activities, but which activities are less political than in the former lodges. New York gave leadership to the rest of the country since the New York lodges were the strongest and had the more politically developed comrades.

These clubs and societies still maintain a medical plan, funeral benefits and mutual aid funds. There are 132 clubs and societies nationally, 63 of which are located in New York City.

A third source furnished information on May 18, 1965 that the clubs and societies are located at 1133 Broadway, Room 1429, New York, New York, under the name of the Jewish Program Service Committee, but are more widely known as the Jewish Cultural Clubs and Societies.

The IWO and the JPFO have been designated pursuant to Executive Order 10450.

## IS CHRIST'S "LOVE THY NEIGHBOR" ONLY FOR CHRISTIANS TO PRACTISE?

By Ralph W. McInnis

We have noted with a great deal of interest the large numbers of rabbis who participate in and perhaps lead the present unholy war against the South; and we feel that this fact is so overwhelmingly significant and so dangerous to our Republic that no loyal American can afford to ignore it.

At present, many of these rabbis have returned to California and are weeping copious tears in print and in public and perhaps even in their vodka over the alleged plight of Negroes in the South. And attempts are being made to arouse the community to a fury of anti-Southern-white regional bigotry.

May we suggest that the rabbis save a few of their crocodile tears and shed them for the million plus Arabs who were thrown out of their homes and driven from their nation by the invading hordes of Israel. If by the time the rabbis read this letter they have any tears left, we trust that they will shed them for the victims of the Der Yassin massacre who failed to flee from their homes in time or who refused to leave them at all.

Students of history and atrocityology should not overlook the fact that over a million Arabs were driven into the deserts of neighboring countries to starve — with not a single tear being shed for them by any rabbi that I know, nor by the perpetrators of this horrendous crime against humanity. And there were no marches in defense of the victimized Arabs by any unwashed demonstrators. We do not recall a single Negro being pushed into the Gulf of Mexico, nor has one of them been driven from his home.

Now I would like to ask the bleeding heart rabbis a few pertinent questions, as follows: Is the South's alleged anti-Negroism somehow worse than anti-Arabism? Is so-called anti-Semitism worse than anti-Germanism? Is it worse than anti-Mississippi-ism? Worse than anti-Union-of-South-Africanism? SO, IF NOT THEN WHY?

You hear about the NEGRO COMMUNITY, a racist organization supported and defended by fanatic Negro church leaders; you hear of JEWISH COMMUNITY, also a racist group and most fanatically defended by odious Jew Rabbis....But where the hell is the ANGLO-SAXON & GENTILE COMMUNITY! the White racial Americans...did our mealy-mouthed, snivelling, servile, gutless brainwashed Jewized, sickening, cringing spiritual leaders castrate the White people and rendered them helpless for the Jew-Communist take-over....And what happened to our patriotic groups...the AMERICAN LEGION, DAR, YAF & V.F.W.---why arn't they out in the streets counter marching and picketing IN DEFENSE OF THE WHITE CHRISTIAN RACE!

## Communism is Jewish

We would like also to ask the rabbis why their particular ethnic group is waging an unholy war against our white citizens of the South? Why the newspapers, TV, and radio owned by the sons of Israel have for years carried on an intensive and unrelenting campaign of villification, hate, and smear against the South and its inhabitants? Also, why do the TV cameramen follow like jackals behind the unwashed, unshaven, evil smelling beatniks to record and publicize every move they make—except perhaps such scenes as massive public urination?

The most vicious prejudice in America today is not anti-Semitism or anti-Negroism but anti-Southern-white-ism! And anti-Mississippi-ism has become a national psychosis. We are not unaware of the fact that hysteria has been masterminded and carefully nurtured by the sons of Israel.

The people of the South have a right to defend themselves! And make no mistake about it, an attack on Alabama or Mississippi or any other state—North, South, East, or West—is an attack on every loyal American, an attack that cannot be endured forever, or endured in silence.

And let no one tell me that I have no right to ask the above questions. Every loyal American has not only the right but the duty to ask them, and to expect intelligent answers. The very life of our Republic is at stake, as well as the lives and properties of every one of its citizens.

We Americans must abandon our little game of shadow boxing in the dark. The whole truth must be revealed. Our people will be defended.

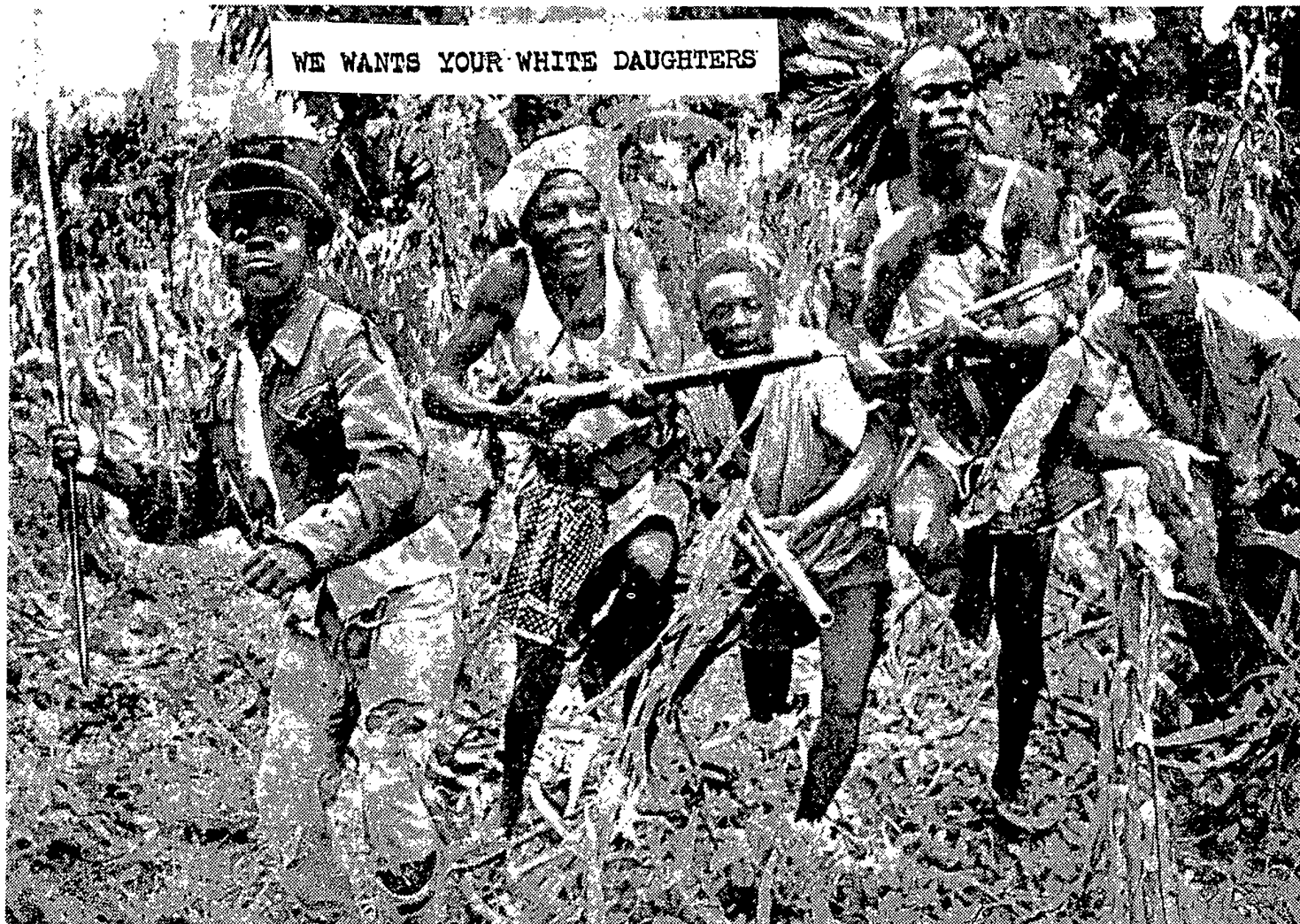

## As We See It

### NRP and Courthouse

By its unanimous decision upholding the right of the Orange County Board of Supervisors to deny use of the Newburgh Court House to the National Renaissance Party, the Appellate Division has fixed responsibility for control of the facility with the county legislators.

Supreme Court Justice Leonard Supple had held the county board could not deny the courthouse to the NRP, a hate group. The Civil Liberties Union joined in the NRP's legal action to enjoin the supervisors.

The lower court ruling, in effect, would have made the supervisors open the courthouse to any group, regardless of the consequences. The appellate decision leaves the supervisors responsible and possessed of the power to deny the facility where judgment so inclines. Presumably, the supervisors would have to use good judgment—not, for instance, denying the building for a legitimate political rally or organizational activity.

Supervisors refused to let the courthouse be used for a meeting at which Jews, Negroes and others would be baited by hate group speakers. While the issue of free speech must be recognized, there must also be consideration of its abuse. Justice Oliver Wendell Holmes, a great liberal, once wrote that freedom of speech did not include the right to cry "Fire!" in a crowded theater.

For a court to rule that no county official could deny use of the courthouse, even in such a case, would be inviting disaster. Furthermore, it would be fixing upon the court full responsibility for the consequences. If rioting or violence occurred as a result of the action, blame doubtless would attach to the court rather than to the county officials who in their discretion had refused to open the courthouse for such an activity.

The courthouse should be available for legitimate political meetings and discussions. The responsibility for determining what constitutes such activity rests with the Board of Supervisors.

At the same time, there is still legal redress in the courts for those who may believe the supervisors have exceeded their authority or arbitrarily denied use of the public facility for a legitimate purpose.

There is room, as there should be, for good judgment and proper exercise of the discretion placed with the legislative, administrative and judicial branches of government by the Constitution and the people.

# Nazi party no closer to first Orange rally

NEWBURGH

The political season may come and go before the neo-Nazi National Renaissance Party (NRP) holds its first public meeting in Orange County.

So far the NRP has had its day only in court. More court action seems likely before it will get its day at a public meeting.

Elliott M. Weiner, Newburgh's corporation counsel, has ruled that the NRP may not use sound equipment at a rally on the corner of Fullerton Avenue and South Street Aug. 20.

At the same time, Weiner told City Manager Paul L. McCauley that the NRP should be permitted to meet. McCauley in turn asked the city's police department to be on hand in full force to make sure the rally does not

get out of hand.

But, while Weiner became the first official in Orange County to rule that the NRP has the right to meet publicly, the party's national leader, James H. Madole of New York, said the meeting will not be held without sound equipment.

Madole threatened to go to court to secure the right to use sound equipment — a right he says is guaranteed by the constitution.

At issue in this dispute is whether the NRP is a political party. This is the same issue at the heart of the NRP's dispute with the county board of supervisors over use of the county courthouse in Newburgh.

By the time the litigation gets through the courts the political season may well be over and Robert J. Burros, regional director of the NRP, may never get

chance to launch his campaign for assemblyman from the 96th district.

Madole claims his party cannot meet without sound equipment because NRP rallies are usually well-attended.

Besides, the national leader added, sound equipment is needed to overcome the hecklers.

Madole said Thursday the city is denying the NRP the right to run a candidate for public office by turning down the party's application for a sound permit.

Weiner disagrees. He says the NRP is not a political party and that only authorized parties may use sound equipment. The NRP's application, he said, was handled just as he would handle the application of any organization that is not a political party.

#### May be first

But at the same time Weiner said that to the best of his knowledge only political parties have applied for such permits. Thus, the NRP's application may be the first the city has ever turned down.

Essentially, Weiner raised the same question that the Appellate Division of the Supreme Court raised last week.

The court ruled that the NRP must prove it is a political party and that its views will not in-

jure the public wear before it will be permitted to use the Newburgh courthouse.

In remanding the case to the lower court for a decision on whether the NRP is a political party, the appellate court said a regulation by the board of supervisors limiting courthouse use to political parties as defined in the election law may be discriminatory.

#### 'Discriminatory'

"In our opinion, the regulation, in so far as it limits use of courtrooms to political parties which polled at least 50,000 votes in the last preceding gubernatorial election, is unconstitutionally discriminatory against genuine independent political parties entitled to recognition under the election law," the court ruled in a unanimous opinion.

It is possible that the NRP will try to link its suit against the county with its potential suit against the city because both hinge on the single question of the NRP's status as a political party.

The suit might even call for a change in the election law, which defines a political party as one which received 50,000 votes or more in the last gubernatorial election.

Madole said he would ask the

New York Civil Liberties Union (NYCLU) to handle the case against the city. Jeremiah S. Guttman of New York, a Jewish NYCLU lawyer, is handling the NRP's case against the county.

Madole claimed Thursday that J. Lee Rankin, New York corporation counsel, and Dr. James E. Allen, Jr., state education commissioner, have affirmed the NRP's place as a political party.

Madole said the NRP has been permitted to use the New York City schools and city buildings for public meetings.

#### 'Treasury depleted'

He said Newburgh would see its treasury depleted if it tries to fight the NRP in court. At the same time, the NYCLU does not charge the clients it represents and it costs the NRP nothing to enlist the services of NYCLU lawyers.

The NRP, an anti-Semitic, anti-Negro group, has been trying to meet publicly in Orange County since January, 1965.

Burros, who originally comes from Orange County, was born to a Jewish father and was Bar-Mitzvahed some 20 years ago in Newburgh. If elected to the Assembly, he says, he will introduce legislation to deprive Jews of their rights.

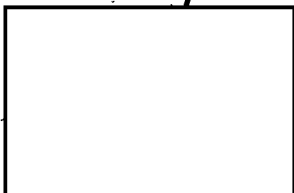

### National Renaissance Party

A confidential source, who has furnished reliable information in the past, advised on September 6, 1966, that the National Renaissance Party (NRP) held a street meeting from 7:45 PM to 9:40 PM on September 2, 1966, at 85th to 86th Street on First Avenue, New York, New York.

There were approximately eighteen individuals representing the NRP and approximately 350 spectators in attendance.

On orders from James Madole, National Director of the NRP, the NRP representatives were not dressed in their storm trooper uniforms in order to conform with recently passed legislation in New York which prohibits the wearing of storm trooper-type uniforms in public.

James Madole was the main speaker. He spoke about the New York law prohibiting the wearing of storm trooper uniforms in public. He stated this legislation was passed for the benefit of minority groups and that the NRP will have an attorney go to court to contest this law.

Robert Burros, Regional Director of the NRP, was also a speaker. He spoke about the Federal Reserve Act, alleging it was only instituted as a temporary measure. He stated it is time to abolish the Federal Reserve Act because Jews are gaining too many benefits from it.

According to this source, a great portion of the speeches were inaudible due to presence of hecklers in the audience. In addition, there was a group of approximately ten individuals from the Jewish War Veterans who attempted to drown out the speakers by singing "God Bless America" and "The Star Spangled Banner". Individuals in apartments located above the location of the meeting opened their windows and attempted to drown out the speakers by playing phonographs at top volume.

This same source advised that police barricades had been erected prior to the meeting and that police officers were on duty during the meeting. With the exception of a few tomatoes which were thrown at NRP representatives, there were no disorders and no arrests were made.

[ ] and [ ] further advised that additional material pertaining to descriptions of the uniforms and material pertaining to the history and evolution of the "Stormtrooper" uniform and existence as a military unit is also available on microfilm from original German Army documents. This material can be copied and certified by NA as requested by the NYPD. (Costs: 75¢ first page and 50¢ each additional page; \$15 or \$20 should, at the outside, provide all of the material needed. This cost to be provided by the NYPD.)

They advised that in order to save time and expense in regard to this material, the NYPD should, in their letter of request for the material, specifically describe what is needed and if possible furnish a copy of the New York statute or ordinance pertaining to the "Stormtrooper" uniform. Also, if feasible, a photograph, preferably in color, of such a uniform. This was desirable, they explained, as the uniform of the so-called "Stormtrooper" varied as to when it was issued or authorized; further, they explained that the popular term "Stormtrooper uniform" may in vague terms relate also to uniforms of other units of the German Army, such as the later "SS" uniform. They noted that, for instance, the uniform normally associated with ROCKWELL's group was more similar to the SA (original Stormtrooper unit before the purge of this unit by HITLER in 1934).

In regard to the above, the illustrations referred to earlier pertain to the SA uniform authorized as of 1943. During the 1920s and 1930s, some units of the HITLER group were referred to as "Brown Shirts" and "Black Shirts" and at one time, the "Prohibition Shirts" (which was a white shirt that was used during a period when HITLER's group had not achieved sufficient power.)

It is further noted that much of the description pertaining to the above material is in German and the NA has no provisions for providing translations. This is action that would have to be provided by the NYPD.

On page 43 is a description of the U.S. Nazi Stormtrooper uniform. It is noted that the photograph of this uniform differs from those set forth in the material in the custody of the NA.

Above referenced airtel advises that Section 1484A of the Penal Law, New York, prohibits the wearing of the "storm trooper uniform or anything similar to it in public." The New York Police Department has been unable to locate reference books describing the official storm trooper uniform of the Nazi Party of Germany.

A review of Bureau files fails to reveal any information concerning this matter.

On September 1, 1966, [redacted] Office of the Assistant Chief of Staff for Intelligence, Department of the Army, Washington, D. C., advised that the U. S. Army has destroyed all available training material concerning uniforms utilized by the Germany Army in World War II, however, some material was sent to the National Archives, Room 11W, 8th and Pennsylvania Avenue, Washington, D. C. This material is on microfilm.

WFO is instructed to review material available and determine procedure New York City Police Department should employ to obtain this information and advise the New York Office expeditiously as the National Renaissance Party has scheduled a street meeting early in September, 1966. A confidential source, who has furnished reliable information in the past, advised on September 12, 1966, that the National Renaissance Party (NRP) held a street meeting from 7:30 PM to 9:30 PM on September 9, 1966, at 85th Street and First Avenue, New York, New York.

According to this source there were approximately 16 individuals representing the NRP and between 700 and 800 spectators.

The source estimated that approximately 200 of the spectators displayed support for the NRP. The remainder of the spectators consisted mainly of hecklers and included representatives of the Jewish War Veterans (JWV). The JWV representatives sang in Hebrew and sang the "Star Spangled Banner" in English in an effort to drown out the speakers.

The NRP representatives were not dressed in storm trooper uniforms on orders from James Madole, National Director of the NRP. During the street meeting Madole stated that the legislation in New York prohibiting the wearing of storm trooper-type uniforms in public is unconstitutional and that the American Civil Liberties Union will represent the NRP and contest this law in the courts.

James Madole spoke about the assassination of Hendrick Verwoerd, Prime Minister of South Africa, on September 6, 1966. He stated that Verwoerd was the legal ruler of South Africa, was popular and was doing a good

Robert Burros, Regional Director of the NRP, was also a speaker. He stated that the civil rights marches and riots in the mid-West are actually instigated by Communists. He urged those present to carry "White Power" signs in order to counteract the "Black Power" forces. He urged those in attendance to stand up for their rights and refuse to take any nonsense from black supremacists.

This same source advised that police barricades had been erected and that during the meeting police officers in uniform and also civilian dress circulated among the spectators. A few tomatoes and eggs were thrown at NRP representatives, however, there were no disorders and no arrests were made.

## NRP Gets City Offer For Rally

Newburgh City Manager Paul L. McCauley has offered the National Renaissance Party a date for a Newburgh meeting — Nov. 15 between 5 and 7 p.m. at the Stern Memorial Parking Lot off the Hudson River.

Mr. McCauley offered a Tuesday meeting date rather than Saturday, Oct. 1, at 2 p.m. requested by the neo-Nazi organization. The NRP asked to hold the meeting at the intersection of Fullerton Avenue, Third and Bush Streets.

In a letter to Robert Burros, liaison officer for the NRP, Mr. McCauley said he was offering the parking lot on Nov. 15 in keeping with a city ordinance allowing the city manager to set the time and place for such meetings.

Mr. Burros plans to run for the State Assembly for the 96th District.

Earlier the NRP had planned an Aug. 20 rally for the intersection of Fullerton Avenue and South Streets but the rally never materialized and the NRP is planning legal action against the city because it claims it was denied its civil right to meet.

Mr. Burros was unavailable today for comment on the time and place suggested by Mr. McCauley for the rally.

# Newburgh gives NRP permit to rally: Nov. 15

By WAYNE PINES

## NEWBURGH

The neo-Nazi National Renaissance Party (NRP) has been granted permission to meet publicly in Newburgh to launch the Assembly campaign of Robert Burros, its regional director.

But the date assigned by City Manager Paul L. McCauley is Nov. 15—one week after Election Day.

"Obviously," said James H. Madole, national NRP leader, "Mr. McCauley has a sense of humor. No one in his right mind would meet in the middle of November on a cold street."

### 'Will refuse offer'

The NRP, Madole said Monday, will refuse McCauley's offer. The NRP had first asked to meet Aug. 20, but had been denied the right to use sound equipment. McCauley, in assigning the Nov. 15 date, was acting on a request for an Oct. 1 meeting.

McCauley offered to permit the NRP to meet from 5 to 7 Nov. 15 in the Stern Memorial parking lot.

Madole asserted Monday that McCauley is denying the NRP the right to campaign—"but maybe he'll find the joke will backfire."

Madole said Burros, a native of Orange County, has

tried to rent a hall in Newburgh to hold a public meeting. But, Madole said, Burros has been denied by everyone from a Catholic college to the Veterans of Foreign Wars. The only Catholic college in the city is Mount Saint Mary.

Madole listed his problems in Orange County, which he considers a "burr" in the side of the NRP:

# Private organizations won't let him hire a hall to meet.

# The board of supervisors won't allow the NRP to meet in the Newburgh Courthouse. A judgement by the Appellate Division in that case probably will be appealed to the Court of Appeals.

# The city won't allow an outside meeting—except in the middle of November, after the election.

### A question

How, Madole asked, can Burros get the 1,500 signatures needed to get on the ballot if he can't even meet publicly in Newburgh?

He claims Burros is being denied his constitutional rights—rights which the NRP, if it were in power, would deny others.

Burros hopes to run against Democrat Gordon K. Cameron and Republican Howard Flemming for the Assembly post in the 96th District.

Madole said his group is permitted to meet in New York City every week, on the corner of 86th Street and First Avenue, but that "petty officials" are keeping him out of Newburgh.

"I think it's rather obvious what's going on," he asserted Monday. "Unless you're a Daughter of the American Revolution, you can't get in anywhere. Our members pay taxes too."

### Number of members

Madole said he did not know how many members the NRP has in Newburgh but that 1,000 persons attend the weekly New York meetings.

"If a city of eight million doesn't have a traffic jam because of us," Madole continued, "how could little old Newburgh?"

Madole said he would contest Newburgh's failure to permit the NRP to meet. But he said Jeremiah S. Gutman, New York Civil Liberties Union lawyer, who is handling the NRP's case against the county, was unavailable Monday.

The question in both the county and city cases hinge on one question: Is the NRP a political party? If it is, the Appellate Division ruled, the county would have no right to restrain it from meeting.

The meeting lasted from approximately 7:30 PM to 9:30 PM. According to the source, there were twelve representatives of the NRP and approximately 250 spectators in attendance. On orders from James Madole, NRP National Director, the NRP representatives were not dressed in their storm trooper uniforms.

James Madole, in his speech, denounced the establishment in New York City of a Civilian Review Board in connection with the New York City Police Department. He urged those in attendance to vote against a civilian review board when voting in a referendum.

# Speaker Ban on Neo-Nazis Is Scored by Liberties Unit

The New York Civil Liberties Union charged the police yesterday with "gross abuse" in denying a loudspeaker permit to the neo-Nazi National Renaissance Party for a scheduled meeting last night.

In making the charge, Aryeh Neier, the executive director of the union, said in a letter to Police Commissioner Howard R. Leary that the National Renaissance Party "is an outspoken advocate of abolition of the civilian review board... and it seems police are engaged in a lawless attempt to save the Patrolmen's Benevolent Association from the embarrassment of support from an unpopular source."

A police spokesman said: "We've made the decision and that's it. We won't make any further statement on this."
