After the opening remark by he introduced spoke about school busing, Biafra, integrated sex films, slavery and the black revolution. He stated the "Jews" are responsible for school busing and the Biafra question. They control integrated sex films and the black revolution and started slavery.
Louis Mostaccio, became so emotionally worked up during his anti-Semitic speech that he became hoarse and then totally incoherent.
James Madole directed his opening remarks to calling a "filthy hippy pig." He then stated that a former NRP member, was a "good guy" and it was "too bad" got involved with drugs which resulted in his being in Bellevus Hospital for skin grafting after being burned in a fire. yelled at Madole, "that's how much you know! He's out."
Madole then stated the "Jews" sell and control pornographic literature. He stated they control the United Nations and the United States (U. S.), which, according to Madole, should be changed by white Christians.
spoke about President Nixon stating that he supports the "Jews" and will side with them against the Arabs. He stated the "Jews" have one last refuge, the U. S., and sooner or later the U. S. will throw them out. He also stated the "Jews" use the Negroes for their own means.





The NRP headquarters is located at 10 West 90th Street, Apartment 8, New York, N. Y.

JAMES H. MADOLE, the founder of the NRP continues to serve as National Director and is in complete control of the party, although persons from a new NRP chapter on Staten Island which is in the formative stages have indicated they are displeased with the leadership of MADOLE due to his failure to advocate a more militant line for the NRP.

HENRY VON SIENNO POTWOROWSKI is currently serving as the National Secretary of the NRP although an informant has reported POTWOROWSKI is supposed to move from New York to Alaska and his future in the NRP is uncertain.

There are no officers in the NRP other than MADOLE and POTWOROWSKI.

Currently membership is approximately 20.

The only persons in the NRP for whom reports are submitted on a continuing basis are MADOLE and POTWOROWSKI.

"MINUTEMEN"

The "Minutemen" was organized in June, 1960. Its present headquarters are Norborne, Missouri. ROBERT B. DE PUGH, Norborne, Missouri, has been publicly identified as the founder and National Coordinator of the organization since its inception. Membership of the "Minutemen" is claimed by DE PUGH to be in excess of 35,000 members; however, confidential sources state this figure is greatly exaggerated and that a more true estimate would be between 500 and 1,000 members. Statement by DE PUGH and literature distributed by the organization indicate its purpose to be the resistance to, and exposure of, the spread of Communist influence within the United States; for the formation of a guerrilla or underground organization to combat the troops of any foreign powers which might eventually occupy this country; to resist passage of laws which would regulate private ownership of firearms.

In April, 1966, DE PUGH stated the "Minutemen" organization was then dividing itself into two bodies: one group to be members who have been able to maintain their identity in complete secrecy from the public and government investigative agencies, and the other group to be made up of members who have been publicly identified and who will become active in the Patriotic Party. National conventions of the Patriotic Party were held in July, 1966, at Kansas City, Missouri, and July, 1967, at Kansas City, Kansas.

Members of the "Minutemen" organization. including ROBERT B. DE PUGH and his close associate, have been arrested in the past on charges of violation of the Federal Firearms Act, Bank Robbery - Conspiracy, Illegal Possession of Firearms and Conspiracy to Commit Arson. They have also engaged in maneuvers utilizing guerrilla tactics wherein machine guns, mortars, grenades, and other firearms were employed.





UNITED KLANS OF AMERICA, INC., KNIGHTS OF THE KU KLUX KLAN

Records of Superior Court of Fulton County, Georgia, reflect that this Klan organization was granted a corporate charter on February 21, 1961, at Atlanta, Georgia, under the name United Klans, Knights of the Ku Klux Klan of America, Inc.

A source advised on February 27, 1961, that United Klans was formed as a result of a split in U. S. Klans, Knights of the Ku Klux Klan, Inc. According to the source, the split resulted from a leadership dispute and United Klans has the same aims and objectives as the parent group. These are the promotion of Americanism, white supremacy, and segregation of the races.

The first source and a second source advised in July, 1961, that United Klans, Knights of the Ku Klux Klan of America, Inc., merged with Alabama Knights, Knights of the Ku Klux Klan. The merged organization established headquarters in Suite 401, the Alston Building, Tuscaloosa, Alabama. (The organization is directed by ROBERT SHELTON, Imperial Wizard, and is the dominant Klan group in the South, with units in several Southern states.)

Second source advised that at a meeting at Prattville, Alabama, on October 22, 1961, the U.S. Klans, Knights of the Ku Klux Klan, merget with the United Klans of America, Inc., Knights of the Ku Klux Klan.

Third source advised on Atgust 4, 1965, that the United Klans of America, Inc., Knights of the Ku Klux Klan, is currently an active organization, with Klaverns in several Southern states. This source said that ROBERT M. SHELTON is the Imperial Wizard of this organization, and was last elected to this position on September 5, 1964, at a National Klonvocation in Birmingham, Alabama. Source said that the activity of the United Klans of America is increasing and that the national office remains in Suite 401, Alston Building, Tuscaloosa, Alabama.

ROY FRANKHOUSER stated that he was very surprised that the people of New York are not aware of the trouble caused here by the Communists and Negroes. His comments were primarily anti-Negro.

On 5/1/69, the captioned organization sponsored a counter-demonstration to be held at the north end of Union Square during the May Day Rally held in Union Square. At approximately 5:15 PM, nine demonstrators from the NRP commenced picketing within barricades set by the New York City Police Department around the area granted to the NRP.

By 6:15 PM, the number of demonstrators had grown to twelve, consisting of eleven males and one female. Of the twelve, SA who observed the counter-demonstration in its entirity, recognized JAMES H. MADOLE, founder and head of the NRP, LOUIS MOSTACCIO, member of the organization and the NRP Security Echelon, and also a member of the NRP.

Throughout the demonstration, NRP pickets carried signs and banners bearing the following inscriptions:

- 1. "BROTHERHOOD IS BULL"
 2. "PACIFICSM IS FEMININE"
- 3. "BROTHERHOOD IS A JEW PLOT TO DESTROY THE WHITE RACE"
- "GI'S DIE WHILE JEWS GET RICH"

- 4. "GI'S DIE WHILE SEWS GET RIOTS"



5. "2-4-6-8, WE DON'T WANT TO INTEGRATE"

Throughout the demonstration, NRP literature was being passed out by an unknown male. A copy of the literature is being placed in the 1-A section of this file. The single-page hand out pictured a Negro beating a fallen white youth with a club and called for all white men to join the "Militant White Man's Party" to smash the black rebellion.

At 6:30 PM, three unidentified male teenagers attempted to cross the police barricade and attack NRP pickets. A scuffle ensued but was immediately quelled by members of the NYCPD and no injuries or arrests resulted.

At 7:05 PM, the NRP pickets departed the area and walked en masse north on Broadway. Several persons gathered along the sidewalk and jeered the NRP members as they departed, but no further incidents resulted.

The National Renaissance Party (NRP) Headquarters is located in the residence of JAMES H. MADOLE, Apartment 8, 10 West 90th Street, New York City.

JAMES H. MADOLE, founder of the NRP continues to serve as National Director and MENRY S. POTWOROWSKI continues to serve as the National Secretary.

The objectives of the NRP are the same as previously stated by JAMES H. MADOLE in the January, 1968, "National Renaissance Bulletin," which reflects in part as follows:

"...It is my intention to organize the American public into a potent force representing the interest of the white race in the United States...Now that our right to peaceably assemble has been enforced by the courts, I intend to hold at least one mass rally each month. I further intend to distribute both through the mail and on the public streets at least 5,000 announcements to each rally. These flyers will also be recruiting leaflets so that recipients may fill out coupons to either join the Party or its militant fighting arm the Security Echelon".

Membership in the MRP is granted upon payment of \$1.00 for which a membership card is issued.

Membership in the Sacurity Echelon is gained after making out an application, signing a loyalty oath and being sworn in.

The activities of the NRP continue to include Thursday night meetings and Funday socials held at the apartment of JAMES H. MADOLE. The NRP also has passed out literature on various occasions and conducted school meetings.

The Thursday night meetings are general discussions about world politics, discussions against Jews and Negroes, welfare, urban renewal, in addition to planning for future meetings and literature distributions. The NRP members

and officers attend these meetings. Sometimes persons from other organizations known by MADOLE are invited to attend. The average attendance continues to be between seven and ten persons.

The Sunday socials are informal gatherings which new members are welcome to attend. The same type discussion takes place as at the Thursday night meeting. The average attendance continues to be from four to six persons.

The primary source of revenue for the MRP is from the sale of MRP publications. There are no known benefactors currently supporting the MRP_{\bullet}



A characterization of the "Morning Freiheit" is attached hereto.
Chapter of the Du Bois Clubs, stated May Day 1969 reveals a year of crisis, taxes, racism and the Vietnam war. The Black Panther Party is being attacked. was arrested because he said the Black Panthers have a right to protect themselves against the pigs. BLACK PANTHER PARTY

According to its official newspaper, the Panther Party (BPP) was started during December, 19 A Oakland, California, to organize black people so the take control of the life, politics, and the destiny black community. It was organized by BOBBY GEORGE SMAIN BPP Chairman, and HUEY P. NEWTON, BPP Minister of Defendance NEWTON is presently serving a sentence of 2 to 15 years and conviction of manslaughter in connection with the killing of an Oakland police officer.

The official newspaper, "The Black Panther", which further describes itself as the "Black Community News Service", states that the BPP advocates the use of guns and guerrilla tactics in its revolutionary program to end oppression of the black people. Residents of the black community are used to arm themselves against the police who are consistently referred to in the publication as "pigs" who should be killed.

"The Black Panther" issue of September 7, 1968, contains an editorial by BPP Minister of Education, GEORGE MASON MURRAY, which ends with the following:

"Black men. Black people, colored persons of America, revolt everywhere! Arm yourselves. The only culture worth keeping is a revolutionary culture. Change. Freedom everywhere. Dynamite! Black Power. Use the gum. Kill the pigs everywhere."

Included in the introduction to an article appearing in the October 5, 1968, edition of "The Black Paniher" is the statement, "... we will not dissent from American Government. We will overthrow it."

Issues of "The Black Panther" regularly contain quotations from the writings of Chairman MAO Tse-tung of the People's Republic of China and feature MAO's statement that "political power grows out of the barrel of a gun."

The national headquarters of the BPP is located at 3106 Shattuck Avenue, Berkeley, California. Branches have been established at various locations throughout the United States.



APPENDIX

NATIONAL RENAISSANCE PARTY

On May 29, 1968, a source advised that the National Renaissance Party (NRP) was founded in 1949, by JAMES H. MADOLE, who continues to serve as its National Director and is in complete control of the NRP.

The source further stated that the NRP has its headquarters in the residence of JAMES H. MADGLE at 10 West 90th Street, New York, New York, Weekly meetings are held, at this location on Thursday evenings.

The source described the NRP as an anti-Negro, anti-Semitic and neo-Fascist organization.

This source stated on July 28, 1966, that JAMES H. MADOLE, as of October, 1955, distributed a printed "program of the NEP", which program had as its announced purpose the establishment of a "Racial Nationalist State". According to the program, this would be accomplished by calling a Constitutional Convention to ratify the necessary amendments to the United States Constitution in order to carry out the NRP program for the establishment of a "Racial Nationalist State".

This source further advised that as of May 29, 1968, this "program of the NRP" remains in effect and that the anti-Negro and anti-Semitic nature of the NRP is exemplified by the following excerpts from this program:

- l. Enact and rigidly enforce legislation to restrict the benefits of American citizenship to mentally and genetically sound members of the Caucasian race.
- 2. Enact legislation to prohibit intermarriage between white and non-white.
- 3. The Jewish race shall be deprived by suitable legislation of their American citizenship and shall henceforth be prohibited from holding any professional, political or educational posts within the Racial Nationalist State. The Jewiconstitutes an alien virus in our national bloodstream and, as such, he must be purged from our cultural, economic, and political life.
- 4. Enact legislation to hasten the repatriation of American Negroes to the newly independent black nations on the African continent under the auspices and guidance of black nationalist leadership in the United States.

W.E.B. DU BOIS CLUBS OF AMERICA (DCA)

A source advised that on October 26-27, 1963, a conference of members of the Communist Party, USA (CI, USA), including national functionaries, met in Chicago, Illinois, for the purpose of setting in motion forces for the establishment of a new national Marxist-oriented youth organization which would hunt forthe most peace; to socialism. The delegates were told that it is reasonable to assume that the young socialists is the continuous this new organization would eventually pass into the CP itself.

A second source has advised that the founding convention for the new youth organization was held from June 19 - 21, 1964, at 150 Golden Gate Avenue, San Francisco, California, at which time, the name W.E.B. Du Pois Glubs of America (DCA) was adopted. Approximately 500 delegates from throughout the United States attended this convention.


The second source advised in September, 1966, that Mike Zagarell, CP, USA Youth Director, stated that in Necro communities the Party still supported the plan to build "left" socialist centers and to solidify the Party base through the DCA. This source also advised in September, 1966, that Daniel Rubin, CP, USA National Organizational Secretary, stated the Party believes the DCA should have a working class outlook and be a mass organization favorable to socialism, socialist countries and Marxism, and in April, 1967, Gus Hall, CP, USA, General Secretary, indicated that the DCA primary emphasis should be on developing mass resistance to the draft.

A third source advised in September, 1967, that Jarvis Tyner was elected Chairman of the DCA on September 19, 1967, near the conclusion of the Third National Convention of the DCA held in New York, New York, from September 8-10, 1967.

A fourth source advised on July 26, 1968, that darwise Tyner continues in his position as Chairman of the DCA.

This fourth source also advised on July 26, 1965, that Jarvis Tyner is a member of the National Committee of the OF. It

This fourth source further advised on Jell 20, 100 that the headquarters of the DCA is located at 34 1. 45 to 1. 1. Street, New York, New York.

WORKERS WORLD PARTY

On April 17, 1959, a confidential source advised that on February 12, 1959, a Socialist Workers Party (SWP) minority group

split from the SWP.

The source stated that this minority group, referred to as the Marcyites, after many years of program and policy differences on varied issues concerning tactics and interpretation of political events, split from the SWP on the grounds that the Party was liquidating itself by departing from the Marxist precepts of LEON TROTSKY and retreating from the fight for the world Socialist revolution. The final issue which ultimately forced the split was the minority's opposition to the SWP regroupment policy which involved cooperation with the Communist Party (CP) peripheryindividuals characterized by the minority as petty-bourgeois.

The minority program, according to the source, advocated unconditional defense of the Soviet Union and has as its goal the building of a revolutionary party with a complete proletarian orientation for the purpose of overthrowing capitalism in the United States and throughout the world.

On May 12, 1960, source advised that this minority group had chosen the name Workers World Party.

On May 1, 1968, a second confidential source advised that the Workers World Party, which maintains headquarters at 46 West 21st Street, New York, New York, supports the People's Republic of China in its ideological dispute with the Soviet Union.

The SWP and CP have been designated pursuant to Executive Order 10450.



On April 1, 1969, a source advised that the National Renaissance Party (NRP) was founded in 1949 by JAMES H. HADOLE, who continues to serve as its National Director and who completely controls the organization. The course advised that the NRP is headquartered in MADOLE's residence at 10 West 90th Street, New York, New York, where weekly meetings and social gatherings are held.

The source described the IMP as an anti-Negro, anti-Semitic, and neo-Pascist organization.

This source stated on July 28, 1966, that the program of the NRP, formulated in 1965, is aimed at the establishment of a "Racial Maticipalist State" to be accomplished by calling a Constitutional Convention to ratify necessary amendments to the United States Constitution in order to carry out the URP program. The source advised that as of April 1, 1969, the URP program remains in effect and includes intentions to enact logislation to prohibit intermarriage between races, restrict American citizenship to mentally and genetically sound Caucasians, and hasten the repatriation of American Negroes to independent black African nations.
