NATIONAL RENAISSANCE PARTY SPONSORS "WHITE POWER" RALLY IN YORKVILLE TO PROTEST GOVERNMENT APPEASEMENT OF MILITANT RACIAL MINORITIES

We should like to ask a few simple questions of the average White working man in the United States, the ordinary fellow whose White European ancestors settled our land and carved an empire out of the wilderness, fought for naked survival against hostile Indian tribes, and erected by his blood and sweat the mighty industrial, scientific, and technological structure which enabled the first heroic astronauts to circle the Earth's moon thus opening a New Frontier in the Space Age.

On February 12, 1969, [redacted] Bureau of Special Services (BSS), New York City Police Department (NYCPD), advised that the speakers at the rally were [redacted] James Madole, and Louis Mostaccio. [redacted] acted as Master of Ceremonies.

In addition to the speakers, the following current or former NRP members were present at the rally:

[redacted] further advised the speeches were the customary anti-Semitic, anti-Negro speeches which are given at all NRP rallies.

[redacted] opened the rally by stating that since they couldn't play the National Anthem he was reading a passage from Revelations.

[] introduced each speaker prior to their appearance.

During the speeches there was a constant exchange of remarks between the speakers and [] and [] in the audience, which at times were boisterous and vulgar.

A second confidential source advised on February 13, 1969, that the rally was attended by 60-70 persons including [] a former NRP member [] the NRP.

After the opening remark by [] he introduced [] spoke about school busing, Biafra, integrated sex films, slavery and the black revolution. He stated the "Jews" are responsible for school busing and the Biafra question. They control integrated sex films and the black revolution and started slavery.

Louis Mostaccio became so emotionally worked up during his anti-Semitic speech that he became hoarse and then totally incoherent.

James Madole directed his opening remarks to [] calling [] a "filthy hippy pig." He then stated that [] a former NRP member, was a "good guy" and it was "too bad" [] got involved with drugs which resulted in his being in Bellavus Hospital for skin grafting after being burned in a fire. [] yelled at Madole, "that's how much you know! He's out."

Madole then stated the "Jews" sell and control pornographic literature. He stated they control the United Nations and the United States (U. S.), which, according to Madole, should be changed by White Christians.

[] spoke about President Nixon stating that he supports the "Jews" and will side with them against the Arabs. He stated the "Jews" have one last refuge, the U. S., and sooner or later the U. S. will throw them out. He also stated the "Jews" use the Negroes for their own means.

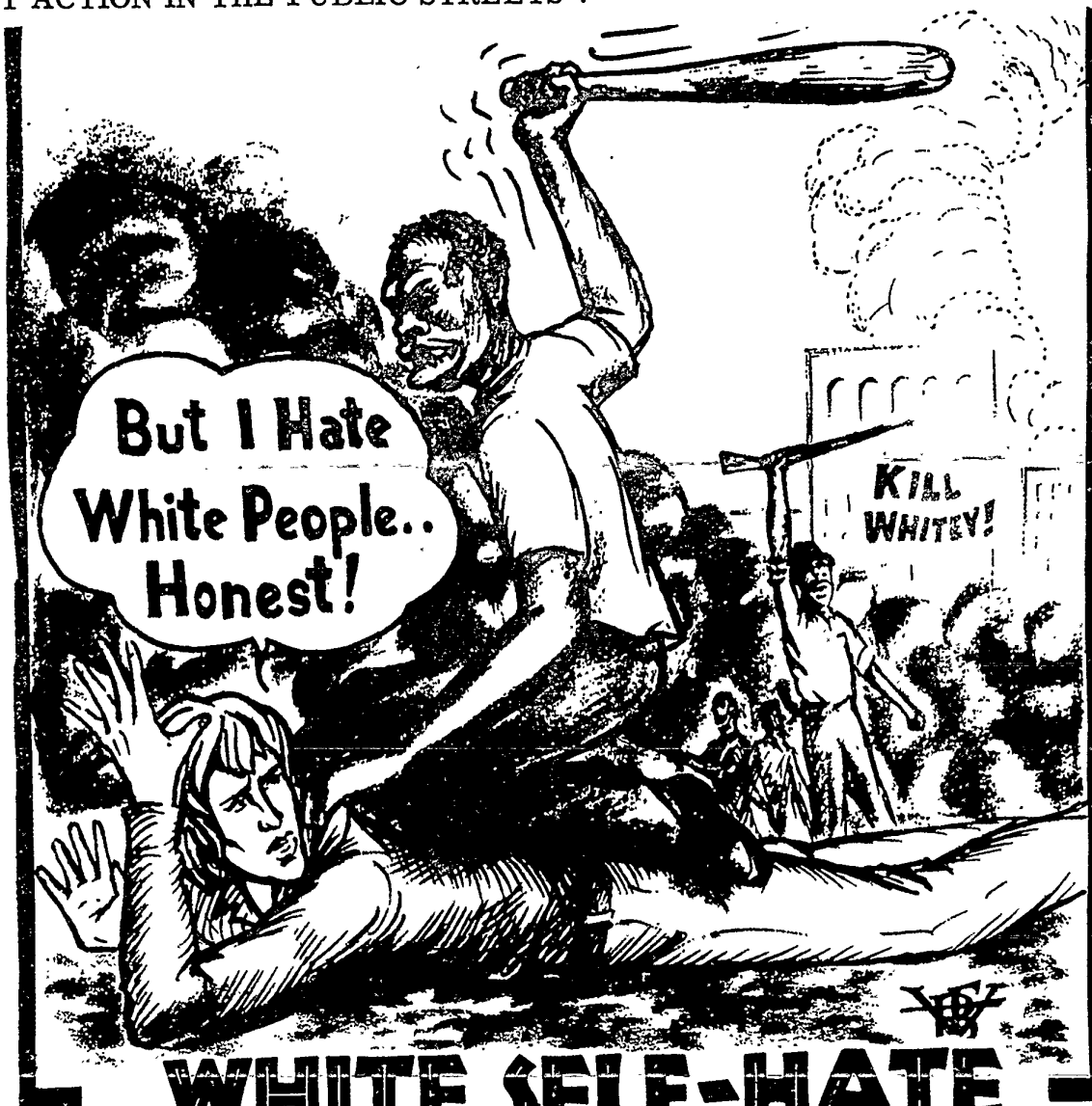

HENRY VON SIENNO POTWOROWSKI is currently serving as the National Secretary of the NRP although an informant has reported POTWOROWSKI is supposed to move from New York to Alaska and his future in the NRP is uncertain.

There are no officers in the NRP other than MADOLE and POTWOROWSKI.

Currently membership is approximately 20.

The only persons in the NRP for whom reports are submitted on a continuing basis are MADOLE and POTWOROWSKI.

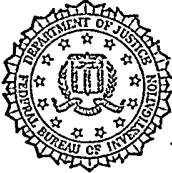

"MINUTEMEN"

The "Minutemen" was organized in June, 1960. Its present headquarters are Norborne, Missouri. ROBERT B. DE PUGH, Norborne, Missouri, has been publicly identified as the founder and National Coordinator of the organization since its inception. Membership of the "Minutemen" is claimed by DE PUGH to be in excess of 35,000 members; however, confidential sources state this figure is greatly exaggerated and that a more true estimate would be between 500 and 1,000 members. Statement by DE PUGH and literature distributed by the organization indicate its purpose to be the resistance to, and exposure of, the spread of Communist influence within the United States; for the formation of a guerrilla or underground organization to combat the troops of any foreign powers which might eventually occupy this country; to resist passage of laws which would regulate private ownership of firearms.

In April, 1966, DE PUGH stated the "Minutemen" organization was then dividing itself into two bodies: one group to be members who have been able to maintain their identity in complete secrecy from the public and government investigative agencies, and the other group to be made up of members who have been publicly identified and who will become active in the Patriotic Party. National conventions of the Patriotic Party were held in July, 1966, at Kansas City, Missouri, and July, 1967, at Kansas City, Kansas.

Members of the "Minutemen" organization, including ROBERT B. DE PUGH and his close associate, [REDACTED] have been arrested in the past on charges of violation of the Federal Firearms Act, Bank Robbery - Conspiracy, Illegal Possession of Firearms and Conspiracy to Commit Arson. They have also engaged in maneuvers utilizing guerrilla tactics wherein machine guns, mortars, grenades, and other firearms were employed.

UNITED KLANS OF AMERICA, INC.,
KNIGHTS OF THE KU KLUX KLAN

Records of Superior Court of Fulton County, Georgia, reflect that this Klan organization was granted a corporate charter on February 21, 1961, at Atlanta, Georgia, under the name United Klans, Knights of the Ku Klux Klan of America, Inc.

A source advised on February 27, 1961, that United Klans was formed as a result of a split in U. S. Klans, Knights of the Ku Klux Klan, Inc. According to the source, the split resulted from a leadership dispute and United Klans has the same aims and objectives as the parent group. These are the promotion of Americanism, white supremacy, and segregation of the races.

The first source and a second source advised in July, 1961, that United Klans, Knights of the Ku Klux Klan of America, Inc., merged with Alabama Knights, Knights of the Ku Klux Klan. The merged organization established headquarters in Suite 401, the Alston Building, Tuscaloosa, Alabama. (The organization is directed by ROBERT SHELTON, Imperial Wizard, and is the dominant Klan group in the South, with units in several Southern states.)

Second source advised that at a meeting at Prattville, Alabama, on October 22, 1961, the U. S. Klans, Knights of the Ku Klux Klan, merged with the United Klans of America, Inc., Knights of the Ku Klux Klan.

Third source advised on August 4, 1965, that the United Klans of America, Inc., Knights of the Ku Klux Klan, is currently an active organization, with Klaverns in several Southern states. This source said that ROBERT M. SHELTON is the Imperial Wizard of this organization, and was last elected to this position on September 5, 1964, at a National Klonvocation in Birmingham, Alabama. Source said that the activity of the United Klans of America is increasing and that the national office remains in Suite 401, Alston Building, Tuscaloosa, Alabama.

JAMES MADOLE's speech was completely anti-Semitic, anti-Negro, and anti-Communist.

ROY FRANKHOUSER stated that he was very surprised that the people of New York are not aware of the trouble caused here by the Communists and Negroes. His comments were primarily anti-Negro.

[REDACTED] comments were extremely anti-Semitic. During his speech he got into an argument with [REDACTED] which ended with [REDACTED] stating, "You Jews are no good".

[REDACTED] told the audience that they should become aware that the Communists are taking over and overthrowing our government.

[REDACTED] commented that he had spent six years in special forces fighting for his country and was proud of it, but wasn't proud of having done it for the likes of the hecklers.

The hecklers held up placards at various times during the speeches which read "Madole Is A Creep". HECKLERS also took NRP literature off a table, ripped it up and made Nazi signs and Jewish symbols on the literature.

SCHUYLER D. FERRIS, billed as one of the speakers, did not show up.

MADOLE made the concluding comments and the school rally ended at 9:55 p.m.

After the rally while walking from the school, several of the NRP members spotted [redacted] and a gy with her who wore an armband with 33,000 on it, walking down the street. LOUIE and [redacted] wanted to attack them, but MADOLE stated they were just waiting for someone to do that so they could have them arrested, and besides it wasn't a good idea as police were standing on the corner.

At the completion of the speeches a discussion took place.

On 5/1/69, the captioned organization sponsored a counter-demonstration to be held at the north end of Union Square during the May Day Rally held in Union Square. At approximately 5:15 PM, nine demonstrators from the NRP commenced picketing within barricades set by the New York City Police Department around the area granted to the NRP.

By 6:15 PM, the number of demonstrators had grown to twelve, consisting of eleven males and one female. Of the twelve, SA [REDACTED] and [REDACTED] who observed the counter-demonstration in its entirety, recognized JAMES H. MADOLE, founder and head of the NRP, LOUIS MOSTACCIO, member of the organization and the NRP Security Echelon, and [REDACTED] also a member of the NRP.

Throughout the demonstration, NRP pickets carried signs and banners, bearing the following inscriptions:

1. "BROTHERHOOD IS BULL"
2. "PACIFISM IS FEMININE"
3. "BROTHERHOOD IS A JEW PLOT TO DESTROY THE WHITE RACE"
4. "GI'S DIE WHILE JEWS GET RICH"

Throughout the demonstration, NRP literature was being passed out by an unknown male. A copy of the literature is being placed in the 1-A section of this file. The single-page hand out pictured a Negro beating a fallen white youth with a club and called for all white men to join the "Militant White Man's Party" to smash the black rebellion.

At 6:30 PM, three unidentified male teenagers attempted to cross the police barricade and attack NRP pickets. A scuffle ensued but was immediately quelled by members of the NYCPD and no injuries or arrests resulted.

At 7:05 PM, the NRP pickets departed the area and walked en masse north on Broadway. Several persons gathered along the sidewalk and jeered the NRP members as they departed, but no further incidents resulted.

It is to be noted that the above counter-demonstration was reported to the Bureau by teletype on 5/1/69 under the MAY DAY RALLY caption. In addition, [redacted] also covered the event and [redacted]

The National Renaissance Party (NRP) Headquarters is located in the residence of JAMES H. MADOLE, Apartment 8, 10 West 90th Street, New York City.

JAMES H. MADOLE, founder of the NRP continues to serve as National Director and HENRY S. POTWOROWSKI continues to serve as the National Secretary.

The objectives of the NRP are the same as previously stated by JAMES H. MADOLE in the January, 1968, "National Renaissance Bulletin," which reflects in part as follows:

"...It is my intention to organize the American public into a potent force representing the interest of the white race in the United States...Now that our right to peaceably assemble has been enforced by the courts, I intend to hold at least one mass rally each month. I further intend to distribute both through the mail and on the public streets at least 5,000 announcements to each rally. These flyers will also be recruiting leaflets so that recipients may fill out coupons to either join the Party or its militant fighting arm the Security Echelon".

Membership in the NRP is granted upon payment of \$1.00 for which a membership card is issued.

Membership in the Security Echelon is gained after making out an application, signing a loyalty oath and being sworn in.

The activities of the NRP continue to include Thursday night meetings and Sunday socials held at the apartment of JAMES H. MADOLE. The NRP also has passed out literature on various occasions and conducted school meetings.

The Thursday night meetings are general discussions about world politics, discussions against Jews and Negroes, welfare, urban renewal, in addition to planning for future meetings and literature distributions. The NRP members

and officers attend these meetings. Sometimes persons from other organizations known by MADOLE are invited to attend. The average attendance continues to be between seven and ten persons.

The Sunday socials are informal gatherings which new members are welcome to attend. The same type discussion takes place as at the Thursday night meeting. The average attendance continues to be from four to six persons.

The primary source of revenue for the NRP is from the sale of NRP publications. There are no known benefactors currently supporting the NRP.

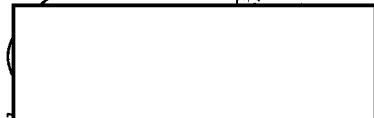

Approximately 60 pro-war counter-demonstrators gathered around the flagpole opposite the bandstand. About 35-40 of these were from Young Americans for Freedom. The rest were a joint group representing the National Youth Alliance and the National Renaissance Party led by [redacted] and [redacted].

The NYA-NRP group carried a confederate flag and several wore military helmets. When this group entered the park they marched into the anti-war demonstrators and caused several fights.

[redacted] was threatened with arrest twice. Most of this group carried pocket "tear gas" canisters to spray at the leftists.

When the police moved the NYA-NRP group back to the flagpole and several fights broke out between them and Young Americans for Freedom who called them neo-Nazi's for chanting "I'm white and I'm right" and because of the NRP's anti-Semitic policy.

At the flagpole anti-war demonstrators heckled both groups and numerous scuffles broke out.

No known members of SDS were noticed in the crowd.

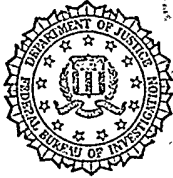

On May 1, 1969, Special Agents of the Federal Bureau of Investigation (SAS, FBI) observed the activities in connection with the celebration of May Day 1969. A sidewalk parade began at 5:10 p.m. at Seventh Avenue and 34th Street, New York City, with 220 participants. The marchers proceeded south on Seventh Avenue, east on 23rd Street and south on Broadway to Union Square. At 23rd Street and Seventh Avenue 363 participants were counted.

[redacted] acted as the Master of Ceremonies. The speakers platform was surmounted by a white banner bearing the words May Day 1969 in red letters and the statement "Freedom for all People, Peace and Socialism".

A confidential source, who has furnished reliable information in the past, has identified [redacted] as a member of the Shorefront Club of the Kings County, New York, Communist Party.

A second confidential source advised that [redacted] was in attendance at the New York District Communist Party (CP) Convention held in New York City in June, 1968.

[redacted] introduced as a member of a painters union, stated May 1969 marks the revolution by Black people and students, which is supported by the CP. This May Day is the beginning of many demonstrations to end the war in Vietnam.

A third confidential source advised that meetings of the National Committee of the CP, United States of America (USA) were held in New York City on January 14-16, 1968, and that [redacted] attended one or more of these meetings.

Paul Novick, introduced as Editor of the "Morning Freiheit", referred to this paper as the progressive Jewish journal. Novick was concerned with the Jewish workers who are in the forefront of the fight for social and political progress.

A characterization of the "Morning Freiheit" is attached hereto.

[redacted] introduced as [redacted] the New York Chapter of the Du Bois Clubs, stated May Day 1969 reveals a year of crisis, taxes, racism and the Vietnam war. The Black Panther Party is being attacked. [redacted] was arrested because he said the Black Panthers have a right to protect themselves against the pigs. The Black Panthers demand the right to their own culture. Union leaders should fight for equal rights for Blacks, Puerto Ricans and whites.

BLACK PANTHER PARTY

According to its official newspaper, the Black Panther Party (BPP) was started during December, 1966, in Oakland, California, to organize black people so that they can take control of the life, politics, and the destiny of the black community. It was organized by BOBBY GEORGE SEALE, BPP Chairman, and HUEY P. NEWTON, BPP Minister of Defense. NEWTON is presently serving a sentence of 2 to 15 years on a conviction of manslaughter in connection with the killing of an Oakland police officer.

The official newspaper, "The Black Panther", which further describes itself as the "Black Community News Service", states that the BPP advocates the use of guns and guerrilla tactics in its revolutionary program to end oppression of the black people. Residents of the black community are urged to arm themselves against the police who are consistently referred to in the publication as "pigs" who should be killed.

"The Black Panther" issue of September 7, 1968, contains an editorial by BPP Minister of Education, GEORGE MASON MURRAY, which ends with the following:

"Black men. Black people, colored persons of America, revolt everywhere! Arm yourselves. The only culture worth keeping is a revolutionary culture. Change. Freedom everywhere. Dynamite! Black Power. Use the gun. Kill the pigs everywhere."

Included in the introduction to an article appearing in the October 5, 1968, edition of "The Black Panther" is the statement, "... we will not dissent from American Government. We will overthrow it."

Issues of "The Black Panther" regularly contain quotations from the writings of Chairman MAO Tse-tung of the People's Republic of China and feature MAO's statement that "political power grows out of the barrel of a gun."

The national headquarters of the BPP is located at 3106 Shattuck Avenue, Berkeley, California. Branches have been established at various locations throughout the United States.

NATIONAL RENAISSANCE PARTY

On May 29, 1968, a source advised that the National Renaissance Party (NRP) was founded in 1949, by JAMES H. MADOLE, who continues to serve as its National Director and is in complete control of the NRP.

The source further stated that the NRP has its headquarters in the residence of JAMES H. MADOLE at 10 West 90th Street, New York, New York. Weekly meetings are held at this location on Thursday evenings.

The source described the NRP as an anti-Negro, anti-Semitic and neo-Fascist organization.

This source stated on July 28, 1966, that JAMES H. MADOLE, as of October, 1955, distributed a printed "program of the NRP", which program had as its announced purpose the establishment of a "Racial Nationalist State". According to the program, this would be accomplished by calling a Constitutional Convention to ratify the necessary amendments to the United States Constitution in order to carry out the NRP program for the establishment of a "Racial Nationalist State".

This source further advised that as of May 29, 1968, this "program of the NRP" remains in effect and that the anti-Negro and anti-Semitic nature of the NRP is exemplified by the following excerpts from this program:

1. Enact and rigidly enforce legislation to restrict the benefits of American citizenship to mentally and genetically sound members of the Caucasian race.

2. Enact legislation to prohibit intermarriage between white and non-white.

3. The Jewish race shall be deprived by suitable legislation of their American citizenship and shall henceforth be prohibited from holding any professional, political or educational posts within the Racial Nationalist State. The Jew constitutes an alien virus in our national bloodstream and, as such, he must be purged from our cultural, economic, and political life.

4. Enact legislation to hasten the repatriation of American Negroes to the newly independent black nations on the African continent under the auspices and guidance of black nationalist leadership in the United States.

W.E.B. DU BOIS CLUBS OF AMERICA (DCA)

A source advised that on October 26-27, 1963, a conference of members of the Communist Party, USA (CP, USA), including national functionaries, met in Chicago, Illinois, for the purpose of setting in motion forces for the establishment of a new national Marxist-oriented youth organization which would hunt for the most peaceful transition to socialism. The delegates were told that it was reasonable to assume that the young socialists entering this new organization would eventually pass into the CP itself.

A second source has advised that the founding convention for the new youth organization was held from June 19 - 21, 1964, at 150 Golden Gate Avenue, San Francisco, California, at which time, the name W.E.B. Du Bois Clubs of America (DCA) was adopted. Approximately 500 delegates from throughout the United States attended this convention.

The second source advised in September, 1966, that Mike Zagarell, CP, USA Youth Director, stated that in Negro communities the Party still supported the plan to build "left" socialist centers and to solidify the Party base through the DCA. This source also advised in September, 1966, that Daniel Rubin, CP, USA National Organizational Secretary, stated the Party believes the DCA should have a working class outlook and be a mass organization favorable to socialism, socialist countries and Marxism, and in April, 1967, Gus Hall, CP, USA, General Secretary, indicated that the DCA primary emphasis should be on developing mass resistance to the draft.

A third source advised in September, 1967, that Jarvis Tyner was elected Chairman of the DCA on September 10, 1967, near the conclusion of the Third National Convention of the DCA held in New York, New York, from September 8-10, 1967.

A fourth source advised on July 26, 1968, that Jarvis Tyner continues in his position as Chairman of the DCA.

This fourth source also advised on July 26, 1968, that Jarvis Tyner is a member of the National Committee of the CP, USA.

This fourth source further advised on July 26, 1968, that the headquarters of the DCA is located at 34 West 17th Street, New York, New York.

WORKERS WORLD PARTY

On April 17, 1959, a confidential source advised that on February 12, 1959, a Socialist Workers Party (SWP) minority group [redacted]

[redacted] split from the SWP.

The source stated that this minority group, referred to as the Marcyites, after many years of program and policy differences on varied issues concerning tactics and interpretation of political events, split from the SWP on the grounds that the Party was liquidating itself by departing from the Marxist precepts of LEON TROTSKY and retreating from the fight for the world Socialist revolution. The final issue which ultimately forced the split was the minority's opposition to the SWP regroupment policy which involved cooperation with the Communist Party (CP) periphery-individuals characterized by the minority as petty-bourgeois.

The minority program, according to the source, advocated unconditional defense of the Soviet Union and has as its goal the building of a revolutionary party with a complete proletarian orientation for the purpose of overthrowing capitalism in the United States and throughout the world.

On May 12, 1960, source advised that this minority group had chosen the name Workers World Party.

On May 1, 1968, a second confidential source advised that the Workers World Party, which maintains headquarters at 46 West 21st Street, New York, New York, supports the People's Republic of China in its ideological dispute with the Soviet Union.

The SWP and CP have been designated pursuant to Executive Order 10450.

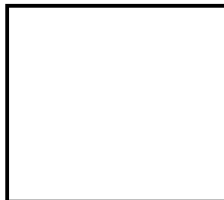

On April 1, 1969, a source advised that the National Renaissance Party (NRP) was founded in 1949 by JAMES H. MADOLE, who continues to serve as its National Director and who completely controls the organization. The source advised that the NRP is headquartered in MADOLE's residence at 10 West 90th Street, New York, New York, where weekly meetings and social gatherings are held.

The source described the NRP as an anti-Negro, anti-Semitic, and neo-Fascist organization.

This source stated on July 28, 1966, that the program of the NRP, formulated in 1965, is aimed at the establishment of a "Racial Nationalist State" to be accomplished by calling a Constitutional Convention to ratify necessary amendments to the United States Constitution in order to carry out the NRP program. The source advised that as of April 1, 1969, the NRP program remains in effect and includes intentions to enact legislation to prohibit intermarriage between races, restrict American citizenship to mentally and genetically sound Caucasians, and hasten the repatriation of American Negroes to independent black African nations.
