**Narrative Description:**

Summary Description

The North Mayfair Bungalow Historic District is located on the northwest side of Chicago, approximately nine miles from the city's commercial center. The district encompasses the 4800 through 5100 blocks of North Tripp, Kildare and Lowell Avenues; the 4900 through 5000 blocks of North Keeler and Kenneth Avenues; the 4900 through 5100 blocks of North Kostner Avenue; and the eastern side of the 4900 and 5000 blocks of North Kilbourn Avenue, as well as the northern side of West Argyle Avenue, 4014 through 4158. The district is bounded on the north by West Foster Avenue, on the south by West Lawrence Avenue and on the east by North Pulaski Road, all busy thoroughfares. Located in close proximity to the neighborhood are the North Branch of the Chicago River, the La Bagh Woods (part of a larger forest preserve), Gompers Park and the Bohemian National Cemetery. The district includes 904 resources, of which 782 were constructed during the period of significance. Of these, 575 are brick bungalows. These bungalows are interspersed with multi-family apartment buildings and several examples of other types of single family homes dating from the period of significance, mainly Tudor Revival cottages. The primary era of development in the district was between 1913 and 1930, with 1923 marking the peak of construction activity. As a result, the patterns of growth are consistent with those of the era, both in terms of individual construction and larger-scale speculative development, underscoring the district's significance as a part of the larger nationwide trend in home construction. Accordingly, the predominant style chosen for single-family residences in the neighborhood was the bungalow, particularly the brick Chicago Bungalow. Multifamily dwellings constructed in the era, typically brick two- or three-flat buildings with limestone accents, feature similar aesthetic features, particularly in materials and ornamentation. The result is a district which is strongly cohesive and unified.

Fifty-seven structures, mainly Tudor Revival cottages from the 1930s and early 1940s and post-World War II raised ranches, have been constructed in the North Mayfair District since the period of significance. With the exception of a group of raised ranches on the 5000 block of North Kenneth Avenue, the majority of these non-contributing structures are distributed primarily on the periphery of the district. Sixty-five structures have been rendered non-contributing due to a loss of integrity, most often as a result of a modification of the roof line. These alterations consist primarily of oversized dormers or large second story additions which obscure the bungalow's original one-and-a-half story design. The 597 contributing buildings in the district retain their early twentieth century appearance, as outlined in the registration requirements of the Chicago Bungalow Multiple Property Listing.

Site & Setting

The North Mayfair District is a quiet residential area lined on three sides by high traffic thoroughfares. Yet, the district is also bordered by a city park, Gompers Park, and a spacious forest preserve north of West Foster Avenue. The district consists of forty-three block faces, each containing between fifteen and twenty lots. The only exceptions are found along the east-west oriented streets, West Argyle and West Ainslie Streets, where blocks range from four to eleven lots. Dimensions of lots within the fifteen to twenty lot blocks average approximately thirty feet in width and one-hundred-twenty-seven feet in depth, although there are individual variations throughout the district. Lot depths tend to be slightly greater on the western side of the district, along North Kenneth, North Kilbourn, and North Kostner Avenues, where depths average approximately one-hundred-thirty-three feet. Along the east-west oriented streets, lot widths average approximately thirty-one feet while depths average hundred-twenty-five feet, although there are again some individual variations, particularly at corner lots. Buildings face east and west along the seven north-south streets which run through the district--North Keeler Avenue, North Tripp Avenue, North Kildare Avenue, North Lowell Avenue, North Kostner Avenue, North Kenneth Avenue, and North Kilbourn Avenue. only exceptions are found along West Argyle Street between North Pulaski Road and North Keeler Avenue and along West Ainslie Street between North Kildare Avenue and North Kostner Avenue. These lots face south along the east-west streets upon which they are situated. With the exception of North Kilbourn Avenue, all of the north-south streets in the district are designated for one-way traffic. The right-of-way on each block face includes street lawns fronting the street pavement, as well as sidewalks between the street lawns and the property lines of the individual building lots. With the exception of the 4800 block of North Lowell Avenue, where lots were plotted with more generous front lawns, buildings are set back approximately fifteen feet from the street.

Because North Mayfair developed during the first phase of the bungalow boom, the building footprints tend to be relatively modest. Since larger bungalows were typically constructed on larger corner lots, the bungalows in the district consistently occupy approximately 20-30 percent of the lot even though footprints range from 616 square feet to 1,836 square feet. An early brick bungalow, dating from 1916 and located at 5136 North Tripp Avenue, has a footprint of 748 square feet and occupies only 20 percent of its thirty by one-hundred-twenty-seven foot lot. Likewise, a later example, dating from 1925 and located at 4136 West Argyle Street, has a footprint of 1782 square feet but occupies only 25 percent of its one-hundred-twenty-five by fifty-eight foot lot. Frame and brick garages measuring approximately twenty by thirty feet occupy the rear portion of most of the district's bungalow lots. Garages that serve the interior lots generally face the alley, while those associated with corner lots tend to face the side street for easier access. The North Mayfair Bungalow Historic District contains 185 garages that date from the period of significance, 1913 to 1930. For the most part, these garages are simple, utilitarian frame or brick structures. A notable example is the garage at 4900 North Kostner Avenue, which is constructed with light-colored face brick and features a clay tile roof, thereby matching the bungalow it serves.

Materials & Stylistic Variation

The North Mayfair area is distinguished among neighborhoods characterized by a large concentration of bungalows by the fact that it developed during the first phase of bungalow construction in the city. As a result, the housing stock is very consistent, despite the fact that the neighborhood emerged over a span of more than a decade and was shaped by both individual construction and larger-scale speculative development. Although prolific and familiar bungalow architects such as Ernest Braucher, B.J. Bruns, Lymon Allison and Reynert J. Reynertson were engaged to design homes in this district, the majority of structures were constructed without the direct involvement of an architect. Brick is the most common building material used in the North Mayfair district. Brick buildings occupying corner lots have face brick on both street-facing elevations, while buildings on interior lots feature face brick only on their façades. The majority of structures, bungalows and multi-family dwellings alike, are constructed of red face brick and share similar aesthetic characteristics, particularly in the limestone accents, fenestration and other ornamentation. Secondary materials include wooden elements used to construct the frame and stucco bungalows in the district, as well as the frame dormers, window frames, exterior doors, and rear porches (many of which have since been enclosed) for brick buildings, and limestone used for planter brackets, window lintels and sills, copings, and decorative accents. Although several homes in the district, particularly late 1920s bungalows, feature original terra cotta tile roofs, the majority of the roofs in the district are modern asphalt tile or asphalt sheet roofing over what was most likely original asbestos shingle roofing material.

Architects and builders in North Mayfair built primarily simple brick bungalows with flat or slightly projecting front bays, groupings of standard double hung or casement windows, recessed corner or side entrances, and minimal limestone detailing. Indicative of the residential development in the district is the structure at 5015 North Kostner Avenue, the district's first brick bungalow. Constructed in 1913 and designed by Ernest Braucher, the brick bungalow features limestone quoining at the corners of the façade,

while the front roofline is accented with a clipped gable. The generous ground level windows are accented with limestone as well. Open front porch bungalows like the one at 4911 North Kilbourn Avenue, which were common on bungalow blocks developed during the 1910s, are surprisingly rare in North Mayfair. However, the structure's red face brick façade, limestone accents, offset front entrance, grouped double hung windows, and front facing gabled dormer are in keeping with the rest of the district's bungalows. In contrast, the bungalow at 5137 North Kostner Avenue, designed by Benedict J. Bruns in 1917, provides a notably early example of the polygonal bay, which is generally seen on bungalows from the mid- to late-1920s. The bungalow features light-colored face brick with limestone accents. The recessed entrance is located on the right of the façade and the hipped roof features a small front facing gabled dormer.

While the majority of the bungalows in North Mayfair were developed singly by small developers or future owners, several blocks were dominated by a single developer and contributed to the feeling of cohesiveness among the bungalows in the district. Among the examples of larger-scale development in the district is the 4800 block of North Lowell Avenue. Twenty-five of the houses on the block were constructed by Fred Cooper in conjunction with architect Charles A. Wheeler, beginning in June 1919. Fourteen homes were built that year, followed by another eleven in 1920. The design of these homes is typical of bungalows in the district. They feature red face brick with limestone accents, a front entrance, and a low, hipped or front gabled roof. The majority feature a bank of windows on the street façade accompanied by a recessed entrance and porch, although some feature a projecting rectangular bay. Small roof dormers are also common to the bungalows on this block. Another prominent developer in the district was Gustav Anderson, who built a number of residences on the 4900 block of North Kildare and Lowell Avenues. Anderson did not use an architect to design any of the homes he built, which suggests that he utilized pattern drawings for these bungalows. On North Lowell Avenue, eight bungalows were constructed in 1923. These structures tend to be one of two types, either featuring a projecting rectangular bay accompanied by a recessed entrance with porch, or featuring a recessed entrance with porch and large bay of windows which dominates the street

facade. Roof lines tend to be front-gabled, hipped with dormer or a combination of the two, found most commonly on the bungalows with projecting bays. While Anderson used primarily red face brick, a few lighter brick bungalows are found on this block. On North Kildare, the six bungalows constructed by Anderson are much more standardized, with projecting front gable bays, covered corner entrances, hipped roofs and groups of double hung windows.

Statement of Significance

The North Mayfair Bungalow Historic District meets the National Register Criteria outlined in the Chicago Bungalows Multiple Property Listing. With 782 contributing resources, 575 of which are brick Chicago bungalows, developed between 1913 and 1930, the district meets National Register Criterion A for local significance by being associated with events that contributed to broad patterns of Chicago history—the promotion of single family homeownership for city residents, countering the twentieth century trend towards increasing residential density that characterized Chicago’s contemporary apartments and tenements. For Criterion A the years of significance are 1913 to 1930, representing the first and last years of significant construction within the district.

Possessed of a high degree of original architectural and urban integrity, the district also meets National Register Criterion C for local significance by embodying the characteristics of a distinctive type, period and method of residential construction—the bungalow. Early Chicago bungalow neighborhoods like North Mayfair offered working class families the opportunity to own solid, well-designed homes and build communities within a quiet and uniform residential setting. The steady rows of bungalows in North Mayfair form a consistent architectural fabric that belied the number of participants involved in building the district and the diversity among the families who first settled there. Bungalow architects Benedict Bruns, Ernest Braucher, Lymon Allison, Charles Wheeler, Reynert J. Reynertson, and Gustav Pearson honed their skills in mass residential design, while building bungalows in Mayfair and other bungalow neighborhoods in the 1910s and early 1920s. North Mayfair, which was built primarily between 1919 and 1923, was an opportunity for bungalow architects, developers and builders to promote the mass appeal of the Chicago bungalow. Prolific designers, Bruns and Braucher are listed as the architects of record for over 140 of the bungalows in North Mayfair, and their plans provided a model of simplicity and function that subsequent architects and builders in the district closely followed. This adherence to a particular architectural form,

coupled with the uniform placement of the bungalows on their lots and within their blocks, created a cohesive landscape that today seems to rival post-WWII planned suburban developments.

The North Mayfair Bungalow Historic District maintains a strictly residential urban pattern that stood in sharp contrast to Chicago's nineteenth century communities, where residential and commercial and industrial activities overlapped in the built environment. Thus, North Mayfair and other bungalow neighborhoods, with their distinct land use patterns that anticipated Chicago's 1923 adoption of comprehensively zoned land uses and building restrictions, also represent a distinctive type as encompassed by National Register Criterion C. For Criterion C the years of significance are 1913 to 1930, indicating the dates of construction for the first and last significant buildings in the district.

Historical Summary

The development of North Mayfair in the 1910s and 1920s was characterized by the rise and enormous popularity of Chicago bungalow neighborhoods between 1907 and 1930. Between 1900 and 1930, Chicago's population doubled as 1.5 million additional residents settled into the city. During this same period, the number of owner occupied housing units in Chicago rose from 86,435 in 1900 to 261,750 in 1930. The tens of thousands of one-and-one-half story brick bungalows built in the city's outlying neighborhoods between 1910 and 1930 stood at the forefront of the expansion of single-family homeownership. Built together, many times in entire blocks, to form a veritable belt around the center city, the unprecedented form of the Chicago bungalow created an entirely novel form of Chicago urbanism. While facilitating the American dream of homeownership for many Chicago residents, neighborhoods like North Mayfair created a harmonious, and aesthetically and culturally cohesive residential landscape from open prairie and farmland.

North Mayfair was originally part of the town of Montrose in Jefferson Township, one of a group of small farming communities northwest of the city. Settlement came early to area, thanks in large part to the favorable location of transportation corridors. The junction of the Chicago & Northwestern and the Chicago,

Milwaukee & St. Paul Railroads, the intersection of Milwaukee and Elston Avenues, and the North Branch of the Chicago River helped give rise to numerous hamlets during the 1850s and 1860s.<sup>1</sup> Early settlers to the area that would become North Mayfair included Richard Spiking, a British horse doctor and farmer who held over 11,000 acres in the area and employed four servants; Peter Erickson, a Swiss farmer with 5800 acres who opened the community's first schoolhouse on his property near Lawrence and Kostner Avenues; and New York real estate agent Charles Race, who owned an astounding 61,000 acres in Jefferson Township.<sup>2</sup> Land speculation began as early as the 1850s, when several farmers began selling parcels of land for development. In 1852, land agent James A. Rees purchased a portion of the Spikings family's land near the intersection of Lawrence and Elston Avenues and carved out ten large, multiple acre lots. In 1873, William O. Cole platted a subdivision of much more modest 28' x 126' building lots between North Keeler and North Karlov Avenues north of West Lawrence Avenue. Anna M. Detwiler created the Ellendale subdivision, bound by Koster Avenue, Kildare Avenue, Ainslie Avenue and Argyle Avenue, in 1887. Ellendale featured even smaller lots, a mere twenty-four feet across.<sup>3</sup>

Mayfair was ripe for growth by the time Jefferson Township was annexed to Chicago in 1889, and inroads were made quickly. By 1894, streetcar lines along Elston, Milwaukee, Montrose and Cicero Avenues linked portions of the area just south of North Mayfair to the center city. Streetcar lines along Pulaski Road (known at different times in its history as 40<sup>th</sup> Street, Crawford Avenue, and Clybourn Avenue) also served to bring Czechs from the city to the Bohemian National Cemetery, which had opened in 1877, despite initial resistance by Jefferson residents, to provide "freethinking" Czech immigrants with an alternative to traditional Catholic burial. The cemetery, which often served as a site for picnics and games, along with the Bohemian Home for the Aged, constructed in 1896, helped to attract a "noticeable number of Bohemian settlers" to the area by the turn of the century, a trend that would continue into the twentieth century, as the area filled with bungalows.<sup>4</sup>

Although the basic infrastructure for wide scale residential development was in place by 1900, and although a smattering of bungalows did appear during the early 1910s, the patch of land north of Lawrence between Pulaski Road and Elston Avenue did not experience significant residential growth until the late 1910s, when the post-World War I population boom created a scramble for new housing in previously undeveloped and underdeveloped parts of the city. Large portions of North Mayfair had been subdivided in 1903 and 1907, and streetcar lines had extended north on Pulaski to Foster and west on Lawrence to Elston, but by 1915 only five homes had been completed within the boundaries of the district.<sup>5</sup> By the end of 1920, just five years later, the number would top 200.<sup>6</sup>

The first brick bungalow appeared in Mayfair in 1913. The bungalow at 5015 North Kostner Avenue was designed by Ernest Braucher for Czechoslovakian tailor Anton Fischer, who had immigrated to Chicago in 1893. Although the bungalow was spacious for one family, by 1930 the house was overflowing. Fischer's widowed mother, a female servant and a male boarder lived with the family of four, and the Fischers rented the upper floors to Harold McCarron, an oil salesman, and his family.<sup>7</sup> Braucher's design is fairly sophisticated for an early 1910s bungalow. Many architects at that time were designing simple open front porch bungalows that closely resembled Chicago's nineteenth century workers cottages.<sup>8</sup> The bungalow at 5015 North Kostner features a side entrance, allowing for an expansive, uninterrupted façade with large window bays for the living room and a front-facing bedroom. The large half story under a clipped gable roof enclosed finished living space, also unusual for an early Chicago bungalow. Subsequent bungalows built in the later 1910s in Mayfair more accurately represent the typical early bungalow. The bungalow at 4930 North Kostner, designed by architect T. N. Bell and completed in 1914, and 5115 North Kildare and 5119 North Kildare, both completed in 1916, are simple frame structures with a flat front bay, corner covered entryway, hipped roof and hipped front-facing dormer. Designed by Braucher for builder George Bergdale in 1916, 5031 N. Tripp was the first stucco bungalow in the district, and exhibited the same simple features.

Although frame and stucco bungalows are generally considered “antecedent” forms of the traditional brick Chicago bungalow, in Mayfair stucco, frame, and brick bungalows were constructed simultaneously. Braucher’s brick bungalow predated the first frame examples, and frame and stucco bungalows continued to be built in the district well into the 1920s. In 1923, Benedict Bruns completed three modern stucco bungalows for developer George Kaabe, 5018, 5022, and 5024 North Tripp, all of which feature a low, almost flat roofline over an offset projecting entrance bay. Prominent projecting eaves serve to further heighten the sense of horizontality. Moreover, several frame and stucco homes in Mayfair exhibit sophisticated design elements. The shingle cottage at 5136 N. Tripp, designed by architect J. Zedek and completed in 1916, features a delicate, broadly curved entryway and a projecting polygonal bay that anticipated the form of many of the district’s late-1920s bungalows.

Such elaborate forms would prove the exception rather than the rule for the majority of construction in North Mayfair. As bungalow building in the district continued at a moderate pace throughout the 1910s, architect and builders adhered to a simple, established economical formula for the basic Chicago bungalow—clean, rectangular forms with corner or side entrances, multiple groupings of double hung or casement windows, and geometric limestone detailing. The bungalows at 4915, 4917, and 4919 North Tripp, designed by Ernest Braucher for developer George Bailey in 1917, are typical examples, with their flat front bays, covered corner entrances, and hipped roofs. Built by Bailey and Braucher in 1917, 4925 and 4927 North Tripp exhibit the same basic form with the addition of a large frame gable with clunky returns. Less than a year later, two groups of very similar bungalows appeared on the 4900 block of North Keeler Avenue. Architects Ira Saxe and Reynert J. Reynertson created practically identical bungalows on either side of the street. Saxe added a modicum of visual interest to his bungalows at 4911, 4915, 4917 and 4921 N. Keeler by offsetting the position of the front doorway and created a sense of enclosure on the front porch by including a low knee wall; otherwise his designs were almost indistinguishable from Reynertson’s bungalows across the street.

Although the similarity among bungalows in Mayfair did little to counter the criticism over the monotony arising from identical bungalows tightly packed onto adjacent urban lots, the benefit to such standardized construction was obvious. The average cost of construction for these bungalows was \$3000 to \$5000, a manageable sum for the working class families who were moving to North Mayfair. Swedish immigrants Anton and Emmy Lundin paid \$4000 in \$20 monthly payments for their bungalow at 4911 North Kenneth, which they purchased in 1923.<sup>9</sup> Builders also applied this bungalow template to the brick two- and three-flat apartment buildings constructed in North Mayfair, which often resembled two or three bungalows stacked on top of one other. Most of the fourteen two-flat apartment buildings constructed within North Mayfair were built just north of North Lawrence Avenue, where proximity to commercial real estate and the subsequent higher land prices encouraged denser residential development. These apartments began appearing as early as 1916, and because of their similarity to the bungalows around them, they complemented the emerging character of the neighborhood.

Despite their restrained style, the early bungalows in North Mayfair were well built and well-designed homes. Architects like Benedict Bruns and Ernest Braucher were just beginning to make names for themselves within the emerging bungalow belt. These early bungalows, though simple, reflected a thorough understanding of the form. As residential construction increased exponentially in North Mayfair between 1919 and 1923, a degree of variety began to emerge among the rows of brick bungalows. However, variations remained well within the framework established by the first homes in the district. Unlike many Chicago bungalow neighborhoods, North Mayfair did not develop in a strictly linear fashion with a clear and predictable evolution of form. The bungalow in Mayfair did not begin simply and evolve into an increasingly complex form, as it did in neighborhoods like Rogers Park Manor and South Park Manor. Instead, architects and developers in the district worked within a much more narrowly constructed definition of the Chicago bungalow. As a result, the district is visually much more cohesive than one would expect

given the number of builders and designers involved, and the streetscapes are more consistent than many Chicago bungalow neighborhoods.

In such a uniform environment, even modest variations to the basic one-and-one-half story rectangular brick bungalow served to create a sense of diversity along the blocks while maintaining the sense of a unified front. One common bungalow variation in North Mayfair features a center bay projecting from the façade and flanked by a single windowed bay on one side and an uncovered entryway on the other, or by two window bays if the bungalow featured a side entrance. When viewed from the front, the center bay bungalow presents a nearly symmetrical façade, with the low gabled or hipped roof of the projecting bay mimicking the bungalow's primary roofline. Architect Charles A. Wheeler particularly preferred this type of bungalow. He alternated center bay bungalows with more traditional corner entrance forms on the 4900 block of North Lowell, where he designed a group of twenty-five brick bungalows for builder Fred Cooper in 1919 and 1920.<sup>10</sup> However, the best example of this symmetrical front configuration is the bungalow at 5059 North Kildare. Designed by Frank Watzke in 1922, the home features an unobtrusive side entrance, a continuous limestone sill, decorative wooden brackets under the eaves, and a large bank of casement windows across the center bay. Other architects and builders developed their own variations. Developer George M. Posner used a front sloping roof and wide shed roof front facing dormer to distinguish the small brick bungalows at 4841 and 4847 N. Tripp. In late 1923, Ernest Braucher partnered with developer F. F. Funk and contractor Charles Chapman to construct a series of fourteen "one-story brick cottages" on the 5000 block of North Keeler. Interspersed among the standard hipped or clipped gable roofs, corner entrances and flat front bays, Braucher included several austere front gable bungalows (5019, 5033, 5043 and 5051 North Keeler) that featured an unusual ground level entrance that was flush with the façade and covered by a projecting wooden portico.

More radical departures from the rectangular bungalow form did appear sporadically in the early late 1910s and 1920s. In 1922, Swedish contractor Gustav Pearson built an elaborate bungalow at 5125 North

Tripp Avenue that featured a projecting polygonal bay with batter piers, art glass windows and a curved entryway. The house, which became the home of Swedish florist Frank Carlson and his family, was only the second polygonal front brick bungalows in the district. Still, most architects and builders in the district preferred to use alterations in brick color, window size and configuration, side or corner entrance location, and surface detailing to distinguish one bungalow from another along the streetscape. Gustav Anderson's bungalows at 5000 and 5002 North Tripp, designed in 1923 by Benedict Bruns, demonstrate the potential effectiveness of such small changes. A simple geometric brick pattern marking the corners and the entryway of these bungalows serves to set them apart from their neighbors. Working without an architect, developer Joseph Holpuch relied on changes in brick color, muntin patterns, and the shape of entryways to add variety to the thirteen brick bungalows he constructed on North Argyle in 1920.

By the end of 1925, the majority of the buildings in North Mayfair had been completed. As the pace of construction slowed, more elaborate bungalows were constructed to fill the remaining empty lots. As in many bungalow districts, the most impressive examples of these later bungalows tended to be on corner lots where the house could be shown to its best advantage. Swedish carpenter and contractor Axel R. Henrickson commissioned architect Lymon Allison to design several impressive bungalows along the 5100 block of North Kostner in 1927 and 1928. 5100 North Kostner Avenue features a broad three-sided front bay with an arched recessed entryway, terra cotta tile roof and art glass windows. With a footprint covering 1,836 square feet, it was the largest bungalow in the district and served as the home of Israel Grosch, a Jewish real estate agent who emigrated from Lithuania in 1891.<sup>11</sup> Henrickson himself lived next door with his wife and three children at 5104 North Kostner in a bungalow very similar to Grosch's. Built in 1927 by Steve Regisby, 4958 North Kostner features a narrow rounded front bay with casement art glass windows separated by battered piers, a terra cotta tile roof and prominent side entrance with a limestone door surround. The bungalow at 4900 North Kenneth, a similarly extravagant design built in 1926, was the home of dentist Clarence Field and features a rounded, projecting front bay, a second rounded window bay beyond the

recessed side entryway, and art glass windows. These more elaborate designs were not new to the district—the first polygonal bay bungalow in North Mayfair was constructed in 1917—nor did they replace simpler bungalow forms, which were still appearing as late as 1928. However, these bungalows do reflect the increasing prosperity of the average homebuyer in North Mayfair towards the end of the decade. Not surprisingly, many of the last buyers in the district were builders who had profited handsomely from the neighborhood's success.

Like most bungalow districts in Chicago, North Mayfair drew families from a diverse array of ethnic and economic backgrounds together under the common goal of homeownership. Over one-third of the homes in North Mayfair were owned by immigrant families; approximately three-fourths of American born heads of household in the district were children of immigrants. American, German, Swedish, Polish and Czech families predominated in the district, but over 25 nationalities, including English, Canadian, Irish, Scottish, Norwegian, Greek, Italian, Russian, Hungarian, Mexican, Romanian, Austrian, and French were also represented on the blocks.<sup>12</sup> Male heads of household worked at a broad array of skilled blue collar and middle-class white-collar jobs that afforded them enough income to make a modest down payment on their bungalows and to keep making monthly payments. A good number of bungalow owners in Mayfair housed extended family or adult children who maintained jobs outside the home and likely made contributions to the household economy. This sort of living situation was especially advantageous, as the financial difficulties of the depression set in during the early 1930s. North Mayfair was home to laborers, butchers, janitors, machinist, streetcar conductors, a physician, salesmen, iron workers, accountants, printers, bookkeepers, store managers, bakers, jeweler, dentists, stenographers, stock brokers, tailors, policeman and teachers, among numerous others. Like many bungalow neighborhoods, the district also housed a large number of homeowners employed in building trades. Carpenters, plumbers, electricians, bricklayers, architects, contractors, and finishers settled in the neighborhood, many into houses that they had helped complete. Swedish born builder John Dawn, who erected several small groups of bungalows in the district, lived with

his wife, son, nephew and sister-in-law in a large corner bungalow at 5100 North Lowell. Otto Voss, a carpenter who also worked in the district, constructed a large yellow brick bungalow with a polygonal front at the corner of Kostner and Carmen for his family in 1927.

The residents in North Mayfair worked in quite varied settings around the city; however, their social class and their bungalow neighborhood effectively created a very different world for them to return home to. They came to share very similar brick bungalows in a residential landscape that depended upon, but was emphatically set apart from, their worlds of commerce, industry, and labor. Despite differences in ethnicity and class, the residents of North Mayfair united under their primary identity as homeowners who took tremendous pride in their neighborhood. Bungalow owners petitioned for a new school to meet the needs of the neighborhood's burgeoning families. In 1926, the city constructed the Palmer School between Kostner and Kenneth north of Arygle to replace several portable schools and the aging nineteenth century public school at the corner of Lawrence and Kostner, which early residents affectionately nicknamed "the Little Red Schoolhouse."<sup>13</sup> After this early success, residents formed the North Mayfair Improvement Organization to petition the city to build sidewalks, put in street lighting, and pave streets. The group stormed city hall in 1929 in their effort to get Foster Avenue paved and mounted an equally successful campaign to establish bus service in the area in 1937.<sup>14</sup> Mayfair was also home to several thriving protestant churches, including the Mayfair Presbyterian Church, which moved to its present home at the corner of Kostner and Ainslie in 1930. The new field house at Gompers Park, just north of Foster, was opened in 1929.<sup>15</sup> Schools, churches, and parks gave newer neighborhoods like North Mayfair a rooted and more substantial appearance and reinforced the broader ideals of family life, child rearing, and moral propriety that served to attractive potential homebuyers and encourage families to stay. With the initiatives that they undertook and with the neighborliness that they fostered the residents gathered in the Improvement Association sought to protect and enhance their residential landscape; in doing so, they furthered the accomplishments of builders and architects in shaping the community.

The bungalows that emerged in North Mayfair between 1913 and 1930 allowed working and middle-class, blue- and white-collar families to also share in the American dream of homeownership. For these families, and for families living throughout Chicago's bungalow belt, the bungalow provided a thoughtfully designed, solidly built, and thoroughly modern home, while providing a place where groups of economically, ethnically, and culturally diverse people could come together into a uniform American residential fabric.

**Boundary Description**

Beginning along West Foster at the alley between Kenneth and Koster proceed east to the alley between Tripp and Keeler turn ninety degrees to the south and proceed along the alley to the intersection of West Carman turn ninety degrees to the east along Carmen and run to the alley between Keeler and Kedvale at the ally turn ninety degrees and head south along the alley to the ally behind the properties fronting on West Argyle turn ninety degrees to the east and run along the rear property lines until the intersection of North Pulaski turn ninety degrees to the south and head along Pulaski to the intersection of Argyle turn ninety degrees to the west and head along Argyle until the alley between Keeler and Kedvale turn ninety degrees to the south and head along the alley until the intersection of West Ainslie turn ninety degrees and head west to the alley between Keeler and Tripp turn ninety degrees to the south and head along the alley to the alley just north of Lawrence turn ninety degrees and head along the alley to the alley between Lowell and Kostner turn ninety degrees to the north and head along the alley to the intersection of Ainslie turn ninety degrees to the west and head along Ainslie until the intersection of North Kilbourn Avenue turn ninety degrees to the north and head along Kilbourn to the intersection of Carmen turn ninety degrees to the east and head along Carmen to the ally between Kenneth and Koster turn ninety degrees to the north and proceed to the point of beginning.

**Boundary Justification**

The boundaries of the district encompass nineteen full residential blocks and 4 single block faces of primarily Chicago bungalows developed between 1913 and 1930, which form a cohesive and uniform landscape consistent with other Chicago bungalow districts. The district is bound on the west by the alley just west of the 4800 block of North Lowell Avenue and by North Kilbourn Avenue between West Argyle Avenue and West Ainslie Avenue. The district's eastern boundary follows the alley between North Keeler and North Kedvale Avenues, and extends along North Argyle Avenue to North Pulaski Avenue. Relatively few significant alterations to the bungalows detract from their original expressions. The district's northern boundary is formed by West Carmen Avenue and West Foster Avenue, and the district's southern boundary follows West Ainslie Avenue and West Lawrence Avenue. The character of the neighborhood is further preserved by the continued use of its bungalows exclusively as private residences.

The architectural continuity of this neighborhood does not extend in any direction beyond the district's boundaries. While a residential character persists directly west of the boundaries, the area does not maintain the consistency of the district area, and the changing street directions west of Kilbourn are a clear dividing point. Commercial buildings line North Lawrence Avenue, a heavily traveled two-way, four-lane street, marking a clear shift in neighborhood character south of the district. The northern boundary of the district jogs to exclude post-World War II development on both the east and western edges. The northern-most edge of the district runs along West Foster Avenue, just south of Gompers Park.

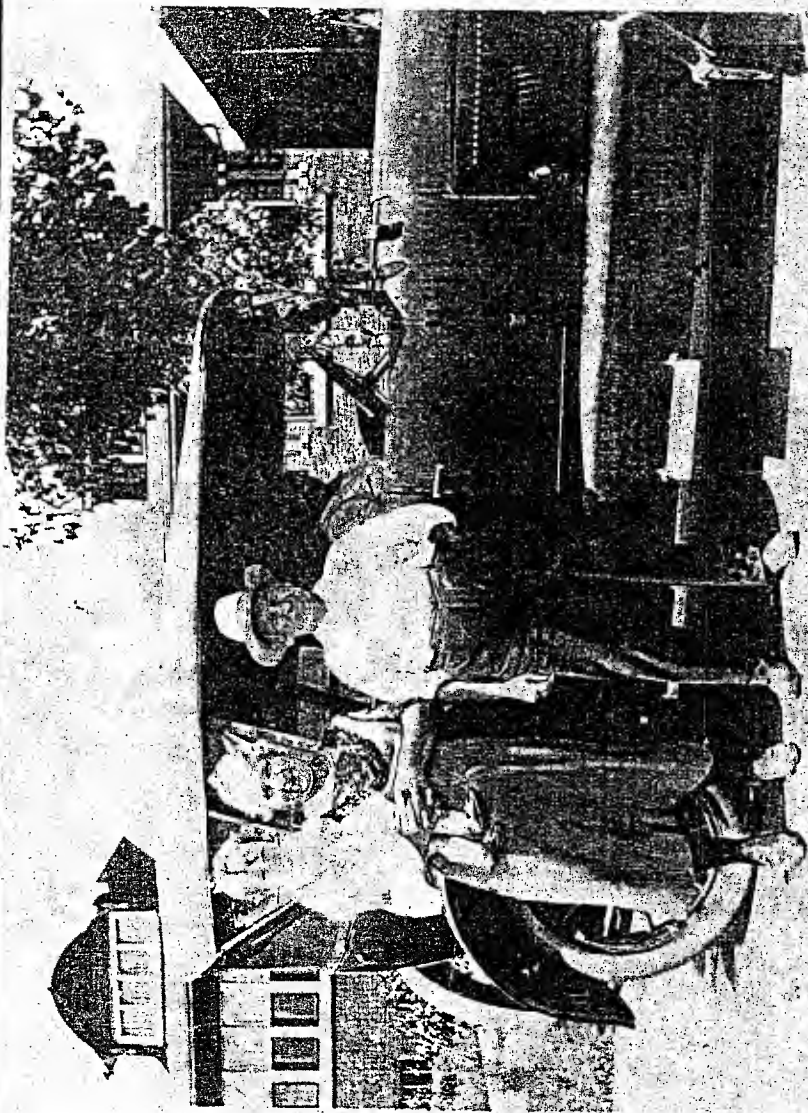

The Commission on Chicago Landmarks finds that:

- the Anton E. Hanson House is an unusual cast-concrete house in the context of Chicago architecture, possesses local significance, and is eligible under Criterion C for listing on the National Register of Historic Places; and
- the North Mayfair Bungalow Historic District is a fine and consistent collection of Chicago bungalows and related buildings built predominantly in the 1910s and 20s. It is being nominated under the Multiple Property Documentation form for "Chicago Bungalows." It possesses local significance and meets Criterion A for community planning and development and Criterion C for architecture; and
- the Pilsen Historic District is significant for its architecture and history reflecting its origins as a predominantly Bohemian immigrant neighborhood in the late 19<sup>th</sup> century and its transformation into a largely Mexican-American community after World War II. The district possesses local significance and meets Criterion A for Ethnic Heritage, Social History and Industry and Criterion C for Architecture.

*Now, therefore, be it resolved by the Commission on Chicago Landmarks* that it hereby supports the listing of all three nominations to the National Register of Historic Places.

SUBJECT: Preliminary Opinion on the North Mayfair Bungalow Historic District

The North Mayfair Bungalow Historic District is a distinct area of Chicago bungalows, Revival style houses and 2-flats in the Albany Park Community Area of northwest Chicago. The district is roughly bounded by West Koster Avenue on the north, North Pulaski Road and North Keller Avenues on the east, both sides of West Ainslie Avenue on the south and North Kilbourn Avenue on the west. The contributing buildings in the district were built between 1913 and 1930. The majority of the residences in the district are clearly Chicago bungalows in form and design. A number of Revival style house, 2-flats and secondary garage buildings are also included within the district. The houses were built by a number of different contractors and architects. The district meets Criterion A for community planning and development and Criterion C for architecture and represents a very consistent and unified area of Chicago bungalows within this area of the city. The period of significance for the district is from 1913, when the first houses were built to 1930, the year to last houses were built. The district retains sufficient integrity to convey both its historic and architectural merit.
