



If there's anything that this week's United Teachers of Los Angeles (UTLA) strike is teaching us, it's that even while we have important differences, what unites us is even more powerful and we have great potential to improve kids' lives. We agree that funding for public schools should grow, and Sacramento needs to act to do more for our most vulnerable students. We agree that teachers, nurses, librarians and counselors do some of the most important and difficult work out there and that they deserve more support from our communities, districts and the state. And we agree that all students need a learning environment that helps them thrive.

While charter schools are not part of contract negotiations between LAUSD and UTLA, we join the chorus of voices encouraging these groups to come to a quick resolution, so we can focus our collective energy on the priorities we share. Los Angeles charter and district public schools are not alone. Across the state, districts are in fiscal crisis. We have an opportunity to march together in Sacramento on March 13 on behalf of all public schools to increase statewide investment for our most vulnerable students. Register here to join us!
