Taxes are due and payable quarterly February 1, May 1, August 1, and November 1.

This bill is for the first two quarters only. Another bill for the 3rd and 4th quarters will be sent later.

The amount of this bill is based on one-half of last year's tax rate. An adjustment to conform to the Tax Rate of this year will be made on the bill for the second half.

DISCOUNTS— $\frac{1}{4}$ of 1% Discount will be allowed for each full month that payment is made in advance of date due.

PENALTIES—Interest at the rate of 7% per annum will be charged until date of payment on all taxes in arrears. When personal taxes become delinquent, Jan. 1st of the following year, a return postage fee and a collection fee shall be charged in addition to the regular 7% interest. When a levy has been made to enforce payment, a 3% penalty of the tax shall be added.
