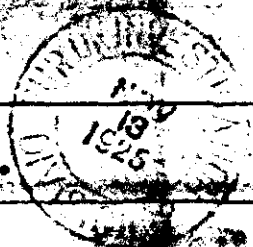

CONCERNING THE MURDER OF W. E. "BILL" SMITH.

JOHN BEARDMORE, Fairfax, Oklahoma. This man is a white man and was interviewed under cover by this agent. He states that day before the home of BILL SMITH was blown up that SMITH told him, BEARDMORE, that he expected to be murdered at any time, as he, SMITH, had just met BILL HALE on the road near Fairfax and HALE drew his six shooter on him, saying to SMITH, "You G--D--S-- of a B--if I hear you talking about these Indian murders, I will send you to hell." BEARDMORE was a close friend of BILL SMITH, the murdered man, and is all right. His occupation is a laboring man, and at the present time he lives in Fairfax, Oklahoma. BEARDMORE further stated that SMITH had moved in his, SMITH'S, home the same day he was blown up.

GEORGE BOLTON, Fairfax, Oklahoma. He is a white man and said to be G. K. and against the HALE and BURKHART factions. At one time HALE had an affair with BOLTON'S sister, this being sometime past. BOLTON is a son-in-law of I. R. HEDGES, who lives at Malton, Oklahoma. HEDGES is an important witness in the ANNA BROWN murder case.

ERNEST BOLTON lives on a ranch near Fairfax, Oklahoma. He is a white man and married to an Indian squaw. He is a brother of GEORGE BOLTON and a close friend of ERNEST and BRYAN BURKHART. It is known by this agent that ERNEST and BRYAN BURKHART have confided in or with ERNEST BOLTON on several occasions with reference to the Indian murders, even admitting to him in their drunken sprees that they were implicated with the Indian murders. ERNEST BOLTON possibly heard BILL HALE say that for \$100.00 he, HALE, could get any G-- of a B--bumped off in Geage County. MR. BOLTON is the son of CHRIS BOLTON, who is an old timer around Fairfax. His father is very friendly to the Government while ERNEST, his son, is believed by this AGENT will tell the truth about what he knows regarding the statements of BILL HALE and ERNEST and BRYAN BURKHART when he, BOLTON, is put on the witness stand. It is suggested by this agent that ERNEST BOLTON not be interviewed at this time, but after BILL HALE and BRYAN and ERNEST BURKHART are in custody, he should be interviewed, and subpoenaed to appear as a Government witness whenever this case is presented for prosecution.

W. E. COPLAND, Fairfax, Oklahoma. He is a white man and sat on the Coroner's Jury after BILL SMITH, his wife and their servant girl were blown up at Fairfax. His occupation is a banker, being assistant Cashier of the First National Bank. He is no good and is a close friend of BILL HALE and does business with HALE. BILL HALE does business at the First National Bank.

DICK CRANDALL, Fairfax, Oklahoma. He is a white man and is said to have heard the death bed statement of BILL SMITH. His occupation is a plumber and he is said to be all right by under cover men.

C. M. CROSSLAND lives in oil fields near Webb City, Oklahoma. He is a white man and said to have seen a car leaving vicinity after explosion of the BILL SMITH home. At the time of the explosion of the home of BILL SMITH, CROSSLAND was night watchman of Fairfax, Oklahoma. It is stated by confidential informants that MR. CROSSLAND has said that a part Indian girl, who worked for HENRY BROWN

at one time, has some information regarding the murder of HENRY ROAN. The girl's name is MAGGIE CLARK McCLURE now living with MOY BUNCH and wife, who was the widow of HENRY ROAN.

ROBERT ELLIOTT lives one mile south of Fairfax, Oklahoma. He is a white man and is said to have seen ARREST BURKHART'S car pass shortly after the explosion of the BILL SMITH home. He is reported by confidential informants to be a good man, as well as a good citizen.

F. C. HOEFER, Fairfax, Oklahoma. He is a white man and it has been previously reported by the confidential informants that he is a man who takes money from the Indians. He has the Ford Agency and further information from one of our best confidential informants is that he is now all right. This man sat on the Coroner's Jury after the explosion of the BILL SMITH home when the SMITH family was murdered.

JIM KASTLE, Fairfax, Oklahoma. He is a white man, squaw man and a brother-in-law to BRYAN BURKHART. He is said by confidential informants to know a good deal about the Indian murders, especially the blowing up of the SMITH home, as well as the HENRY ROAN and ANNA BROWN murders.

W. G. LYNN, Fairfax, Okla. He is a white man and is a witness in the BILL SMITH murder case. He is thoroughly trust worthy and is a good citizen. He also sat on the Coroner's Jury. MR. LYNN is the Guardian of BRYAN BURKHART'S wife, who is an Indian woman, her name being ROSA LINDLEY BURKHART. MR. LYNN is an important witness in the W. K. (Bill) SMITH murder case and after the apprehension of BILL HALE, ARREST and BRYAN BURKHART, will be needed by the agents of the Bureau when ROSA, BRYAN BURKHART'S wife naturally will come to MR. LYNN for assistance. This matter is to be considered very confidential.

SID DELPLANS, former Chief of Police of Ponca City and is now living in Ponca City, Okla. He is a white man and a witness said to have a lot of general information. From the reports of confidential informants this man is very doubtful and he associates with the HALE and BURKHART gang.

WALTER DOLIK, Oilton, Oklahoma. He is a white man and knows the proposition made by BILL HALE to murder Indians and blow up the SMITH home. He is reported by confidential informants to be a brother-in-law of DUKE BURKHART, who is a brother to ARREST and BRYAN BURKHART.

GEORGE JAMES, Fairfax, Oklahoma. He is a white man, a gambler, a friend of the boot leggers and said to be a friend of HALE and his gang. He has rented land from HALE. He is reported by one of the confidential informants to be all right and will tell the truth when he is put on the witness stand, but other informants report that he will be handled by HALE if HALE is brought up for prosecution. JAMES'S daughter married one of HALE'S nephews.

BILL PRYOR, Grayhorse, Oklahoma. He is a white man and is said to be a witness and can give considerable general information. There is no such man as J. PRYOR, but there is a BILL PRYOR living at Grayhorse and is O. K., if he is the same man mentioned in previous reports as J. PRYOR.

M. M. HICKSBIN, Indian Agent, Fairfax, Okla. He is a white man and is close friend of BILL HALE, and wears suits of clothes purchased by HALE. He is no good, crooked and will do what BILL HALE says to do. This man is a coyote and is said to be the party who is putting out information obtained through the Indian office at Pawhuska, Oklahoma. He is said to be a constant companion of BILL HALE and will help him when he and his gang are brought up for prosecution.

CHARLES ROFF, Fairfax, Oklahoma. He is a white man and was County Attorney at the time of the BILL SMITH murder. He is no good, crooked and a close friend of BILL HALE. He is listed in previous reports as MR. ROTH, but there is no such man as MR. ROTH living in Osage County. MR. ROFF testified at the Coroner's Jury held after the SMITH murder.

FRED ROWE, Pawhuska, Okla. He is a white man and his occupation is cow man. He is reported by confidential informants to be a strong HALE man and a very close friend of BILL HALE.

BILL SHAW, Fairfax, Okla. He is a white man, good citizen and bears a good reputation. As to giving out facts with reference to Indian murders it is said he knows some facts regarding the blowing up of the BILL SMITH home.

FRANK SMITHILL, Pawhuska, Okla. He is a white man and is mentioned in previous reports as witness of the SMITH murder case. This man is said to know facts regarding the SMITH murder case. He is planning, according to reports, to go to Mexico.

HENRY WARD, Fairfax, Okla. He is a white man and is Agent for Jewett automobiles. He is now reported to be absolutely O. K. and is a bitter enemy of BILL HALE and his gang and has quite a lot of general information. He stated to this Agent that if subpoenaed and brought before the Court that he would tell all he knows and more too. WARD has been very useful and has helped this Agent considerable in this investigation of Indian murders heretofore mentioned, in fact this Agent knew WARD's relatives when they lived in Hayes, Blanco and Leno Counties, Texas.

L. A. WISMEYER and not J. G. WISMEYER, Fairfax, Okla. He is a white man and a brother-in-law of HOMER HUFFAKER, who is a strong HALE man and also a banker being connected with the First National Bank of Fairfax, Oklahoma. WISMEYER is in favor of the Government and is a bitter enemy of BILL HALE. He is a witness in this case on general information and he is now in Idaho on a hunting trip, but will return shortly to his home in Fairfax.

FRANK GIRMER, Fairfax, Okla. He is a white man, ex-boot legger and his occupation is that of a carpenter. He talks considerable around town in barbers shops and pool halls. He stated that BILL HALE has and will run off several witnesses. GIRMER claims to know all about the SMITH home being blown up. This man at the proper time should be interviewed by an agent of the Bureau and if what he claims is

true, a subpoena should be issued for him to testify before the Grand Jury.

DR. ALEXANDER LICKAY, Fairfax, Okla. Chiropractor. He is a white man and is now making efforts to get information with reference to the Government on the investigations of Indian murders and is turning said information over to BILL HALE. He is a close friend of BILL HALE, HALE being a patient of his, as well as an endorser of a note for a good amount of money at the First National Bank of Fairfax, Okla.

PHILIP REED, Fouraker, Okla. He is a white man and he will be a witness for the HALE faction and is a close friend and also a former partner of BILL HALE when HALE insured his grass for \$30,000 and later having it burned and collecting the insurance. This man will be a character witness for BILL HALE and said to swear to anything HALE will want him to swear to when HALE is brought up for prosecution.

HENRY LAYS, Pawhuska, Okla. He is a white man. He was interviewed and made a statement to Agent J. A. STREET at the Phoenix, Arizona, Bureau office at which time he told MR. STREET he was going to move to Canyon City, Colo., within a short time. He is now back in Osage County living at Pawhuska, Okla. This man was reported by confidential informants to be a HALE man and probably will be a witness for HALE and the BURKARTS in case they are brought up for prosecution. This man came back to Osage County from Arizona with the idea of trying to get in the service of the Indian Agency with the purpose of running down the murderers of the Osage Indians, but is merely wanting to get into the service of the Indian Department for the salary, only expecting to do little or no work towards solving the Osage Indian murders.

Following are the cow boys of BILL HALE, who will probably be witnesses for him. They are all white men:

BRETT COVERT, Fairfax, Okla. He has been with HALE about six or eight months.

SAM DONALDSON, Fairfax, Okla. He has been with HALE about two years.

MR. BERGER, Fairfax, Okla. He has been with BILL HALE about three or four years and with L. L. OLLER, HALE'S partner.

JIM LYNN, Fairfax, Okla. He has been with BILL HALE about six months and leases his grass to HALE. He is not related to WARD LYNN.

JOE BOLERT, Fairfax, Okla. He has been with BILL HALE about one year and is a strong HALE man.

MILES BOLERT, Fairfax, Okla. He is a cow man and a close friend of BILL HALE. They are in business together.

OTHER CLOSE FRIENDS OF HALE:

BRIGHT BOBBY, Pawhuska, Okla. He owns a furniture store and is a look out man for BILL HALE and after the BILL WHITE home was blown up, BOBBY was inquiring around among the different ones under cover, if WARD LYNN, who sat on the Coroner's

Jury, favored HALE at the Coroner's Jury. HODDY later asked MR. LYNN after the inquiry if he, LYNN, favored HALE at the Coroner's inquest. HODDY is reported by confidential informants that he will be a witness for the HALE faction.

H. G. BURT, Winfield, Kansas, who visits Fairfax, Okla. He is a first class crook and bears a bad reputation. He is a murderer and a close friend of BILL HALE and will assist HALE if possible, but it is reported to this Agent by confidential informants that when this man is put on the witness stand that he will be compelled to tell the truth, regarding the Indian murders, and it is further stated that this man knows considerable with reference to Osage Indian murders in Osage County, Oklahoma. This man is [REDACTED] and of late he has been visiting Fairfax and has been in close communication with BILL HALE on several occasions.

SETH LEWIS, Pawhuske, Okla. He is also a notorious character connected with H. G. BURT. He has lately been visiting Fairfax and conferring with BILL HALE and his friends. It is said that SETH LEWIS will favor HALE in his trouble and will assist him in every way possible, when HALE is brought before the Court. LEWIS at the present time is under indictment in the Federal Court of Oklahoma on violation of the narcotic laws.

GEORGE MEDDERS, Deming, N. M. For the past six months up until very recently MEDDERS has been employed by W. A. ADAMS, who lives at 3104 Pershing Drive, El Paso, Texas, as a cow hand taking care of cattle owned by MR. ADAMS and pastured by BILL HALE in his pasture near and in the vicinity of Fairfax, Okla. MEDDERS at the proper time should be interviewed by an Agent of this Bureau, as it is reported by confidential informants that MEDDERS has heard some conversation from HALE as well as HALE'S cowboys with reference to the Indian murders of Osage County, Okla. MEDDERS will lie if given a chance as he naturally favors the HALE faction.

W. A. ADAMS, the cow man mentioned above, does not believe that HALE is guilty. He and HALE have been closely associated together for the past six or eight months, that is by HALE pasturing ADAMS'S cattle and helping him make large sales of same. During this year, 1925, HALE has pastured about 3000 head of cattle for MR. ADAMS. It is said by confidential informants that ADAMS will assist HALE if he is prosecuted by advising him, HALE, to get a certain firm of lawyers living at Ft. Worth, Texas, to defend him. Names of lawyers unknown, but this information can be secured at a later date. Adams if subpoenaed and brought into Court will have to tell what he knows about HALE'S talk to him with reference to the Osage Indian murders. It is a known fact that ADAMS advised HALE'S detective and spy, JIM MOSS, gave him names of some of the Government agents, who were investigating the Osage Indian murders. Adams did give AGENT some help at first when Agent went to Fairfax, but was given to understand that HALE did or should know that this Agent was a Government agent, after Adams stated that he could not believe HALE could do such a thing, that is having a home blown up.

SAM TURNER, Tonkawa, Okla. He is a white man and a close friend of BILL HALE and H. J. BURT. He will assist BILL HALE in case that he is prosecuted for the Indian murders of Osage County. SAM TURNER will in all probability will be a witness for HALE and his faction.

BUCK ELDREDGE, now living at Guthrie, Okla. He is a white man and is now in the employ of the HALE faction making efforts at Guthrie to find out just what the Government is going to do in regard to the HALE faction or in regard to the HALE investigation. He is making inquiries of different citizens living in Guthrie as to when Court meets etc. It has been stated to this Agent that ELDREDGE is probably figuring on who will be on the Jury and will, if possible, try to fix the Jury or get someone on the Jury, who would favor the HALE faction in case prosecution is brought by the Government.

MR PRICE, first name unknown. Address unknown but now residing at Guthrie, Okla. He is a white man and is also under the employ of HALE and is making inquiries as to who the different Government Agents are and what their business is in Fairfax, as well as the Osage Country. He is posing as a cow man. This party is stopping at the Ione Hotel and is accompanied by a short heavy set American, whose name is unknown but will be ascertained at a later date. These two men are closely associated with BUCK ELDREDGE.

ROY BOON is a white man and was a telephone operator at Galston, Okla., at the time the W. K. Smith home was blown up, and whose present whereabouts are unknown. He stated that a man who said his name was Kelsie Morrison put in a telephone for BILL HALE after the explosion and later talked with party and told him everything was all right and for him to come in. The above information came to me thru MR. E. M. PIKE.

L. L. OLLER, Fairfax, Okla. He is a white man and his occupation is that of a cow man. He is associated with HALE in grazing interests. Recently his son, WILLARD OLLER, was arrested at Pawhuska and charged with cow theft, as well as theft of mules. At first L. L. OLLER, father of WILLARD OLLER, was very bitter in his denunciation of BILL HALE, because HALE, his partner, took an active part in the prosecution of OLLER'S son, WILLARD. WILLARD OLLER is charged in the district Court of Osage County with theft of certain cattle and mules belonging to different persons, mules in particular belonging to GEORGE BOLTON. Following are names of men, who are charged jointly with theft of cattle and mules with WILLARD OLLER: DENT THOMAS, L. BORN, RAYMOND COVERT and JOHN CARROLL. Recently BILL HALE and L. L. OLLER have buried the hatchet and it is reported by confidential informants that HALE will endeavor now to assist WILLARD OLLER, L. L. OLLER'S son, to get out of trouble. However, L. L. OLLER has demanded from HALE a division of property. HALE in the end will favor OLLER'S son and cut trade OLLER in the division of the property, which is owned by him and HALE. This agreement as reported by confidential informants is that JIM MOSS and others brought HALE and OLLER together and got them to agree on certain terms, as L. L. OLLER was gunning for HALE at a previous time or at the time OLLER'S son, WILLARD, was arrested for cow and mule theft. GEORGE BOLTON was requested not to press the prosecution against young OLLER for the theft of his, BOLTON'S cattle and stock.

COL. E. WALTERS, Skedee, Okla. He is a white man, live stock, real estate and Government auctioneer. This man is not known to this Agent but is reported by an under cover informant to have said recently, that he did not believe that BILL HALE was guilty of anything wrong in the Osage country. That he, WALTERS, was sure of that. That he has been in business and has sold a number of leases as well

as live stock for the Government and the Indians for a long time and was well acquainted with BILL HALE, and that the investigation made of BILL HALE, if there was any, was a mistake. This man further stated to confidential informant that he had been an employee of the Department of Justice and had a badge on, which he said was given to him by the Indians for his services and square dealings, which he now wears. Confidential informant further stated that above the badge that he, WALTERS, wore and connected with it was the words "Department of Justice." It is not known whether this man was trying to seek information from the confidential informant or really meant what he said. However, he stated to confidential informant that the Government had some new information regarding the Osage Indian murders, which in no way showed HALE was connected with the Indian murders.

CHARLIE MENDOR, Fairfax, Okla. He is a Syrian and his occupation is that of a peddler of women's silk clothes etc. MENDOR has resided in Fairfax and vicinity for the past twenty years. He is well acquainted with the citizens of Fairfax. It is reported by confidential informants that MENDOR could give some information regarding the Indian murders. MENDOR has not been interviewed by an agent of the Bureau, but this agent under cover talked to him on several occasions but it is my belief that MENDOR can give valuable information regarding the Indian trouble of Osage County, Oklahoma. MENDOR resides at the Francis Hotel when in Fairfax, but most of the time he is out among the people selling his goods. He is said to be a good man.

FRANK ADAMS, Fairfax, Okla. He is a white man and his occupation is that of a tailor. He has made BILL HALE'S clothes for several years. Confidential informants report that this man probably knows some facts regarding some of HALE'S activities in and around Fairfax. ADAMS has not yet been interviewed but at the proper time an agent of this Bureau will interview him.

MARY EVANS, Fairfax, Okla. She is a white woman and lived near the house of BILL SMITH the night or morning of the explosion. She is a close friend of BILL HALE, in fact HALE got her to marry at one time an Osage Indian by the name of DON WICKERSON for the purpose of getting the Indian's money. She is no good and is a sporting woman, and is a strong HALE supporter and will help HALE and his faction in case they are brought up for prosecution.

S. M. SMITH known as SOL SMITH, Fairfax, Okla. He is a white man and his occupation is ranchman and cattle owner and very wealthy. He is now very friendly to BILL HALE. Recently BILL HALE visited SOL SMITH when he was in the hospital at Fairfax where he was recovering from an operation for appendicitis. It was previously reported that SOL SMITH and BILL HALE had a big falling out over SOL SMITH'S wife, but it is a fact that SOL SMITH and his wife had not lived together for quite awhile. SOL SMITH in all probability will be an important witness for BILL HALE in case he or his gang are brought up for prosecution.

The following men are look out and spys for BILL HALE and his faction:

VEAN FRAZLER, Fairfax, Oklahoma, white man.

JIM MOSS, Fairfax, Oklahoma, white man.

JOM BOONS, Fairfax, Oklahoma, white man.

PITTS BEATTY, Mayor of Fairfax, Oklahoma. He is a white man and head of the Klu Klux Klan.

BILLY MARTIN, white man living near Burbank, Oklahoma, a short distance from Fairfax, Okla.

BRIGHT BODDY, Pawhuska, Okla. He is a white man and has a furniture store.

PHIL REED, Fouraker, Okla., white man.

CONDEMNING THE MURDER OF ANNA BROWN.

ERNEST BOLTON living near Fairfax, Okla. He is a white man and a squaw man, who is continually associated with ARREST and BRYAN BURKHART and can, if made to tell, give information regarding ARREST and BRYAN BURKHART'S connection with ANNA BROWN and other Indian murders.

MRS. NORA BARKER, Bartlesville, Okla. She is a white woman, who is mentioned in previous reports and knows facts concerning movements of ANNA BROWN at the time of the ANNA BROWN murder. She is a woman of bad repute and is one of HALE'S personal friends.

MARY BLACKBARD, Grayhorse, Okla. She is an Indian woman and is reported by confidential informants to be close friend of BILL HALE and can be handled by HALE and BURKHARTS in case they are brought up for prosecution, but if pressure is brought to bear after the arrest of HALE and the BURKHARTS, it is believed that she can be made to tell the truth, as she is reported in previous reports to know some facts concerning the murder of the Indian woman, ANNA BROWN.

BOB SHROPS, Fairfax, Okla. He is a white man and is said to be a look out for BILL HALE and partly raised by BILL HALE. If used as a witness for HALE, he will make a good one for the HALE and BURKHART faction. He is very sharp and evidently from reports of confidential informants will assist HALE and the BURKHARTS if they are brought to justice.

EDITH DAVIS, 40 N. Yorktown St., Tulsa, Okla. She is a white woman and former maid for ANNA BROWN. She is reported by confidential informants to be a woman of shady character and will be for the BURKHART and HALE faction when the show down comes.

I. R. HEDGES, Malston, Okla. He is a white man and is said to have seen BRYAN BURKHART and ANNA BROWN together on the night of the murder. He is reported by confidential informants to be a good man. He is the father-in-law of GEORGE BOLTON, GEORGE BOLTON being mentioned as a likely witness in the Osage Indian murders.

LEW HINZLE lives near Grayhorse, Okla. He is a white man and is previously reported that he is said to be the man who saw BRYAN BURKHART early in the morning of the murder of ANNA BROWN. It is reported by confidential informants that

be handled by the HALE and BURKHART faction, and will swear for them. Confidential informants further state that witness should be watched as at one time in a case against the BURKHARTS, he helped them prove an alibi with reference to some charge of cattle theft, which happened some time past.

ROBERT KAZAK or KISSE, Fairfax, Okla. He is a white man and as previously reported went to the home of ANNA BROWN on the night of the murder, also the next day but found no one there. This man worked for ARREST BURKHART on farm, also worked for HALEs hauling cotton seed cake etc for HALE on many occasions to feed cattle. This man is doubtful and should be watched, and kept under observation when HALE and BURKHARTS are brought up for trial.

MAGGIE CLARK MCCLURE, Indian woman now living with MOY BUNCH and his wife, formerly the wife of HENRY MOAN, deceased. She is working as a servant and reported in previous reports that she saw BRYAN BURKHART and ANNA BROWN leave ANNA BROWN's home on the night of the murder and reported by J. L. CROSSLAND to know some facts concerning the murder of ANNA BROWN. She is a woman who is now drinking lots of liquor and is absolutely afraid of the HALE and BURKHART faction. MR. CROSSLAND states positively that this woman knows a good deal concerning the murder of ANNA BROWN. Investigation will be made and the party interviewed at the proper time.

ED HAINY, Malston, Okla. He is a white man and reported previously as E. D. HAINY, who is said to have seen ANNA BROWN and BRYAN BURKHART in Malston on the night of the murder. He is a strong HALE and BURKHART man, and will assist them in their trouble and is a very close friend to HALE as well as BRYAN and ARREST BURKHART.

Mrs. ANNA SIFESLY, Fairfax, Okla. She is a white woman and reported by confidential informants to be all right. She is a married woman and lived near ANNA BROWN and is reported to have cooked the last meal in the evening before ANNA BROWN was murdered.

MELVIN CASE, Fairfax, Okla. He is a white man, squaw man and in the cow business. He is friendly to the Government and lived adjoining neighbor to ANNA BROWN and the house that ANNA BROWN owned is now owned by BILL HALE and he and his family are living there at the present time. MR. CASE will be very useful and will help the Government in case the prosecution is brought against the BURKHARTS and HALE. This man has not yet been interviewed by an agent of this Bureau as to any positive facts, but it is believed by this agent that when the proper time comes, MR. CASE can give some very material evidence. He is a little skittish, in fact his Indian wife was almost a nervous wreck after the reign of terror and CASE had to take her away from Fairfax for while after the Indian murders.

MR. TURKIN, Arkansas City, Kans. He is with the Kirkpatrick Furniture Company, but formerly of Fairfax, Okla. He was an undertaker at Fairfax at the time of the Indian murders and handled and prepared the body of ANNA BROWN, as well as the different ones, and while there worked as undertaker for the Big Hill Trading Company, which is controlled by HALE, SCOTT MATHIS and HOMER SUFFARD. SCOTT MATHIS fired TURKIN from the Big Hill Trading Company. MR. TURKIN is absolutely all right and bitterly hates the HALE gang and will testify in behalf of the

Government if this case is brought up for prosecution.

CONCERNING THE MURDER OF HENRY ROAN.

JOHN EMBRY, Oklahoma City, Okla. He is a white man and representative of an Insurance Company in the BILL HALE suit against the Insurance Company to recover insurance on HENRY ROAN. This Agent was asked by the Bureau to get MR. EMBRY'S first name, which is JOHN.

MARIE FLETCHER, Pawhuska, Okla. She is an Osage Indian woman and is said to know some facts concerning the ROAN murder. She is a woman of very little sense and can not be depended on.

E. M. PIKE, formerly Kansas City, Mo., now Fairfax, Okla. He is a white man and a former private detective and said to be in the employ of the Interior Department working under J. GEORGE WRIGHT, Indian Agent, located at Pawhuska, Oklahoma. It is reported by confidential informants that PIKE knows considerable about the HENRY ROAN murder as well as the ANNA BROTH murder. This Agent has met PIKE but at this time cannot state positively how PIKE is getting along, but apparently he is doing the best he can. He has been sick lately and reports that it is just a waiting game with him. It is reported by confidential informants to this Agent that PIKE tells some of the residents of Fairfax that nothing more can be done with reference to the investigation of the Indian murders of Osage County, and that the case is at its end, and at others he states that the parties, HALE and the BURKHEARTS, will be brought to justice and will be prosecuted in a short time. MR. PIKE is living with his wife and child at the FRANCIS Hotel and from his talks to this Agent and his connection with the Interior Department under J. GEORGE WRIGHT we will have to trust him in these investigations, that is he is there for a certain purpose hoping that HALE, so he states, may offer him a bribe and if he is offered a bribe he will immediately advise the Bureau and bring in other witnesses to co-operate the bribery of HALE, if such a thing happens.

ARCE BARGER, Fairfax, Okla. He is a white man and his occupation is Manager of BAN Pool Hall. From confidential sources the following information was obtained: ROY BURCH came to BARGER and showed him a pistol and wanted him, BARGER, to keep it for him, saying "Just like for you to keep this pistol, I am afraid that I will get into trouble about it if I keep it myself." This occurrence was a short time before HENRY ROAN, Osage Indian's body was found. Confidential informants further state that there was only two pistols like the one in Osage County that ROY BURCH wanted BARGER to keep for him. This statement was made by BARGER to JOHN LYNN, son of WARD LYNN. JOHN LYNN is now in Kansas attending school studying law. His father and mother reside at Fairfax and are good people. ARCE BARGER is considered a good white man.

This Agent was introduced to BILL HALE about Aug. 16th at the Smith-Williams Hotel in Fairfax, Oklahoma, HALE'S T.O.N. Since that time from time to time this Agent has met BILL HALE and HALE has been very talkative with reference to his cattle deals and his boyhood days, how he ran away from home and became a cowboy. He has a very high opinion of himself and is money mad, as well as a good

He has stated to Agent at different times that he is suffering with stomach trouble, and lately has also stated to this agent that he has been unable to get any sleep or rest for nearly a month. He is very nervous and has further stated to this Agent that he has sold out all of his cattle interests, which has been verified, and has only about 250 head of cattle on hand, as well as about 75 tons of cotton seed cake. He does not know just what he is going to do, but he thinks he needs a long vacation. He has been very friendly to this Agent, in fact has introduced me to quite a number of the citizens of Fairfax, Oklahoma, and from further investigation he is now making all the propoganda he can to favor himself by giving presents, suits of clothes, as well as going on notes for different people of Fairfax, and giving ponies away to young boys and being kind to those who are afflicted, as well as to old people. Of late he has not been coming down town at night and through his tailor he has ordered a suit of clothes as well as an overcoat, and states to his tailor that he is going to make a trip to Florida. His daughter, a young girl about eighteen years old, has stated to the wife of a confidential informant, that they have everything packed and are ready to go at a moment's notice, and that there is another woman trying to get her papa and she and her mother are very much worried about this. It is not probable that BILL HALE will flee to another country, but this agent is not able at this time to state the exact plans of BILL HALE. He has stated on one occasion, in the presence of this Agent, to others, that he is too slick and keen to catch cold, and was tired of two bit crooks riding the public on his reputation. This was in a conversation with reference to the cow theft of WILLARD OLLER, son of HALE's partner, L. L. OLLER, and WILLARD'S associates mentioned he etorore. HALE is very bitter in his denunciation of the K. K. K. and curses them openly on the streets of Fairfax, but his close bosom friend, PITTS BEATY is a high member of the K. K. K. located at Fairfax and is continually giving him information as well as assisting him, HALE, in all of his crooked deals.

PITTS BEATY is a man about fifty years old and has had considerable experience in the cow man game. He is an arch trickster and will resort to most anything to help out HALE and his gang in case they are brought to justice. MRS PITTS BEATY, the wife of subject, BEATY, is a very nervous and weak woman and is almost on the verge of hysterics for fear that her husband will be brought into some trouble by HALE and his gang.

MRS HALE, wife of BILL HALE, is almost a nervous wreck and it is probable that HALE will take her to Florida or some other resort to let her recuperate. HALE controls the majority of the citizens of Fairfax by his methods, and is closely allied with the big interests of Osage County, and will resort to most any trickery to gain his point or his freedom if brought to justice. At this time HALE has made about \$75,000 in cow business as well as other matters in this year, 1925. HALE is a 32nd degree Mason and has assisted several of his friends in getting into the Masons, as well as putting them through to higher degrees. HALE at this time knows that this agent is in the employ of the Government and is connected with the Bureau of Investigation. Agent will continue to do the best that he can on this investigation reporting facts obtained during his stay in Osage County.

ERNEST BURKHART, Fairfax, Okla. He is a white man and is married to an Indian squaw named Mollie, who is a sister of ANNE BROWN, murdered Indian. His occupation is that of a poker player and he handles liquor. He is a nephew of BILL HALE and in all probability will be one of the defendants in the Indian murder case.

ERNEST'S home is in Fairfax and of late he does not come out much at night. He occasionally visits what is called the Hall Chief Pool Hall. He is a very nervous man and from appearances and inquiries that he has been making among the different ones of Fairfax, he expects something to happen regarding his activities in the Indian murders. No doubt when this man is apprehended he can be easily broken down by the Agents of the Bureau and made to tell the truth concerning his connection with the Indian murders. This is also the opinion of confidential informants working in connection with this Agent at Fairfax and vicinity.

BRYAN BURKHART, Fairfax, Okla. He is a white man and is married to an Indian squaw, her name being ROSE LADLEY BURKHART. BRYAN BURKHART in all probability will be one of the defendants in the Indian murder cases. He is a nephew of BILL HALE and a brother of ERNEST BURKHART. He is some younger than ERNEST, his brother, and from actions and his inquiries among his friends with reference to investigation being made at this time by the Agents of the Bureau, he is not so much worried as his brother, ERNEST, and is a different type of man from his brother. He is more reserved, sneaking and will keep things to himself and it will be hard for him to be made to tell the truth in his connection with his Uncle, BILL HALE, and his Brother, ERNEST BURKHART, in their complicity in the Indian murders committed in the past in Osage County, Oklahoma.

HORACE BURKHART is a brother to ERNEST and BRYAN BURKHART, and also a nephew of BILL HALE. He is a different type of man in comparison to all the other three, his Uncle, BILL HALE, and his two brothers, ERNEST and BRYAN BURKHART. At the present time he is living ten or twelve miles northeast of Fairfax, Okla., and is in partnership with his Uncle, BILL HALE. They own some steers together. This party very seldom comes to town and does not seem to associate with his brothers at Fairfax when he does visit this city, and in no way does he take any part in the poker games and the bootlegging operations of his two brothers, ERNEST and BRYAN BURKHART. He, however, will do just what his Uncle, BILL HALE, tells him to do in the event that his brothers and his Uncle are brought up for prosecution in connection with the Indian murders.

BILL HALE recently has had a talk with LEAHY, McDONALD and FILES, attorneys, located at Lawhuska, Oklahoma, with reference to the probability of his being prosecuted in the Federal Court about the Indian murder cases, and in all probability has given this firm an attorney fee, and it is said by confidential informants that they will represent HALE and his faction in case they are brought into Federal Court. Further HALE has also employed GAMBEL, SCOTT and HAMILTON at Lawhuska to defend him in case he is prosecuted for the Indian murders of Osage County, Oklahoma. This information is considered correct as it was secured from clients of the above mentioned law firms, the clients being very friendly to the Government.

An alphabetical list has been prepared by this Agent of the residences and citizens of Fairfax, Oklahoma, and vicinity using the telephone directory and opposite each name is given their occupation, their nationality, as well as their reputation, also their friendship for HALE and connection with HALE and his gang of murderers. This data is in the files of the Bureau office of this District, being so much it is not included in this report, however, it can be made into another report if the Bureau so desires such a report.

It seems to be the universal opinion of the people living in Fairfax and vicinity that in the event the United States Government is not successful in prosecuting BILL HALE and his allies for the various murders of Osage Indians that they will move from that section of the country in order to protect themselves and families, as they feel that it will only be a period of time until they themselves will be subject to attack of BILL HALE and his allies for any activities they may have taken in assisting the Government to solve these Osage Indian murders. It is a positive fact that when the Government takes into custody BILL HALE and his allies, that these people, who now fear for their lives, will come forward and tell all they may know relative to these murders and the reign of terror conducted by HALE and his faction in the vicinity of Fairfax, Oklahoma.

This Agent is not now working under cover as he has previously been, as it is not considered necessary at this time, because Agent has made known his connection with the Government.

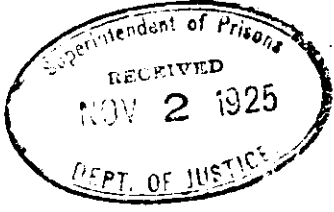

About three weeks before ROAN was found dead, I was at HENRY CORNETT'S Ranch and ROY BUNCH, BILL TAYLOR and MARY ROAN drove up in a car. HENRY CORNETT made the remark to ROY BUNCH that if he did not look out that HENRY ROAN would catch him with his, ROAN'S, old lady and kill him or something like that, and BUNCH remarked that he would beat ROAN to it. Then TAYLOR said leave him to me, meaning ROAN, and I will cold cock him. There was several other remarks made. Three days before HENRY ROAN'S body was found I was going from my home to Burbank, when I got within a short distance from where the road coming from HENRY CORNETT'S ranch run into the Fairfax road, I saw ROY BUNCH and BILL TAYLOR coming from toward CORNETT'S ranch in a Buick car. As I went through the gate BUNCH motioned to me to leave the gate open, which I did. I drove on and turned in to the Burbank road and BUNCH and TAYLOR turned into the Fairfax road going toward Fairfax. Just after I turned into the Burbank road I met HENRY ROAN coming from toward Burbank in a Buick car. When he passed me I saw he was drinking or under the influence of whiskey. He passed me and went toward Fairfax. From where I met BUNCH and TAYLOR on the CORNETT road, they would have just about had time to meet HENRY ROAN when he got to where they struck the main Fairfax road. After I passed ROAN I paid no more attention to either of them. After I heard of ROAN being found dead, the first think I thought of was that BUNCH and TAYLOR had met him and killed him.

STATEMENT OBTAINED FROM ROY JOOK:

Pawnee, Okla. Nov. 19, 1935.

At the time HENRY ROAN was killed and prior thereto, I was operating a pool hall at Fairfax, Oklahoma. It was public talk prior to ROAN'S death that ROY BUNCH was laying up with ROAN'S wife, and that there was likely to be a killing between BUNCH and ROAN.

Sometime before ROAN was killed, ROY BUNCH entered my pool hall hurriedly and went into the rear of the building and hid behind a partition. In a few seconds HENRY ROAN entered my place and from his expression he was mad and looking for somebody. He went towards the rear of my place with his hand in his coat pocket. He did not go far enough back to see BUNCH behind the partition. ROAN then walked out of my place and after he had gone, BUNCH came from behind the partition and asked me which way ROAN went. I told him down the street. BUNCH said ROAN was looking for him and intended to kill him and that he would have hard luck. BUNCH then left. BUNCH left the impression with me from his remarks that if ROAN had come back behind the partition where he was, that he would have been killed. I have seen BUNCH with a small caliber automatic pistol two occasions.

COOK RELATES THE MURDER OF W. E. "BILL" SMITH.

At the time of the murder of HENRY ROAN, W. E. "BILL" SMITH and others, the father of ROY COOK was Sheriff of Osage County. ROY COOK stated to Agent that his father was very much interested in bringing to justice the murderers of ROAN, SMITH et al, and unquestionably is in possession of material information of interest to the Government.

Informant [redacted] advised Agent that W. K. BLOYD mentioned in confession of BUNCH LAMBSON set out in this Agent's report dated Oct. 27th, 1933, shortly after murder of W. E. "BILL" SMITH, stated to him that he, BLOYD, was in possession of material information concerning the murder of SMITH and had given such information to one SAM TUCK, who was at that time in the employ of the Interior Department in the Indian Service, and at present City Chief of Police at Ponca City. That SAM TUCK took the information that he, BLOYD, gave him and immediately divulged it to W. K. "BILL" HALL, the apparent master conspirator in the Osage murder cases, and that BLOYD stated that he saw no use in attempting to further assist in the developments of these cases, due to the fact that his efforts were being blocked.

Investigation develops that BLOYD was involved in transportation of stolen automobiles from Oklahoma to Joplin, Missouri, where he was charged by the Government for violation of the National Motor Vehicle Theft Act sometime in 1933. That SAM TUCK went to Joplin, Missouri and obtained the release of BLOYD and later gave him employment on the police force at Ponca City, as a police officer, where he, BLOYD, remained until sometime in June, 1934, at which time

he disappeared.

Leads are now being followed at Joplin, Mo., by the Kansas City office at the request of the Oklahoma City office in the interest of locating BUCKY.

That at the present time subject resides with his wife VIDA BLOYED, at 729 Connor Ave, Joplin, Mo., he has two automobile trucks (Maxwell and a 1 Ton Ford Truck) which he uses inhauling coal and wood out of Columbus, Kansas. Subject formerly resided at Bellville, Mo. for about 1 year and moved to the Connor Ave. Place during the latter part of August 1925. It is said that subject's parents operate a farm at Cottonwood Springs, Mo.

The following wire was then dispatched to the Oklahoma City office:

"RE A M BLOYED LOCATED 729 CONNOR AVENUE JOPLIN MISSOURI.
WIRE INSTRUCTIONS, IF ANY."

and in answer thereto Agent received the following telegram from the Oklahoma City office:

In the above connection, I am herewith enclosing additional information prepared for the abstracts in the above cases. This information has been secured since I mailed these abstracts to you and has reference to the W. E. (Bill) Smith case, as well as the Henry Roan and Anna Brown cases. I have had memorandums attached to each of these sheets showing just how to file them in the one that you have.

I am having the agents working on this case prepare additional detailed reports on what they have accomplished since the last report rendered to you in this connection. I have delayed somewhat in furnishing you with these detailed, investigative reports on account of expecting every day to secure another confession in the case of Henry Roan, in order that I could submit a report including the confession and any additional information secured; thereby, making a more intelligent recital of the developments in the case. But, inasmuch as it appears now that it will be two or three more days before I get the expected confession, I am, as I have stated, preparing reports setting forth information thus far obtained in these cases.

I might say that arrangements have been made whereby a Grand Jury will be called to hear these cases January 4th and all arrangements are being made accordingly to have the cases in such shape that they can be presented expeditiously and intelligently at that time.
