It is stated the building will be made largely of steel and will cost over \$1,000,000.—The intention of the Messrs. Luke is to make it the largest pulp plant in the United States.

### Hillsboro, Pocahontas County, Items.

We have been informed that a move is now on foot to stack forty million feet of lumber on the streams of Sugar creek, Kerr's creek and other tributaries of Williams river. Operations will begin at once. Supplies will, in all probability, be brought from Hot Springs, Va., a distance of fifty miles. It has been reported that Samuel Gay has secured the contract for the hauling, and that James Sheets will furnish feed for the camps. John R. Butler has contracted for the building of roads, which will cost about \$5,000. H. Nathan has been engaged to repair the big dam on the river, which has not been operated for twelve months. When he gets through repairing the dam, he will go to Chicago to purchase stock for W. G. Gray, foreman for the Gauley Co. It will require 50 teams and 300 men to complete the work for next spring's drive. The contract for the year's furnishings will amount to about two hun-

One hive, belonging to the writer, yielded a surplus of 112 pounds, and three others about 84 pounds each. James Gibson, on Elk, secured 1,200 pounds. Those who have a sufficient number of colonies consider it a fortunate circumstance when bees show no disposition to throw off swarms and thus devote their full strength to the storage of honey in the parent hive.

Allen R. Kinnison closed with the railroad company for the right of way at \$2,040; the company is to build him a road out, and he is to release his right to fences. He owns a long, narrow farm on the banks of the river, the bottoms being something like three to five hundred feet in width and over a mile long. He is a good farmer and has his place in a good state of cultivation.—The center of the line runs through his house, which is a comfortable residence of a story and a half, and over which he has trained the finest grapevine in the country. The line also takes about half a mile of his private road. He will build a road up the mountain and out through Alvin Clark's place. The right to fences, which he released to the railroad, is estimated to be equivalent to \$1,500.

**Hillsboro, Pocahontas, Items.**

It is with a sad heart that we announce the death of Rev. M. D. Dunlap, which occurred at his residence near here on last Tuesday morning, the 24th ult., in the 83rd year of his age. He passed peacefully away, his last hours being attended with but little suffering.— Death resulted from kidney trouble and general debility, occasioned by old age. He leaves no family, his beloved wife and two children having gone on before. He leaves, however, a large circle of sorrowing friends and relatives here and in Monroe county.

Mr. Dunlap was born in Augusta county, Va., in the year 1809. At the age of 25 he graduated at Washington College with high honors, and was shortly afterward ordained as a minister of the Southern Presbyterian Church.

ing which time he also attended to his duties as pastor of the Oak Grove Presbyterian Church. As a teacher he gained great distinction and was the founder of the old Academy, one of the finest institutions of learning near here in that day, and from which the post-office at this place derives its name.

During his ministry, which covered a period of 40 years, he espoused the cause of his Master faithfully and zealously, and the Church prospered in his hands. How many of us remember the old brick Church that stood a mile south of here, and the able and stirring sermons that fell from the lips of Mr. Dunlap. He was one of the most exemplary christians we ever knew.
