Captain's Pass puts you in control, as you explore the ship from bow to stern, and island to keel.

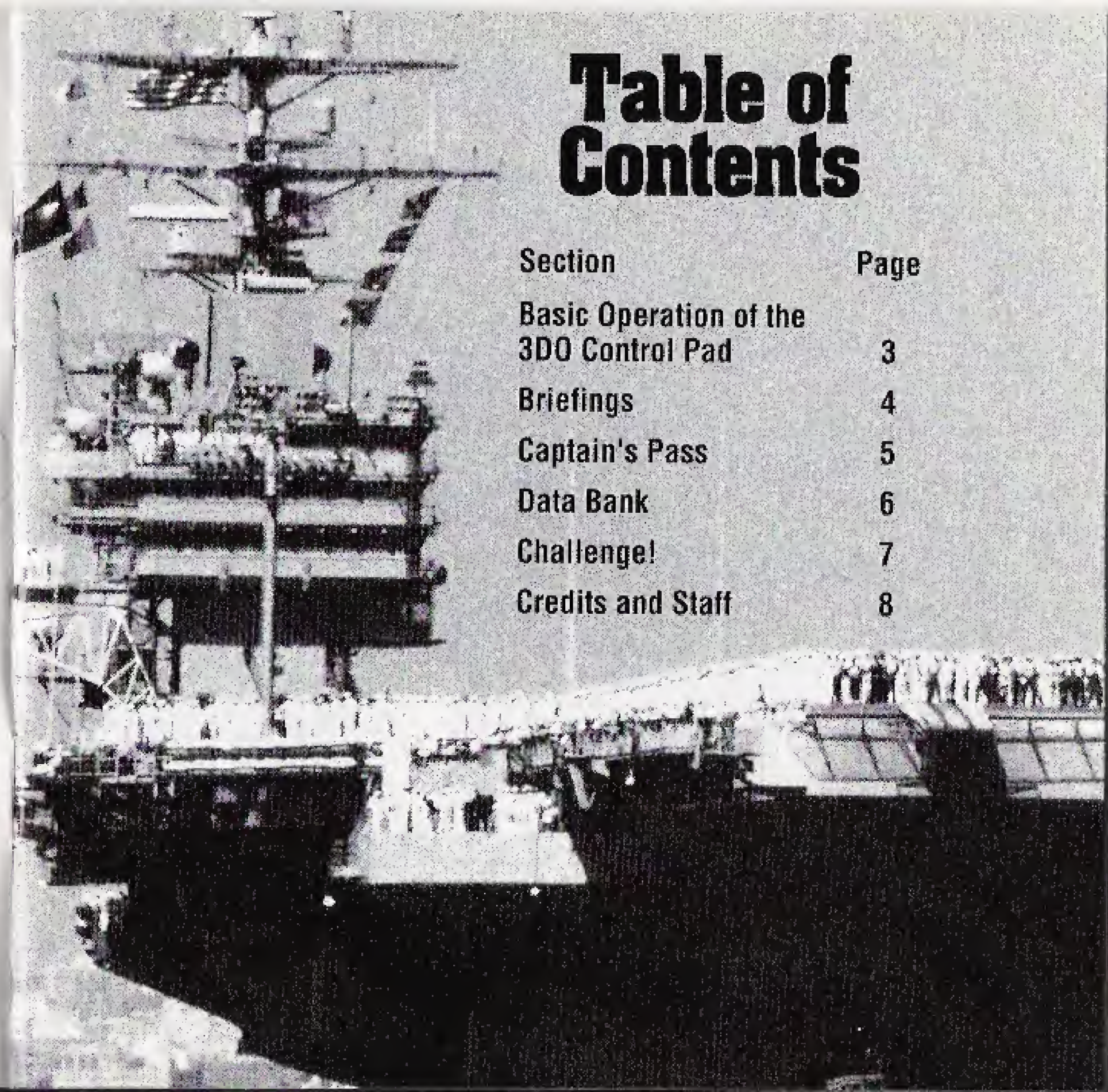

And when you're ready for a time-out, **Challenge** gives you a first-hand perspective of the task of landing on the deck!

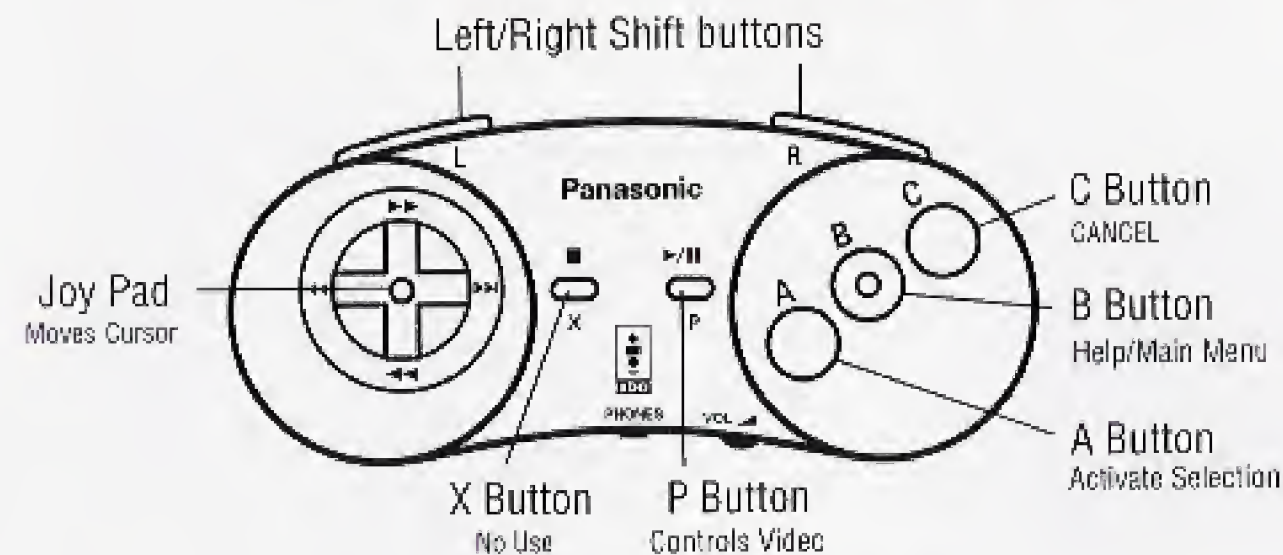

Basic Operation of the 3DO Control Pad



Joypad

Moves the cursor to highlight each available selection

A Activates a highlighted selection

P Play/Pause
(controls video and animation play)

B Help/Main Menu
(not available during video play)

C Cancel (terminates your last selection)

Shift and Joypad Accelerate scrolling

Data Link

After each briefing, the DATA LINK button will be highlighted.

Use joypad to scroll through selections. Press A to access detailed information from the Data Bank about topics covered in the briefing.

Captain's Pass

- Joypad** Moves to each access way in the corridor
- A** Select (to travel or enter rooms)
 - A** Play/Pause the video (only during playback)
 - B** Help/Main Menu (not available during video play)
 - C** Cancel (terminates your last selection)

Special Menu Items

- MAP** Allows you to select and explore any deck of the ship
- EVENT*** Special activities will be announced; press A to attend the event
- SITE LINK*** Select to follow an ongoing or related activity
- DATA LINK*** Access detailed information on related topics
- Tour** An automated guided tour of many important locations on the ship
- Index** An alphabetical menu of every available location and event

*These items will highlight automatically when active.
Press the A button to go directly to the location or event.

- CAMERA** (icon) Displays photographs
- MAP** (icon) Displays maps

- FORWARD/PREVIOUS LINK** (icon) Go to the next/previous map or photo
Accesses related topics; select with joypad and A button
- I.D. BAR** Displays or accesses the last selected screen

Button functions during play

- Joypad** Bank left or right and control altitude with up or down
- A** Lowers landing gear and tail hook

Pilot's Tip: Landing gear/tail hook must be lowered, and nose must be raised in order to catch the wire and make a successful trap.

Precautions

Medical Precautions

Compact Disc Usage Precautions



To open the case, gently press both sides of its top.
