PRELIMINARY INVESTIGATION IN THIS MATTER DETERMINED THAT THE UNSUB IS A FREQUENT BUT NOT REGULAR CUSTOMER OF THE BANDOS RESTAURANT. HE IS KNOWN TO THE MANAGER AS A SOMEWHAT ECCENTRIC PERSON WHO FREQUENTLY COMPLAINS TO THE MANAGER ABOUT THE QUALITY OF THE FOOD, YET RETURNS TO DINE.

INTERVIEW OF [REDACTED] WAITRESS WHO SPOKE TO THE UNSUB, DETERMINED THAT AROUND 10:30 FRIDAY, OCTOBER 12, 1990, THE UNSUB HAD DINNER AND ATTEMPTED TO ENGAGE THE WAITRESS IN WHAT SHE CONSIDERED INAPPROPRIATE CONVERSATION. HE WAS ASKING SOME QUESTIONS REGARDING [REDACTED] AND REQUESTED TO SPEAK WITH HIM. THE SUBJECT THEN ADVISED THAT HE WOULD SHOOT PAUL SIMON AS WELL AS [REDACTED]

[REDACTED] WAS INTERVIEWED AND HE ADVISED THAT HE TOO WAS FAMILIAR WITH THE SUBJECT BY SIGHT
