ON MONDAY MORNING, OCTOBER 23, 1989, SHE FOUND THE FOLLOWING MESSAGE ON THE TELEPHONE RECORDING MACHINE IN SENATOR SIMON'S OFFICE:

"I'M GOING TO BOMB SENATOR SIMON'S OFFICE."

SHE STATED THE IDENTITY OF THE MALE WHO LEFT THE MESSAGE IS UNKNOWN. THE MESSAGE WAS RECORDED SOMETIME BETWEEN 1730 HOURS, OCTOBER 20, 1989, AND 0830 HOURS, OCTOBER 23, 1989.

DETECTIVE [REDACTED] STATED THAT HE ADVISED [REDACTED] [REDACTED] OF SENATOR SIMON, WDC, OF THE BOMB THREAT ON OCTOBER 23, 1989. DETECTIVE [REDACTED] ALSO ADVISED THE UNITED STATES SECRET SERVICE (USSS), WDC.

CREATED A DISTURBANCE AT THE SENATOR'S OFFICE ON OCTOBER 6, 1989. SHE ADVISED THAT MATUSKA CAME TO SENATOR SIMON'S OFFICE TO SEEK HIS ASSISTANCE IN RECOVERING A BOND CHECK FROM THE CLERK OF COURT. MATUSKA HAD REFUSED TO PASS THROUGH A METAL DETECTOR INORDER TO REACH THE CLERK'S OFFICE AND PICK UP HIS CHECK.

[REDACTED] ADVISED THAT THEY CALLED THE CLERK'S OFFICE AND WERE ADVISED HE HAD TO PASS THROUGH THE METAL DETECTOR INORDER TO PICK UP HIS CHECK. MATUSKA REFUSED TO PASS THROUGH THE METAL DETECTOR AND BECAME IRATE, ACCUSING THE SENATOR'S STAFF OF NOT ASSISTING HIM AND REFUSED TO LEAVE THE OFFICE. [REDACTED] STATED THAT THE FEDERAL PROTECTIVE SERVICE WERE CALLED AND MATUSKA WAS ARRESTED. [REDACTED] STATED THAT THEY HAVE HAD NO FURTHER CONTACT WITH MATUSKA. [REDACTED] WAS APPRISED OF MATUSKA'S ARREST FOR ATTEMPTED MURDER ON APRIL 19, 1988 WHEN HE FIRED SHOTS AT OFFICERS FROM THE ANIMAL WELFARE LEAGUE IN DES PLAINE, ILLINOIS WHO WERE ATTEMPTING TO REMOVE A SKUNK MATUSKA HAD IN A CAGE.
