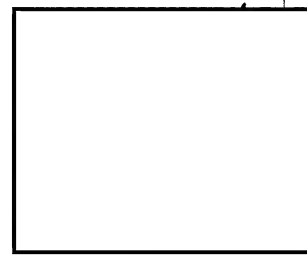

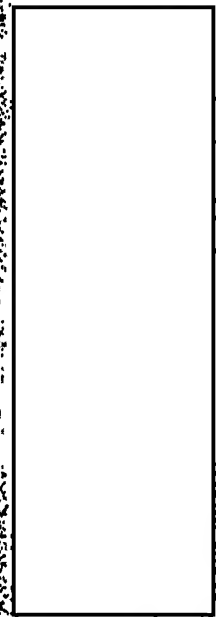

S. Government officials, as well as prominent figures within the African-American community, has been brought to my attention.

I am aware that your performance of duty in this instance is typical of the outstanding fashion in which you discharge your responsibilities in support of our investigative operations and I am appreciative of your efforts.

Your rapid response in this instance led to the immediate identification and subsequent neutralization of a potential threat, not only to intended named victims, but to the general security of the Kentucky Derby itself, which is of great concern not only to our office but to all law enforcement and civic officials in the Louisville, Kentucky area.

Your personal self-initiated follow-up attention to this matter, early the next morning during your normal off-duty hours, typifies your outstanding cooperative attitude.

Review of files maintained by the Federal Bureau of Investigation (FBI) at Louisville, Kentucky, revealed following information possibly identifiable with "Brother De Prez" mentioned within unsigned typewritten letter received by Courier-Journal on May 4, 1994, containing threat against President of United States:

Information developed in connection with criminal investigations of violations of the Civil Rights Act of 1964 - Interference with Federally Protected Activities, related to court ordered desegregation of Louisville (Jefferson County) public schools circa 1975-1976, through forced busing of students. Individual identified as ROBERT DE PREZ, employed at that time by International Harvester Company (Louisville, Kentucky) and residing at 5506 Applegate Lane, Louisville, Kentucky, was described by reliable confidential sources as anti-busing activist with known connections to United Klans of America (UKA), National Organization to Restore and Preserve Our Freedom (NAPF) and Citizens Against Busing. ROBERT DE PREZ reportedly was arrested September 5-6, 1976, while participating in violent anti-busing demonstration at Louisville, Kentucky.

On May 18, 1994, review of Law Information Network of Kentucky (LINK) computerized records revealed that ROBERT B. DE PREZ, 5506 Applegate Lane, Louisville, Kentucky, previously owned vehicle registered to him at same address, under Social Security Account Number (SSAN) 347-28-2915. Pursuant to statutory and directed responsibilities relative to the detection and prevention of terrorist acts and/or to provide adequate and efficient response should same have occurred in connection with Kentucky Derby 1994, a major sporting event of great international interest, the Federal Bureau of Investigation (FBI) initiated the following pre-emptive investigative actions:

General counterterrorism concerns, both of domestic and international nature, as well as other matters of potential federal interest were coordinated with other federal, local, and state law enforcement agencies, as well as Churchill Downs Security Department. ③

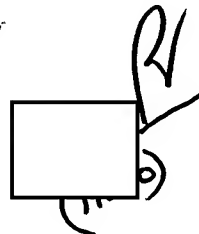
FBI field offices throughout the United States were requested to remain alert for any information indicative of plans by any groups and/or individuals to disrupt Kentucky Derby 1994, either directly or indirectly through violence against any foreign officials, national leaders, entertainment/sports celebrities, etc., expected to be in attendance.

With the continuing expansion of television coverage to foreign markets, potential terrorists are presented with increased opportunity for international exposure of their causes should they select the Kentucky Derby as a potential target. Although there is no information indicative of same at present, the possibility thereof should always be considered and precautionary measures taken accordingly.

In a matter directly related to the general security of the Kentucky Derby, cooperative investigations were expeditiously instituted at Louisville, Kentucky, by both the Secret Service and FBI on May 5, 1994, upon receipt by the Courier Journal newspaper of threatening, unsigned, typewritten letter making reference to and threatening various public officials, including the President of the United States and Attorney General of the United States, while suggesting that author was possibly connected with an unidentified white supremacist organization in possession of machine guns and grenades. Letter specifically warned intended victims not to attend Kentucky Derby or they would be killed. Individual initially believed to have authored letter was interrogated evening of May 5, 1994, and additional suspects developed. Investigation continues into possible federal violations of Threat Against President (Secret Service) and Extortion (FBI).

Law enforcement officials (Louisville Division of Police/Jefferson County Police Department/Churchill Downs Security Department) were apprised of above threat and investigative reaction thereto, on a timely basis.

Professional cooperation and courtesies extended by [redacted] and [redacted] [redacted] Churchill Downs, Inc., are greatly appreciated.

The letter was signed by an individual who was subsequently thoroughly interviewed by Agents of the United States Secret Service and the Federal Bureau of Investigation (FBI). Several other interviews have taken place as regards the

threats with both agencies fully cooperating with one another. At the outset, it was determined that the United States Secret Service would assume primary jurisdiction inasmuch as the President had been threatened and that the FBI would assist in the investigation as requested. To date, the only suspect is believed to be the ex-wife of the signatory of the letter or possibly an associate of hers. SA [redacted] has been advised by the FBI that if further assistance is needed, it will be made available to SA [redacted]

In view of the above, this office will conduct no further investigation into this matter unless specifically requested by the United States Secret Service.
