On the morning of February 9, 1988, at 11:50 a.m., an unidentified caller, who sounded like a caucasian male, with a Chicago accent, between thirty and forty years of age, telephonically contacted her, at the aforementioned number, and stated:

"SENATOR SIMON's Secret Service had better stop bothering me and if they don't I will take revenge on them. If that doesn't stop them, I will hurt PAUL SIMON."

The caller identified himself as WILLIAM POYTS, from the "Chicago-land area".
