

1. On 16 May 1990, DC/PPS and the PPS QRPLUMB case officer met with the QRPLUMB principal agents to inform them formally of the decision to terminate the project and to discuss plans for secure and effective transition from government to private support. main points of discussion were the intent of QRPLUMBs regarding continuation of the project and the amount of termination payment which would be required for a secure transition. The QRPLUMBs stated that they definitely wish to carry on with the work of their organization, taking advantage of the new and constantly evolving opportunities to promote the cause of democracy and economic freedoms in Ukraine. They estimate that in order to make a secure transition and continue the work at the present level for an indefinite period of time, a capital investment of ten million dollars would be required. DC/PPS said that this amount of money is simply not available. He indicated that the amount of termination payment presently being considered is (

which possibly could be increased somewhat out not by much. ORPLUMBs were asked to prepare a detailed plan for transition, listing specific needs and financial requirements. They were told that a cleared management consultant could be made available to them to assist in planning for their financial future and they said that they wish to avail themselves of this offer. The exact date for termination will be determined mainly by the required termination audit. We are now aiming for around the end of FY-90. Further details of the discussion with QRPLUMBs and other points raised during the meeting are provided in the attached Memorandum for the Record of 17 May 1990 (Reference B).
