



APPENDIXCOMMITTEE TO SECURE JUSTICE FOR MORTON SOBELL

A source advised on May 4, 1961, that the Los Angeles Sobell Committee is the Los Angeles, California, affiliate of captioned organization.

"Following the execution of atomic spies ETHEL and JULIUS ROSENBERG in June, 1953, the 'Communist campaign assumed a different emphasis. Its major effort centered upon MORTON SOBELL', the ROSENBERGS' codefendant. The National Committee to Secure Justice in the Rosenberg case - a Communist front which had been conducting the campaign in the United States - was reconstituted as the National Rosenberg-Sobell Committee at a conference in Chicago in October, 1953, and 'then as the National Committee to Secure Justice for Morton Sobell in the Rosenberg case'...."

("Guide to Subversive Organizations and Publications", Revised December 1, 1961, page 116.)

In September, 1954, the name "National Committee to Secure Justice for Morton Sobell" appeared on literature issued by the Committee. In March, 1955, the current name, "Committee to Secure Justice for Morton Sobell", first appeared on literature issued by the Committee.

The 1960-61 Borough of Manhattan telephone directory lists the "Committee to Secure Justice for Morton Sobell" as being located at 940 Broadway, New York, New York.

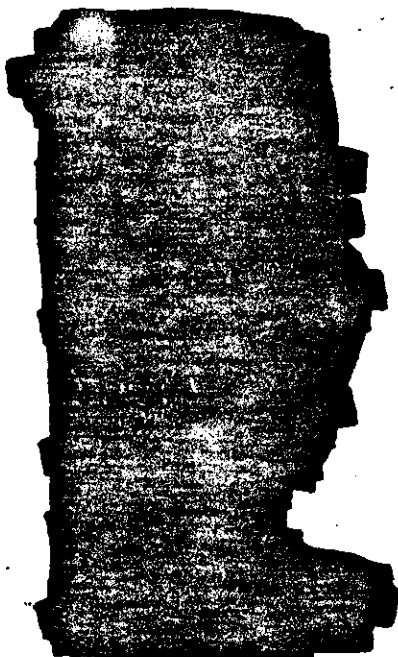

"JEAN PESTANA told about the experiences she and ROSE ROSENBERG had as Freedom Riders to Jacksonville, Miss., and having been sent to jail four times.

"From Jacksonville they went to Mexico, and from there to Cuba.

"She found the Cubans doing all they could to help CASTRO.

"She said, 'Cubans could attend any church they wished.'

"'Negroes are on an equal basis with white people, there is no discrimination.'

"'There is not an over abundance of food, but every one has enough to eat and the same amount.' 'Two chickens per month each and 3/4 pound of meat a week.'

"'The farmers take their share first and then ship their produce to the markets.'

"'Education is very important and 1000 students were sent to Russia to complete their education and only three failed.'

"'They are trying to develop their oil fields and refineries, and also the sugar cane plantations.'

"'The people love CASTRO and are all working for the good of Cuba.'

"'CASTRO keeps informed on everything that happens in Cuba, on the schools all the factories etc. and makes unexpected inspection.'

"'There are many people from England and Europe there.'

JEWISH FRATERNAL COORDINATING COMMITTEE, formerly known as Jewish Information Service (Los Angeles Jewish Cultural and Fraternal Clubs; Fraternal Medical Plan of the California Fraternal Service Association)

On May 3, 1961, a source reported that it was announced at a meeting of the Westside Jewish Cultural Club in Los Angeles on February 3, 1961, that the Jewish Information Service was to be known henceforth as the Jewish Fraternal Co-Ordinating Committee.

This source had previously advised on May 2, 1960, that the Jewish Information Service was formed about January, 1954, in Los Angeles for the purpose of continuing "Cultural" activity of the International Workers Order. Prior to March 4, 1956, the Los Angeles Jewish Cultural and Fraternal Clubs were identified as the Los Angeles Jewish Cultural Clubs, this group being formerly known as Lodges of the Jewish People's Fraternal Order. The Los Angeles Jewish Cultural and Fraternal Clubs are currently active in the Los Angeles area.

The Fraternal Medical Plan of the California Fraternal Service Association was formed about January, 1954, for the purpose of continuing the activity of the Jewish People's Fraternal Order Medical Plan. Since that date the functioning of the Fraternal Medical Plan of the California Fraternal Service Association has been integrated into the operation of the Los Angeles Jewish Cultural and Fraternal Clubs, inasmuch as the service provided by the Fraternal Medical Plan of the California Fraternal Service Association is made available almost exclusively to members of the Los Angeles Jewish Cultural and Fraternal Clubs; further, effort is made to have members of the Los Angeles Jewish Cultural and Fraternal Clubs also become members of the Fraternal Medical Plan of the California Fraternal Service Association.

The Fraternal Medical Plan of the California Fraternal Service Association is currently active in the Los Angeles area.

The International Workers Order and the Jewish People's Fraternal Order have been designated by the Attorney General of the United States pursuant to Executive Order 10450.

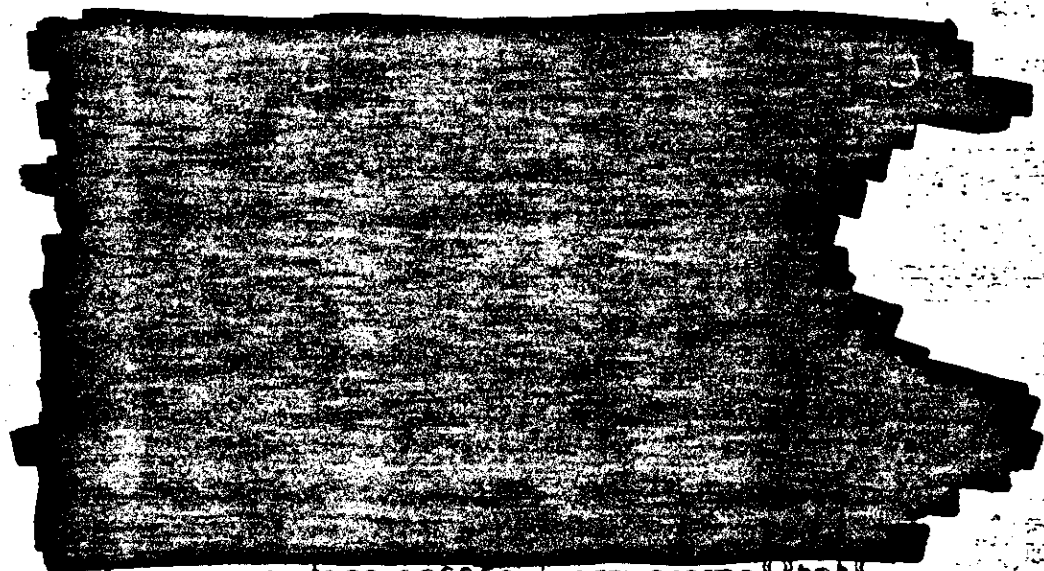

A buffet dinner was held to honor Dr. WILLARD UPHAUS on March 15, 1964 at the Marc Ballroom, 27 Union Square West, New York, New York.

After the dinner MIRIAM FRIEDLANDER, executive secretary of the Citizens Committee for Constitutional Liberties which sponsored the affair, addressed the group. She spoke of Dr. UPHAUS as a light comparable to that hanging in the North Church which warned that the British were coming during the Revolutionary War. She also spoke about the McCarran Act saying that this was the year to carry the message against it to the people.

MIRIAM FRIEDLANDER introduced HENRY ABRAMS as one who had been active in the peace movement. He handled the remainder of the program. ROBERT THOMPSON was introduced as a representative of the Communist Party. He did not speak. STEWART MEACHAM, a Quaker, spoke about the McCarran Act. Mr. MEACHAM said that people were condemned after being identified with an ideology. He said that the McCarran Act forbade people the ability to develop relationships with other people and that they were forced into isolation. He said that the Communist Party had representatives in the gathering because they were bound up with the struggle not to be condemned on a characterization.

LEE HAYS said that he knew Dr. UPHAUS and his wife from Arkansas and joked throughout his entire speech.

JOHN RANDOLPH said that he had been subpoenaed by the House Un-American Activities Committee. He read from portions of Dr. UPHAUS' book Commitment.


HERTA WARE lead in folksinging and WILLIAM MALONEY read poetry.

ANNETTE RUBINSTEIN said that she had lectured at World Fellowship at the request of Dr. UPHAUS when he was in prison in New Hampshire.

Rabbi ROBERT E. GOLDBURG said that he had known Dr. UPHAUS at Yale University and that he was the only clergyman that he (GOLDBURG) listened to. He said that he was on his way to Washington, D.C. to help honor AUBREY WILLIAMS and thereby he was against the House Un-American Activities Committee.

Dr. UPHAUS spoke against the McCarran Act as repressive. He repeated what STEWART BRACHAM said about what it means to be a full human being and not cut off from our development of human relationships. He said that man must be lifted from their plateaus.

Approximately 300 people attended this affair.
Rev. WM. WELSH made the pitch for money.

|| Mrs. ROSE SOBELL, mother of MORTON SOBELL, stated that she had visited her son recently and that he looks well.

Dr. PHILIP MORRISON, M.I.T. physics professor, gave a history of the development of the A-bomb. He stated that at the time of the trial when expert witnesses were needed, few came forward.

Mrs. SOBELL, wife of MORTON SOBELL, spoke of the 17 years her husband has spent in jail as a victory through his example of living and thinking. Mrs. SOBELL appealed for contributions to defray the legal costs of her husband's struggle for freedom. Mrs. SOBELL announced that \$3,400.00 was collected from the audience and others throughout the country.

Dr. HAROLD C. UREY, Nobel prize winner, stated that he did not have an opinion on MORTON SOBELL until he read a transcript of the trial. He stated that he is convinced that MORTON SOBELL is innocent.

The National Committee to Secure Justice in the Rosenberg Case, a Communist front which had been conducting the campaign in the United States, was reconstituted as the National Rosenberg-Sobell Committee at a conference in Chicago in October, 1953, and then as the National Committee to Secure Justice for Morton Sobell in the Rosenberg Case."

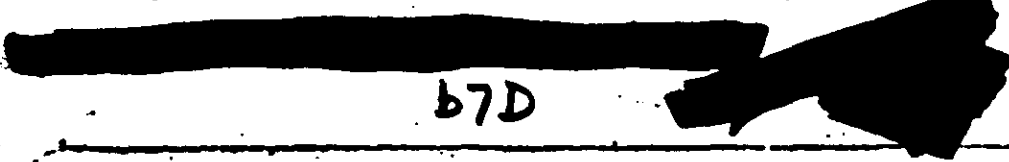
