CHILDREN'S TRUST FUNDS

T-2, of known reliability, advised that on July 13, 1953 savings account No. 1482167 was opened at the Union Dime Savings Bank, Sixth Avenue and 40th Street, New York City in the name of EPHRAIM CROSS, in trust for MICHAEL ROSENBERG. The signature card for this account listed CROSS' residence as 215 West 98th Street, NYC; father's name, ABRAHAM; mother, ROSE. CROSS was born in the year 1893 and is a citizen of the United States. His wife's name is MARY. The beneficiary of this account, MICHAEL ROSENBERG, address was listed as Toms River, New Jersey; father's name, JULIUS; mother, ETHEL. MICHAEL'S birthday was listed as merely the year 1943.

According to T-2, when CROSS opened this account, he attempted to include ROBERT ROSENBERG as a beneficiary; however, according to the informant, the Union Dime Savings Bank does not permit two beneficiaries to appear in a single account and therefore the name of ROBERT was deleted from the title of this account. On October 28, 1953 the balance in this account amounted to \$5,745.60.

On the following day, October 29, 1953, a check in the amount of \$5,500.00 was issued to the customer from this account. The check was payable to EMANUEL H. BLOCH, Trustee. A review of this check, CG 365990 revealed that EMANUEL BLOCH, endorsed this check with the name of the Rosenberg Children's Trust Fund, EMANUEL H. BLOCH, Trustee. BLOCH deposited this check in the Chase National Bank, Worth Street Branch. The balance in the savings account at the Union Dime Savings Bank on January 12, 1954 amounted to \$1,497.27.

T-3, of known reliability, advised that on September 17, 1953 a checking account was opened at the Chase National Bank at Broadway and Worth Street, New York City in the name of the Rosenberg Children's Trust Fund, care of EMANUEL H. BLOCH, 401 Broadway, New York City. The signature card for this account reflects that the checks drawn on this account must bear BLOCH'S signature and that of one other trustee.

The bank's records indicate EMANUEL H. BLOCH is Secretary for this fund, MALCOLM SHARP, Chairman and the Trustees are JAMES ARONSON, YURI SUHL and SHIRLEY GRHAM. The balance in this account as of February 6, 1954 amounted to \$13,967.65.

JERO PUBLISHING COMPANY

T-3 advised that on July 20, 1953 a checking account was also opened at the Chase National Bank, Worth Street Branch in the name of the Jero Publishing Company, 401 Broadway, New York City. The initial deposit amounted to \$1,135.20 which according to the informant was made up of \$35. in cash, a \$1,000. check drawn on the NCSJ and the balance in smaller checks. The signers for this account are EMANUEL H. BLOCH, Secretary and MORTON FRIEDMAN. The balance in the account of the Jero Publishing Company as of January 6, 1954 amounted to \$8,765.69.

**SYNOPSIS OF FACTS:**

The NCSJ continues to maintain a checking account at the Chase National Bank, NYC. Informant has furnished information concerning the identity of numerous contributors to the Committee, details of which are set forth. The deposits in October amounted to \$9,382.56; November, \$4,923.71 and December, \$5,011.61. The balance in this account as of 12/31/53 amounts to \$112.84. The informant was also able to identify various payments made by the Committee during the period October, November and December, 1953. The credits to this account during the period 7/16/52 to 12/31/53 totaled \$323,468.93. The informant has also advised that deposits to the Rosenberg Book Committee totaling \$3,622.21 were made during the period October 1 through December 31, 1953. The balance in this account as of 12/31/53 amounted to \$664.75. Informant has also advised that EPHRAIM CROSS maintains a savings account at the Union Dime Savings Bank, NYC in trust for MICHAEL ROSENBERG. The balance in this account as of 1/12/54 amounted to \$1,497.27. Informant has also advised that a checking account is maintained at the Chase National Bank, North Street Branch, NYC entitled Rosenberg Children's Trust Fund, which account is handled by EMANUEL H. BLOCH. The balance as of 2/8/54 amounted to \$43,957.65.

DETAILS:

BACKGROUND FOR NATIONAL COMMITTEE TO SECURE  
JUSTICE IN THE ROSENBERG CASE (NCSJ)

On March 29, 1951, JULIUS ROSENBERG and his wife, ETHEL, were convicted in the United States District Court for the Southern District of New York of conspiracy to commit espionage for the Soviet Union. On June 19, 1953 they were both executed at Sing Sing Prison, Ossining, New York.

On January 3, 1952 there was announced the formation of the National Committee to Secure Justice in the Rosenberg Case (NCSJ). MR. HOWARD RUSHMORE, writer for the "New York Journal-American" made available a copy of a press release announcing the formation of this committee which was dated December 31, 1951. This committee is headed by JOSEPH BRUNIN, who is described as a journalist and author. With this committee he holds the rank of Chairman while DAVID ALMAN is the Executive Secretary. The purpose of this committee was to raise money for the defense of the ROSENBERGS and to arouse public sympathy for them.

THE ROSENBERG BOOK COMMITTEE

T-1, of known reliability, on July 14, 1953 advised that a checking account was opened at the Times Square Branch of the Chase National Bank, New York City in the name of the Rosenberg Book Committee, 1050 Avenue of the Americas, New York City. It will be noted that this is the same address used by the NCSJ. The signers for this account are SARAH LITCHENBERG and NORMA ARONSON.

The "National Guardian" dated June 15, 1953 stated that the "Death House Letters of Ethel and Julius Rosenberg, a one dollar book of the letters of the couple to each other, their children, their attorneys and others, came off the press June 11. Published by Jero Publishing Company. Profits will be held in trust for the Rosenberg Children, Michael and Robbie."

FINANCIAL INFORMATION CONCERNING THE NCSJ

The following information is made available on a confidential basis and should not be made public except in a usual proceeding following the issuance of a subpoena duces tecum.

The NCSJ continues to maintain a checking account at the Chase National Bank, Times Square Branch, 41st Street and Seventh Avenue, New York, New York.

The column captioned "Amount" indicates the amount of the contribution and the column "Remitter" is the contributor's name as furnished by the informant. The column "Method of Payment" indicates the bank on which the contributor drew the check or other means used to transmit these funds. **DETAILS:**

**BACKGROUND FOR NATIONAL COMMITTEE TO SECURE JUSTICE IN THE ROSENBERG CASE (NCSJ)**

On March 29, 1951, JULIUS ROSENBERG and his wife, ETHEL, were convicted in the United States District Court for the Southern District of New York of conspiracy to commit espionage for the Soviet Union. On June 19, 1953 they were both executed at Sing Sing Prison, Ossining, New York.

On January 3, 1952 there was announced the formation of the National Committee to Secure Justice in the Rosenberg Case (NCSJ). [REDACTED]

[REDACTED] made available a copy of a press release announcing the formation of this committee which was dated December 31, 1951. This committee is headed by JOSEPH BRUNIN, who is described as a journalist and author. With this committee he holds the rank of Chairman while DAVID ALMAN is the Executive Secretary. The purpose of this committee was to raise money for the defense of the ROSENBERGS and to arouse public sympathy for them.

**THE ROSENBERG BOOK COMMITTEE**

T-1, of known reliability, on July 14, 1953 advised that a checking account was opened at the Times Square Branch of the Chase National Bank, New York City in the name of the Rosenberg Book Committee, 1050 Avenue of the Americas, New York City. It will be noted that this is the same address used by the NCSJ. The signers for this account are SARAH LITCHENBERG and NORMA ARONSON.

The "National Guardian" dated June 15, 1953 stated that the "Death House Letters of Ethel and Julius Rosenberg, a one dollar book of the letters of the couple to each other, their children, their attorneys and others, came off the press June 11. Published by Jero Publishing Company. Profits will be held in trust for the Rosenberg Children, Michael and Robbie."

The following information is made available on a confidential basis and should not be made public except in a usual proceeding following the issuance of a subpoena duces tecum.

On March 29, 1951, JULIUS ROSENBERG and his wife, ETHEL, were convicted in the United States District Court for the Southern District of New York of conspiracy to commit espionage for the Soviet Union. On June 19, 1953 they were both executed at Sing Sing Prison, Ossining, New York.

On January 3, 1952 there was announced the formation of the National Committee to Secure Justice in the Rosenberg Case (NCSJ). Mr. HOWARD RUSHMORE, writer for the "New York Journal American" made available a copy of a press release announcing the formation of this committee which was dated December 31, 1951. This committee is headed by JOSEPH BRAIMIN, who is described as a journalist and author. With this committee he holds the rank of Chairman while DAVID ALLEN is the Executive Secretary. The purpose of this committee was to raise money for the defense of the ROSENBERGS and to arouse public sympathy for them.

### ATTORNEY GENERAL'S OFFICE ADMITS CHIEF WITNESSES LIED IN TRIAL

A major break has taken place in the Rosenberg-Sobell case. The U. S. Attorney General's Office has admitted that new evidence proves David and Ruth Greenglass lied. The Attorney General's Office said:

"The console table evidence, the Attorney's memoranda, the affidavit about David's uranium theft-- All of these are at most evidence tending to show that the Greenglasses had some motive to lie and some facts from which it might be inferred that they had done so."

This revealing statement was made in the government's brief of Jan. 21 to the U.S. Supreme Court in the Sobell case.

By exposing these lies, the new evidence refutes the Greenglass' entire story about the atomic conspiracy. The same evidence exposes the use of perjured testimony by the Attorney General's Office itself.

### WHO IS MORTON SOBELL?

Morton Sobell, a young scientist, was convicted in the trial with Ethel and Julius Rosenberg. He was charged with "conspiracy to commit espionage". Condemned to thirty years in prison, he was sent to Alcatraz by the Office of the U. S. Attorney General.

Morton Sobell has steadfastly maintained his innocence. The only specific acts charged against him were having had five conversations with Julius Rosenberg. The only witness who attempted to link him with any alleged espionage activity was Max Elitcher, a former neighbor. Elitcher admitted on the stand that he faced a possible indictment for perjury. By testifying against Sobell, he avoided the indictment and was assisted by the government in getting a job. However, the "conspiracy" nature of the indictment made the testimony of the Greenglasses apply to Sobell--even though the Greenglasses did not implicate him.

## NEW LEGAL MOVES PLANNED TO WIN NEW TRIAL FOR SOBELL

Several strong courses of legal action are open to Morton Sobell. Attorneys are now deciding on the next legal steps to obtain a new trial.

The U. S. Supreme Court, which has never reviewed the Rosenberg-Sobell case, turned down Morton Sobell's appeal on Feb. 1. This appeal was started in the lower courts before the execution of the Rosenbergs. It was therefore based on the same new evidence on which the Supreme Court refused to grant the Rosenbergs a stay.

In order to have reviewed the Sobell case on the same legal motion, the Supreme Court would have had to reverse itself on the Rosenberg decision.

One important victory was won in the recent Supreme Court appeal. The government had to concede that the new evidence proved the Greenglasses lied.

The Rosenberg-Sobell Committee commented: "The fight will be carried in the courts, and in the arena of public opinion until Morton Sobell wins a new trial."

## NEW YORKERS JOIN NATIONAL CAMPAIGN FOR SENATE PROBE OF CONDUCT OF U.S. ATTORNEY GENERAL'S OFFICE

It is within the power of the American people to stop the Attorney General's Office from continuing the methods it has used against the Rosenbergs and Morton Sobell. People throughout the country are directing appeals to the Senate Judiciary Committee to investigate the conduct of the Attorney General's Office in this case. New Yorkers have launched a petition, post-card, and letter writing campaign to bring the facts before the public and the Senate.

On Dec. 1st the National Rosenberg-Sobell Committee filed a brief with Senator William Langer, Chairman of the Senate Judiciary Committee, urging an inquiry. Senator Langer said he would present the brief to the full Judiciary Committee at the earliest possible moment. The brief documented seven charges against the Attorney General's Office.

One charge involves the use of perjured testimony, as proved by the new evidence. Another charge deals with the attempt by the Attorney General's Office to keep the new evidence from the courts. The Attorney General's Office is also accused of withholding clemency appeals from two U. S. Presidents. There is also information indicating that the Attorney General's Office tampered with the judicial system by conferring with the Chief Justice of the Supreme Court after the Court had been called back into session to review the stay granted by Justice Douglas.

## Urge Inquiry On Alcatraz Imprisonment

On Thanksgiving Day 1952, Morton Sobell was sent to Alcatraz, three thousand miles away from his wife, children, and defense attorney. This was done by the Attorney General's Office while Sobell's appeal for a new trial was still pending.

The imprisonment of Morton Sobell in Alcatraz on a thirty year sentence violates all legal and moral precedent. Alcatraz, known as America's Devil's Island is used only for hardened criminals who are considered dangerous because of their long criminal records. Morton Sobell does not fit into this category. He has no previous criminal record and was never convicted of so much as a traffic violation.

The National Committee To Secure Justice for Morton Sobell in the Rosenberg Case has charged that Sobell was put in Alcatraz in an effort to force from him a false "confession" that would whitewash the conduct of the Attorney General's Office in this case.

A Petition asking the Senate Judiciary Committee to investigate the circumstances of Morton Sobell's imprisonment in Alcatraz is being circulated.

[REDACTED] said HERMAN TINSKY (\*) of Boston attended this conference as a delegate from New England. b7d

[REDACTED] stated TINSKY (\*) indicated the present objective of the committee was not to strive for a reduction in MORTON SOBELL's sentence, which would admit some guilt on his part, but to try for his complete release, thereby exonerating him. [REDACTED] b7d

[REDACTED] Informant stated EMILY ALLEN from New York City, a national functionary of this committee, spoke to those present about future plans of The National Rosenberg-Sobell Committee. According to [REDACTED] ALLEN stated that this time the committee intended to work from the top down, rather than from the bottom up in securing well known civic and religious leaders to sign amicus curiae briefs. [REDACTED] said this referred to the efforts made by the National Committee to Secure Justice in The Rosenberg Case, the organization which preceded The National Rosenberg-Sobell Committee. [REDACTED] recalled that ALLEN also instructed the group to raise b7d

part of a national \$60,000 fund by having at least 200 persons in the Greater Boston area give \$30 each. MILLIN said a national officer of The National Rosenberg-Sobell Committee would come to Boston in the near future to handle the committee's publicity in this area.

██████████ stated approximately thirty-five persons attended a meeting of The National Rosenberg-Sobell Committee, held on November 21, 1953, in Milton, Massachusetts. ██████████ stated ELLIE MILLIN of New York City, a national officer of the group, was the principal speaker at this meeting which was designed to raise funds and to plan a signature campaign for SOBELL. b7d

██████████ stated a meeting of The National Rosenberg-Sobell Committee was held on ██████████ at ██████████

██████████ stated the group discussed the raising of funds for the committee and the selection of civic and religious leaders to be solicited for signatures on various curiae briefs. b7d

██████████ stated SUE KORITZ (\*), one of the principal leaders of the Boston Branch of The National Rosenberg-Sobell Committee, during December, 1953, stated she (KORITZ (\*)) hoped to contact certain scientists attending the American Association for The Advancement of Science convention, being held in Boston, Massachusetts, to get their signatures on various curiae briefs on behalf of MORTON SOBELL. b7d

██████████ stated as of December, 1953, ROSE DEVORE (\*) stated there was no meetings or other activity on behalf of The National Rosenberg-Sobell Committee in the Greater Boston, Massachusetts area. b7d

██████████ stated as of February 8, 1954, The National Rosenberg-Sobell Committee in the New England area was a loosely knit organization. b7d

with no officers or headquarters, and held only occasional meetings at the homes of various members. [redacted] said the group conducted little or no activity since changing its name from the Boston Committee to Secure Clemency in The Rosenberg Case to The National Rosenberg-Sobell Committee. b7d

On February 20, 1953, a special checking account was opened on behalf of the Boston Committee to Secure Clemency in The Rosenberg Case at the First National Bank, Boston, Federal Street, Boston, Massachusetts, in the name of ILLYAN SHUBERT (\*), 33 Greenock Street, Dorchester, Massachusetts.

Boston Informant T-9 has furnished the following information reflecting the activity in this account from September 1, 1953 to January 31, 1954:

There is no record of a \$50 check withdrawn on November 30, 1953, and T-9 believes this may have been a personal withdrawal.

On December 1, 1953, a check in the amount of \$9.18, payable to RICHLEL BUCKELN (\*) dated November 22, 1953, and signed ILLYAN SHUBOV (\*) and endorsed RICHLEL BUCKELN (\*) was drawn on the above account.

Other checks drawn on this account were for utilities and services.

[REDACTED] stated that at a national conference of The National Rosenberg-Sobell Committee, held in Chicago, Illinois, on October 10 and 11, 1953, HERMAN TRISKY (\*) was elected as a member of the National Executive Committee, representing Boston, Massachusetts. b7d

[REDACTED] stated as of February 8, 1954, The National Rosenberg-Sobell Committee in the New England area had no officers as such, although SUE KORITZ (\*) had assumed the leadership of the group, arranged for meetings and the notification of members of the activities of the organization. b7d

IV. ESTIMATED MEMBERSHIP OF THE NATIONAL ROSENBERG-SOBELL COMMITTEE IN THE NEW ENGLAND AREA

[REDACTED] stated as of February 8, 1954, The National Rosenberg-Sobell Committee in New England was a loosely knit organization with members in Lawrence, New Bedford, Fall River, Quincy, Springfield and Greater Boston, Massachusetts, although there was no formal organizational set up in any of the above named cities. [REDACTED] stated he could not estimate the number of members of the group due to the inactivity since its inception but knew the total membership was substantially less than the 100 to 125 members of the Boston Committee to Secure Clemency in The Rosenberg Case. b7d

D. PHILIP KORITZ (\*) - Boston Informant [redacted] of unknown reliability, a former Communist Party member, identified PHILIP KORITZ as a Communist Party member in Winston-Salem, North Carolina, during 1947. b7d

E. DR. BENJAMIN WEINSTEIN (\*) - Boston Informant [redacted] stated Dr. BENJAMIN WEINSTEIN was a person he knew as a Communist Party member during 1952. b7d

G. LILYAN SHUBOW (\*) - [redacted] during February, 1953, identified LILYAN SHUBOW as a "member of or associated with the Communist Party in Massachusetts." b7d
